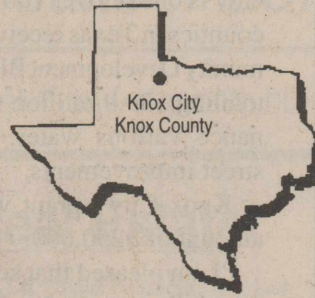

## Lions maul Greyhounds 27-6 in game at Roby

The Knox City Greyhounds found themselves outgunned again last week when they traveled to Roby to take on the Lions. Roby wasted no time in establishing both a strong offense and a strong defense. The Lions scored early in the first quarter and discovered that their running game worked well against the right side of Knox City's defensive line. Play

after play and series after series, the Lions pounded that side of the line to gain big yardage throughout the game.

Greyhound defenders found that it took more than one tackler in order to stop the Lion running backs. Gang tackling later in the game proved more effective, but the Knox City defense looked disorganized throughout most of the

game.

On the offensive side of the ball, the Greyhounds tried running most of the night, and were not very successful against the tough Lion defense. Finally, late in the 4th quarter, passing plays were called in from the sidelines and the Hounds were able to move the ball down towards the goal line, but were stopped short of a

second touchdown attempt.

Knox City travels to Petrolia this Friday night in the last non-district game of the season. Game time at Petrolia is at 8:00 p.m. District action for Knox City and district 9 will begin next Friday, October 8, with the Greyhounds taking on Knox County rival Munday. District games will start a half hour earlier at 7:30 p.m.

### Knox City Junior Varsity wins over Anson, O'Brien Bulldogs lose to Roby

In football action last Thursday evening at O'Brien, the Greyhound Junior Varsity easily defeated the JV from Anson, 27-6. In spite of playing a class 2-A JV team, the class 1-A Hound Junior Varsity advanced their season

record to 4-0, after previously defeating Class 2-A Seymour twice in games at Seymour and O'Brien, and defeating Class 2-A Quanah in a Saturday afternoon game at Quanah the week before last. This week, the Quanah JV

will travel to O'Brien on Saturday to once again battle the Greyhound Junior Varsity in a game set for 7:00 p.m.

The 7th and 8th grade Bulldogs from O'Brien played a tough game against the Roby Jr. High

Pups in the first game last Thursday at O'Brien, losing to Roby by a heartbreaking score of 8 to 6. Under the direction of Coach Jimmy Chappell, the Bulldogs from O'Brien Mid School have an open date this week.

## Counts urges vote on amendments in November 1999 Texas elections

AUSTIN - Voters will have the opportunity to change the Texas Constitution this November on issues like money for student loans, reverse mortgages and vacancies in the governor's office.

Seventeen amendments to the state's constitution have been proposed by the Texas Legislature for the general election on Tuesday, November 2, 1999.

The proposed amendments will appear on ballots across the state using specific language already approved by legislators.

"Since the adoption of our state's constitution in the late 1800s, almost 400 changes have been approved by voters," State Rep. David Counts (D-Knox City) said.

"Many of the amendments we proposed for November help

clean-up or clarify old language."

One amendment, Proposition 1, clarifies old language by expressly stating that once there is a permanent vacancy in the governor's office, the lieutenant governor becomes the governor of the state for the remainder of the governor's term and must vacate the office of lieutenant governor.

Counts said some of the proposed amendments have ore substance and should be reviewed carefully by voters before the election.

Proposition 2 would make changes in reverse mortgages which were allowed in Texas when voters approved them in 1997.

This proposition raises the eligibility for reverse mortgages to

age 62 and allows more flexibility in the timing and amount of money advanced to the lender.

Another amendment, Proposition 13, allows the legislature to authorize up to \$400 million in general obligation bonds with the proceeds used to provide education loans to students.

"The November election allows voters to have a say in changes to their constitution," Counts said. "I hope lots of voters come out and let us know what they think."

## Knox City is \$250,000 HUD grant recipient

United States Senator Phil Gramm has announced that Knox City is one of over 100 cities and counties in Texas receiving Community Development Block grants totaling \$30.9 million to help finance various water, sewer or street improvements.

Knox City's grant was in the amount of \$250,000.

"I am pleased that some of the tax dollars sent by Texans to Washington are being returned to benefit area citizens by financing improvements to the areas where we work and live every day," Gramm said in making the announcement.

The funds are provided by the U.S. Department of Housing and Urban Development and will be administered by the Texas Department of Housing and Com-

munity Affairs through the Texas Community Development Program. "My strong commitment is to assure a fair return to Texas taxpayers on the money we pay in federal taxes," the senator said.

The Community Development Block Grant program, one of HUD's largest, is designed to assist communities in carrying out a wide range of development activities aimed at neighborhood revitalization, economic development and improved community facilities and services. Senator Gramm is chairman of the Senate Banking Committee, which has statutory authority over the CDBG program.

Area towns also receiving grants were Rochester, \$250,000; Hamlin, \$250,000; and Seymour, \$150,000.

## FSA emergency farm loan applications being accepted

Applications for emergency farm loans for damages and losses caused by extreme fire hazards that occurred on August 1, 1999 and continuing, are being accepted at the Farm Service Agency (FSA) office located in Knox City, FSA - Farm Loan Manager Bobby G. Cude said.

Knox County is 1 of 227 in Texas recently named by President Clinton as eligible for loans to cover part of actual production losses resulting from the extreme fire hazards.

Cude said farmers may be eligible for loans of up to 80% of their actual losses or the operating loan needed to continue in business, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest is 3.75 percent.

"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be

eligible for an FSA emergency loan," Cude said. Farmers participating in the Federal Crop Insurance program will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until May 1, 2000, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over into the new farming season," Cude said.

FSA is a credit agency of the U.S. Department of Agriculture. FSA is authorized to provide disaster emergency loans to recognized farmers who work at and relay on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U.S. citizens and to farming partnerships, corporations or cooperatives in which U.S. citizens hold a majority interest.

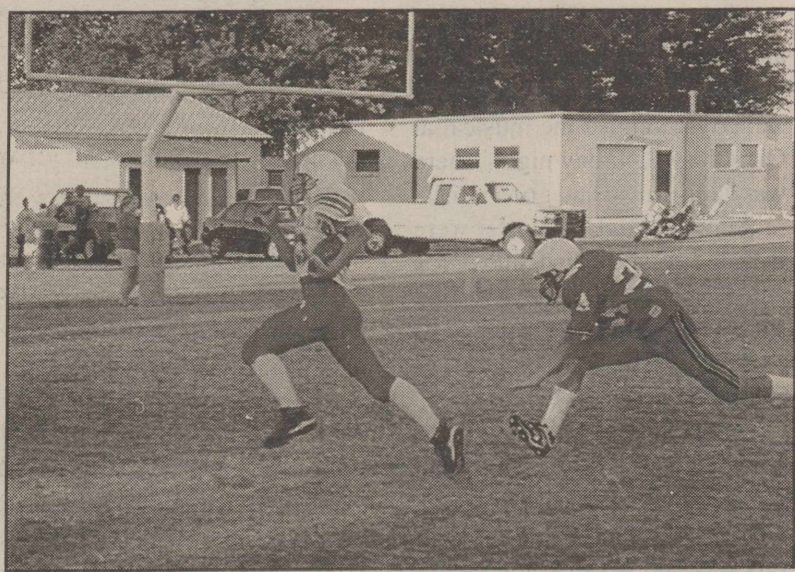

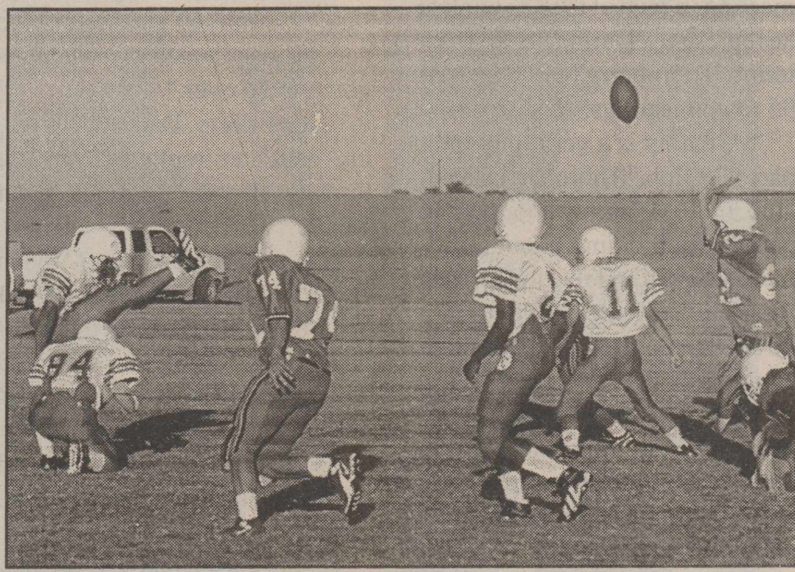

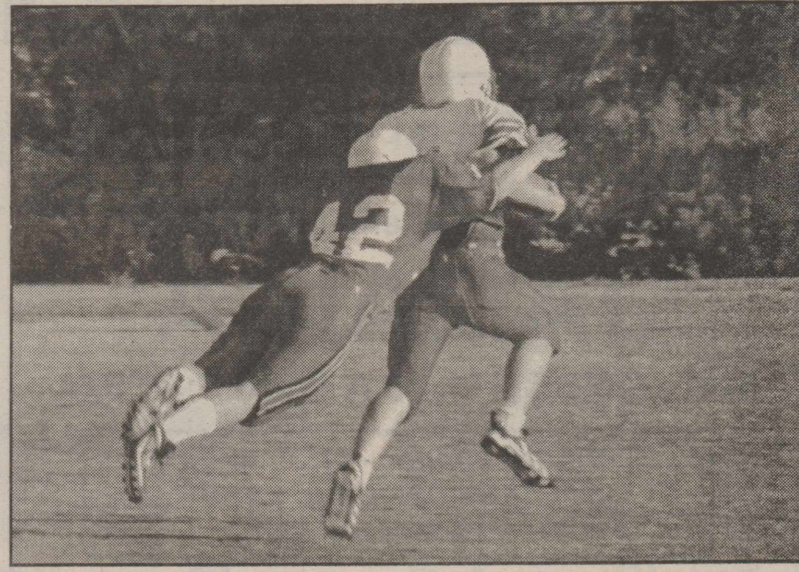

**RYNE BURKHAM** goes for the goal line to add another 6 points to the scoreboard during the game against the Anson JV last week.



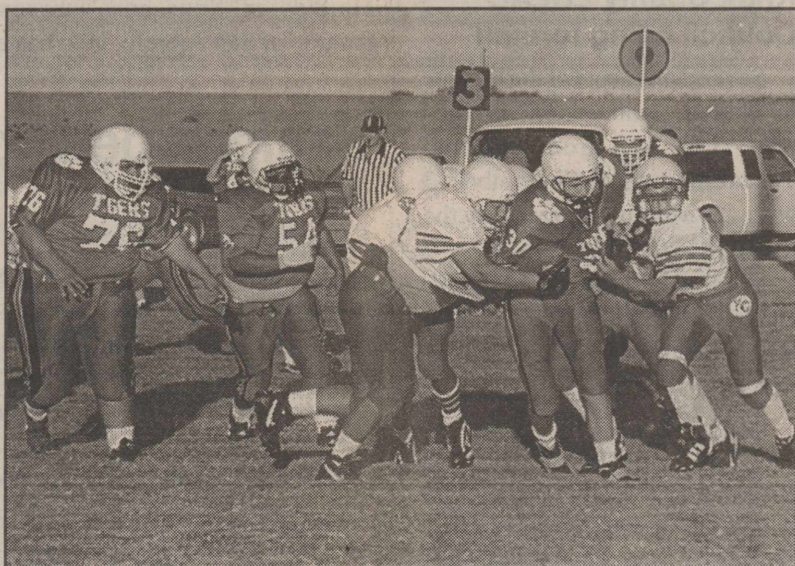
**DOMINIQUE COLLIER** kicks another extra point in the game against Anson. Brad Johnson (84) is placing the ball.



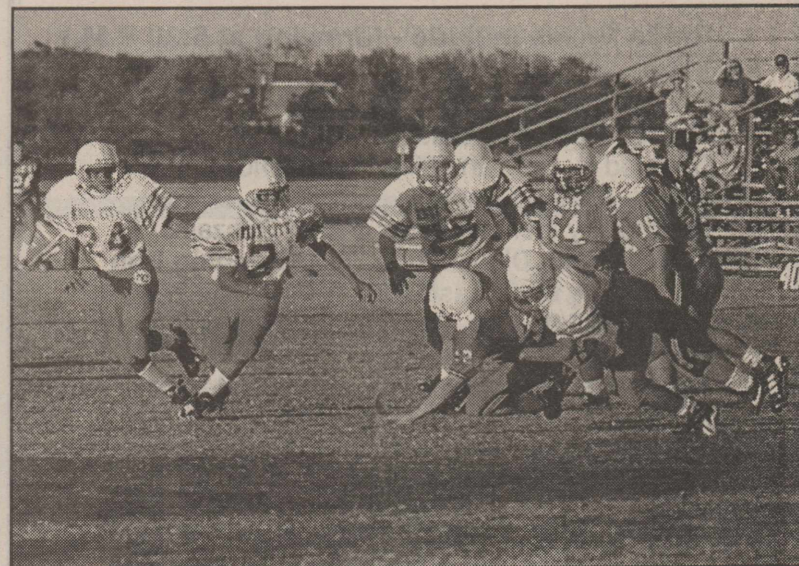
**SCOOTER THOMPSON** made a long run down the field before being stopped just short of the goal by an Anson defender.



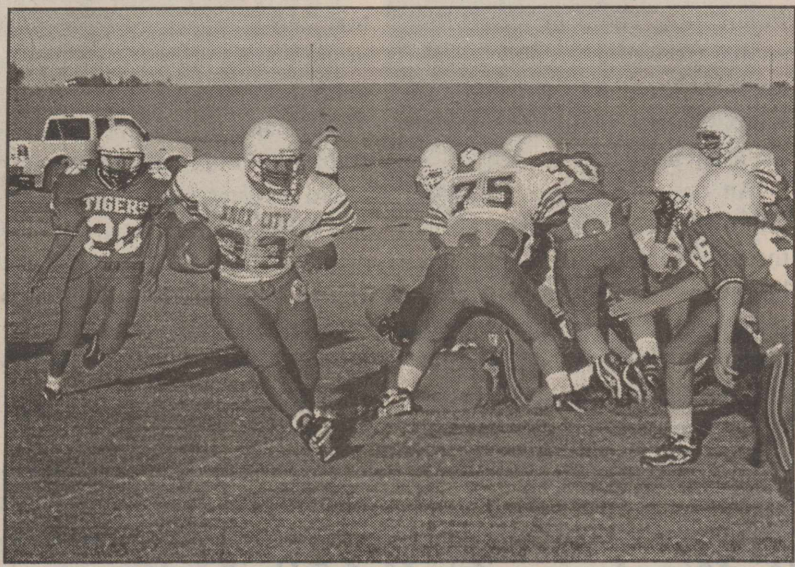

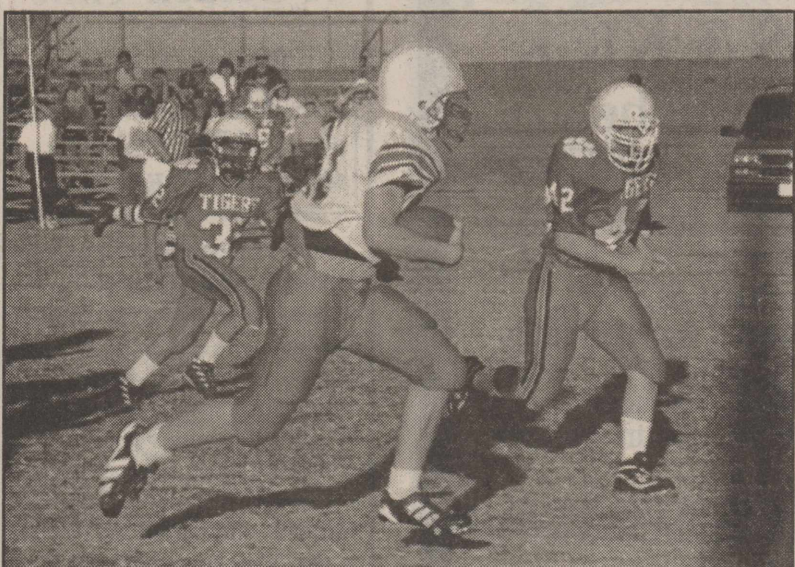

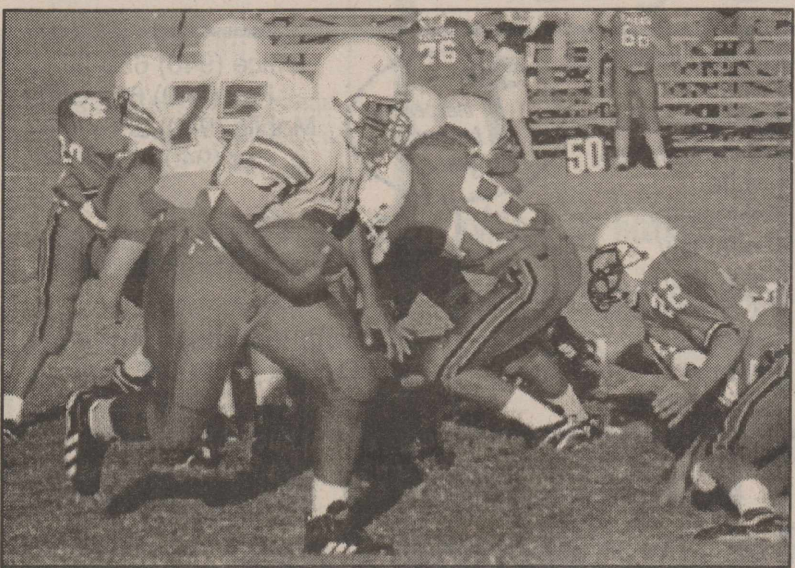

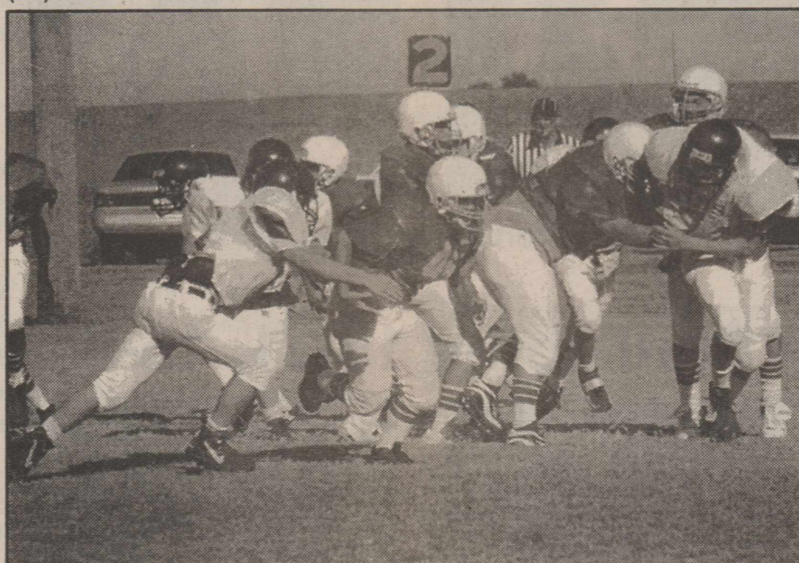
