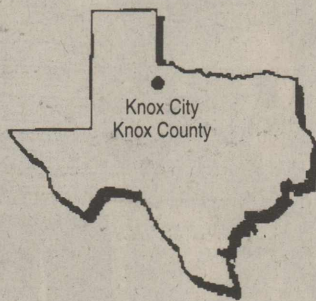

## M-System becomes Lawrence Brothers

Lawrence Bros. IGA is now at home in Knox City following a purchase by the Sweetwater-based chain acquiring the local M System supermarket as well as those in Anson, Seymour and Munday.

The acquisitions became official Saturday at midnight.

Kyle Lawrence, one of the owners of the 72-year-old family business, confirmed the purchase.

For now, only the name will change and the employees will be retained in each city, he said.

Lawrence continued by saying that former M-System manager Danny Lain will remain on board as store manager and the same personnel will continue from 'top to bottom'.

The purchase of the remaining four M-System stores brings the total of Lawrence Bros. IGA and Fiesta Foods supermarkets in the Big Country to 24.

The actual sale developed quickly over the last few weeks but had its roots many years ago, Lawrence said, explaining that the four M-Systems were owned by longtime friends of the Lawrence family, the Pace family of Fort Worth.

"We'd talked for years about buying their stores



when they got ready to sell," he said. The pending retirement of the Pace family's operations manager influenced the timing.

Lawrence said the family friendship goes back to Lawrence Bros.' founder, his grandfather J.M. Lawrence, and the patriarch of the Pace family gro-

cers, J.C. Pace. Each started his first grocery store in 1927, Lawrence in Sweetwater and Pace in Cisco.

Pace later moved to Fort Worth and at one time owned a chain of more than 100 supermarkets, known as Buddy's.

"It was one of the biggest supermarket chains in

Texas at one time," Lawrence said. The M-System supermarkets purchased by Lawrence Bros. were the last four supermarkets left among the Pace family's holdings, he said.

The Lawrence family also operated Piggly Wiggly stores for over 20 years.

Kyle's father, Jere and his brother Tere Lawrence, returned to the family business in 1953.

With Seymour being the northeast corner stretching to near Lubbock and the Midland-Odessa area back to Brownwood, Lawrence Bros. has a number of stores in communities the size of Knox City.

Lawrence stressed that they cater to the smaller, rural areas and have area locations in Aspermont, Spur and Hamlin.

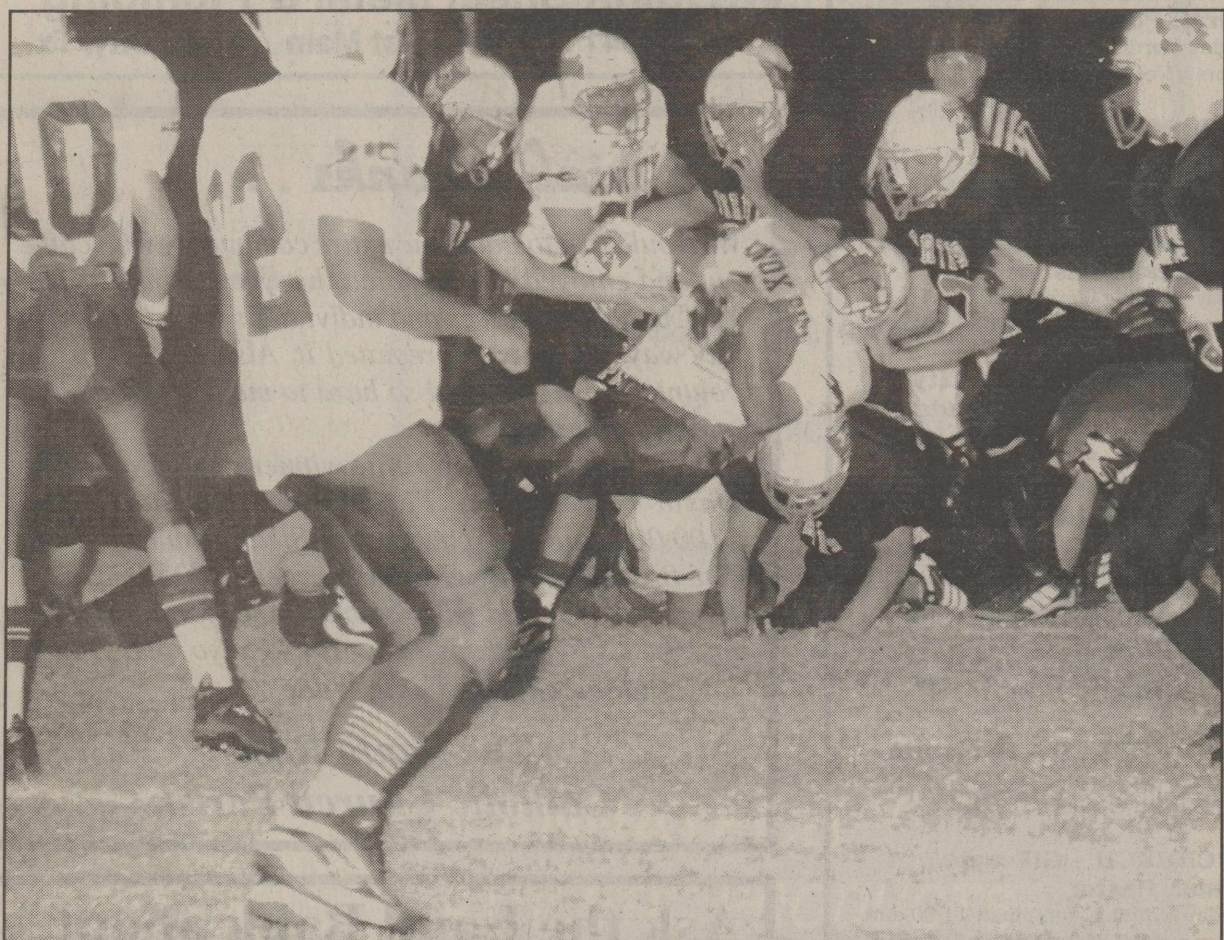
He also said that with their product and service, he feels they will be able to offer lower prices to customers.

Lawrence Bros. IGA inserts will appear in each issue of *The Knox County News* as the firm believes in supporting the local economy, he said.

The IGA label will replace Shurfine and Rainbow will replace the Shursavings label.

## Petrolia Pirates fire 36-0 broadside into Greyhounds

1-4 Pre-season record is history, district action begins Friday against arch-rival Munday

During the long bus trip home from Petrolia last Friday night, the Greyhound Varsity Football Team had plenty of time to ponder the 36-0 loss administered by the Pirates in the 'Hound's last non-district game of the 1999 season.

With hopes of ending a 3 game losing streak since winning their season opener back on September 3rd, the Greyhounds appeared fired up during the pep rally last Friday before leaving for Petrolia. That enthusiasm did not last long on the field however, as the Pirates totally dominated Knox City on both offense and defense.

KC won the toss and elected to receive, but were unable to move the ball against a very tough Petrolia defense. The punt on 4th down seemed to be the signal of things to come as the Pirate who caught the punt returned it for a touchdown.

Throughout the game, the Greyhounds were once again hampered by a rash of yellow flags, with team spirit seeming to take a nose dive every time a flag dropped or the Pirates added to their numbers on the scoreboard. Although the evening did not go the way coaches, players, or fans would have wanted, Knox City did see a few bright spots along the way. With Sophomore Shawn Speck

starting as a receiver, the Greyhound passing game showed improvement as he caught pass after pass. Senior Myles Richardson also displayed his skill by coming up with a big pass interception that stopped another Pirate touchdown.

Now this sad note about the game: While most of our Greyhounds were playing their hearts out on the field, a few of their teammates displayed very unsportsmanlike conduct on the sidelines by using profanity, or by actions such as laughing while the school song played at the end of the game.... despite

## Knox County Hospital Health Fair starts this Saturday morning at 9:00

Y-4H (Year for Health) is the theme for the 1999 annual Health Fair to be held Saturday, October 9, on the front lawn of the hospital from 9:30 a.m. until noon.

Among the features this year will be free blood pressure checks, free cholesterol screening, free glucose levels, free child finger printing, blood drive, free tee shirts to be given away in drawings and memberships for wellness program, along with many other extras.

The Hospital Auxiliary, aka 'Pink Ladies' will provide refreshments and register everyone for the drawings to be given away. As in prior years, flu shots for \$5.00 payable at time of service for all non-Medicare patients, will be offered. Medicare patients need to bring their Medicare card.

First Flight air ambulance will be landing on the new hospital Helipad. Again this year, the bone density scan testing will be performed at no charge to the patient. The purpose of this test is early detection of possible bone loss and osteoporosis. The test is completely painless and is conducted on adults over the age of 30 and

results are tabulated instantly.

As well as the above mentioned, there will be healthcare providers from all around the community and county.

The two newest additions to this year's Health Fair will be the American Red Cross Disaster Relief Team and the American Red Cross Bloodmobile. There will be a blood drive in the American Red Cross Bus in front of the hospital. Blood supplies are at an all time critical low and they are pleading for donors. Remember when deciding whether to donate or not, the blood donated could possibly be used to save your child, grandchild, wife, husband or yourself in a crisis.

'Year for Health' (Y-4H) is the perfect time to sign up for "Wellness". The hospital's Wellness Center is always a climate controlled atmosphere with the latest in treadmills, exercise bicycles, rowing machines, stair

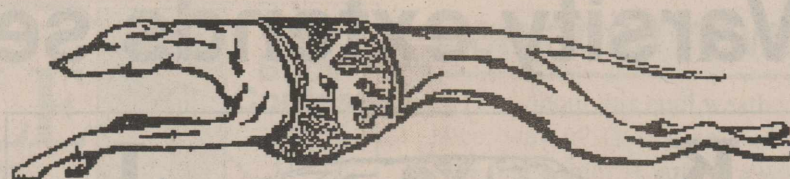

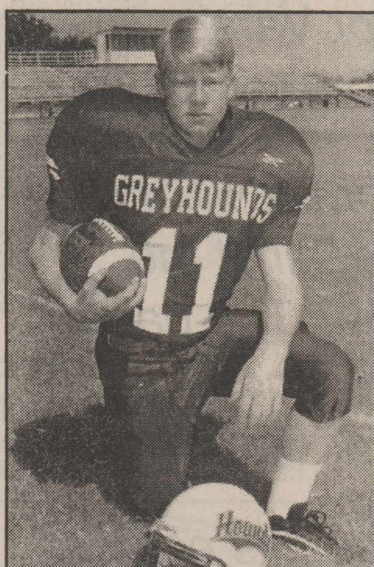

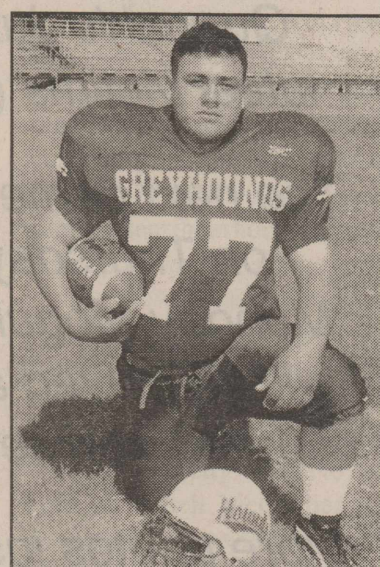

### Emergency Disaster Relief is Needed, But Larger Problems Facing Agriculture Must Also Be Addressed

Most people agree that one of the main causes of the economic crisis in agriculture today is the collapse of the Asian economy.

The loss of this market and its impact on world commodity prices has been severe. Partly as a result, Congress provided over \$6 billion in emergency disaster payments to farmers and ranchers last year. This past week, the House gave final approval to nearly \$9 billion more in disaster payments.

While these payments are clearly needed, we must address the larger problems facing agriculture. The House took a step in this direction last Wednesday by approving a bill that will make crop insurance more accessible to producers. Among other things, this bill will reduce the insurance premiums producers have to pay, increase producers' insurable yields, and establish new risk management for livestock producers.

But beyond these payments and this bill, there are a number of critical things Washington must do.

First, we need to sell more of our products overseas. The Clinton Administration must begin taking advantage of the resources it has at hand to promote and encourage exports.

At the same time, both Congress and the President must take a serious look and hopefully overhaul the current trade sanctions and embargo policy, which all too often punishes our farmers and ranchers more than it does a foreign government.

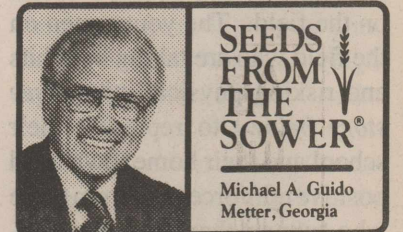
We must also continue the push to reduce the high taxes and over-regulation which producers struggle with every day. Finally, we should reexamine the Farm Bill from top to bottom to see how it can work better in times of low prices.

We have a lot of work to do in the coming weeks and months to address the problems facing agriculture. It's critical that those of us from rural areas speak with one voice on this issue to build a better safety net for producers and provide farmers and ranchers much-needed relief.

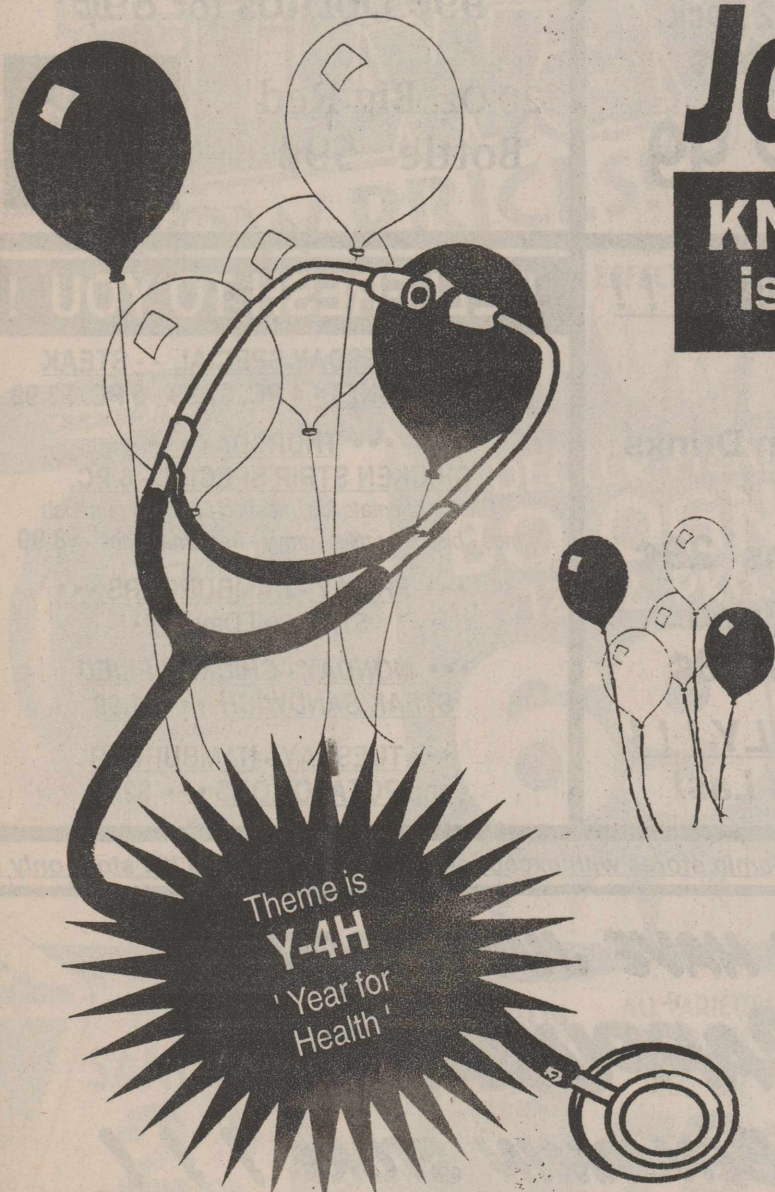

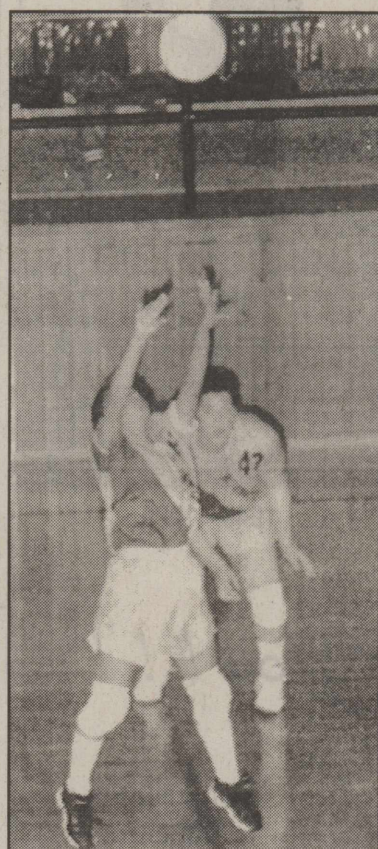
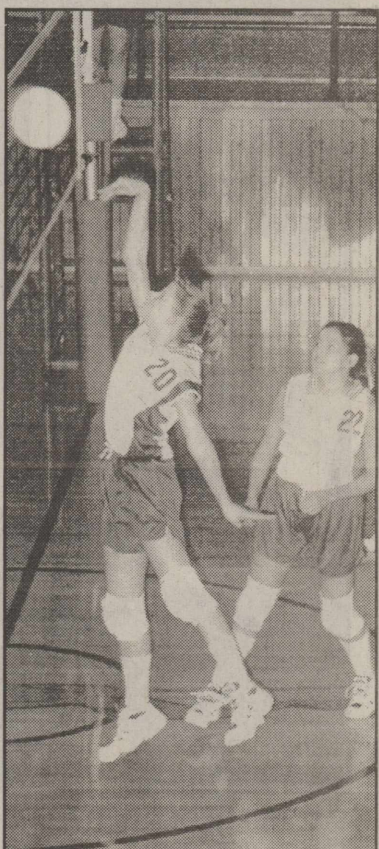

## Rep. David Counts encourages public awareness of airborne monitoring website

AUSTIN - The state's development of an air monitoring website now makes it easy to check air pollution and ozone conditions from Beaumont to El Paso on an hourly basis.

The Texas Natural Resource Conservation Commission (TNRCC) monitors air quality across the state and is responsible for reporting that information to the public. The agency has set-up air monitoring stations across Texas that report local conditions back to Austin every hour via computer for placement on the website.

State Representative David Counts (D-Knox City) chairs one of the environmental legislative committees that oversees the TNRCC's activities.

"I'm always supportive of state developments that provide the public with more information," Counts said. "This website has already raised public awareness

across the state, and the data has helped state regulators combat air pollution in Texas."

The website provides information on ozone exceedances, weather conditions, and air quality standards. It also contains

hourly updates and alerts the public when an "Ozone Action Day" is in effect.

The air monitoring units across the state have helped the TNRCC determine where the most problematic regions of the state exist. The data has also been used to separate air pollution that has been generated inside the state from other sources across state lines.

"Good data helps the TNRCC make better reports to federal agencies like the EPA," Counts said. "Our agency has discovered that while some air pollution comes from Texas cities, some can come from as far away as a sandstorm in the Sahara Desert in Africa."

Counts represents House District 70 from Big Spring to Knox City including Borden, Fisher, Garza, Howard, Jones, Kent, King, Knox, Lynn, Nolan, Scurry and Stonewall Counties.

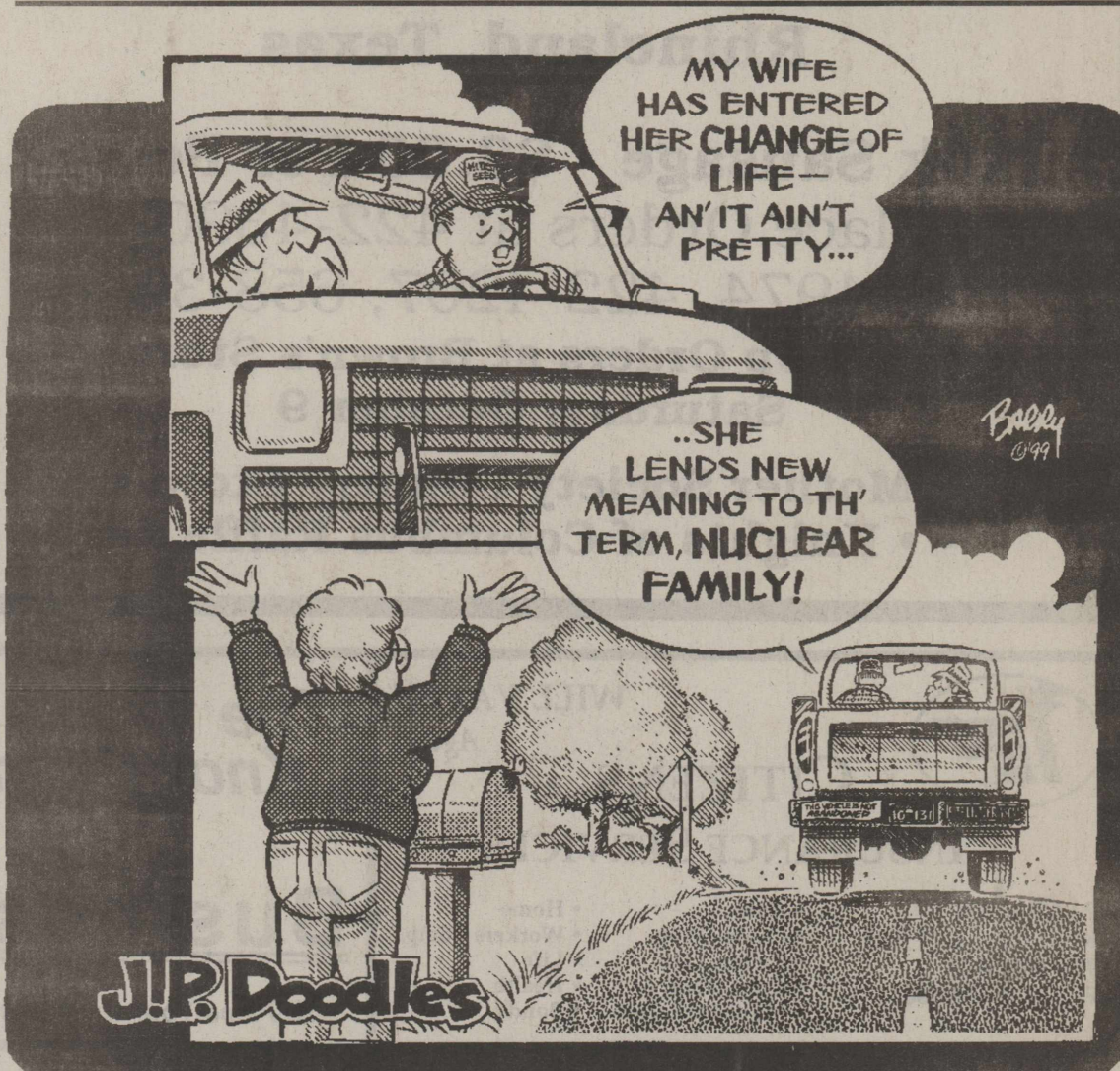

Mr. Hacker, 91, died Friday, October 1, in Knox City following a brief illness.

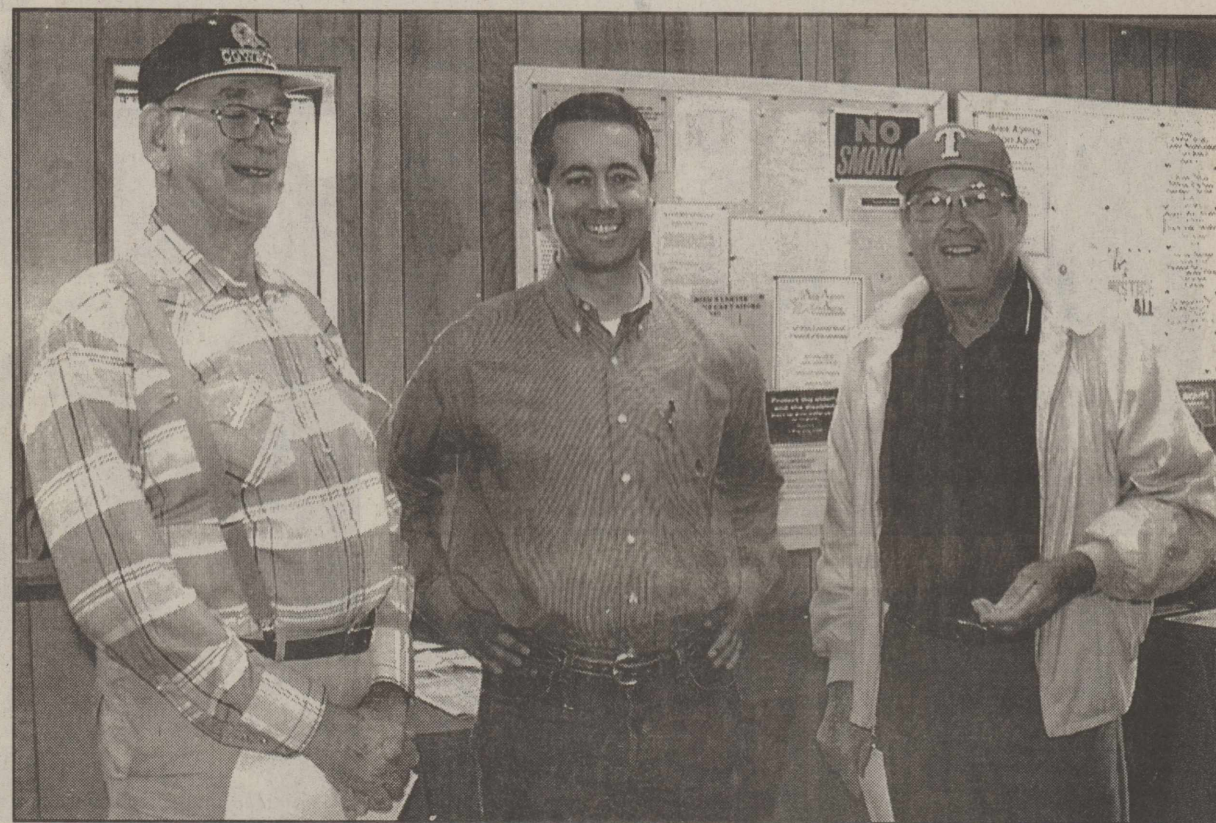

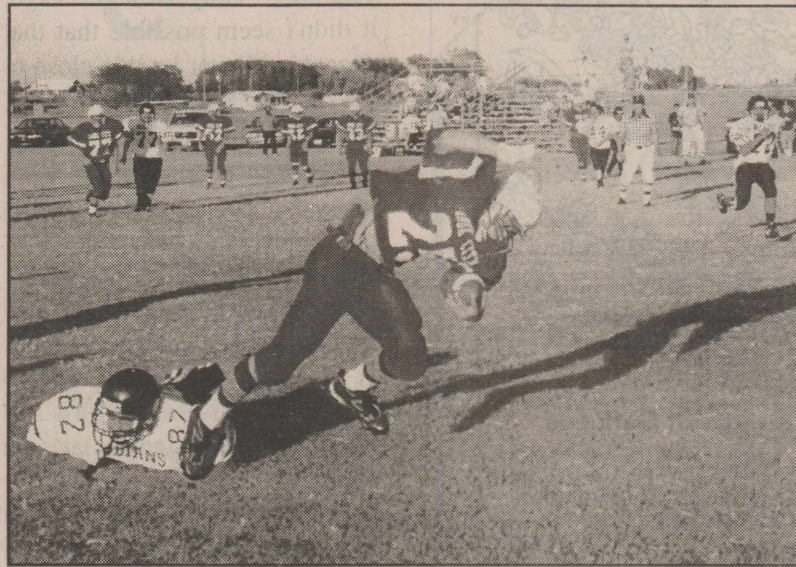
