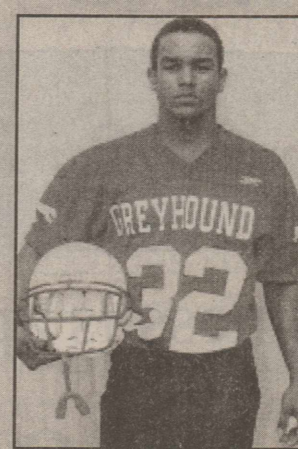
Led by Senior Nefro Gonzales, the 'Hound defense played a very tough game, keeping the 'Hornets from 'swarming' towards the goal line.

Knox City will travel to Crowell this Friday night to take on the wildcats, kickoff is at 7:30.

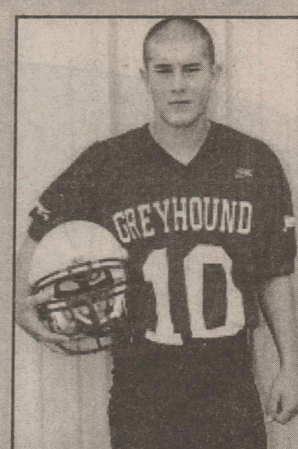

If readers will look at the Volume number at the left hand top of the front page, you will notice that *The Knox County News* is beginning its 30th year of publication with this week's issue.

It was October 21, 1971, that the first issue of the *News* was published, beginning another hometown newspaper out of necessity after *The Knox County Herald*, 66-year-old publication, was closed on October 13, 1971.

A town meeting was called on October 14, 1971, by Chamber of Commerce manager Doris Crownover and with the pledged support of Knox City merchants, churches and individuals, this 'new baby of Knox County' was established that afternoon, making us 'the oldest established newspaper in Knox County'.

My mother, Billye Angle, who had worked for the previous owner and my father, the late Buddy Angle, 'backed their ears' and took the plunge into the newspaper business, never looking back.

With the help of longtime *Stamford American* publisher, the late Roy Craig and his wife Dorothy, the two helped, coach, guided, critiqued and molded my mom and dad's efforts of this publication into what I consider the finest there is. It has been a pleasure to continue the family tradition.

Many other area weekly newspapers have come and gone during the last 29 years, and we are thankful to have lasted this long and proud everytime someone tells us 'we are the best!!'

APPLICATION AND PRELIMINARY DECISION. City of Knox, P.O. Box 128, Knox City, Texas 79529, has applied to the Texas Natural Resource Conservation Commission (TNRCC) for a renewal of TNRCC Permit No. 10416-001, which authorizes the discharge of treated domestic wastewater at a daily average flow not to exceed 200,000 gallons per day. Issuance of the proposed Texas Pollutant Discharge Elimination System (TPDES) Permit No. 10416-001 will replace the existing NPDES Permit No. TX0035505 issued on September 8, 1995 and TNRCC Permit No. 10416-001. This application was submitted to the TNRCC on November 2, 1999.

The facility is located approximately 0.5 mile north of the intersection of Farm-to-Market Road 143 and State Highway 6, on the eastern bank of China Branch in Knox County, Texas. The treated effluent is discharged to China Branch; thence to the Brazos River Above Possum Kingdom Lake in Segment No. 1208 of the Brazos River Basin. The unclassified receiving water uses are no significant aquatic life uses for China Branch. The designated uses for Segment No. 1208 are high aquatic life uses and contact recreation.

The TNRCC executive director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The executive director recommends issuance of this draft permit. The permit application, executive director's preliminary decision, as contained in the technical summary and/or fact sheet, and draft permit are available for viewing and copying at City Hall, 200 N. Central Avenue, Knox City, Texas.

MAILING LISTS. You may ask to be placed on a mailing list to obtain additional information regarding this application. You may also ask to be on a county-wide mailing list to receive public notices for TNRCC permits in the county. To get on a mailing list, send a request to the Office of the Chief Clerk, at the address listed below.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. The TNRCC will hold a public meeting if the executive director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

Written public comments and requests for a public meeting should be submitted to the Office of the Chief Clerk, MC 105, TNRCC, P.O. Box 13087, Austin, TX 78711-3087 within 30 days of the date of newspaper publication of this notice.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for public comments, the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. The response to comments, along with the executive director's decision on the application, will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application. The mailing will also provide instructions for requesting reconsideration of the executive director's decision and for requesting a contested case hearing. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

A contested case hearing will only be granted based on disputed issues of fact that are relevant and material to the Commission's decision on the application. The TNRCC may act on this application to renew a permit without providing an opportunity for a contested case hearing if certain criteria are met. Further, the Commission will only grant a hearing on issues that were raised during the public comment period and not withdrawn. Issues that are not raised in public comments may not be considered during a hearing.

EXECUTIVE DIRECTOR ACTION. The executive director may issue final approval of the application unless a timely contested case hearing request or a timely request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the executive director will not issue final approval of the permit and will forward the application and requests to the TNRCC Commissioners for their consideration at a scheduled Commission meeting.
