

## **Knox County Hospital to** hold blood drive on Monday

#### To benefit Meek Blood Center

The Knox County Hospital will host a blood drive on Monday, July 9. The Meek Blood Center Bloodmobile from Abilene will be at the hospital from noon until 6:00 p.m. "This is our first time to have a blood drive in Knox City, and we are looking forward to building a long-term relationship with the good-hearted people of Knox City and the surrounding community," Frances Baker, donor recruiter, said. "The summer months always present a difficult challenge, so we are grateful to the hospital for hosting this blood drive. The blood drives are crucial in helping us maintain ad adequate supply of safe blood."

Meek Blood Center, which is part of Hendrick Health Systems, as established in the early 1950's by Dr. Jarrett Williams. From the beginning, the mission has been to be the "life blood of the Texas midwest". The Center supplies blood for Hendrick Medical Center as well as fifteen other medical facilities.

Less than five percent of healthy Americans eligible to donate blood actually donate each year, yet seventh-two percent of the populations will require a transfusion of some type of blood product or component before the age of 70. Accident victims, cancer patients, premature babies and patients being treated for severe anemia are some of the recipients of blood donations. Each donation can help up to three different people. Platelets and plasma are separated from the red cells to

meet the differing needs of the public.

To be eligible to donate blood, a person must be between the ages of 17 to 71. They must weigh at least 110 pounds. Most maintenance medications (such as blood pressure, hormones, cholesterol, etc.) can be accepted.

Giving blood is easy. Following registration, the donor will answer simple medical history questions and receive a miniphysical.

Only a brief pinch will be felt and the five to eight minute donation will be over with before one knows it. Afterward, the donor can relax for a few minutes with refreshments.

Each donor will receive a Tshirt, compliments of Meek Blood Center, to show their appreciation for the donation.

Another way Meek shows their appreciation is to offer a free cholesterol screening each time a donation is made.

Those wishing to participate in this should call the Meek Blood center three days after donating to receive the results.

The staff at Meek Blood Center is glad to have the opportunity to meet new friends. Most of all, they are glad to know someone who will have a chance for tomorrow because of their blood donation today.

## Vernon College releases GED testing dates

VERNON - Vernon College will offer students the opportunity to take the GED test to earn their high school diploma equivalency. The test will be given on July 17 and 18, September 9 and 10, and October 9 and 10 on the Vernon campus.

To use portions of the test that a person has successfully completed, the person must have the rest of the GED completed by December 31, 2001. Anyone not completing all five sections by that date will be required to take all of the test again because major revisions have been made that will take effect on January 1, 2002.

Pre-registration is required at least five working days in advance of the test. Call 940-552-6291 ext. 2278 or register in person at Vernon College Student Services Office in the Sumner Applied Arts Center on the Vernon campus.

Everyone taking the GED must present a Texas driver's license or Department of Public Safety ID card and social security card at registration and each night of testing. If a driver's license is not available, a notarized statement bearing a recent photo and the date of birth and signature of the test-taker can be used. This form can be obtained at the Student Services Office. Bring the notarized form to the test along with proof of residency (a bill with the test takers name giving a Texas address).

The full battery of tests cost \$40, and checks or money orders made payable to Vernon College are acceptable.

There will be approximately 200 pieces of art exhibited and


each will have its own intriguing interesting title. The prices of art range in price from \$90.00 to \$4,800.00.




