





Stricter laws affect new teen drivers

As of January 1, 2002, there are several changes in Texas law that will affect teenage drivers who receive their licenses after January 1 and parents should be aware of the changes.

Graduated Licensing

This new Texas law will extend the time it takes a 16 or 17 year old to get a drivers license. It is also designed to give them more driving experience before they can drive solo. Under the new law, once teenagers turn 16 and are enrolled in school, they can take a driver's education program and get a full privilege driver's license. Teens can get a learner's permit at 15, and take the course, but they can't get a full license until age 16. The new law also mandates that teenagers have a learner's permit for at least six months before they can apply for a driver's license.

After new teen drivers get their license, there is another six month probationary period.

Driving Hours

During the above mentioned six month probation period after a teenager first receives his or her license, they will not be allowed to operate a motor vehicle between the hours of midnight and 5:00 a.m. unless they are directly returning home from work or school related activities.

Passengers

Also during the six month probation period after a teenager first receives his or her new license, they are not allowed to carry more than one passenger under the age of 21 who is not a family

Penalties

Violations of these new laws will be a Class C Misdemeanor

with a \$500.00 fine, plus court costs. If a teenager gets two traffic tickets while driving with a provisional license, the license can be suspended for 90 days.

The new laws are designed to reduce deaths and injuries among the teenage driver population. Car crashes are the leading cause of death among teenagers in the United States. According to government statistics, 41 percent of teenage driving deaths occurred between 9:00 p.m. and 6:00 a.m., when teens are most likely to be driving without parental supervision. Sixty three percent of teenager passenger deaths occurred when another teen was driving.

As more accident and risk data becomes available. Texas lawmakers may seek to tighten these laws even further in a future legislative session.







Intro to commodity futures and options workshop set

An introduction to commodity futures and options workshop will be held on Tuesday, January 8, 2002, from 8:30-11:30 a.m. at the Knox City Community Center.

This is a "beginners" workshop designed for all agricultural producers or agribusiness persons interested in learning about futures and options.

Purpose of this workshop is to familiarize farmers and ranchers with the terminology associated with hedging and learn how to perform basic calculations.

Examples used in the workshop will focus on cotton, cattle and wheat. Topics to be covered include The mechanics of Hedging, Basis, Margins, Advantages and Disadvantages of Futures vs Options and How to Select a Broker. The instructor for the course will be Rob Borchardt who is an agricultural economist with Texas Cooperative Extension.

A \$10.00 registration fee will be charged and all interested persons should call 454-2651 by Friday, January 7. There will also be a discussion of the possibility of forming a marketing club.

The past years of depressed commodity prices have ushered in a new era for producers. It set the stage for a new environment for economic decision-making by the producer.

Helping to improve the risk management sills of producers is a high priority of Texas Cooperative Extension and requires intensive educational programming. The formation of marketing clubs is one way to improve the marketing skills of producers.

A marketing club is usually made up of 10 to 25 producers who meet once or twice a month with the common goal of increasing their knowledge of marketing and other risk management con-

The marketing club is usually made up of 10 to 25 producers who meet once or twice a month with the common goal of increasing their knowledge of marketing and other risk management concepts. The marketing club meetings are designed to pick up where the workshop left off and conclude include topics such as Developing a Marketing Plan, Determining Cost of Production by Commodity, Using USDA Reports, Fundamental Analysis, Technical Analysis, Price Seasonality, and Working with a Broker among others. Typically, members watch the markets ad learn to evaluate various alternatives at any point in time.

A study in the Archives of Internal Medicine maintains that living wills can save about \$60,000 per patient in medical costs Researchers studied 474 patients who died in a hospital during 1990-92. Bills for those without living wills were three times as high.

Currently only one medical school in the entire country, out of 126, has a full-fledged department of geriatrics: Mt. Sinai School of Medicine in New York.




