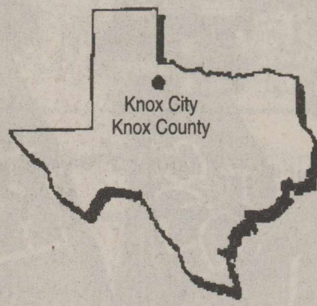

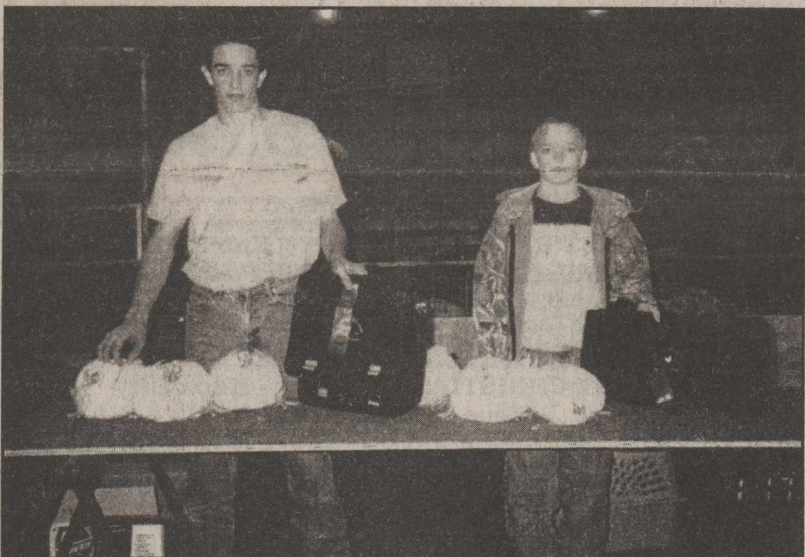

## Commissioners approve Knox County Museum

A Knox County Museum will be built. The Knox County Historical Commission received approval from the Knox County Commissioners Court at a regular meeting on January 14, 2002 to proceed.

Preservation of Knox County has been a dream which began with the pioneers who settled here over a hundred years ago. Hilory Green Bedford, often call the father of Knox County, wrote a book, Texas Indian Troubles, published in 1905 to help Texans remember our past history.

In 1964 another step in holding on to local history was Judge L. A. Parker's appointment of Mrs. C. C. Hoge to head the Knox County Historical Survey Committee. Mrs. Hoge's prime aim was the publication of a Knox County history. Mrs. Josephine Hooper Campbell took charge of the project and appointed chairmen in every community to gather local history. The determination and support of this group made possible the 1966 Knox County History. The books sold well those 36 years ago and at about \$7.00 a copy, creating dreams for a museum.

Meanwhile in the courthouse,

glass cases from old county stores have displayed donated artifacts, documents and photographs. Small steps, but worthwhile and appreciated now as valuable items might have been lost otherwise.

In 1976 the Truscott Bicentennial Committee published a brochure to help promote the committee's production and sale of the Knox County 'coin'. This money was used to reprint the 1966 county history book with the stipulation that one-third of the profits would go to a museum fund.

This made the museum dream grow, as did the several thousand dollars raised in 1986 through the Texas Sesquicentennial Knox County Committee and the Wagon Train Committee. Ranch Day in 1987 also netted a sizeable amount to the museum fund. Another fundraiser at that time was the cake sale at the Munday Vegetable Festival. In 1998 an annual fundraiser barbecue was first organized. This has grown to be almost a county reunion with up to 450 county and former residents and friends attending. This year all profits will go into the museum building fund.

In 1999 the Knox County Vet-

erans Memorial project was taken up by KCHC with intense planning and that same determination which produced the 1966 book. Today anyone driving through Benjamin can see Knox County's pride in local history as it fits into the nation picture of patriotism. It took hundreds of volunteers and thousands of hours to make the beautiful memorial a reality, along with a flood of monetary donations. The same combination will be needed to build and fill the planned museum.

The commissioners court has helped in many ways, including adding the KCHC to the county budget to help with daily operation.

~ Fundraising dinner ~

The Friends of KCHC, organized in January 2000, and the KCHC invite everyone to attend our annual fundraiser dinner Feb. 3rd at the Benjamin Memorial Building from 11:30 to 1:30, tickets are \$7 for adults and \$4 for children 12 and under. There will be door prizes and a handmade quilt, "Stars Over Knox County" given away. The beautiful quilt was pieced by Mary Cartwright and quilted by Mary Birkenfeld and the Rhineland quilters.

In the wake of the national tragedies on 9-11-2001 in both New York and Washington, D.C., a lot of attention has been focused on emergency workers across this great nation of ours.

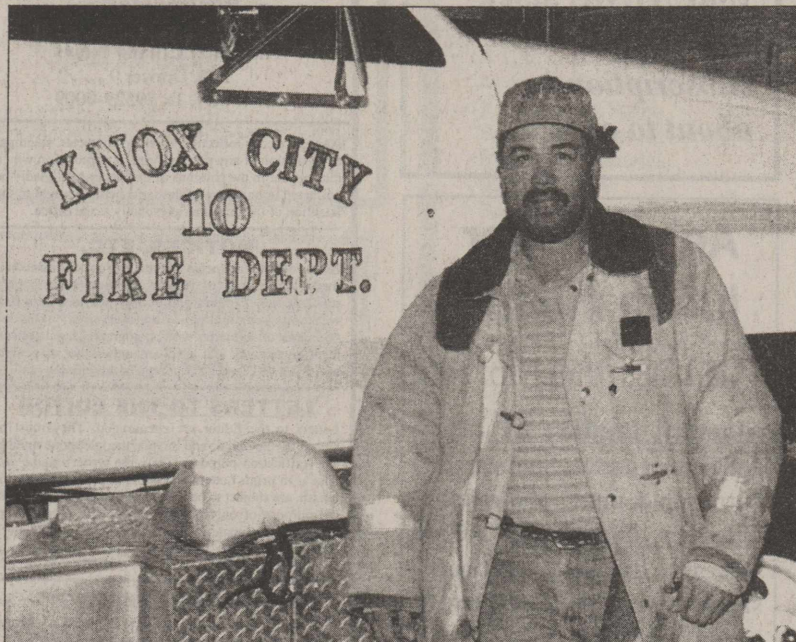
Here in Knox City, we depend on volunteer men and women to staff our local fire department.

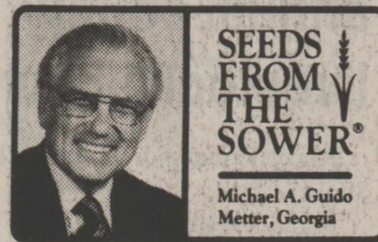
**Benjamin news**
