

Need to clear out closets but don't want to do a garage sale?


Then donate those old treasures to a museum fundraiser - garage sale sponsored by the Friends of the Knox County Historical Com-

April Police Dept. report

The Knox City Police Department had another busy month during April 2003, receiving a total of 766 calls and tasks that required attention. This total included five actual criminal offenses. Four charges were filed in regard to the above offenses, with none of the offenses involved juveniles as offenders.

Offenses reported include: Burglary of a Vehicle - 1, M.I.P. -3, D.W.L.S. - 1, Traffic Charges Filed - 7, Warnings Issued - 28, Accidents - 2.

Other items reported to the Knox City Police Department during April are classified as incidents. These incidents are not considered as a criminal offense however, they must be handled in a responsible and proper manner.

Incidents reported include: Open Door - 3, Assist EMS - 5, Dog Call - 3, Motorist Assist - 4, Assist other agencies - 11, Funeral Escorts - 1, Landing Zone -2, Gas Drive-off - 1, Loud Music -6, Prowler - 1, Domestic Dispute - 1.

During March 2003, this department received several calls from the following agencies: Central (911) - 58, Sheriff's Office - 28, City Hall - 15.

Conservation reserve signup now thru May 30

A Conservation Reserve general sign-up is now underway, starting May 5, through May 30. Producers can sign up at local USDA service centers across the nation.

The 2002 Farm Bill authorized USDA to maintain CRP enrollment up to 39.2 million acres.

CRP protects millions of acres of American topsoil from erosion and is designed to improve the nation's natural resources base. Participants voluntarily remove environmentally sensitive land from agricultural production by entering into long-term contracts for 10 to 15 years.

In exchange, participants receive annual rental payments and a payment of up to 50 percent of the cost of establishing conservation practices.

Current participants with contracts expiring this fall - about 1.5 million - can make new contract offers.

Contracts awarded under this sign-up will become effective either at the beginning of the next fiscal year, October 1, 2003, or the following year, October 1, 2004, whichever the producer

One other general signup will be offered through 2007.

The Farm Service Agency will evaluate and rank eligible CRP offers using the Environmental Benefits Index (EBI) for environmental benefits to be gained from enrolling the land in CRP.

Decisions on the EBI cutoff will be made after the sign-up ends and after analyzing the EBI numbers of all the offers.

Those who would have met previous sign-up EBI thresholds are not guaranteed a contract under this sign-up.


Logan plans to attend Vernon Regional Junior College where he will major in Farm and Ranch Management.

Dr. Barretto shares information on Severe Acute Respiratory Syndrome

CDC continues to support the World Health Organization (WHO) in the investigation of a multicountry outbreak of unexplained atypical pneumonia referred to as Severe Respiratory Syndrome (SARS).

As of March 26, a total of 1,323 suspected and/or probable SARS cases has been reported to WHO from 14 locations using the WHO case definition or country specific variations.

These reported SARS cases include 41 deaths (case fatality proportion: 4%). The Chinese authorities have reported 792 suspected/probable cases, including 31 deaths, which occurred in Guandong province during November 16, 2002 to February 28, 2003.

CDC is assisting in epidemiologic investigation of cases in Hong Kong, Vietnam, Taiwan and

Thailand. CDC also is conducting surveillance and prevention activities in the United States Definition For Severe Acute Respiratory Syndrome (SARS) Suspected Case: Respiratory illness of unknown etiology with onset since February 1, 2003 and the following criteria:

• Measured temperature 100.4 degrees F or 38.0 degrees C or higher;

• One or more clinical findings of respiratory illness (E.G., cough, shortness of breath, difficulty of breathing, hypoxia (low oxygen level) or x-ray findings or either pneumonia or acute respiratory distress syndrome).

• Travel within 10 days of onset of symptoms to an area with suspected or documented community transmission of SARS, (Hong Kong, Guandong Province, China; Hanoi, Vietnam; Singapore; area in the U.S. and Canada with suspected or con-

firmed cases of SARS (excluding areas with secondary cases limited to health care workers or direct household contacts).

• Close contact (having cared for, or having lived with, or having had direct contact with respiratory secretions and/or body fluids of a patient suspected of having SARS) within 10 days of onset of symptoms with either a person with a respiratory illness and travel to a SARS area or a person under investigation or suspected of having SARS.

Standard precaution includes hand hygiene and washing, using mask and with direct contacts using gowns and gloves precautions. Until the mode of transmission has been defined more precisely, eye protection also should be work for all patient contact.

As more clinical and epidemiologic information becomes available, interim recommendations will be updated.

BETTER DIABETES

Electronic Logbook Helps Patients Eliminate Paper And Identify Patterns
For Better Blood Sugar Management

(NAPS)—Keeping a diary or logbook of your blood sugar results and what you eat, together with a good counseling program, may be good for your health if you have diabetes.

That was one of the key findings of a study reported recently in *Diabetes Care* magazine. The study examined blood sugar monitoring in 250 patients with type 2 diabetes, which affects 90 to 95 percent of all diabetes patients.

The research showed that when blood sugar testing was performed prior to and one hour after meals in patients who received a standardized counseling program, there was a significant improvement in A1C levels, an important measure doctors use to tell how well a diabetes patient is managing the disease. Researchers found significantly less progress in patients who did not test their blood sugar and did not get regular counseling. What's more, among the patients who tested their blood sugar around meals, those who also kept a combined diary for blood sugar data and information on what they'd been eating showed twice the improvement in A1C levels and even improved their sense of well-being.

Research shows that people with diabetes can reduce their risk for eye, nerve and kidney damage by up to 60 percent if they regularly test and control their blood sugar, and a logbook is one of the key tools they use to stay on top of their blood sugars and other diabetes information, like exercise, medication and what they eat. But paper logbooks can be a burden to maintain, and patients can find it difficult to spot patterns or identify problem areas in

their blood sugar levels simply by looking at individual entries.

That's why diabetes patient Debra Chase recently switched from using a paper diary to a new blood sugar meter that's combined with an electronic logbook. The new device, the OneTouch® Ultra-Smart™ Blood Glucose Monitoring System, organizes blood sugar results and diabetes information into simple, meaningful charts and graphs that can help patients see how factors like food, medication and exercise are affecting their blood sugars.

In one instance, Chase, who carefully watches what she eats and checks her blood sugar levels frequently, noticed a graph on the new system that showed her blood sugar levels spiking after lunch on Thursdays only. Recalling that she ate at the same deli every Thursday, she checked with the deli and found out that the lentil soup she'd been eating actually contained split peas instead of lentils. Learn-

ing from her nutritionist that split peas have a higher carbohydrate content than lentils, she was able to make a change in her diet and avoid something that could have, otherwise, continued to result in

high post-lunch blood sugars.

"If I hadn't seen a chart that showed my after-lunch blood sugar levels spiking just on Thursdays," Chase said, referring to the new device, "I might not have learned that I was eating a food that was bad for my diabetes management."

Chase added that with the new system, she now feels that her goal of good blood sugar control is within reach.

In addition to its helpful charts and graphs, the new palm-sized system that Chase uses provides blood sugar results in five seconds and prompts the user to enter a comment from a menu when a test result is outside the user's target blood sugar range. This can shed light on what might be the cause of the out-of-range result. The device also features SmartButtons™, which are identified by easy-tounderstand icons and offer dropdown menus to simplify information related to exercise, food, medication and overall health.

"A tool like the OneTouch Ultra-Smart is a major step forward in empowering people with diabetes to understand how their actions directly affect their blood sugar levels," stated Gillian Katz, M.D., clinical assistant professor of medicine (endocrinology) at New York University School of Medicine.

vehicles in spaces reserved for the handicapped. All you have to do is pay attention as you drive around Knox City and you can see first hand what I am talking about. The handicap parking place in front of the post office is constantly being used by folks who have no handicapped license plates or blue mirror placard, and a lot of the folks who take up the space when they go in to get their mail also keep it tied up for longer periods of time when they come out and sit in their car or pickup while opening and reading all their

The handicap parking places at the grocery store are others that are constantly being used by folks showing little regard for those who actually do need the convenience of parking in a little closer. One lady uses one of these spaces every time she goes to the store, it seems to be her private parking place.... but she is not handicapped, not even close.

Our school system needs to address better accessibility for handicapped people, it sure wasn't much fun trying to get a wheelchair into the auditorium for graduation last Saturday night. The threshold of both doors on the ground level are very hard to get over, and the only place inside the auditorium that looks like it might be for wheelchairs to park isn't even big enough for a small wheelchair with a leg extension.

Getting around the downtown business district is the biggest challenge of all, there are gaps, holes, ridges and bumps in the sidewalks that can toss someone right out of a wheelchair. The only designated spot at the north end of the west side of the business block isn't even painted with the traditional handicap markings, and as far as I can tell, there are no designated parking places or access ramps on the east side of the street. Our city leaders need to address this issue, they could easily construct a handicap parking place and ramp right in the middle of the downtown business block, on both sides of the street. Our newspaper is just about in the middle of the west side of the downtown business block, and the city is more than welcome to use parking places right out front if it will make life easier for those with disabilities. My stay in a wheelchair will only last months, some are there for life and we all need to be reminded that handicapped folks have special needs.

There are laws that deal with all of this, laws that are enforced at the federal level under the ADA or American Disabilities Act passed by Congress. Short of filing complaints with different governmental agencies, the only hope that handicapped folks have is to depend on the common sense of others. 

NOTICE OF GAS RATE INCREASE REQUEST

TXU Gas Company (the "Company"), in accordance with the Gas Utility Regulatory Act as set forth in the Texas Utilities Code, hereby gives notice of its intent to implement new schedule of rates for natural gas service to be charged to all of the customers served by the Company in the incorporated municipalities and unincorporated areas in the Company's statewide gas utility system (the "System"). The proposed revisions to the respective rate schedules will impact all classes of service and all fees and charges presently being assessed by the Company on its transmission and distribution systems. As of the filing date of the Company's Statement of Intent to change rates, the proposed rates are expected to approximately produce a \$69,524,311 or a 7.24 percent increase in the Company's annual revenues from customers in the System. The proposed change will affect approximately 1,344,030 residential, 125,603 commercial, and 1,441 industrial sales and transportation customers in the System. The proposed change constitutes a "major" change as that term is defined by Section 104.101 of the Texas Utilities Code. The proposed changes will have differing impacts on individual customers, depending on consumption and current applicable rate schedules. The proposed changes in rates will not become effective for environs customers until similar changes have become effective within the nearest incorporated city or town. A residential customer receiving a bill for 6 Mcf will see a bill of approximately \$41.69, which would constitute an average increase of approximately \$3.59 per month or a 9.4% increase. A commercial customer receiving a bill for 30 Mcf will see a bill of approximately \$173.04, which would constitute an average increase of approximately \$13.91 per month or a 8.7% increase. The effect of the proposed changes to rates and services for industrial sales and transportation customers, which may be significant for individual customers, will vary depending on type of service and consumption. The proposed change would constitute an increase of \$0.00 or a 0% increase in annual revenues to the Company for industrial sales and transportation customers. A complete copy of the Statement of Intent, filed with the Railroad Commission of Texas and all of the System cities and towns on May 23, 2003, is available for inspection in the Company business office located at 1601 Bryan St., Dallas, Texas 75201. Persons with specific area questions or who want information about this filing may contact TXU Gas Company at 1-800-460-3030. Any affected persons located inside of the city limits of a municipality served by the Company may file written comments or protest concerning the proposed change in rates with their respective municipality. Any affected persons located outside of the city limits of a municipality served by the Company may file written comments or protest concerning the proposed change in rates with Docket Services Section of the Legal Division, Railroad Commission of Texas, P.O. Box 12967, Austin, Texas 78711-2967, but have a limited time to do so. Pursuant to the Rules of the Railroad Commission of Texas, Title 16 of the Texas Administrative Code Section 7.230, any affected persons may file written comments or a protest concerning the proposed change in the environs rates with the Docket Services Section of the Railroad Commission of Texas, at any time within 30 days following the date on which the change would or has become effective. The Company is proposing to have these proposed rates become effective on June 27, 2003.
