

#### Albany Lions - 41, Knox City Greyhounds - 0

The Knox City Greyhounds put up a hard fight last Friday night at Albany, but the Lions flexed their muscles and held the 'Hounds to minus 14 yards offense in the first half and a total of 39 yards for the entire game. Matching their defense, the Albany offense scored 41 points and a total of 223 yards on 35 ground carries and 139 yards through the air.

C.J. Bruce was the leading ground gainer for Knox City, picking up a total of 41 yards on 14 rushing attempts.

Penalties and turnovers were evenly matched throughout the game, Knox City and Albany each had 30 yards penalized on four penalties. The Greyhounds attempted 6 passes with 1 completion and 1 interception, Albany passed 12 times with 6 completions and 1 interception. One of the key factors in the game was first downs, the Greyhounds were only able to pick up 3 first downs, while the Albany Lions picked up a total of 16 first downs.

Standing at 0-5 on the season, the Knox City Greyhounds have an open date this Friday night before starting district competition next Friday, October 10 at Hamlin against the Pied Pipers. Other district action includes Paducah there on October 17, Crowell here on October 24, Rotan there on October 31, and Munday here on November 7.










