

With "Super Tuesday" coming up March 8, it is imperative for those who have not registered to vote to do so before the Friday, February 5, deadline.

Registration forms are available at the Chamber of Commerce office in Knox City, thus saving prospective voters a trip to Benjamin or the necessity of requesting one by mail from Oscar Mangis, Knox County Tax Assessor-Collector.

Voters who have participated in a primary or general elections during the past-few years are probably still registered. However, if a person is not sure of his or her voter registration status, or if they have moved since they last voted, they will need to contact Mr. Mangis at his office in Benjamin

All persons, 18 years of age or older, who live in Knox County and have no criminal record, are eligible to register and vote.

A number of very important races are coming up in the March 8 election, and voters need to be ready to cast that "all important ballot."



he published the National Quarterhorse Journal here and she worked during the time Ace Reid drove to Knox City on a weekly basis to draw cartoons for the monthly magazine.

Reid grew up during the Depression on a ranch near Electra, and according to Kelso, "When Reid drew about rough times on the ranch, he drew from experience." His dad, Ace Reid Sr. sent some of Ace Jr.'s cartoons to Mr. Bateman, and the editor liked what he saw, and life as a professional artist

Quoting from the feature story, "He paid me \$3 a piece to drive 150 miles from Wichita Falls to Knox City to draw a cartoon," Ace recalled. "He'd give me the \$3, and I'd drive 150 miles back. And that easy money like to drove me crazy...I had a choice to either starve to death punching cows

or starve to death drawing cartoons. So I picked the one I could do in the

Mr. Bateman employed Charlie Moss and his wife Ann to do the publishing of his magazine as well as a registry book for the association. The Mosses had been publishers of the local paper and sold out to Irene and the late Jimmie Branch to assume the new business. Also assisting in the publishing were former residents Dale Graham and D.C. Hughes. This writer dealt with proof-reading, circulation, and secretarial work. The publication was located in the building just east of the present Knox City Laundry. Following Mrs. Bateman's death, Mr. Bateman eventually ceased publication and moved from Bateman Ranch to Fort Worth.

METER TAMPERING NOW A FELONY

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

Meter tampering consists of, but is not limited to:

- (1) Diverting electricity from passing through a meter device.
- (2) Preventing electric service from being correctly registered by a meter device.

(3) Unauthorized activation of electric service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies the Cooperative should be notified as soon as possible so that the meter can be resealed.






