

CHANGING CAREGIVERS AND CHILDREN'S STRESS

Imagine going to work one morning and discovering that you have a new boss. Then imagine that you got a new boss every few weeks or months. You'd probably find the adjustments required by these working conditions to be quite stressful. Yet parents may not realize their young children experience this same kind of stress when caregivers are constantly changing. According to Dr. Sarah L. Anderson, a child development specialist, U.S. Bureau of Labor Statistics figures show that child-care workers have the highest rates of turnover of all occupations. "In some day care centers, children may be cared for by a revolving supply of child care workers," says the Texas A&M University Agricultural Extension Service home economist. "Also, when parents move children from one daycare center, family daycare home, neighborhood babysitter or relative to another, the child has to adjust to new people and new surroundings," says Anderson. The specialist notes that some children are better at adjusting to changing circumstances than others. However, sleep disruptions, changes in eating habits, regression in toileting, clinging and being more demanding may be signs of stress in

ACID-WASHED JEANS LESS DURABLE

COLLEGE STATION-If you bought this season's fashionable "acidwashed" or "frosted" denim clothing, don't expect it to last as long as the other denim clothes in your wardrobe.

According to Dr. Ann Beard, a clothing and textiles specialist with the Texas A&M University Agricultural Extension Service, white or acidwashed jeans are washed with volcanic rock that may have been pickled in hydrochloric acid.

'This harsh treatment bleaches the dye to make the surface fibers white. However, it also may reduce the strength and durability of the denim fabric by as much as 25 to 50 percent,'

'If the acid treatment comes after the garment is sewn, it may also have the effect of weakening the seams so they split open easily," says Beard.

The specialist notes that acidwashed denim clothing is typically higher priced than regular denim, but consumers should understand they're paying extra for the fashion look and not durability

A NEW WAY OF DOING THINGS

Beginning with this issue of *The Knox County News*, those outside of the Knox City area who subscribe by mail should be noticing an improved time difference in the delivery of their newspaper. Things have been changing around here, and we hope that the changes will mean a faster paper delivery for our out of town subscribers.

The changes were brought about after a close inspection of the way we were mailing our newspapers out. Knox City Postmaster Jimmie Wilheim advised us that our mailing system was outdated and not up to the latest Post Office regulations. When I had an opportunity to review the updated regulations and talk with Jimmie, I saw exactly what he was talking about. There had indeed been a drastic change and it occurred long before Jimmy took over as Postmaster here, but we have never been made aware of the change before now.

The changes I am talking about are in where we actually mail newspapers to. Since our papers go second class, we have been mailing them to sectional postal centers for distribution to all parts of the United States. The changes that took place changed from sectional centers or SCF's to distribution centers, with the majority of our out of town papers now going to Dallas for separation and forwarding.

Another change that should help speed your newspaper along is in the way that we bundle them for mailing. We have always wrapped the bundles in brown paper, then written the destination on the bundles with magic markers. Little did we know that the bundles may have been receiving third class treatment instead of the faster second class that we were paying for, all because the destination was not outlined in pink to indicate second class. This was another item that Jimmie brought to my attention, and with the change this week to computerized bundle labels outlined in pink, all postal employees up and down the line will see the pink second class designation.

I have already told our local postmaster that I appreciate his help and his advice and I want to take this opportunity to pass that on to each subscriber. Jimmie is in a position where he is required to abide by countless numbers of regulations, and many of us, including myself, fail to remember the many rules he has to abide by when we are only concerned with how our mail is handled.

In the past few months Jimmie has felt that this newspaper was taking a stand against him, and after listening to things from his point of view, I was able to understand why he felt that way. We have a policy of printing Letters To The Editor as long as they are signed and fall within the guidelines of good taste. Several letters from subscribers who complained about the way they received their papers have been printed and Jimmie felt that those were aimed at our local Post Office. Another item that apparently fed fuel to the fire was a story that we ran a while back on a lady who recently received a postcard that was mailed in 1965. That story or our Letters To The Editor were not meant as any reflection on anyone, the letters are printed as long as they fall within the guidelines. The story was published because a reader brought it to our attention more than once and thought it was interesting. We ran it as just that, an interesting story

I am willing to work with Jimmie in every way possible to insure the timely delivery of this newspaper to its subscribers. I appreciate Jimmie's taking the time to look into our method of mailing and pointing out the corrections that have since been taken. I just wish that we had been corrected on this years ago so we could have avoided the delays and hard feelings.

Jimmie Wilheim hasn't been a very popular person since he took over as Postmaster here and a lot of sidewalk conversations have used him as a topic for gripes. I know what I'm talking about because I was right in there griping along with the rest, but in all fairness to Jimmie, I wish that each and every person who gripes could

WINDOW CONDENSATION CAN **CAUSE PROBLEMS**

The condensation that forms inside windows in the winter is usually just a nuisance, but can be a sign of a larger problem with humidity, according to a housing specialist with the Texas A&M University Agricultural Extension Service. "Foggy or wet windows inside your home shows that the temperature of those surfaces has dropped below the dew point temperature at which water vapor in the air will condense on surfaces," says Dr. Susan Quiring. "Condensation may not be damaging to your home if it is temporary and vaporizes as the surface warms during the day," she explains. "But moisture which lingers on the surface and eventually pools on the window frame could damage the frame, especially if it's


