### **Runoff Election Is Tuesday**

Tuesday, April 12, will be another day of voting when top winners in the primaries square off in the runoff election to determine whose name will appear on the ballot for the General Election in November. Some of the candidates are unopposed.

Voters in the Democratic Party Primary Runoff Election in Knox County will choose either William L. (Bill) Hudson or Charles E. McDonald as a Member, State Board of Education, District 14.

In the race for District Attorney, 50th Judicial District, voters will elect either Chad Williams or Larry Evans.

Both 7N and 7S voters will again cast their ballots at the Knox County Aging Center from 7:00 a.m. until 7:00 p.m. The three boxes in Munday along with Sunset voters will vote at City Hall, while all other county locations will remain the same, according to David Counts, Knox County Democratic chairman. Bud Reynolds is election judge for Knox City, and Juanita Nelson is election judge for Munday.

Republican chairman Bill Baker advised the News office that the Knox City Community Center will be the location for Knox City Republicans with Bruce Campbell Jr. as election judge. Munday voters will cast their ballots in the Munday Elementary Library where Ernestine Dickerson will be election judge. In Truscott, voters will vote at the Community Center with LaNay Cash as election judge.

Appearing on the Republican ballot for U.S. Senator will be Beau Boulter and Wes Gilbreath; for U.S. Representative, District 13, Larry S. Milner and Bob Price; for Railroad Commissioner, Ed Emmett and P.S. (Sam) Ervin; and for Justice, Supreme Court, Place 2, Ronald S. Block and Nathan Hecht.

Absentee voting for the runoff elections may be done in person until Friday, April 8, at 5:00 p.m. and ballots

may be received by mail up until the day of the election, Tuesday, April 12, officials said. Also, voters who cast their ballots in the primaries are ineligible to vote or participate in another political party's runoff election. In other words, if a person voted in the Democratic Party's Primary Election, he or she is ineligible to vote in the Republican Party's Runoff Election, and vice versa.

### Planting Date Set For May 16

Approximately 200 persons from across the county were in Rhineland Monday night for the Cotton Uniform Planting Meeting.

Producers voted by secret ballot and selected May 16 as the planting date for Knox County. Four dates were presented and the percentage of the voting was May 9 - 11%, May 16 - 55%, May 23 - 30% and May 30 - 4%.

Speakers at the meeting included Emory Boring, extension entomologist; and Jeff Sloffer of the Texas A&M Research in Vernon. A fish fry, sponsored by the Knox County Boll Weevil Association, was prepared by Stanley White of Stephenville.

### Tornado Seminar Slated Monday Night In Munday

Munday Chief of Police and Knox County Sheriff Elect Henry Dancer has informed *The Knox County News* about a seminar that will be conducted in Munday by Keith Hayes from the National Weather Service Office in Abilene. The seminar will take place at 7:00 p.m. on Monday, April 11, at the Munday Fire Department. The discussion will center around the formation and spotting of tornados.

Since the season for tornados is rapidly approaching, Chief Dancer thought this was an appropriate time for the class. He encourages all law enforcement personnel, ambulance personnel, firemen, utility workers, school officials and news media from throughout Knox County to attend this very important meeting.

Aided by the use of National Weather Service films, Hayes will discuss all aspects of tornados and the proper precautions that need to be taken whenever a tornado is spotted. Always interesting, the tornado information presentations by the National Weather Service are given as a public service and designed to pass on information that could be helpful in the event of an emergency involving a tornado.

# Tennis Netters Win Places At Roscoe Meet

Knox City tennis players won a first, a second, a third, and a fourth place at the Rotan Spring Invitational Tournament, March 28 and 29, to inaugurate the high school tennis season. Knox City-O'Brien netters got more doubles teams and individuals into the semifinal round, into the finals, and won more trophies than any other school participating.

It was a feat just to make it to the second-day semifinals, as the number of players/teams in a division ranged from 32 to 45, and three or four victories were required just to make it that far. Two of our singles players and two doubles teams did so. Physically, the tournament was wide-ranging, also, as matches were played on the courts of Snyder, Sweetwater, and Hamlin, as well as at Rotan.
