Knox City Woman Now Officer In Charge

With the temporary assignment of Knox City Postmaster Jimmie Wilheim as Officer in Charge of the Rotan Post Office, Cathye Williams of Knox City has been appointed Officer In Charge of the Knox City Post Office. An employee of the U.S. Postal Service and the Knox City Post Office for nine and a half years, Cathye has now assumed total responsibility of the local postal facility as Officer In Charge.

Beginning her postal career as a part time flexible clerk in 1978, Cathye has received many periodic step advances while working in Knox City. Officially assuming the responsibilities as Officer In Charge on April 5, Cathye will remain as OIC from two to six months. The exact length of the appointment depends on how long it takes to name a new postmaster in Rotan, thus allowing the return of Postmaster Wilheim to Knox City.

As Officer in Charge, Cathye is required to set and meet certain objectives. During her tenure, she hopes to complete several tasks including updating the letters and zip numbers identifying the local facility from the outside, relabeling names on the post office side of rent boxes for easier identification by postal employees and removal of the old route cases now standing in the lobby. She also hopes to work on internal supply reorganization and employee training.

Active in community affairs, Cathye is currently in her second year as president of the Knox City Chamber of Commerce and has previously served as vice president for one year and a director for two years. She was also a Junior Girl Scout leader for two years.

Cathye is married to Brian Williams, an 18 year veteran of the Texas Department of Public Safety who currently holds the position of Highway

Roland Marion Announces For Hospital Seat

Roland Marion announced as a candidate for a seat on the board of directors of the Knox County Hospital District before the deadline last week, making it a three-man race now for the two seats on the board.

Jerry Williams, who was appointed last year to fill out the unexpired term of Maurine Reeder, is seeking election this year, and incumbent Vernal Zeissel is running for re-election.

The hospital district will have its election along with those of the city and school on Saturday, May 7.

Absentee voting by personal appearance began Monday of this week and will continue through May 3. Mailin ballots can be received up to the day of the elections; however, request for mail-in ballots must be received no later than April 29.

Chad Williams Elected As New District Attorney

Chad Williams of Seymour won Tuesday's Democratic Primary runoff election for district attorney of the 50th Judical District. He garnered 1,853 votes to defeat Larry Evans of Paducah who received 1,396 in the four-county district comprised of Baylor, Knox, Cottle, and King.

Williams carried Baylor and Knox counties, and Evans carried Cottle and King, the same counties that each carried in the March primary in which incumbent Tom Schranct of Seymour was defeated.

In Knox County, Williams received 378 to Evans' 223. In Baylor County, Williams had 1,271 votes, and Evans'


