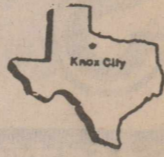

Victory Crusade Set

A Victory Crusade against occult and satanism is planned for August 11-12 at the Haskell Football Stadium at 8:00 p.m.

Larry Nelson, an associate of the Mike Warnke Ministries, will speak. Recognized as an expert in this field, he has counseled countless individuals who have been involved in occult and satanism. He has conducted meetings for the University of Kentucky sociology classes, various state police, sheriff, investigation, and intelligence groups, the University of Cincinnati sociology classes, and many church groups and seminars.

Two seminars will be held Friday, August 12, at the Haskell National Bank Community Center. Seminar No. 1 will begin at 9:30 a.m. and will deal with what occult and satanism are,

symptoms to look for, and what a Christian can do to combat it. Seminar #2 will be a video and film presentation with time for questions and answers. All interested persons are invited and there is no charge.

After the service on Thursday night, a youth fellowship will be held with refreshments and a time to get to know Larry Nelson, a spokesperson said.

These meetings are sponsored by churches in Knox City, Munday, O'Brien, Rochester, Weinert, Rule, Haskell, Stamford, Hamlin, and Anson and came about as a result of meetings in area churches after rumors circulated about a cult meeting that was held June 17-18 on the Haskell side of Lake Stamford.

In a recent meeting at the Four-square Church in Knox City, a large

crowd was told that peace officers observed the cult members from a distance while they were at the lake and reported approximately 30 adults and six to eight children taking part in the rituals. Reportedly, the participants were from the Midland-Odessa, Dallas-Fort Worth, and Houston-Galveston areas. They also reported that the alleged human sacrifices had been thoroughly investigated, with no evidence of any type being uncovered.

In another meeting at the First United Methodist Church in Haskell, the Rev. Kenny Kirk, pastor, said, "One of Satan's greatest weapons to use against us is fear. If he can get us so worried and paranoid that we take our eyes off Jesus, then he has won this battle. We must never forget that as Christians, we have nothing to fear from Satan."

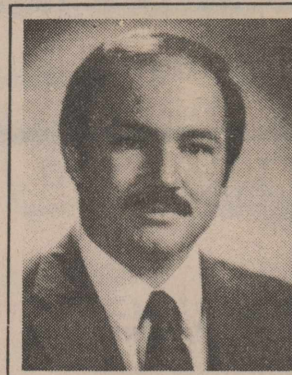

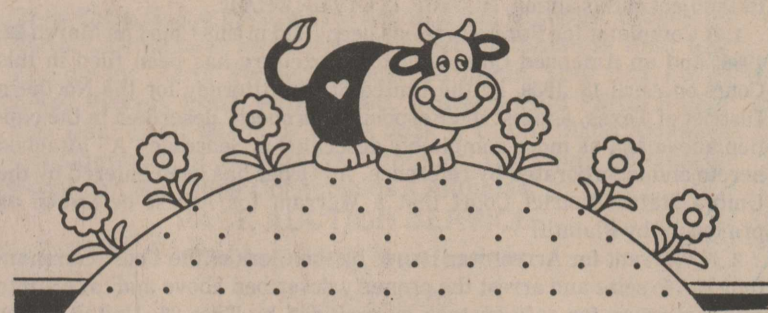

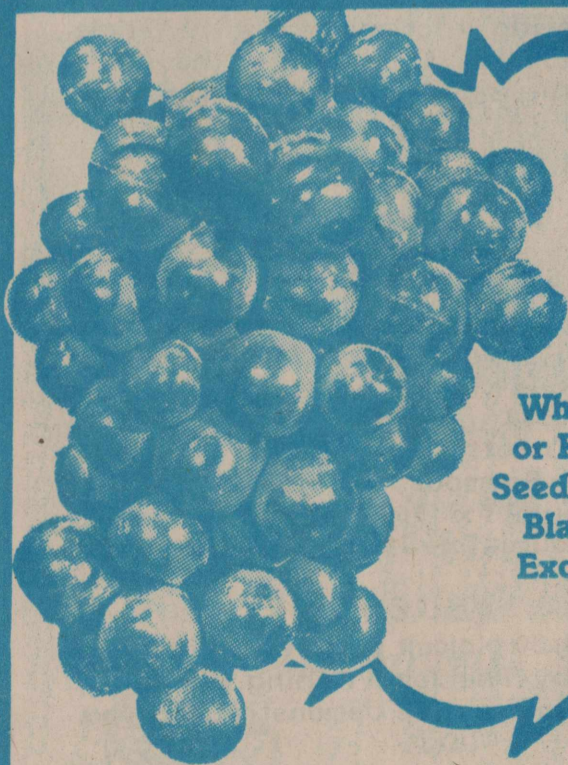

The Farmers Home Administration (FmHA) is accepting nominations for County Committee elections for Knox County. 

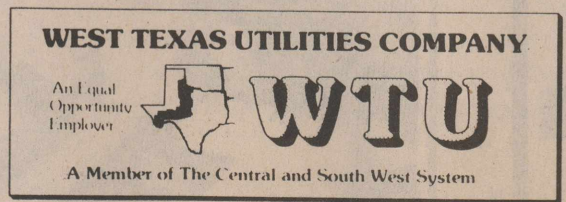
