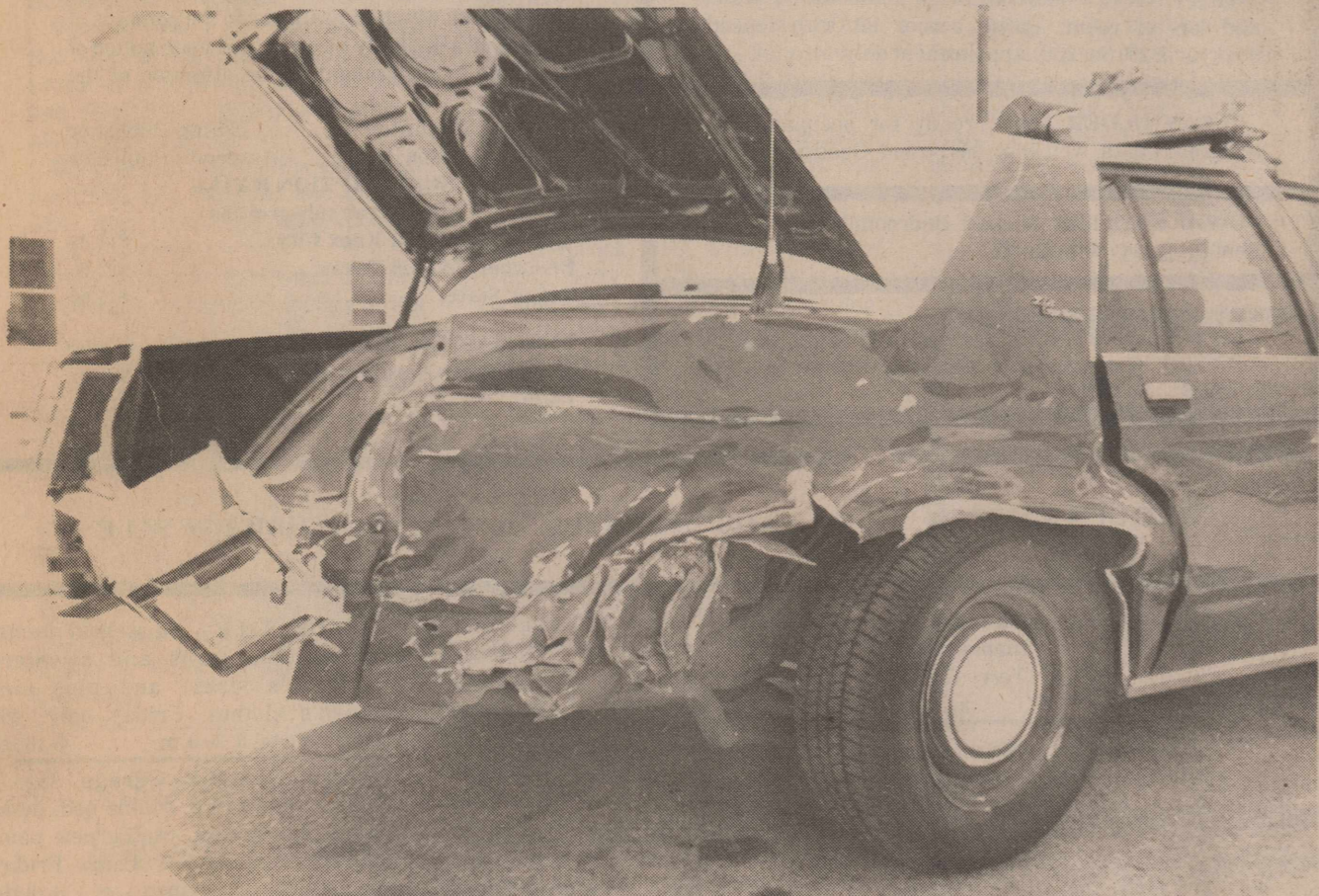

Carriker Wins 'Big'

For Senate Seat

State Rep. Steve Carriker won handily with 62 per cent of the vote in the special election Saturday defeating Republican Bobby Albert of Wichita Falls to fill Ray Farabee's 30th Senatorial seat until the end of the year. The senate seat became open when Farabee vacated it to take a position as vice chancellor and general counsel with the University of Texas system.

Carriker, D-Roby, won all 30 of the 30 counties in the 30th Senatorial District

with 17,408 to his opponent's 10,594. In Knox County, it was Carriker with 421 to Albert's 93. The special election was set by Gov. Bill Clements to fill the interim term.

Carriker and Albert will face each other in the November 8 general election to obtain the seat for the new term beginning in January 1989.

In a release this week, Texas Democrats say the special election sweep of all thirty counties, including

his opponent's home county, is hailed as a good sign for November. Bob Slagle, chairman of the Texas Democratic Party, said, "Carriker's opponent ran the kind of name calling Republican campaign that was full of rhetoric and labels but short on substance. The nature and margin of Carriker's victory, coupled with phone bank results and poll data from rural Texas indicate Democrats and independents are ready for a return to Democratic leadership."

Moorhouses To Compete In Annual Ranch Roundup

Cowboys from the Moorhouse Ranch are busy this week readying for the upcoming Texas Ranch Roundup scheduled to begin Friday, August 19, in Wichita Falls. The showdown will continue through Saturday with the awards presentation to begin at 10:30 p.m.

The Moorhouse Ranch Co. is no stranger to the Roundup, which is now in its eighth year. The Moorhouse Ranch won the "bragging rights" as the best ranch in Texas in 1982.

The competition is patterned closely after daily ranch chores, and also includes team roping, team branding, penning, horse breaking (better known as bronc riding), and wild cow milking.

In addition to arena competition, roundup participants challenge each other in a chuckwagon cookoff; a first lady contest honoring ranch women for contributions and knowledge of the industry; and a talent competition featuring painting and photography, as well as favorite campfire songs and skits.

This two-day event also revives the traditional concept of the "rodeo", which began as both reunion and friendly competition. Twelve of the largest, most legendary ranches in Texas will compete against each other in the events. The Roundup is co-sponsored by Budweiser and the North Texas Rehabilitation Center, and will benefit three state charities. Participating will be the R.A. Brown Ranch, Throckmorton; Burnett/Triangle Inc., Guthrie; Cowan and Son, Circle Bar Ranch, Seymour; Double U Hereford Ranch, Levelland; JA Cattle Co., Palo Duro; King Ranch, Inc., Kingsville; Lewis Ranches, Clarendon; Moorhouse Ranch, Benjamin; Pitchfork Land & Cattle Co., Guthrie; Renderbrook-Spade Ranch, Colorado City; Tongue River Ranch and Spur Headquarters Ranch, Dumont; and the W.T. Waggoner Estate, Vernon.

Jack Idol of Benjamin will receive recognition as one of three cattlemen honored in special ceremonies as "Texas Ranch Roundup's Trail Blazers".

Moorhouse Ranch team members for the Roundup include Roundup Events, John Moorhouse, Tom Moorhouse, Mike Stephens, Bob Warner, Ronny Patterson, Johnny Kimmel and Tim Jones; Ranch Cookoff, Lonnie

Vincent, Togo Moorhouse, Wanda Warner, Kristy Kimmel and Karen Patterson; Talent Contest, Tim Jones-photography, Dorothy Spikes-weaving, and Moorhouse Kids-skit; and First Lady contest, Dolly Mae Vincent.

More than 50 years old, the Moorhouse Ranch is one of the youngest of the ranches participating in the Roundup. These participants are not the ones who drive Mercedes Benz or wear 10 gallon Stetsons. They are the real McCoy, sunup to sundown, weathered cowboys who punch cattle on the open range for a living because

it's "the best kinda life there is."

Those attending this year's Roundup will be missing someone special, Sue Moorhouse, wife of Tom Moorhouse of the Moorhouse Ranch Co., who died July 10. Sue was featured in the Texas Ranch Roundup supplement in the Tuesday edition of the *Wichita Falls Times*. Staff writer Joe Brown remembered Sue as one of the most popular participants in each year's roundup and a member of the first place team penning trip the year the ranch won the championship. This year, she was featured in Texas Monthly magazine as one of the state's outstanding cowgirls.

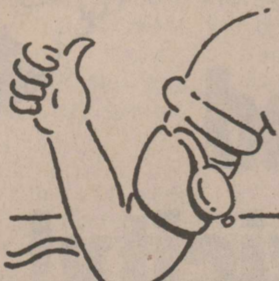

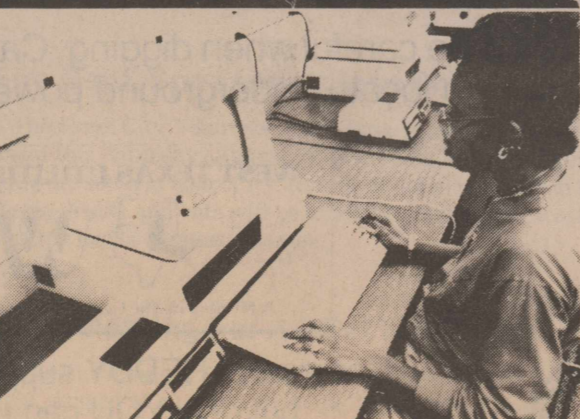
