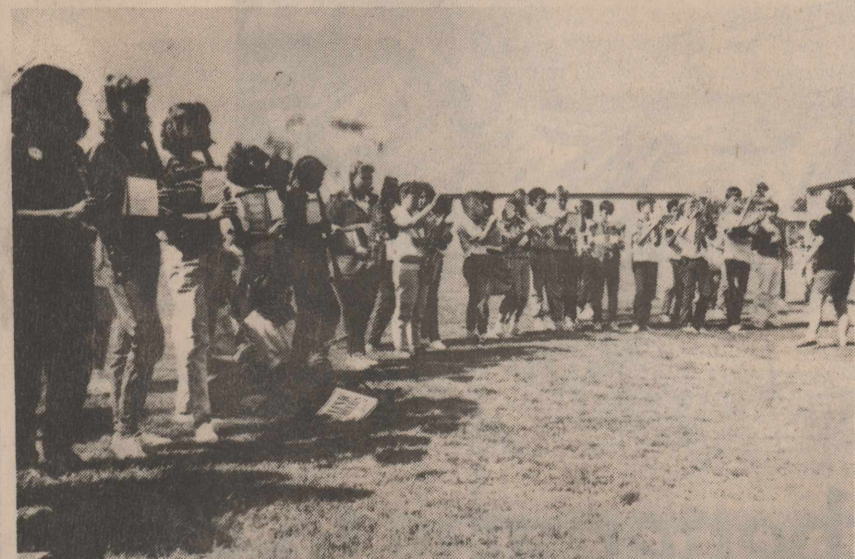
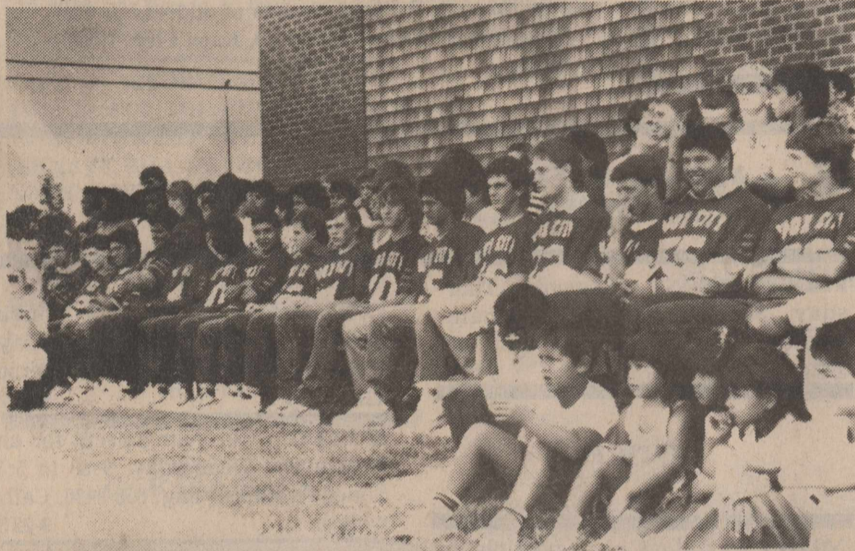
## A Little Straight Talk

## Hounds Fall To Albany

### To Travel To Spur For Opener

Wearing their familiar red uniforms with white and blue trim, the Knox City Greyhounds played to a third straight home town audience when they hosted the Albany Lions Friday evening at Greyhound Stadium. Unbeaten in outings against both Seymour and Aspermont, the Hounds appeared confident and sure of themselves when they opened the game by kicking off to Albany after the coin toss.

Albany received the kick and immediately fumbled the ball following a hard tackle. With the Hounds taking over on the Albany 20 yard line, the first drive started with a fumble recovered by Quarterback Billy Large. The very next play saw Chad Carter roll around the right side and move into the end zone for the first touchdown of the evening. The following extra point kick was good and put Knox City into the lead 7-0 early in the 1st quarter.

The first offensive drive for Albany stalled when they fumbled on their third possession and the ball was recovered by Greyhounds on their own 47 yard line. The first play saw a run down to the Lion 31, followed by a run and then the first incomplete pass of the evening from Large to Jim Ford. Another incomplete pass from Large to Chad Carter forced the Hounds to go for the down on a 4th and 3 to go situation. The play resulted in a 1st down when a pass interference penalty was called against Albany. Two plays later Alex Ledesma took the ball right up the middle for the second touchdown of the night with 7:07 left on the clock in the 1st quarter. With the second straight good extra point kick by Fred Ledesma, the Greyhounds opened up an early wide lead over the Lions 14-0.

A good second effort by Fred Ledesma pushed the Albany runner

out of bounds on the kickoff return and a clipping penalty against the Lions set them back on their own 9 yard line to open their second offensive series of the evening. A second down fumble by Albany that was recovered by Greyhound Alex Flores once again saw the Hounds opening up an offensive drive on the Albany 14 yard line. The

Greyhound offense stalled as the Albany Lion defense toughened up and the Hounds ended up with a field goal by Fred Ledesma on 4th down to widen their lead 17-0 with 4:34 left in the 1st quarter.

Albany responded to the kickoff with a 95 yard touchdown runback by Greg Boland as he broke through every

Greyhound defender on the field. The following extra point run was good for two points, netting Albany 8 points to the Greyhounds' 17.

With Albany kicking back to Knox City, Billy Large took quite a shot as he

## Coach's Comments

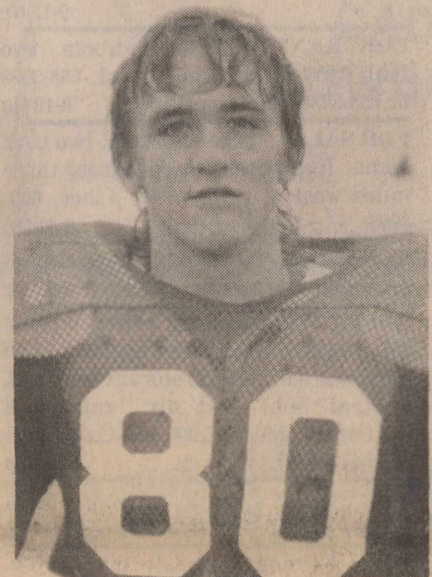

The Greyhounds went down to defeat to a fine Albany team Friday night, 31-34.

Although we jumped out to a 17-0 lead in the first five minutes, injuries to quarterbacks Billy Wayne and Boyce forced the Hounds to use our starting flanker Chad Carter as quarterback to finish out the first half. Following the injury to Billy in the first quarter, we had a mental letdown and Albany scored 34 unanswered points the remainder of the first half. Half-time saw the Hounds down 34-17 and trying to adjust offensively to using Chad as our quarterback. At halftime, coaches cut the offense down to six basic plays, and then we had a nice visit with the kids about pride and character. The second half, we were able to shut out the Lions and under the guidance of Chad Carter scored a quick touchdown to close the gap to 24-34. Unfortunately, Chad broke his hand on that scoring drive, and we had to go to Willie Rodriguez as our fourth quarterback of the night. Willie ran the ball club for one offensive possession, then Billy Wayne was able to return as quarterback. We scored again with

## Bike-A-Thon Planned For October 1

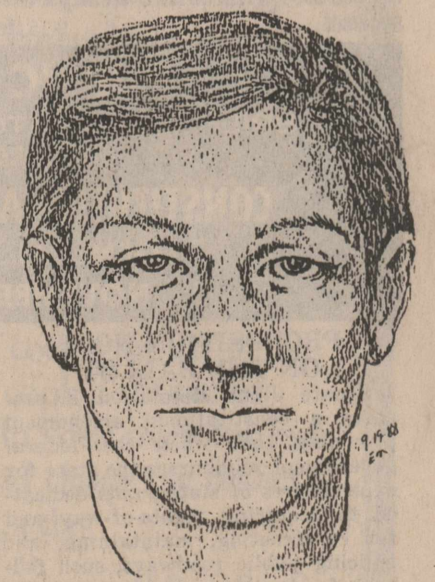

## PUBLIC NOTICE

### BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOVEMBER 8, 1988

#### PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 8 proposes a constitutional amendment providing that when the federal government reimburses the state for expenditures of state funds dedicated to acquiring rights-of-way and for constructing, maintaining, and policing public roadways, such federal funds must also be used for those purposes.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment and/or clarification providing that federal reimbursement of state highway dedicated funds are themselves dedicated for the purpose of acquiring rights-of-way and constructing, maintaining, and policing public roadways."

#### PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 2 proposes a constitutional amendment to establish an economic stabilization fund in the state treasury. The fund would consist of one half of the unencumbered balance of general revenues at the end of a biennium and three fourths of the difference between the net oil and gas production taxes received in a fiscal year and the net oil and gas production taxes received in the 1987 fiscal year. During any fiscal biennium, the amount in the economic stabilization fund could not exceed 10% of the total deposited in general revenue in the preceding biennium. The state comptroller and the state treasurer could decide to trans-

fer monies from the fund into the general revenue fund to alleviate a temporary cash shortage in general revenue. The legislature could make appropriations from the fund on approval by a three fifths vote of each house to make up the difference between anticipated general revenue and appropriations. On approval of two thirds of the members of each house of the legislature, the legislature could appropriate monies from the fund for any purpose.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment establishing an economic stabilization fund in the state treasury to be used to offset unforeseen shortfalls in revenue."

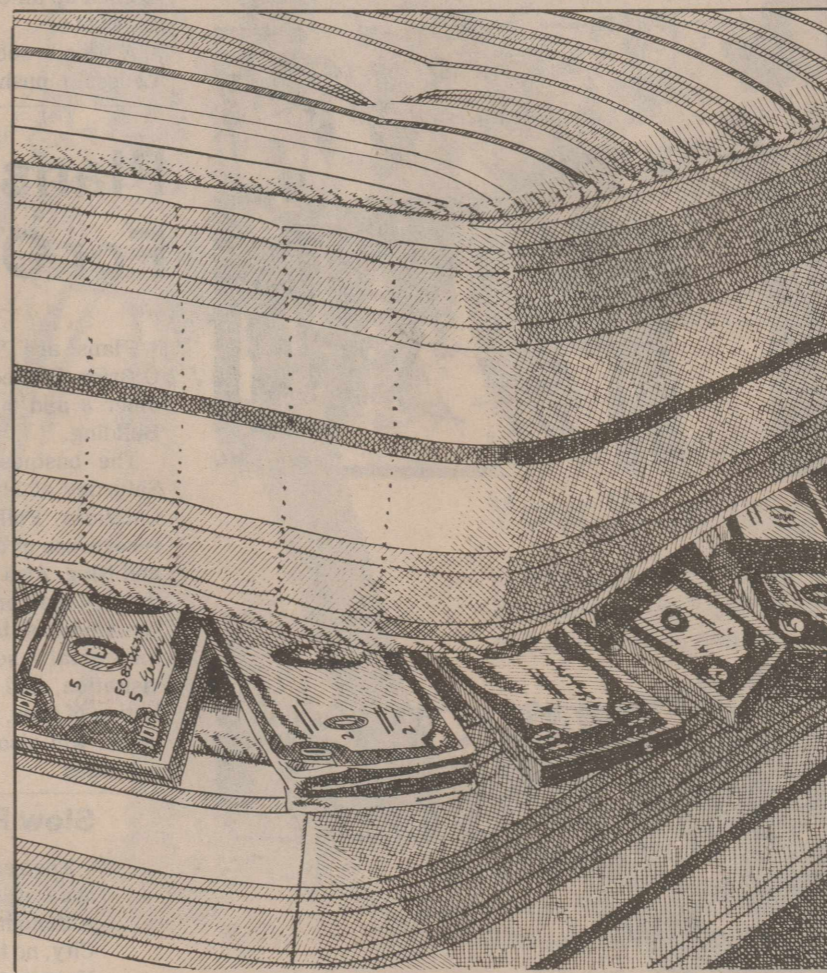
#### PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 5 proposes a constitutional amendment that establishes the Texas growth fund. All investments of the Texas growth fund must be directly related to furthering economic growth and employment opportunities in Texas. At least 50 percent of the fund must be invested in equity and/or debt security for the initial construction, expansion, or modernization of business or industrial facilities in Texas. Not more than ten percent of the fund may be invested in venture capital investments. Of the funds available for venture capital investments, not more than 25 percent may be invested unilaterally, and the remaining investments must be matched at least equally by funds from other sources. The Texas

growth fund will be managed by a board of trustees consisting of four members appointed by the Governor and one member from and elected by the membership of each of the following: The Board of Regents of the University of Texas System; The Board of Regents of the Texas A&M System; The Board of Trustees of the Teacher's Retirement System of Texas; The Board of Trustees of the Employee's Retirement System of Texas; and the State Board of Education. The trustees may set the investment policy of the fund, enter into investment contracts, and take any action necessary for the creation, administration, and protection of the fund. The amendment authorizes the Board of Regents of the University of Texas System and the State Board of Education, in managing the permanent university fund and the permanent school fund, to acquire, exchange, sell, supervise, manage, or retain any kind of investment, including investments in the Texas growth fund. The fund will be phased out after the tenth anniversary of its creation, but the Legislature may create a second growth fund by a two thirds vote of each house.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide for the investment of the permanent university fund, the permanent school fund, and public employee retirement systems in the Texas growth fund created by the amendment, which will directly create, retain, and expand job opportunity and economic growth in Texas."

was tackled while trying to run the ball back. Boyce Tankersley then came in to the game as quarterback to open the series. A tough Albany defense held its ground and forced the Hounds to punt on 4th and 20.

Following the punt by Alex Flores, Albany once again fumbled on the run-back and the ball was recovered by Fred Ledesma to put Knox City in possession on its own 34 yard line. It appeared that Albany had really studied game films of the Knox City offense as their defense read every play perfectly, stopping the Hound offense cold and forcing another 4th down punt by Alex Flores.

An equally tough Greyhound defense took the field and shut down runs and passes by Albany. With a 4th down and 7, Albany punted back to Knox City.

The Greyhounds took over with 1st and 10 on their own 11 yard line following the punt and short yardage return. As in the previous series, the Greyhound offense faltered under a hard rush by the Albany defense. A penalty for illegal procedure against Knox City set the Hounds back to a 3rd and 15 and with no gain on the play, Knox City was again forced to punt from deep in its own territory.

With the Lion offense taking over on the Greyhound 39, a strong defensive stand by Fred Ledesma, Jim Ford and Mike Manuel failed to stop the first Lion 1st down of the evening. Jim Ford, Robbie Whitford, Chad Carter teamed up their defensive efforts with solid tackles, but Albany rolled on to another 1st down on the Greyhound 13. Three plays later, Albany had another 1st down, then crunched their way in for a touchdown one play later. The extra point was good and left the scoreboard showing Knox City 17, Albany 15.

A completed pass from Tankersley to Alex Flores on 2nd and 15 allowed the Hounds to move down to their own 30 yard line, but again had to punt away on 4th down. A penalty against Albany moved the ball to their own 20 following the punt return.

Jim Ford stopped the first play of the series, but Albany came back with a 78 yard combination pass and run for another Lion trip across the goal line. Jim Ford stopped the extra point attempt to leave the score 21 to 17 in favor of the visiting Albany Lions for the first time in the game.

Roy Roberson made a 20 yard punt return with several tacklers hanging on, then Tankersley once again opened up the Hound offensive series. 1st down brought a 5 yard penalty against Knox City, then 2nd down saw a 15 yard penalty against Albany to give the Greyhounds a 1st down with 3:14 left in the 1st half. Albany intercepted a Greyhound pass just three plays later and returned it for another Lion touchdown. With a failed attempt at a two point run for extra point, Albany led the ball game 27 to 17 with 2:08 left in the half.

Knox City ground out 1 more first down in their next offensive series, but a fired up Albany defense refused to allow anything else. Knox City lost their backup quarterback when Boyce Tankersley was shaken up during the series and Chad Carter took over for Large and Tankersley, who were both out after receiving hard hits and being shaken up. On 4th down, the Greyhounds again punted the ball away.

A second down long pass completion by Albany netted them another 1st down and moved the ball down to the Knox City 31 yard line. One play later Albany ran up the right side 31 yards for another touchdown. A good extra point kick moved Albany ahead 34 to 17 with :35 left in the half.

Knox City ran out the clock to end the half. For the first time this season, Knox City entered the locker room at half time behind in a game with the scoreboard favoring a visiting team to Greyhound Stadium. The Scarlet Belle Drill Team, Knox City band and Twirlers gave an impressive show to entertain the home fans. When the twirlers performed, Band Director Dick Wupperman announced that twirler Kristen Perdue was chosen best individual twirler in the West Texas Fair and Rodeo Parade in

Abilene the previous Saturday. This announcement netted Kristen a rousing cheer from both Knox City and Albany fans.

Second half action began with Knox City kicking off to Albany and the Lions taking over on their own 12 after a short yardage runback attempt. Albany opened with an aerial attack that faltered with good coverage and good tackles by Chad Carter and Mike Manuel. Albany tried to run out a 4th down play, but the Hound defense stopped the play and Knox City took over on the Albany 20 yard line with Chad Carter at quarterback. On the second play of the series, Carter passed to Jim Ford for another Knox City touchdown. With a good extra point, Knox City closed in on Albany's lead, 34 to 24.

Good tackling by Roy Roberson and Mike Manuel stopped a runback on the kickoff return by Albany. A 1st down penalty moved the Lions back another 10 yards for a 1st and 20. Two plays later Alex Ledesma intercepted an Albany pass on the 21 yard line to return ball control to Knox City.

With Billy Large, Boyce Tankersley, and now Chad Carter out for an injury, the Knox City 4th string quarterback, Willie Rodriguez, took over the offensive reins. With no gain in the series, Knox City turned the ball over to Albany on downs deep in Lion territory. Robbie Whitford, Bob Burkham and several other Knox City defenders showed their defensive skills with strong tackles but the Lions managed another 1st down to their own 40 yard line. On 2nd and 7, Albany fumbled but recovered with a loss of yardage. When Albany tried to punt on 4th down, Harvy Rocha blocked the punt and Roy Roberson made a diving,

scrambling recovery deep in Lion territory to regain possession for Knox City.

Billy Large returned as quarterback for the Greyhounds and quickly moved the team down for another touchdown just five plays and one 1st down later. The touchdown was made by Willie Rodriguez after a short yardage pass from Large. The extra point kick moved Knox City closer to Albany's first half lead with the scoreboard now showing Albany 34, Knox City 31 with 3:19 left in the 3rd quarter.

The Lion runback attempt was stopped with an open field tackle by Robbie Whitford. A penalty set Albany back to open from its own 12 yard line. Monte Owens, Mike Manuel, Jim Ford made tackles to stop the series as Albany punted back to Knox City on 4th and 6.

A face mask flag against Albany on the Greyhound punt return moved Knox City to the Lion 36 yard line for 1st down. Knox City then got a 5 yard penalty for 1st and 15. During the next 3 plays, the Lions shut down Knox City, forcing a punt on 4th and 15.

Taking over on its own 20, Albany played one down and a penalty replay prior to the end of 3rd quarter action. Fourth quarter action started with the Greyhound defense sacking the Lion quarterback deep in his own territory. A solid stop on the next running attempt brought a 4th and 16, leaving Albany to punt back to Knox City with the Greyhounds taking over on the Lion 37 yard line.

With the Lions playing tough defense, Knox City soon faced a 4th and 6 before a timeout for a sideline coaching conference. The Hounds came back and went for the 6, only to have Large sacked deep behind the line.

Another aerial attack by Albany followed with the Lions picking up one 1st down before punting back to Knox City and downing the ball on the Greyhound 6 yard line.

Deep in their own territory, Knox City ground out short yardage plays and soon faced a 4th and inch situation. Large went for it up the middle and gained the badly needed 1st down with an inch or two to spare. Another 1st down soon followed with an up the middle run by Roy Roberson. A clipping call against the Lions following a pass interception placed them with ball control on their own 45 yard line. A fumble recovered by the Lions on the following play and a personal foul penalty against the Greyhounds quickly moved the ball downfield. Clipping against the Lions was called next as it appeared that tempers were getting as short as the time left on the clock 2:20. Another 1st down and several short yardage plays to retain possession and run out the clock resulted in the final buzzer sounding and the Albany Lions winning the game by a score of 34 to 31.

# Information For ACT Is Released

As the new fall term opens, more than one million high school juniors and seniors across the nation will move one step closer to college and other postsecondary plans by registering to take the ACT Assessment.

The ACT Assessment, which consists of four academic tests that measure educational development and a detailed questionnaire that collects information relevant to educational and career planning, is recommended or required by more than 3,000 postsecondary institutions and scholarship programs.

Most students take the ACT Assessment during junior year or early in senior year, so their results will be available in time for use in planning for postsecondary education and careers.

High school guidance offices have the information and forms students need to register for the ACT Assessment. ACT also provides free copies of the booklet, Preparing for the ACT Assessment, which contains information about getting ready for the examination, plus a complete practice test.

There is a basic registration fee for the Assessment. Late registration will be accepted for an additional late handling fee. For 1988-89, ACT has established this test date schedule: Test Dates - October 22, 1988, December 10, 1988, February 11, 1989, April 15, 1989, June 10, 1989.

Registration Deadlines - September 23, 1988, November 11, 1988, January 13, 1989, March 17, 1989, May 12, 1989.

Late Registration Deadlines - October 11, 1988, November 29, 1988, January 31, 1989, April 4, 1989, May 30, 1989.

It takes about three hours to complete the four ACT examinations in English, math, social studies, and natural sciences. The Assessment also includes a two-part questionnaire that students complete at home when they register. It focuses on interests, academic and nonacademic accomplishments, and vocational and educational plans and needs.

Colleges use information from the ACT Assessment for academic advising, admissions counseling, course sectioning and placement, student services, and institutional research. ACT Assessment reports are sent to students, their high school counselors, and the institutions and agencies students specify.

The ACT Assessment is a major service of The American College Testing Program, which has national headquarters in Iowa City, Iowa.
