ARDMORE, OK - Lila Rector of Knox City, Texas, was one of 16 from Oklahoma and North Texas who participated during the month of June in an agriculture camp sponsored by the Ardmorebased Samuel Roberts Noble Foundation, Inc.

AgVenture is a five-day handson learning experience for selected agriculturally inclined students. The fourth AgVenture class studied a variety of disciplines represented in the Noble Foundation's Agricultural Division. This is done through a series of tours, programs and activities designed to increase the students interest, awareness and knowledge in agriculture. Soil and hay sampling, wildlife management, raised-bed gardening, cattle judging, grass management, agricultural communication, and mapping were only a few of the topics studied during the camp.

The AgVenture participants were selected from 35 junior and senior applicants in the two-state area, and were housed at the spacious Noble Foundation Conference Center.

County Continues State Of Emergency

Knox County Judge David N. Perdue has declared that a state of disaster still exists in Knox County, "due to the extreme potential and imminent threat of widespread or severe damage to life or property, due to destructive wildfires". This order is an extension to the original order signed on June 27, 1994 and will extend for seven days, beginning July 7.

Judge Perdue states, "that if conditions do not improve by the end of this most recent order it shall be continued every seven days until terminated by court order or precipitation that would ease the danger of wildfires.

This emergency order prohibits any open burning in the unincorporated areas of Knox County except in approved enclosures, such as trash barrels and grills which are designed to contain all flames and embers.

King Co. 4-H Horsemen Win Big At District Show

Eleven King County 4-H horsemen participated at the District 4-H Horse show in Vernon on June 17-18 being one of the largest shows in several years with 215 entries.

Ryan Antilley and Tara Merrick are two of the top 35 horsemen that will be representing District 3 at the State Qualifying show to be held in Abilene on July 25-30. Ryan got an automatic bid by winning Grand Champion Gelding. Tara qualified receiving enough points by placing fifth in Western Riding and seventh in Poles. Other competing in the qualifying portion of the show were Jake and Dan Merrick.

In the Open Show, all 11 4-H'ers participated in one or more events. Kendra Williams finished fourth high point in total open events by placing first in both

working cow horse and reining and was team captain on the third place team penning team with Byron Fields and Jodie Boykin from Cottle County. Byron also won fourth in the working cow horse event. Jake Merrick took a tenth place finish in working cow horse. Panel Named To Look Into Family Violence

AUSTIN - Lt. Governor Bob Bullock has named a special Senate committee to look into possible changes in the way Texas handles family violence under criminal and civil laws.

"You don't have to look to California, you don't have to leave Texas to see painful reason to reassess the protection we afford abused spouses and children in our own state," Bullock said in appointing Sen. Mike Moncrief of Fort Worth to chair an interim committee on domestic violence.

"I worry that victims of domestic violence can fall through the cracks in the justice system", Bullock said. "We have got to see if there are holes that should be closed in our laws, including the new staking law."

Besides Moncrief, Bullock appointed Sens. Judith Zaffirini of Laredo, Florence Shapiro of Plano, Buster Brown of Lake Jackson and Royce West of Dallas to the committee.

"These senators each have unique expertise to contribute to this work. Failure to deal with domestic violence aggressively from the outset is asking for greater problems and more tragedy down the line," Bullock said.

"We must tear down any legal barriers to swift and sure concerted action by the courts, the police and the human service agencies, both public and private, which deal with family violence. The right hand must know what the left hand is doing and they must work together," he said.

Bullock said that Moncrief, author of the stalking law, is particularly well suited to head up the study becuase "he has keen insight into family violence and the toll it takes, as well as the compassion that must be afforded the victims."

Bullock noted that besides the tragic circumstances of direct victims of family violence, domestic violence is also on of the most dangerous -- as well as frustrating -- areas law enforcement officers face

"This will have priority when the Legislature convenes in January," Bullock said.

the table selections was "puppy chow".


