# **Greyhounds Clobber Hornets, 35-0**

The Knox City Greyhounds flexed their muscles last Friday night by soundly defeating Aspermont in the opening game of District 9-A action before a large Homecoming crowd. With the Greyhounds controlling the Hornets 35-0, other action in District 9-A openers saw Paducah defeating Munday 15-13, and Roby defeating Crowell 46-14. Knox City will play at Crowell this Friday night, face Roby here on Friday, October 21, play at Paducah on Friday, October 28, and play at Munday on Saturday, November 5 for Munday's Homecoming game.

The Greyhounds dominated action on both offense and defense last Friday night, completely shutting down the Hornet offense and ripping huge holes through the Aspermont defense. With Knox City dominating action early in the game, Greyhound Head Coach Rob Wills was able to play quite a few Junior Varsity players during the second half. The entire JV team was suited up with the Varsity for the Homecoming game since there was not a JV game against Aspermont on Thursday evening.

Action started with Knox City receiving the opening kickoff and immediately moving the ball down the field for three quick first downs before Louis Diaz fumbled the ball to the Aspermont defenders. Aspermont started an offensive series that was short lived, having to punt the ball to Knox City from the 7 yard line after three downs that included a fumble that Aspermont recovered. The punt was caught on the 50 yard line by Kevin Dorsey, who then provided the fans with an exciting runback good and KC moved ahead 7-0.

Aspermont's kick return was stopped abruptly when the receiver was hit hard and brought down by Eric Richardson on the 19 yard line.

In their next series, Aspermont was able to pick up a first down with the help of a facemask pen-



as he brought the ball back to the 11 yard line before being dragged down. A penalty on the Greyhounds for illegal blocking moved the ball back before quarterback Wes Grimsley took over and ran the ball 6 yards on first down. Lance Dever quickly picked up a first down with a run to the 14 yard line, then two plays later an 11 yard touchdown pass from Grimsley to Diaz put the first points on the scoreboard with 2:41 left in the first quarter. The extra point kick by Duane Toliver was alty by Scott Stephens and despite a fumble that was ruled dead after the whistle.

Brutal tackles by Ryan Marion and David Dudensing quickly brought up a 4th and 5, Aspermont went for it with a pass that was incomplete.


Taking over on downs, Knox City quickly picked up a first down with two runs by Lance Dever. Three more runs by Diaz, Grimsley and Diaz moved the ball to the 8 yard line, with Lance Dever Taking the ball in for another KC touchdown. The extra point kick by Toliver was good, putting Knox City ahead 14-0 with 7:54 left in the second quarter.

Aspermont's next series was held to just one first down as Logsdon, Dever, and Stephens spurred the KC defense with some extremely hard tackles. The Hornets punted back to KC on 4th and 12, the ball was whistled dead on the 29 yard line.

A 15 yard pass from Grimsley to Diaz picked up another first down that was quickly followed by another after runs by both Diaz and Dever. On the next play, Kevin Dorsey ran the ball from the 49 yard marker down to the 36, breaking at least 6 Hornet tackles on the way for another KC first down. An incomplete pass from Grimsley to Diaz was followed by runs from Dorsey and Dever, gaining KC another first down. Grimsley passed on 1st and 10, firing the ball off to Ryan Marion and a 31 yard touchdown play. The extra point kick by Toliver moved the score to KC 21, Aspermont 0, with :47 seconds left in the first half.

Aspermont recovered the kick on their own 5 yard line, moving the ball out to the 12 yard line before being stopped by Dorsey. Three plays later the first half ended.

The second half of action did not see the Hornets improving any, their first series after receiv-See Greyhounds, Page 6



# Chamber Schedules Parade Planning Meeting




# **Rites Held In Littlefield For Lillian Fowler**


## **CAN WINDBREAK TREES BE USEFUL TO YOU**


Windbreaks provide protection for people, animals, buildings, crops, and natural resources. They reduce soil erosion by wind and contribute to the control of runoff from agricultural lands. Trees and shrubs planted as windbreaks provide wind erosion control, improve crop yields and enhance the quality of many wind sensitive crops. Farmstead windbreaks protect the home site and reduce energy consumption. Windbreaks can reduce stress on livestock, improve weight grain, and reduce mortality of young animals. Finally, windbreaks add beauty to the landscape and increase the value of the land.

A few weeks ago we were reminded how harsh the wind can be in Knox County. Windbreaks can reduce damage caused by strong winds.

Windbreak trees may be purchased now until February 9, 1995 thru the Wichita-Brazos Soil and Water Conservation District. Trees will be delivered February 16, 1995. Several species of evergreens and hardwoods are available along with wildlife packets to promote deer, quail and pheasant, turkey or squirrel. Potted evergreen trees will sell for \$32.00 for 20 trees. Evergreens will only be sold in lots of 20 trees. Hardwood trees will sell for \$15.00 for 25 trees. Hardwoods will only be sold in lots of 25 trees. Wildlife Packets will sell for \$40.00 a packet. Each packet contains 4 species and 25 seedlings of each species. (100 seedlings total).


# **WTU Supports Red Ribbon Drug Week**


