'Dawgs' Stomp Munday, 23-12

In a final tribute to their coaches and fans, the 1994 Knox City Greyhound Football Team gave their community a lasting and fitting end of season gift last Friday night when they defeated the arch rival Munday Moguls 23-12 at Munday for the Mogul Homecoming.

Playing a superb brand of football, the Dawgs jumped out in front of the Moguls early in the game and never relinquished that position on the scoreboard. The final score of 23-12 brought on a jubilant celebration on the visitors side of the stadium, watched with a somber, quiet hush on the Munday side of the field.

The first quarter of action saw the ball change hands several times with a lot of hard hitting action on the field. Knox City received the opening kick and quickly moved the ball down the field with two complete passes and a run before Munday intercepted a KC pass on the 12 yard line.

Munday's first possession went nowhere, after picking up one 1st down the Moguls punted back to KC on a 4th and 5 yard play. Four plays later, KC punted back to Munday as Brian Rosencranz booted the ball high and long.

Munday kept the ball for 11 plays, picking up 2 1st downs before attempting a field goal that went wide to the right.

The first quarter ended during the Dawgs next series. Shortly into the second quarter, KC punted back to Munday on a 4th and 19 yard play.

Munday's quarterback felt the onslaught of the Dawg defense

during the next series as Scott Stephens hit the QB with a brutal crunch and dropped him for a 10 yard loss. On the next play, Munday punted back to KC.

Wes Grimsley, KC's quarterback, was no stranger to being sacked as he was also hit hard for a 10 yard loss during the next series. Recovering quickly, he threw a bullseye pass to Kevin Dorsey for a 14 yard gain, then Lance Dever took the ball down the field for several ground gaining runs before Munday intercepted a Grimsley pass on the 49 yard line.

Facing a KC defense that resembled a stone wall, Munday

went nowhere and quickly punted back to Knox City.

A fumble by Dever and recovered by the Moguls gave the ball back to Munday just three plays later. Four plays later, Munday attempted to pass for a fourth down conversion, only to have the ball intercepted by Kevin Dorsey.

In the next five plays, the Dawgs picked up four first downs before Ryan Marion took an 18 yard pass across the goal line for the first Knox City touchdown of the night with just :07 seconds showing on the board to end the first half. Duane Toliver booted in the extra point, putting the

 3. Pursuant to Section 12.02 (a), Texas Family Code, Roy Lerma is a presumed father of the child. Pursuant to Section 12.06 (a), Texas Family Code, the Attorney General denies that Roy Lerma is the biological father of the child.

PERSONS ENTITLED TO NOTICE
 4. The child resides with SYLVIA ANN LERMA, the mother of the child, in KNOX CITY, TX. The Office of the Attorney General requests the issuance and service of process on this person in accordance with the attached service information sheet.

DETERMINATION OF PATERNITY
 7. The Court should determine the paternity of the child subject of this suit. If any party denies paternity the Court should immediately order paternity testing. The Court should fix a reasonable fee for such testing, order how such fee should be advanced, and the tax the fee as court costs.

CONSERVATORSHIP
 8. Because the parents of the child are separated, the Court should appoint a managing conservator pursuant to Section 14.01 (a), Texas Family Code.

NAME CHANGE
 9. The Court should consider whether good cause exists to change the surname of the minor child to reflect the paternity, if established, and enter an order concerning the name of the child pursuant to Section 13.43, Texas Family Code.

SUPPORT
 10. The Court should order appropriate regular, retroactive, lump sum, and medical child support for the child, including temporary support pursuant to Sections 13.04 (f) and/or 11.11 (a), Texas Family Code. In determining the amount of retroactive and/or lump sum support to be ordered, the Court should consider the duty of each parent to support his or her minor child, all applicable provisions of the Texas Family Code, and the amount of public assistance provided under Chapter 31, Texas Human Resources Code.

WITHHOLDING FROM EARNINGS FOR SUPPORT

Rites Are Held Sunday In Seymour For Dr. Ben Grill

Funeral mass for Dr. Benjamin F. Grill of Seymour, father of Patsy Gonzales of Knox City, were held Sunday afternoon, November 6, at four o'clock in Sacred Heart Catholic Church in Seymour. The Rev. Bart J. Landwermeyer officiated and burial was in Seymour Catholic Cemetery.

Dr. Grill, 78, died Saturday, November 5, in a Seymour hospital.

Born September 2, 1916, in Shiner, Texas, he was raised in Shiner. He attended the University of Texas at Austin and the University of Texas Dental School at Houston. He practiced as a dentist in Texas City, Texas, for four years. He then served in the United States Army Air Forces and was stationed at Sheppard Air Force Base during World War II. He moved to Seymour in 1946 and practiced as a dentist in Seymour for 48 years.

He and Lorene Cotton were married May 24, 1941, in Texas City.

Dr. Grill was a member of Sacred Heart Catholic Church,

Knights of Columbus, KJZT Lodge, Seymour Lions Club, Seymour Chamber of Commerce and the American Legion. He was a former school board trustee of the Seymour Independent School District. He was a past director of the Salvonic Mutual Association and was instrumental in the organization of the Baylor County youth league baseball program. Dr. Grill was a life member of the American Dental Association as well as the Texas Dental Association.

Survivors include his wife; three daughters, Mary Kay Linn of San Antonio, Patsy Gonzales of Knox City and Elizabeth Grill of Austin; a son, Benny of Seymour; and six grandchildren, Nefro and Nikki Gonzales of Knox City, Kate Grill of the University of Texas at Austin, Diahndra Grill of Seymour, Matt Linn of Arlington and Micah Linn of San Antonio.

METER TAMPERING NOW A FELONY

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

Meter tampering consists of, but is not limited to:

- (1) Diverting electricity from passing through a meter device.
- (2) Preventing electric service from being correctly registered by a meter device.
- (3) Unauthorized activation of electric service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee.

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies the Cooperative should be notified as soon as possible so that the meter can be resealed.

Seminar To Highlight Wills, Trusts, Taxes

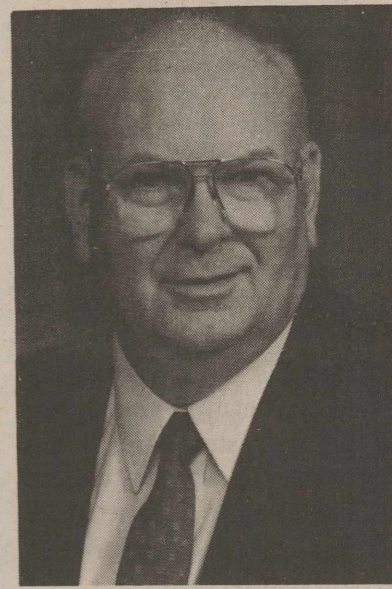

Dawgs ahead 7-0 and setting off wild cheering on the visitors side of the field.

Second half action exploded early when Kevin Dorsey took a Munday punt on the 40 yard line and ran the ball back 60 yards for the second touchdown of the night for Knox City. That TD came with 10:00 left in the third quarter. Toliver's point after kick was good, putting the Dawgs ahead 14-0.

Third quarter action toughened as both teams played a strong brand of defense and traded the ball back and forth several times. This seasaw action lasted until Louis Diaz intercepted a Munday pass on the 47 yard line and ran the ball back to the 1 yard line before finally being dragged down. Anthony Ainsworth soon put another 6 points on the board when he ran the ball in for another touchdown, much to the delight of a Knox City crowd that was delirious with excitement! Toliver's point after kick went wide right, leaving the score at 20-0 in favor of the Dawgs, with 4:08 left in the third quarter.

The Moguls finally scored later in the third quarter with a short pass into the end zone. With :12 seconds left in the third, Munday attempted to pass for 2 extra points, the pass was incomplete and left the score at 20-6.

The most exciting - and most controversial - play of the game came after Munday scored their second touchdown with 8:08 left in the game. The Moguls tried to run for the 2 point conversion, the ball was fumbled after a hard tackle and picked up by Lance Dever who then ran it 99 yards down the field for what appeared to be a touchdown. The play was called back on a penalty, and a referee explained it to me this way: "the penalty was called for a block to the back by Knox City during the runback." The call stood and the score remained at 20-12 in favor of the Dawgs.

An onside kick by Munday that was combined with a penalty gave KC the ball on the Mogul 49 yard line. The ball once again traded back and forth until Duane Toliver kicked a 32 yard Knox City field goal with 1:28 left in the game. That three points determined the final score of the game.

Thanks To The Dawgs

The 1994 football season is over. Equipment has been placed in storage until next year as players turn their attention to basketball.

The stadium sits quietly, vacant until track season starts. Gone are the familiar sounds of fall: the cracking of pads, the groans of hard hits, the cheering of enthused cheerleaders, the support of the fans, the synchronized melodies of the marching band and loud blasts of an air horn that signified achievement on the field.

This season for the Knox City Greyhounds, or 'Dawgs' as they named themselves, was not just another football season. This season was new, it was special, and it served as a springboard for the community to come together with hopes and dreams of victory under a new coaching staff.
