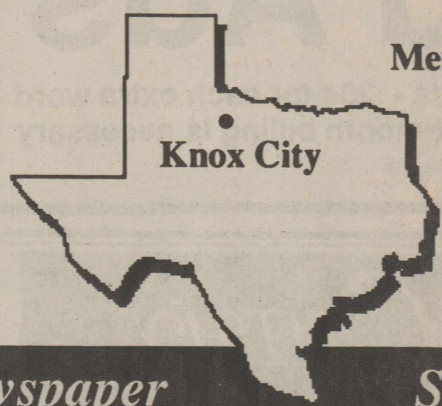

# EDC - Key To The Future

The future of Knox City was the main topic of discussion at a meeting of the new Economic Development Corporation last Thursday night, and the end result of the meeting could very well determine what course the future of our community will take.

With a declining economic base and a deteriorating physical appearance, the future of Knox City is of prime importance to many who live in and depend on Knox City for a living. The basic nature of those concerns led to several meetings of concerned citizens, then to the formation of the Economic Development Corporation.

While the citizens who have expressed an interest are both needed and appreciated, the help of many more within our community is a must if the overall long term goals of the EDC are to succeed.

At Thursday night's meeting, several committees were identified and a call went out to all

those interested in serving on any of the committees.

Members of the community and the surrounding area are encouraged to contact Bertha Driver at Citizens Bank in Knox City if there is an interest in serving on any of the committees identified as Finance & Funding, Economic Development, Cultural & Recreation, City Infra-Structure, Beautification & Restoration, and Education & Healthcare. A chart of the committees and areas from which expertise could be helpful within each committee is included with this story.

After a period of time for interested persons to make known their intent to serve, another full meeting of the EDC will be held. That meeting date has been set for Thursday, February 16, at 6:30 p.m. in the Knox City Community Center. During the February meeting, the committees will be tasked to identify committee goals. Those goals will be identified in three different areas: short range, intermediate range and long

range.

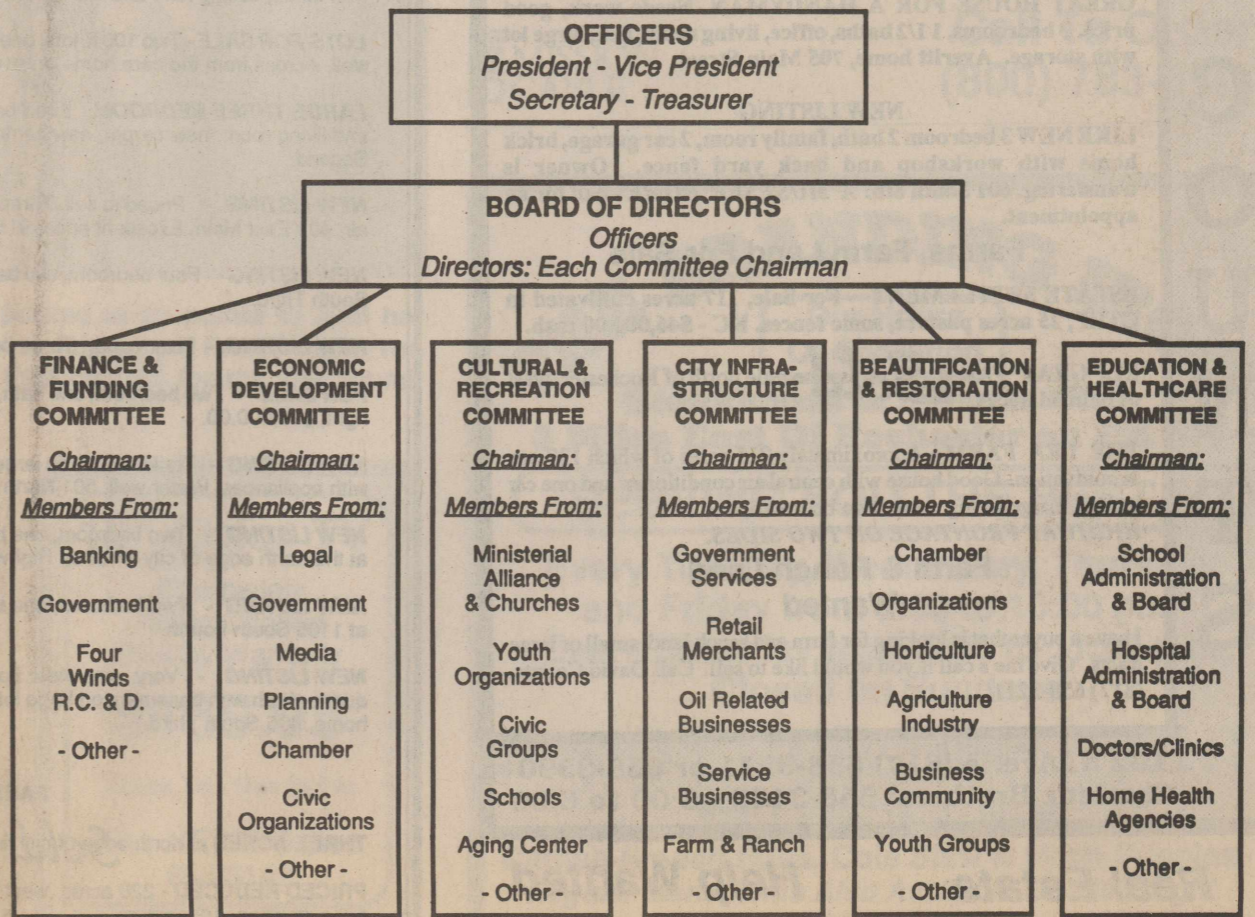
While the committees are formulating project goals, the EDC will be filing all legal paperwork to become an official non-profit corporation in order to solicit future grants and possible private entity funding to accomplish project goals established by the committees.

Once committee goals are established, projects will be placed on a priority basis for implementation with criteria based on whether the project falls into the short, intermediate or long range areas.

One point stressed throughout the meeting and emphasized by the committee chart is that this is not just a "Let's beautify the downtown area" organization. While the beautification of certain areas will fall within the area of the Beautification and Restoration Committee, that project will be just one of many that will encompass all facets of life within our

## Petition Filed With Public Utility Commission For Toll-Free Calling

On January 9, 1995, a petition for expanded local calling service (ELCS) from the Knox City exchange to the exchanges of Aspermont, Benjamin, Hackmont (Guthrie), Haskell, Munday, Rochester, Rule, Seymour, Truscott, and Weinert was filed.

As many Knox City and area residents and businesses are interested in the expanded toll-free calling, Stan Wojcik, who has been instrumental in securing the necessary forms to be filed, brought information to the *News* on the scheduling order for the petition. As Wojcik explained, it will be a day to day process on orders issued and on February 14, 1995, the General Counsel files Staff's recommendation as to whether the petition should continue or whether the petition should be denied on the basis of Local Exchange Companies (LEC) exemption request, geographic proximity or community of interest.

On February 20, 1995, the presiding officer issues an order notifying petition coordinator and affected LECs if the petition is sufficient or if petition is denied based on the granting of an LEC exemption, geographic proximity or community of interest. If the petition is sufficient, the presiding officer shall issue an order notifying the LEC serving the petitioning exchange to proceed with balloting the subscribers.

On March 27, 1995, a notice must be published by the LEC 15 days before any ballots are mailed indicating that a ballot is forthcoming.

On April 10, 1995, ballots must be distributed to all subscribers in the petitioning exchange - subscribers have 15 days to vote.

On April 14, 1995, a master list of subscribers is issued to the staff by the LEC. The LEC must file a

publisher's affidavit attesting that notice was published in compliance with the rule.

On April 24, 1995, ballots must be returned to the commission.

The General Counsel files Staff's report on May 9, 1995, on the ballot notifying the presiding officer, the petition contact person and the affected LECs.

In case of an affirmative ballot, General Counsel notifies presiding officer, petitioners and the LECs that the ballot has passed and that the LEC should submit costs and an implementation plan within 30 days.

If it is a negative ballot, General Counsel notifies presiding officer, petitioners and the LECs that the ballot has failed and recommends that the petition should be denied in whole or in part.

If it is a negative ballot, on June 8, 1995, presiding officer issues an order denying the petition in whole or in part. On the same day, cost studies are submitted by LEC indicating the costs to provide for the expansion of toll-free calling, the initial fees for the service and the implementation schedule for the service.

On June 23, 1995, interim approval is granted, and July 6, 1995, is the deadline for any party, including General Counsel, to contest the implementation schedule.

On July 10, 1995, the presiding officer issues an order approving, modifying, or denying implementation schedule, and if further investigation is not requested, the presiding officer shall issue an order granting final approval of the fees on August 22, 1995.

## Administrator's Column

At the beginning of a new year, it is appropriate to talk about the future of Knox County Hospital because the future of our hospital may help determine the future of our community.

Changes in federal funding, the changing economy, massive changes in health care delivery systems have all contributed to make the last few years at our hospital turbulent ones. As we have adjusted to the constant changes in the health care delivery system, we have had to be open and creative in our thinking to keep the hospital operating on an even keel.

A few months ago, we began a long, complicated process to help us meet the future *proactively*, by developing a strategic plan that gives us a clear idea of our mission, our goals, our values and beliefs, and the steps were intended to take to reach those goals and fulfill our mission. There are

many reasons for a strategic plan:

- \* to stimulate ideas for the future
- \* to look at opportunities
- \* to discard outmoded, outdated ideas and services
- \* to develop guidelines for future decisions and actions
- \* to build a consensus for the future
- \* to insure that tax dollars are used effectively and efficiently

During many long sessions, the board of directors, the medical staff, hospital managers, and other staff members worked to bounce around ideas, hopes and dreams. We have developed and polished those ideas, and now we have a good idea of the direction our hospital will take in the future.

In the next few weeks in this column, I will share with you the various parts of the strategic plan so that you can see the direction we hope to take Knox County Hospital in the next few years.

## Here's To Your Health

A popular word in health care in the last few years is "wellness". Where once we talked about "good health" or "feeling good", now our concern is "wellness". What exactly does the concept of wellness encompass?

Wellness is more than just freedom from disease or illness. Wellness implies that the individual has chosen a life style that will promote good health, that will bring him or her to their full physical, emotional and mental potential.

Some of the components of a wellness program are education, exercise, good nutrition, wise lifestyle choices, stress management, and regular physical exams. Each component of an overall wellness program enhances the other measures, so that once an individual is making an effort in all these areas, he or she begins to achieve a state of wellness.

This week we will look at edu-

cation and exercise.

\* Education: we each bear the primary responsibility for our own good health and wellness. To make the correct choices, we must educate ourselves about lifestyle choices, common illnesses, preventive measures, new diagnostic techniques, and effective treatments.

\* Exercise: adequate exercise promotes flexibility and good health for people of all ages. The key to exercise is to follow the simple FIT formula (frequency, intensity and time). According to the majority of fitness experts, most of us should exercise three to four times a week (frequency), at our target heart rate (intensity), for 20 to 30 minutes (time).

However, if you haven't exercised regularly in years, check with your physician before beginning any exercise program.

# Police Department Gives Report For December, End of Year

The Knox City Police Department had another rather busy month during December responding to and completing a total of 226 calls and miscellaneous tasks. Reported during the month were 12 criminal offenses, of which 11 have been cleared or otherwise taken care of. Juveniles were not involved as offenders in any of the reported offenses.

Offenses reported include: Domestic Assault (class C) - 1, Domestic Assault (class A with injury) - 3, Domestic Criminal Trespass - 1, Assault (class A with injury) - 1, Sexual Assault - 1, Theft (class B, \$20.00-\$500.00) - 1, Theft (class A, \$500.00-\$1,500.00) - 1, Criminal Mischief (class B) - 2, Attempted Burglary of a Habitation - 1, Traffic Tickets issued - 3, Warnings issued - 20, Accidents - 2.

The Knox City Police Department Reserve Officers contributed a total of 50 1/2 hours of on duty time to the City of Knox City during the month of December.

On December 5 - 7, Officers Curd, Steen and I attended a required course titled 1021 that was held in Stamford, Texas. The course covered many different areas of interest, including liability, sexual assault, family violence, and child abuse.

On December 10, the Knox City Police Department, along with help from the Knox County Sheriff's Department, Munday Police Department, Knox City Fire Department, and the Texas Department of Public Safety, successfully managed to work traffic for a very nicely put together parade held in the City of Knox City. This department would like to thank those again for their help in controlling traffic without any more inconvenience to other traffic than necessary.

On December 13, the Knox County Grand Jury met, at which time they did find evidence to indict both cases that were pending from the Knox City Police Department.

At the November 27 meeting of the Knox County Peace Officer's Association meeting, it was voted on and approved to induct both Knox City Police Department Reserve Officers into the Association. The Association is dedicated to keeping a good working relationship between the different departments that operate within the county. Any education or information that can be exchanged may be helpful to another officer. Congratulations to Officers Harry Steen and William (Buddy) Curd.

ber of calls answered or tasks completed, 1,634, 2,738.

The listed categories do not include some violations of city ordinances, such as violations of the Dilapidated Building or the Junk Vehicle ordinance.

The number of traffic accidents has increased during the year of 1994 also, with a total of 23, up from 15 in the previous year. The major cause of accidents, in the City of Knox City, seems to be Driver Inattention, which accounted for 56% of the accidents. Other statistics reveal that female drivers accounted for 63% of the drivers, while 34% of all drivers involved were between 15 and 25 years old. The youngest driver was 15 with the oldest being 80 years old. 78% of the accidents occurred during clear weather between the hours of 12 noon and 6 p.m. Only one accident involved a DWI.

Officer Jerry Walker and I have spent many hours of investigation on these cases listed, and have created a mountain of paperwork in an attempt to document everything imaginable. We make every effort to investigate every case as thoroughly as possible as this is a profession that requires our most complete attention.

## 'On A Wizer Note'

Phones are ringing off the wall at Extension offices all across Texas. Many farmers have found out that their pesticide license/certificate will expire on February 28, 1995 unless they receive enough Continuing Education Units (CEU's). Hopefully the following information will answer some of these questions.

Anyone who has a certificate - Certified Private Applicator - has two choices. The first choice is to receive 15 CEU's prior to the expiration date. Once this is done a new certificate will be mailed. Choice number two is to let this certificate expire and test to become a licensed private applicator.

The differences between a licensed private applicator and a certified private applicator are few and simple. A certified private is unable to supervise someone applying chemicals while a licensed private may supervise. A licensed private applicator pay \$50 every five years and a certified private has no charges.

No matter which you have - license or certificate - they both require CEU's. Each one requires 15 CEU's every five years. In-

cluded in this 15 must be two CEU's in Laws and Regulations and one in Integrated Pest Management.

If testing for a licensed private applicator is in your plans please note that this testing is conducted monthly in Abilene. If interested in attending please call Gary Bomar at the Taylor County Extension office at (915) 674-1321. Mr. Bomar can give better details.

Those who wish to test but do not want to drive to Abilene will be able to test in Rhineland Thursday, April 27, 1995. More details may be obtained through the Knox County Extension office.

**Reminder To Taxpayers**

**JANUARY 31, 1995**  
IS THE LAST DAY TO PAY YOUR 1994 TAXES  
AND AVOID THE ADDITIONAL PENALTY  
AND INTEREST CHARGES

**HOMESTEAD EXEMPTIONS**  
Homeowners are not required to file a homestead exemption annually. If you are already receiving the state mandated \$5,000 homestead exemption or additional over sixty-five \$10,000 exemption, you need not reapply for the taxing year of 1995. However, if you became 65 after January 1, 1994, and before January 1, 1995, you need to apply for the additional over 65, \$10,000 exemption. If you have changed your place of residency you need to apply for a new exemption. All homestead exemption applications must be filed with Chief Appraiser Stanton Brown, between the dates of January 1, 1995 and May 1, 1995. These exemption forms are available at the Knox County Appraisal District Office, which is located in the Knox County Courthouse.

**AG-USE EXEMPTIONS**  
Annual applications for qualifying land for agriculture use is not required. If you have been receiving the AG-USE exemption on your land in prior years, you need not reapply for the exemption. If you have recently purchased a farm, you need to report this to the Chief Appraiser. AG-USE exemption forms are also available at the Appraisal District Office. Deadline for filing new exemptions are between January 1, 1995 and May 1, 1995.

**DISABLED VETERANS EXEMPTION**  
These exemptions need to be applied for annually. If you received your exemption on the 1994 tax roll, you will automatically receive it for the tax year of 1995. However, if your disability percentage has changed, you need to report the change to the Chief Appraiser. Deadline for filing new exemptions are between January 1, 1995 and May 1, 1995.

**RENDITIONS**  
Taxpayers are reminded that it is still their responsibility to render their property to the Chief Appraiser. These rendition forms are also available at the Appraisal District Office. Deadline for tax renditions is between January 1, 1995 and April 1, 1995.

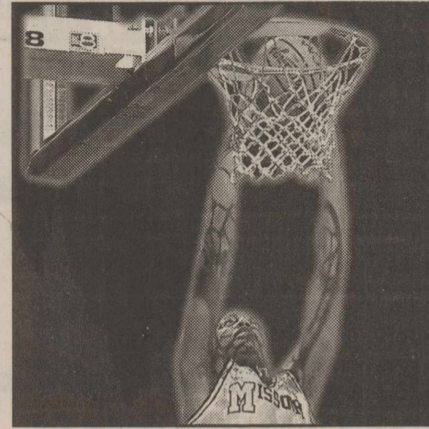

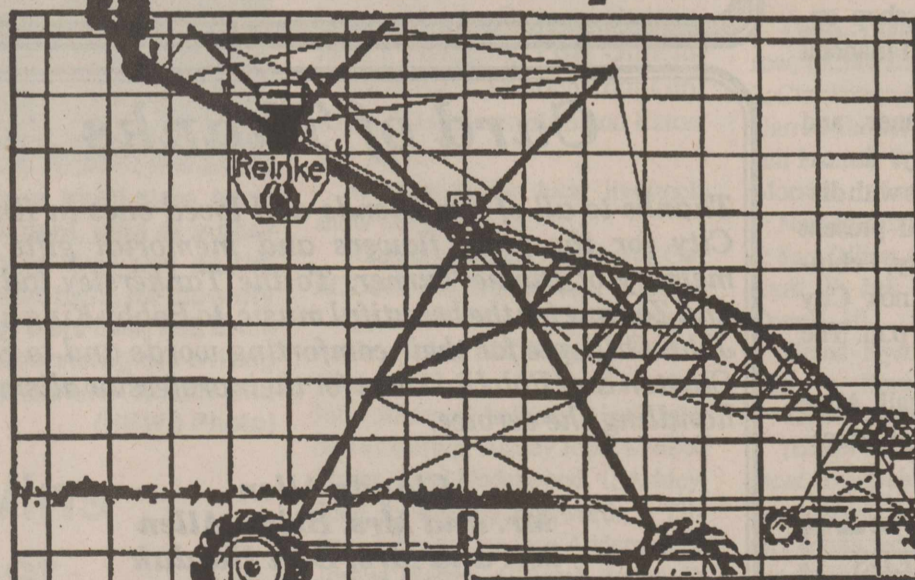
