# State Sends \$17,613.65 To KC **For March Sales Tax Rebate**

Rebate Up A Record 93.18% From Same Period Last Year, Year To Date Totals Up 21.41% From This Time Last Year

(Austin,,May 12, 1995) State Comptroller John Sharp today delivered \$176.7 million in monthly sales tax rebates to 1,076 Texas cities and 111 counties, including a check of \$17,613.65 to Knox City. The rebate to Knox City reflects an increase from a check of \$9,117.61 one year ago. City Hall advised that this large payment was a one time audit payment to Knox City. Overall payments for the year to Knox City are \$45,997.57, up 21.41% from \$37,884.45 one year ago at this same time.

Texas cities received \$176.7 million, up 1.5 percent above the \$174 million delivered last year at the same time. Counties received a total of 17.2 million in rebates, 4% percent more than the payment of \$16.6 million a year ago.

This month's payments include taxes collected by monthly filers on March, 1995 sales and reported to the Comptroller in April.

For other Knox County cities, Benjamin received \$731.94, in-

creasing their yearly total to \$1,770.80. a 5.87% decrease over the same period a year ago. Goree received \$986.11, increasing their yearly total to \$3,213.76, up 13.47% from last year at the same time.. Munday received \$9,132.09, falling 19.64% from a payment of \$11,364.61 last year at this same time. Munday's yearly total now stands at \$33,180.66, down 4.86 from \$34,878.07 in 1994. Munday collects a 1.500% rate of sales tax, while Knox City, Benjamin and Goree only collect a 1.000% sales tax.

In Haskell County, Haskell received \$37,392.03, up 37.40% from a payment of \$27,213.13 in 1994. Haskell collects a 2.000% rate of sales tax. O'Brien received \$514.84 to increase their yearly total to \$1,244.63, up 34.54% from this time a year ago. Rochester received \$1,587.66, increasing their yearly total to \$4,331.11, up 7.81% from last year's total of \$4,017.00.

In Jones County, Stamford received a payment of \$50,311.38,

down 2.93% from a payment of \$51,833.93 in 1994. Stamford also collects a 2.000% rate of sales tax.

In Baylor County, the city of Seymour received a payment of \$18,528.75, down 2.45% from a payment of \$18,994.28 in 1994.

In Foard County, Crowell received a payment of \$6,336.56, up 5.40% from a payment of \$6,011.77 in 1994. Crowell collects a 1.500% rate of sales tax

In Dickens County, Dickens received a payment of \$2,421.87, down 10.95% from a payment of \$2,719.78 in 1994. Spur received a payment of \$3,345.32, down 14.40% from a 1994 payment of \$3,908.31. Dickens collects a 1.5% rate of sales tax, while Spur collects a 1% rate.

In Cottle County, Paducah received a payment of \$5,342.07, down 11.92% from a payment of \$6,065.56 in 1994. Paducah collects a 1% rate of sales tax.

Sales tax figures are furnished by the State Comptroller's office as an economic indicator.



# Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals, You may follow these appeal procedures if you have a concern about:

- The value placed on your property.
- Any exemptions that may apply to you.
- The cancellation of an agricultural appraisal.
- The taxable status of your property.
- The local governments which should be taxing your property.
- Any action taken by the appraisal district that adversely affected you.

#### **Informal Review**

If you think that you have something wrong with the appraisal of your property, you may contact the Knox County Appraisal District. The telephone number is 454-3891. We will try to help you with these problems, but if we are unable to solve any questions that you have, you still have the right to file a protest with the Appraisal Review Board.





Equal Housing LENDER If you can't resolve your problem informally with the appraisal district staff, you may have your case heard by the appraisal review board (ARB).

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the appraisal district to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. The hearing will be informal you and the appraisal district representative will be asked to present evidence about your case. The ARB will make its decision based on the evidence presented. You can get a copy of a protest form from the appraisal district office at P.O. Box 47, Benjamin, Texas, 79505.

Note: You shouldn't try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

#### **Review by the District Court**

After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you receive the ARB's order. If the appraisal district has appraised your property at \$1,000,000 or more, you must file a notice of appeal with the chief appraiser within 15 days of the date you receive the ARB's order.

You can also get a phamplet describing how to prepare a protest from the appraisal district or from the State Comptroller's Property Tax Division at Post Office Box 13528, Austin, Texas 78711-3528.

#### Deadline for Filing Protests with the ARB

#### **Usual Deadline**

On or before June 8 (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have good cause.

Late protests are due the day before the appraisal review board approves records for the year. Contact your appraisal district for more information.

#### **Special Deadline**

For change of use (the appraisal district informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is before the 30th day after the notice of the determination was mailed to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change didn't result from a protest you filed), the deadline is before the 30th day after the notice of the determination was mailed to you.

If you believe the appraisal district or ARB should have sent you a notice and did not, you may file a protest until the day before taxes become delinquent (usually February 1). The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.
