## **Postal Service Honors POW's & MIA's**

With Issue Of Special Commemorative Stamp

The U.S. Postal Service has just released a special commemorative stamp honoring those Americans who have been prisoners of war and those still listed as missing in action from all the wars and conflicts the United States has been involved in.

Featuring a flag background and dog tags that read "POW & MIA - Never Forgotten", the stamps have special meaning to all veterans and families of those held prisoner or still missing. That special feeling of pride is evident with one local veteran who was himself a prisoner of war during World War II.

Expressing gratitude that the stamp was issued to remember all those POW's & MIA's, John B. Lippard of O'Brien vividly recalls the 42 months he spent as a prisoner of the Japanese Army during World War II. Captured by Japanese forces while serving as a United States Marine on the island of Corregidor, Moved from camp to camp, Lippard was held at Bilibid Prison in Manilla. Cabonatuan in Central Luzon in the Philippines, Mukden in Manchuria and Komioka in Japan. Following 42 months in captivity, Lippard was released in October of 1942 and returned to the United States. Prior to his being taken prisoner on Corregidor, Lippard also saw combat duty on the island of Bataan and was a survivor of the Japanese bombing of the Marine Barracks Navy Yard at Cavite in the Philippines. He also served on the aircraft carrier USS Lexington and the cruiser USS Houston. Retiring from the Marine Corps after a total of 23 years service, Lippard served duty as both an enlisted man and as an officer. He spent 12 years in the enlisted ranks before being commissioned as



## Dr. Kristina M. Boone **Joins Kansas State Staff**


Kristina M. Boone and her husband, Kyle R. Mankin, are joining the faculty of Kansas State University in Manhattan, Kansas, in July.

#### Excerpt from the By-Laws of B-K Electric Cooperative, Inc.

**ARTICLE IV** DIRECTORS


SECTION 4.01. NUMBER AND GENERAL POWERS. The business and affairs of the Cooperative shall be managed by a Board of seven (7) directors. The Board shall exercise all of the powers of the Cooperative except such as are by law or by the Cooperative's Articles of Incorporation or Bylaws conferred upon or reserved to the members.

SECTION 4.02. QUALIFICATIONS. No member shall be eligible to become a director or to hold any position of trust in the Cooperative who is not a member receiving service from the Cooperative at his primary residential abode in the area served by the Cooperative, or is in any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the Cooperative, and no person shall take or hold office as a director who is the incumbent of or candidate for an elective public office in connection with which a salary is paid. When a membership is held jointly by a husband and wife, either one, but not both may be elected as director, provided however, that neither one shall be eligible to become or remain a director or to hold a position of trust in the Cooperative unless both shall meet the qualifications herein above set forth. Any director who shall miss three (3) Board of Directors' meetings in a row, without an excuse duly accepted and noted by the Board, shall lack eligibility to further serve and it shall be the duty of the Board of Directors to remove him from the Board. No former employee whose employment has been terminated by the Cooperative may be eligible to serve as director. Any employee who resigns or retires from employment by the Cooperative shall not be eligible to serve as a director for a period of ten (10) years following such resignation or retirement. Nothing contained in this Section shall, or shall be construed to, affect in any manner whatsoever the validity of any action taken at any meeting of the Board of Directors, unless such action is taken with respect to a matter which is affected by the provisions of this Section and in which one or more of the directors have an interest adverse to that of the Cooperative.

In the event an incumbent director, having served on the Board of Directors a minimum of six years, ceases to meet the requirement of receiving service from the Cooperative at his primary residential abode, such incumbent director shall nevertheless be qualified to continue to serve as director so long as he remains a member of the Cooperative and his primary residential abode is located within the area served by the Cooperative, or in close proximity thereto.

SECTION 4.03. ELECTION. At each annual meeting of the members, directors shall be elected by secret written ballot by the members and from among those members who are natural persons; provided however, that when the number of nominees does not exceed the number of directors to be elected, and if there is no objection, secret written balloting may be dispensed with and voting may be conducted in any other proper manner. Directors shall be elected by a plurality of the votes cast unless the members in advance of any balloting resolve that a majority of the votes cast shall be required to elect, and this Bylaw provision shall be drawn to the attention of the members and explained to them prior to any balloting. Drawing by lot shall resolve, where necessary, any tic vote.

SECTION 4.04. TENURE. The business and affairs of the Cooperative shall be managed by a Board of seven (7) directors which shall exercise all of the powers of the Cooperative except such that are by law, or by the Articles of Incorporation of the Cooperative, or by these Bylaws conferred upon or reserved to the members. Beginning with the Annual Meeting of the members of the Cooperative held on August 21, 1954, two (2) members of the Board of Directors shall serve for a period of one year, two (2) members shall serve for two years, and three (3) members shall serve for three years, and that lots be cast as to the length of time each director shall serve; and beginning with the Annual Meeting of the members held in 1954, those directors whose terms expire, such vacancy shall be filled for a period of three years. SECTION 4.05. NOMINATIONS. Notwithstanding the provisions contained in this Section, failure to comply with any of such provisions shall not affect in any manner whatsoever the validity of any action taken by the Board of Directors after the election of directors.

#### **METER TAMPERING NOW A FELONY**

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

- Meter tampering consists of, but is not limited to: (1) Diverting electricity from passing through a meter device.
- (2) Preventing electric service from being correctly registered by a meter device.
- (3) Unauthorized activation of electric service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee.

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies the Cooperative should be notified as soon as possible so that the meter can be resealed.


