

#### **Administrator's Column** By Stephen Kuehler, Knox County Hospital

If nothing else, the healthcare industry continues to grind out new terminology that may effect all our lives. Have you heard the word "capitation" floating around? If you've been anywhere close to a hospital business office lately, you probably have.


"Capitation" is part of the terminology spawned by the managed care system that seems to be the wave of the future. Briefly, in a managed care environment, capitation is a system which pays providers (hospitals and doctors) on a permember, permonth basis. That means that the hospital and/ or doctor gets paid a certain amount regardless of how much care is provided for any one patient.

Capitation works on the same basic ideas as the DRG (Diagnosis Related Groups) system that the government uses for Medicare. The idea behind both DRGs and capitation is to give rewards to the hospital that provides care in the most efficient manner, and penalize hospitals who are inefficient. For example, if Hospital A can care for a pneumonia patient at a cost of \$1,000, but Hospital B provides the same level of care for \$800, Hospital A will make more money.






