## Knox City Gets 'Turned On' Thursday Morning At 10:45

#### GTE Will Activate New Phone Systems & Services

Traveling to Knox City for this very special event, Kathy Harless will be very busy while she is here. Following the system activation at 10:45, Ms. Harless will also take time to talk with students in our school system. This talk is scheduled for 12:30 at the W.R. Baker Auditorium on the

Knox City School Campus. Ms. Harless's program to the students is also open to the public.

To fully brief residents on the new system and options available, GTE will be offering tours of it's Knox City facility and will have a booth set up to allow local telephone customers the opportunity to sign up for the many new options available with this modern system.

Along with Ms. Harless, other dignitaries scheduled to be here in Knox City for the ceremonies are State Representative David Counts, State Senator Tom Haywood, Knox City Mayor Bud Reynolds, Oscar Gomez, GTE

Vice President of Regulatory and Governmental Affairs, David Russell, GTE Director of Public Affairs, and Hardy White, GTE General Manager of Customer Operations.

A 1972 graduate of UT, Austin, Kathy Harless has become a catalyst for change at GTE. ## KC Customers Must Dial All Seven Calling Digits

SAN ANGELO - Beginning October 26, 1995, customers in Knox City will need to dial all seven digits when making local calls within the Knox City serving area.

Changes in the local calling area that will provide extended local calling to and from Benjamin, Haskell, Munday-Goree and Rochester have required modifications of equipment in the Knox City switching center. These changes require all seven digits of local telephone numbers to be dialed before a local call can be


completed.

The implementation of this service may require modification to come telecommunications equipment such as fax machines, speed calling, PABXs, key systems, automatic dialers and other equipment that may restrict or automatically dial long-distance numbers.

The service changes (NRC) for some of the new calling features will be waived for 90 days beginning October 26. To order special calling features call 1-800-346-4300.



#### METER TAMPERING NOW A FELONY

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree. Meter tampering consists of, but is not limited to:

(1) Diverting electricity from passing through a meter device.

(2) Preventing electric service from being correctly registered by a meter device. (3) Unauthorized activation of service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies, the Cooperative should be notified as soon as possible so that the meter can be resealed.

The Knox City Police Department Reserve Officers contributed a total of 101 hours of duty and classroom time to the City of Knox City during the month of September 1995.

Other items reported to the Knox City Police Department during September are classified as incidents. These incidents either did not occur in the City of Knox City or for some other reason were not able to be considered as criminal offenses.

Incidents Reported Include: Disturbance (Domestic) - 1, Criminal Mischief (Domestic) -1, Child Abuse - 1, Missing Person - 2, Theft - 1, Lost Property -

Although the incidents are either not considered as criminal offenses or were not reported as a criminal offense, they must be investigated to determine if they are to be referred to another agency of if a record is to be made for future reference. During the month of September, all incidents were settled to the satisfaction of this department.

On September 21, Knox City Police Department Officers Walker, Curd, Steen and I attended a Criminal Law Update Course in Abilene. The items discussed were the new and revised laws that recently went into effect, as well as some new laws that are about to become effective.

Also during the month of September, the 1992 Ford patrol vehicle was placed into the repair shop for some minor mechanical repairs, while the 1990 Cheverolet patrol vehicle was taken to the shop three times. Two of the times were also electrical problems while the third time was for front end trouble. At times when we are called, we are told that the abuse or problems have been going on for quite some time, but the victim didn't want to call and report it because of embarassment or fear that reporting it will make the offender mad. When responding to a possible domestic call, the officers of this department will contact the Sheriff's Department dispatcher and advise them of what the "known" situation is. This is for the safety of the first officer on

the scene as it allows the other officers in the county to begin their response if they intend toback up the first officer. Reporting a domestic abuse or assault problem is the best action to take as "no" person has the right to assault or injure another without that person's consent. This department will make every effort to settle the problem and attempt to make suggestions for obtaining further help for the victim and offender if deemed necessary.
