Knox County Hospital Celebrates Hospital Week's 75th Anniversary

"Maybe we should . . . after all you can find something to celebrate at a hospital any day of the year. Every time a new baby enters the world, every time a loved one begins feeling better, every time something is learned from today that brings hope to someone's tomorrow there's plenty of reason to celebrate."

This week's celebration centers around the theme for the event, "Dedicated to caring, community and commitment."

"Our dedication has been tested though time, and will be again," Kuehler said. "Technology is everchanging. New treatments are evolving, and our hospital is constantly rising to the challenge to continually offering the most effective health care available to our community," Kuehler contin-

"With all the changes being discussed in health care, we want our community to see our spirit of dedication to the important aspects of the profession have not

In June of this year, O'Brien Co-Op will be observing 60 years. Prior to 1936, the gin was originally O'Brien Milling and Gin and Farmers Gin, according to gin manager Tommy Chapman. The gin serves farmers in O'Brien, Knox City, Rochester, Rule, Munday, Haskell, and the Truscott-Gilliland area.

Directors for O'Brien Co-Op include John Grindstaff Jr., James Albus, David Albus, Paul Chambers, and Don Brothers. Grindstaff, who has served as a director for 26 years, and James Albus, who has served for 23 years, were presented pen and pencil sets.

Your Kids and Alcohol: An Open Letter To Parents From The Chief Of Police

I was contacted by an individual who expressed his concern over the reported alcohol abuse by the young kids of the community. It was told to me that some of the parents were upset and were requesting assistance trying to stifle the easy flow of different types of alcohol to our youngsters. I agreed that something needed to be done and called the Texas Alcoholic Beverage Commission. Through several contacts, I managed to have the Knox City/O'Brien school and the TABC make contact, with the hopes of the TABC presenting some information to the kids at school.

I was also asked if the Knox City Police Department could possibly be more strict on the kids as far as alcohol, whether drinking or in possession. The Knox city Police Department uses discretion but yet follows the law when enforcing a wide variety of laws. We cannot continually watch the kids who are intent on obtaining alcohol. When caught with alcohol, we try to do as the law requires. When the kids get tired of being contacted about one thing or another, they either go out of town and hold their parties or tell their parents that we are harassing them. Some of the parents promptly feel that they and their kids are being discriminated against, refusing to believe that they, along with their kids, are a large part of the problem.

In many instances, when the parent either leaves town to go visit for the weekend or allows their kids to spend the night with a friend, they never think of checking on their kids to see if they are where they should be. Its a great opportunity for a party when the parents leave town for a couple of days, especially over the weekend. As Police Officers on patrol, we spend our nights on patrol, and we see this happen time after time. When the parents come home, if they are lucky, they will figure out what happened by the condition of their damaged house. If not, well, next time they leave, there probably will be another party. The way to control this problem is for the parents to care and be "nosey" about what their kids are doing out at night. There are not to many things to do out after midnight except drink, unless the kids are waiting on their parents to come home drunk from a dance or party. Believe it or not, they will learn by example. Set a bad example and the kids will learn that much more quickly than they will a good

I'm not saying that all kids out at night are drinking or trying to get in trouble, but its the few that do what is wrong that get noticed and ruin a fun night for the rest. Some time ago, one of the local parents did get out and did locate their child. They were upset about the child being at the party out in the country, and did make the child go home with them. At least they did see that many of the local kids are out and drinking, and didn't have to take the word of the local law enforcement when we come knocking on the door in the early hours of the morning.

On a regular basis, I am told by parents that they don't mind if their kids drink as long as they do it at home, or at least have someone along to drive them home. If a person was to sit and think about it realistically, its kind of silly to think that if allowed to go so far that the kids won't try to go a little further. They may drink inside the house, then on the front steps, then the front yard, maybe in the street, in a vehicle with someone driving, then feel that they have a good reason to get behind the wheel. If the kids spend time at a friends house, and the friends parents give alcohol to that child, they are violating the law. If a person, who is not the court appointed guardian or Parent gives alcohol to the child or minor, which is a person under 21 years of age, they are violating the law. It doesn't matter if they are in a private residence.

METER TAMPERING NOW A FELONY

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree. Meter tampering consists of, but is not limited to:

(1) Diverting electricity from passing through a meter device.

(2) Preventing electric service from being correctly registered by a meter device. (3) Unauthorized activation of service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies, the Cooperative should be notified as soon as possible so that the meter can be resealed.



counting, computers, and general office work.

The Nursing Department at Knox County has a variety of roles. Registered nurses, licensed vocational nurses and nurse aides care for patients in all areas of the hospital. Nurses also work in specialized areas, such as infection control and risk management.

The Medical Records Department transcribes and archives all written information generated when a patient is in the hospital, including test results, physician comments, etc. Staff in that department receive special training in medical terminology and medical records technology.

The Laboratory is responsible for anatomical pathology and hematology, microbiology, chemistry and blood banking. The lab also administers EKGs (electrocardiograms) and is staffed by licensed medical lab technicians.

The Radiology Department provides routine radiology (xrays), fluoroscopy, ultrasound and CT scans.



Police Activity Report

The Knox City Police Department had another very busy month during March, receiving a total of 258 calls and situations needing to be handled. This total included 14 actual criminal offenses, of which 12 where cleared or otherwise handled. No charges were filed in regard to the above offenses, with five offenses involving a juvenile as an offender. The cases involving juveniles as offenders were either dropped due to the wishes of the parent(s) or at the request of the victim.

The Knox City Police Department Reserve Officers contributed a total of 79 hours of on duty and time spent receiving education to the City of Knox City during the month of March, 1996. Other items reported to the Knox City Police Department during March are classified as incidents. These incidents either did not occur in the City of Knox City or for some other reason were not able to be considered as criminal offenses.

During the month of March, all incidents were settled to the satisfaction of this department. One of the above incidents involved a juvenile as an offender.

On March 5th-7th, Officers William Curd and Harry Steen attended a 24 hour course held in Wichita Falls dealing with Child Abuse. The course is now required of all licensed Peace Officers and contains a great quantity of information on recognizing child abuse as well as how to deal with it. When dealing with child abuse, the investigating officer must learn to deal with the legal side of the investigation as well as the impact that crimes against children have on that same investigating officer.

On March 12th, the Knox City Police Department held it's regular monthly meeting. A film was viewed dealing with various ar-

rest situations and procedures to follow. After the film, a discussion about the film followed.

On March 25th-27th, Officer William Curd and I attended a Field Sobriety Testing course that was held in Stamford. This was a 24 hour course that dealt with the field testing of a suspected intoxicated driver as well as the gathering of information during a confrontation with the suspect.

Many individuals drink a moderate amount of alcohol and drive, thinking that their actions and reactions are still as quick and deliberate as when they are not drinking. A person who drinks and obtains a Blood Alcohol Content of .10 is considered legally intoxicated, however, a person may be arrested, charged, and convicted of Driving While Intoxicated with a Blood Alcohol Content somewhat less than that if his driving or other actions indicate that the said driver has lost an obviously noticeable amount of his control over his movements. Also, some may drink a small amount along with smoking marijuana or taking other drugs. The driver who does this may also be charged with Driving While Intoxicated, even if the BAC is very low.

An intoxicated driver can cause so much damage to other peoples lives in so short of time. An intoxicated driver may complain when stopped, "I'm just going home", or "You know me", if that driver had any common sense or consideration, he of she would have either stayed home and drank or had another licensed person along for the drive home.

One of usual uneducated comments made after an accident involving an intoxicated driver in an automobile is that "if he hadn't been drunk, he might have been killed". Not so, if the person hadn't been drunk, he either may

not have been in the accident or as statistics show, he would have been more likely to have had his seat belt on. They say that kids learn by watching the adults or parents. If they see the adults drinking and driving, they will grow up to think its okay to be intoxicated and get behind the wheel of a 3000 + pound piece of metal and hurl it down the roadway at speeds in access of 70 m.p.h..

The Knox City Police Department had another very busy month during April, receiving a total of 373 calls and situations needing to be handled. This total included 21 actual criminal offenses, of which 16 where cleared or otherwise handled. Four charges were filed in regard to the above offenses, with two offenses involving a juvenile as an offender. The cases involving juveniles as offenders are pending and may either be pursued or dropped, depending on what further actions the offenders take.





To help diabetes victims and family members, and health care professionals who work with the disease, a seminar, "Living Well With Diabetes", will be held in Wichita Falls May 23 at the Multi-Purpose Exhibit Center, 1002 Fifth St. It is co-sponsored by the **Extension Service Rolling Plains** District and Vernon Regional Junior College. It begins at 9 a.m. and ends at 3 p.m.

"This conference will provide the latest information on prevention, treatment and management of health problems often associated with diabetes", said Pamela Foster, Childress County ExtenBy Jane Rowan, Knox County Extension Agent - FCS

sion Agent, a member of the planning committee. Professionals who are required to earn continuing education units (CEUs) will receive four credits from Vernon Regional Junior College.

Healthy food choices, newly revised nutrition recommendations and recipe conversion tips will be presented by Dr. Mary Kinney Bielamowicz, a registered dietitian and professor with the Extension service, College Station. She has been active in diabetes education in Texas for 22 years. For the past two decades she has been developing research-based programs and resources for diabetes education. She serves on the program and cultural diversity outreach committees of the American Diabetes Association-Texas Affiliate.

SAFE SITTER CLASSES TO START

The goal of Safe Sitter is to reduce the number of accidental and preventable deaths among children being cared for by babysitters. Thousands of young adolescents across the country have been trained by Safe Sitter to handle life threatening emergencies.

All medical information is taught by a certified professional. During the course, students gets hand-on practice in basic lifesaving techniques so they are prepared to act in a crisis.

Safe Sitter participants also receive helpful tips to make them more confident caregivers. They learn safety and security precautions, such as what to do if a stranger comes to the door and when and how to call for help. They receive information on child development and age-appropriate activities. And they learn about the business aspects of babysitting.

To successfully complete the Safe Sitter program, the students have to pass a rigorous practical and written test to show that they have mastered the key concepts and have the skills necessary to handle an emergency.

Knox City Listed In 1996 Information Publication Released By Texas Midwest Community Network

Knox City has been listed in a recent information guide published by the Texas Midwest Community Network. A handbook sized publication describing towns and events, the regional information guide has been distributed to Texas Information Centers throughout the state.

The guide is a project of the Texas Midwest Community Network and supported by Abilene Regional Medical Center, Hendrick Medical Center and Texas State Technical College. The booklets are designed to attract and assist visitors to this area. Knox City is described on page 27 of the publication as follows:

"The Garden Spot of the Famous Knox Prairie" was the first slogan for Knox City. Today it is "Knox City, Texas - PACE City USA" an acronym for People Action in Community efforts. In the spring of 1903 it was learned the Orient Railroad would be passing through where Knox City now stands. A farsighted group of business men

saw an opportunity to establish a new community. In order to get the town and depot where they wanted them they each gave fifty acres of land for a townsite and Orient began to grow. However, when the promoters applied to the Federal Government for a post office for "Orient", they found there was already an Orient post office in Texas. The name Knox City was then selected taking the name from the county named for Gen. Henry Knox, a member of George Washington's cabinet. Knox City has grown from primarily cotton producing and processing of concentrated stock feed to an agri-business and petroleum based economy. Hailed as the "Seedless Watermelon Capital of the World" a festival is held the last Saturday in July offering free watermelon for all. Contests, music, games and food, crafts and booths attract people from a wide area. Melons are shipped all over the US and Canada and seeds for the melons are shipped around the world. Lighted tennis courts, swimming pool, a 9-hole golf course are all to be enjoyed. Abundant quail, dove and wild hog abound for the hunter. Unique shops from hand crafted wooden items, exclusive gift shop to a commercial greenhouse ablaze with poinsettias during the Christmas season and a unique bread and breakfast happily welcome visitors. DPS Adds More To CDL Testing

AUSTIN—Beginning June 3, applicants for Class A or B Texas Commercial Driver Licenses will be required to pass pre-trip vehicle inspection tests.

"This is really just some finetuning of our CDL program," said DPS Inspector John Hall.

"New applicants will be required to pass a test to make sure they can determine whether a commercial vehicle is safe to operate on the highway. It should only take about 10 minutes."

- CDL applicants previously only had been required to pass an airbrake inspection of their vehicle, Hall said.

The new pre-trip vehicle inspection test, which will include the airbrake inspection, is mandated by federal and state regulations, the inspector said.

CDL applicants should prepare for the test by obtaining and studying a copy of Section 10 of the Texas CDL Handbook at any DPS Driver License office. Since Texas' federally mandated CDL law went into effect on Sept. 1, 1990, some 560,000

*Texans have been issued Commercial Driver Licenses. The pretrip vehicle inspection test requirement is the first change in the licensing program since then, Hall said.

Anyone needing more information on this new requirement should contact their local Drivrs license office.


