



Two KC seniors awarded Carr scholarships at ASU

SAN ANGELO - Two high school seniors from Knox City have been awarded Carr Academic Scholarships at Angelo State University for 1997-98.

Students are Melissa J. Barnard and Diana J. Estrada from Knox City High School.

Over 300 Carr Academic Scholarships for 1997-98, ranging in value from \$1,500 to \$6,000, have been awarded to qualified high school seniors. During the current year approximately 900 students from throughout Texas and the nation, as well as numerous foreign countries are attending Angelo State University on Carr Academic Scholarships.

As a general rule, students must rank in the top 15 percent of their high school class and present either a combined math and verbal score of 1140 on the SAT 1 or a composite score of 25 on the

Supported by a growing multimillion dollar trust established by the late Robert G. and Nona K. Carr of San Angelo, the undergraduate scholarships may be renewed annually by the University for students who maintain the required academic record. During a four-year course of undergraduate study at ASU, Carr Academic Scholarships can be worth from \$6,000 to \$24,000.

Parenting Fair scheduled for Tuesday night at KC High School gymnasium

The Knox County Extension Family and Consumer Sciences Committee will be conducting a "Parenting Fair" on Tuesday, March 25. The free come and go type fair will be open from 4:30 to 6:30 p.m. at the high school gym in Knox City.

Parents are encouraged to come view the various exhibits and obtain free information regarding services, ideas, and products available for use in raising children. Exhibits will include electric safety, kid-proofing the home, nutrition education, free finger printing, drug abuse prevention, child development, child protection and care, seat belt and safety seat protection, health care, free immunizations, and others.

'Roll Over Convincer' to return again this year

A special feature will be the Texas Agricultural Extension Service's "Vehicle Roll-Over Convincer". The roll-over convincer simulates what could happen to a passenger if involved in a rollover crash and not wearing a safety belt. The roll-over convincer is designed to target audiences of all ages, but most specifically pickup drivers and passengers. According to survey results conducted in 25 rural Texas counties, only 36 percent of pickup occupants were wearing their safety belts, compared with over 50 percent for passenger-vehicle occupants. Some drivers and passengers may feel "invincible" in a pickup. They may believe that they have a better chance of survival if thrown clear. The facts, almost 34 percent of vehicle occupants killed in Texas crashes

were in light trucks. The chance of severe injury or death increases 25 percent if a person is thrown out of the vehicle. Demonstrating the convincer is just one step to making Texans aware of the risks that they take by not wearing a safety belt.

Plans to have one of the medical helicopters available to tour is also in the works.

Many exhibitors will be offering free materials and door prizes will be given throughout the fair.

Little League season about to begin, registration meeting scheduled next Tuesday



It's that time of year again, the sound of baseball is about to be heard in full

force with the onset of another season of Little League Baseball in Knox City. With teams made up of boys and girls in Pre-K through 12 grade age groups from Knox City, O'Brien, Benjamin, and the surrounding area, the local Little League organization is gearing up for another great season. The first step of the process for the 1997 season is registration of players, and that has been set for Tuesday night, March 25, from 6:30 to 8:00 p.m. in the Knox City school auditorium. One or both parents of every player planning on participating in Little League this year need to be present for the registration in order to fill out release forms and pay the league's registration fee. With an increase in the registration fee this year, parents will be paying \$25.00 for each child playing in the league. Unless prior arrangements are

made, the registration fee will be due the night of registration. Sharla Carver, Secretary for the local league, wants parents to know that the increase this year is based on rising costs, and will

cover a uniform and insurance for each player. The insurance on each player is not an option, it is required by the Little League charter. A large part of the increase is to provide uniforms for each

player. Each player receives a team cap, shirt and pants that are required to be turned in at the end of each season. The league has over \$1000.00 worth of uniforms from last season that were never turned in, so a larger purchase than normal has to be made this year. Mrs. Carver urges parents of returning players who might still have uniforms from last year to please bring the uniforms to registration and turn them in.

The deadline for late applications will be at 6:00 p.m. on Monday, March 31. No applications will be taken after that time. Late applications may be turned in to Marion Conoco Station prior to the deadline.

The local Little League organization is also in need of adult volunteers. Since this is an organization dedicated to children, adults from throughout the community are urged to participate and help make the season a success. Adult volunteers are needed



METER TAMPERING NOW A FELONY

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree. Meter tampering consists of, but is not limited to:

(1) Diverting electricity from passing through a meter device.

(2) Preventing electric service from being correctly registered by a meter device.

(3) Unauthorized activation of service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee. All Cooperative meters are sealed. This seal should not be cut or broken without

special authorization. In cases where the seal must be cut for emergencies, the Cooperative should be notified as soon as possible so that the meter can be resealed.
