

### Legislature passes Rural Electric Cooperative bill authored by State Representative David Counts



(AUSTIN).... A bill authored by State Representative David Counts (D-Knox City) to provide rural scholarships passed in both the Texas House and Senate recently, and now awaits the Governor's signature.

The bill would give nonprofit agricultural and electric cooperatives the option of retaining unclaimed funds for local scholarships or to provide for rural economic development. Currently, the unclaimed funds that go unclaimed are sent to the state comptroller.

Counts noted that the unclaimed funds are general capital investments and customer deposit that are abandoned. "Cooperatives try to get these funds back to the right people," noted Counts. "However, many times those individuals can not be found or are deceased."

"Since these funds are generated in the district, I think they should stay in those local communities and be put to use there, instead of being sent to Austin," stated Counts. "This legislation will allow those local cooperatives to use those funds to provide scholarships for local students or to help spur on economic development."

"I can not think of a better use of these funds," stated the Knox City lawmaker. "This program will utilize these funds to invest in the future of our rural communities."

### **Texas House passes Boll Weevil Legislation**

(AUSTIN)... State Representative David Counts (D-Knox City) worked with the bill's sponsor, Representative Robert Junell, in support of legislation to continue the Boll Weevil Eradication program. During the previous week, Counts had testified before the committee and presented a notebook containing hundreds of letters of support he had received from farmers around District 70.

Senate Bill 1814, authored by Senator Robert Duncan, passed by the House corrects the problems noted by the Supreme Court in their ruling which rendered the program unconstitutional. "This program is crucial to District 70," stated Counts. "I have had numerous calls and letters from folks urging the quick passage of this legislation so that we can get the program up and moving again."

Counts stated that he has heard from farmers and business leaders in the district who are already seeing the early signs of continued boll weevil problems this year. In addition, the Texas Agricultural Extension Service has predicted 1.5 to 3 times as many boll weevils as last year due to the winter climate. "Time is of the essence," stated the Knox City lawmaker. "We have worked to put together the best piece of legislation we can to help our farmers before it's too late."

Counts noted that he has kept in close contact with Congressman Charles Stenholm (D Stamford) to see that federal money will remain available. "Charlie has been working hard in Washington to make assurances that this program will continue and that the federal dollars will not go somewhere else." Counts also noted that Stenholm is working to secure federal "bridge" loans which would provide emergency funding for the program's basic operations until regular funding for the foundation resumes.

The new legislation will call for referendum elections every four years for the continuation of the program in each zone. Counts stated that while the bill was of paramount interest to those in the farming community, its effects are felt throughout the district. "Some people think this is just an issue for farmers," said Counts. "In this district, where approximately 75 to 80 percent of our economy is based directly or indirectly on agriculture production, the reality is that this issue affects us all."

### **Counts works on ammendments offered to Senate Bill**

(AUSTIN)... Representative David Counts (D-Knox City), Chairman of the House Natural Resources Committee, announced an amendment by Representative Ron Lewis (D-Mauriceville) that would remove provisions from Senate Bill 1, the omnibus water bill, which would have placed a tap fee on water users of more than 7,000 gallons a month to help develop water supply and waste water projects to meet the growing water demands of the state.

The amendment Counts worked on in conjunction with Representative Lewis would call for an interim study by House and Senate members to study the issue of providing adequate water resources to meet the state's increasing demand, and how the state can best assist communities in meeting these demands.

"This is a vital issue," stated Counts. "So many of the small rural communities in District 70 are having severe problems meeting their current demand with the resources they have. In addition, many of our efforts to bring economic development to our area are going to require additional water, which will in turn, increase that demand."

"It is important that we at least look at and discuss this issue now," stated the Knox City lawmaker. "Some would rather wait until this issue becomes a crisis. However, if we do not plan ahead now, when we reach that crisis state it will be too late for our rural communities."

"I appreciate the input from folks back in the district regarding their concerns. This interim study will allow us an opportunity to bring everybody to the table to help find a workable solution to providing the infrastructure our state will need," stated Counts.

Under the amendment, the interim committee would review the state's current inventory of water resources, the state's water needs to the year 2050, the role of the state, regional, and local entities in water projects, and the implementation of Senate Bill 1. The committee would make recommendations to the next legislature on ways to assist local communities with their water supply and waste water infrastructure needs and the costs of meeting water quality regulations. It would also make recommendations on legislation to ensure efficient allocation of state and local resources through the us of regional water facilities and management, including water market transactions.

### Fuel surcharge to be added to WTU bills

West Texas Utilities Company retail customers will see a slight increase in the total amount of their electric bills beginning this week. The surcharge is being added to customer bills over the next 12 months to collect unrecovered fuel costs and interest.

The Public Utility Commission of Texas approved WTU's request to recover approximately \$13 million in unrecovered fuel costs and interest that are the result of unforeseen and significant increases in the cost of natural gas that have occurred over the last year throughout the country.

Implementation of the sur-

charge will result in a 1.6 percent increase in customers' bills over the 12-month period. Typical residential customers using 1,000 kilowatt-hours of electricity a month would see their bills increase on average, by approximately \$1.22. The effect of the surcharge on customers' bills will vary depending on the rate schedule under which they take service.

Investor-owned electric utilities in Texas, like WTU, use fuel factors based on cost estimates to collect the projected cost of fuel used to generate electricity at their power plants.

When the actual costs of fuel significantly exceed the fuel

charges that customers are paying in their monthly bills, PUCT rules require that the utility request permission to surcharge the additional amount. When the actual costs of fuel are significantly lower than what customers are paying in fuel charges, the electric utility is required to issue a refund.

Since this fixed fuel cost recovery mechanism was placed into effect in the late 1980s, WTU has refunded over \$49 million in fuel cost reductions to its customers.

throughout the country.

The cost of natural gas was 38 percent higher during 1996 than it was in 1995. The increases were even more significant during colder months. For example, the actual cost of natural gas in December 1996 was 82 percent higher than the December 1995 cost.

Approximately 55 percent of WTU's annual generation of electricity is produced by power plants fueled by natural gas. This year steers will be required to have a tattoo, an ear tag, nose print and Polaroid picture. The date chosen to validate Knox County steers is Tuesday, June 17. The location and time have not been set.

Validation cost this year is \$3.75 per calf. This covers the validation ear tag, Polaroid film, nose print ink and cards, and tattoo ink. This fee is payable at the time of validation.

Anyone who plans to validate a steer for the 1997-98 show year should plan to attend. If this date conflicts with previous plans, notify Paul Weiser in the Knox County Extension office at 817-454-2651 or the local ag science instructor. Extension programs serve people of all ages regardless of socioeconomic level, race, color, sex, religion, disability or national origin.

Three ladies gave a report on the Spring Convention which was held in Waco celebating the 100th birthday of Texas Federation of Women's Clubs.



Excerpt from the By-Laws of B-K Electric Cooperative, Inc.

ARTICLE IV DIRECTORS

SECTION 4.01. NUMBER AND GENERAL POWERS. The business and affairs of the Cooperative shall be managed by a Board of seven (7) directors. The Board shall exercise all of the powers of the Cooperative except such as are by law or by the Cooperative's Articles of Incorporation or Bylaws conferred upon or reserved to the members.

SECTION 4.02. QUALIFICATIONS. No member shall be eligible to become a director or to hold any

position of trust in the Cooperative who is not a member receiving service from the Cooperative at his primary residential abode in the area served by the Cooperative, or is in any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the Cooperative, and no person shall take or hold office as a director who is the incumbent of or candidate for an elective public office in connection with which a salary is paid. When a membership is held jointly by a husband and wife, either one, but not both may be elected as director, provided however, that neither one shall be eligible to become or remain a director or to hold a position of trust in the Cooperative unless both shall meet the qualifications herein above set forth. Any director who shall miss three (3) Board of Directors' meetings in a row, without an excuse duly accepted and noted by the Board, shall lack eligibility to further serve and it shall be the duty of the Board of Directors to remove him from the Board. No former employee whose employment has been terminated by the Cooperative may be eligible to serve as director. Any employee who resigns or retires from employment by the Cooperative shall not be eligible to serve as a director for a period of ten (10) years following such resignation or retirement. Nothing contained in this Section shall, or shall be construed to, affect in any manner whatsoever the validity of any action taken at any meeting of the Board of Directors, unless such action is taken with respect to a matter which is affected by the provisions of this Section and in which one or more of the directors have an interest adverse to that of the Cooperative.

In the event an incumbent director, having served on the Board of Directors a minimum of six years, ceases to meet the requirement of receiving service from the Cooperative at his primary residential abode, such incumbent director shall nevertheless be qualified to continue to serve as director so long as he remains a member of the Cooperative and his primary residential abode is located within the area served by the Cooperative, or in close proximity thereto.

SECTION 4.03. ELECTION. At each annual meeting of the members, directors shall be elected by secret written ballot by the members and from among those members who are natural persons; provided however, that when the number of nominees does not exceed the number of directors to be elected, and if there is no objection, secret written balloting may be dispensed with and voting may be conducted in any other proper manner. Directors shall be elected by a plurality of the votes cast unless the members in advance of any balloting resolve that a majority of the votes cast shall be required to elect, and this Bylaw provision shall be drawn to the attention of the members and explained to them prior to any balloting. Drawing by lot shall resolve, where necessary, any tic vote.

SECTION 4.04. TENURE. The business and affairs of the Cooperative shall be managed by a Board of seven (7) directors which shall exercise all of the powers of the Cooperative except such that are by law, or by the Articles of Incorporation of the Cooperative, or by these Bylaws conferred upon or reserved to the members. Beginning with the Annual Meeting of the members of the Cooperative held on August 21, 1954, two (2) members of the Board of Directors shall serve for a period of one year, two (2) members shall serve for two years, and three (3) members shall serve for three years, and that lots be cast as to the length of time each director shall serve; and beginning with the Annual Meeting of the members held in 1954, those directors whose terms expire, such vacancy shall be filled for a period of three years.

SECTION 4.05. NOMINATIONS. It shall be the duty of the Board of Directors to appoint, not less than sixty (60) nor more than ninety (90) days prior to the date of a meeting of the members at which directors are to be elected, a Committee on Nominations, consisting of not less than five (5) nor more than eleven (11) members of the Cooperative who are not existing Cooperative employees, agents, officers, directors or known candidates for director, who are not close relatives (as hereinafter defined) or members of the same household of such existing employees, agents, officers, directors or known candidates for director, and who are so selected so as to give equitable representation on the committee to the geographical areas served or to be served by the Cooperative. The Committee shall prepare and post at the principal office of the Cooperative at least thirty (30) days prior to the meeting a list of nominations for directors to be elected. Any fifteen (15) or more members of the Cooperative, acting together, may make additional nominations in writing over their signatures, listing their nominee(s) in like manner, not less than twenty (20) days prior to the meeting, and the Secretary shall post such nominations at the same place where the list of nominations made by the Committee is posted. The Secretary shall mail to the members with the notice of the meeting, or separately, but at least ten (10) days prior to the date of the meeting, a statement of the names and addresses of all nominee(s) showing clearly those nominated by the Committee and those nominated by petition, if any. The chairman at such meeting, after all nominations so made have been duly announced, shall call for additional nominations from the floor. Notwithstanding the provisions contained in this Section, failure to comply with any of such provisions shall not affect in any manner whatsoever the validity of any action taken by the Board of Directors after the election of directors.


