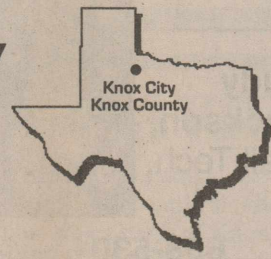

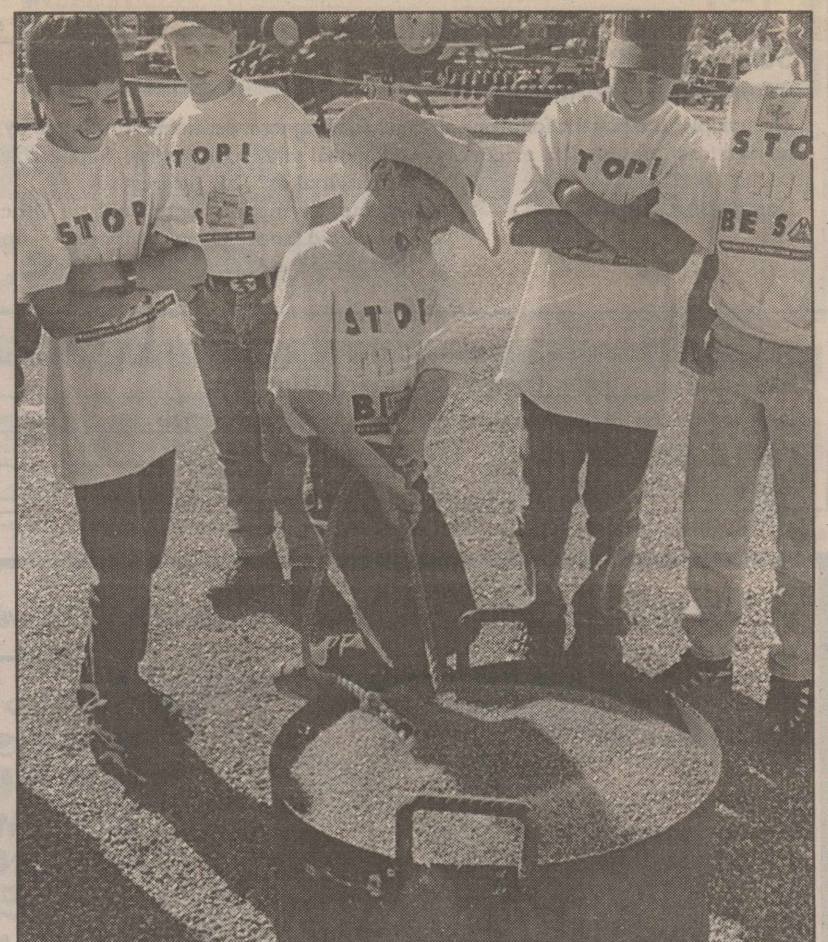

## Youth Farm Safety Camp is described as huge success with 83 participants

Eighty-three youth participated in a day packed with farm safety topics on Saturday, May 10, 1997 in Munday, TX. The Farm Safety Day Camp was one of many being held across the nation by Progressive Farmer Magazine and was locally sponsored by The Texas Agricultural Extension Service - Knox County. A task force comprised of concerned individuals from Knox County planned and conducted the camp with the help of many local, area, and national donors. Over sixty volunteers devoted their time and efforts into making the day a success by serving as instructors, groups leaders, conducting registration, and organizing the noon meal and snacks.

The days activities began with a farming accident victim, Cliff Etheredge of Roscoe, TX, speaking to the group about his experience. The youth then rotated among 11 different sessions focusing on a variety of possible farm hazards. The sessions taught and instructors were: Chemical Safety - Kelly Griffin, Texas Dept. of Agriculture; Shop Safety - Duane Gilly, Haskell Ag. Science Instructor; Electrical Safety - B-K Electric Employees - Stanley Decker, Pete Winn, Phil Loftin, and Jim Novac; ATV Safety - Brad Teplicek, certified ATV safety instructor; Basic First Aid - Knox County 911/EMS; Grain Entrapment - Corey and Chris Moore; Fire Safety - Bill Williams and Spike Bryan; Lawnmower Safety - David Davis,

Haskell County Judge; Tractor/Equipment Safety - Quality Implement and John Deere & Co. - Mike Jordan and Dale Mullis; Grain Explosion - Charlie Black, Anson Ag. Science Instructor; and PTO Entanglement - Jerry Lowe and Bill Myers. The day concluded with a video review of the days activities, door prizes, goody bags full of safety information, and the presentation of completion certificates. Camp coordinators were Jane

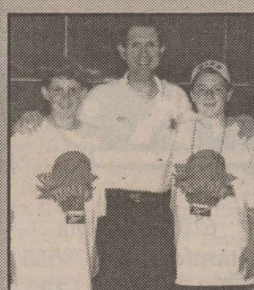

1997 Property Tax Rates in Knox County Hospital

This notice concerns 1997 property tax rates for Knox County Hospital. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's effective tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's rollback tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

**Young farmers contest applications due Sept. 12**

Production agriculture is a challenging, ever-changing profession. It is even tougher for young people to enter and remain in the business. For this reason the Texas Farm Bureau is sponsoring a young Farmer and Rancher Program. This program is designed to identify these young producers and to provide as much help, education and recognition as possible.

Qualifications for entering any of the contests are simple. The producer must not be older than 35 as of January 1, 1998. He or she must be involved in production agriculture a current Farm Bureau member.

There are two contests that these young farmers can enter. The first is the Outstanding Young Farmer and Rancher Contest. Each district winner will receive a custom trophy belt buckle and fifty dollars cash.

The two state runners-up receive one year use of a 1998 Ford F-150. The state winner receives one year use of a 1998 3/4 ton 4x4 Ford Power-Stroke Diesel pickup, one year use of a Case IH tractor, one year subscription to DTN service, and an all expense paid trip to Charlotte, North Carolina to compete in the national contest.

The second contest is the Discussion Meet Contest. The qualifications for this contest are: as of January 1, 1998 the contestant must be between the age of 18 and 35. The individual must be actively involved in production agriculture and cannot have received a fee, royalty or honorarium for speaking.

This program will also offer several tours and educational events throughout the year. AGLEAD-Leadership Development Program is one such event. Producers that are between the ages of 25 and 40 qualify for this program. The 1998 AGLEAD group will tour Waco, Austin, Rio Grande Valley/Mexico, California, Lubbock, College Station, Washington D.C./Chicago, IL, Houston/East Texas, and go on an international trip that will be announced on a later date.

All producers interested in completing an application for one of the contests or becoming involved in AGLEAD may receive more information from the Farm Bureau office in Munday (422-4555) or the Knox County Extension office in Benjamin (454-2651).

### Noncitizens benefits extended one month by Social Security

New legislation extends Supplemental Security Income (SSI) payments through September 1997 for noncitizens whose SSI eligibility would have ended in August 1997 under last year's welfare reform legislation.

A supplemental appropriations bill signed into law by the President changes the original ending date from August 22, 1997 to September 30, 1997 for ineligible noncitizens who were receiving SSI when the 1996 welfare reform law was enacted.

Under this extension, affected recipients will receive their last checks in September 1997, and SSI eligibility will be suspended effective October 1, 1997.

### Widows and widowers get alert on higher retirement benefit

Using a new automated system, Social Security is now reminding surviving spouses four months before they reach age 65 that they may be eligible for a higher benefit based on their own earnings record.

Although surviving spouses are told at the time they apply for widows or widowers benefits at age 60 (or age 50 if disabled) that they may be eligible for a higher retirement benefit at age 65, many fail to contact Social Security to file a claim.

## Ken Lawson Jr. Ph.D. receives Distinguished Service Award

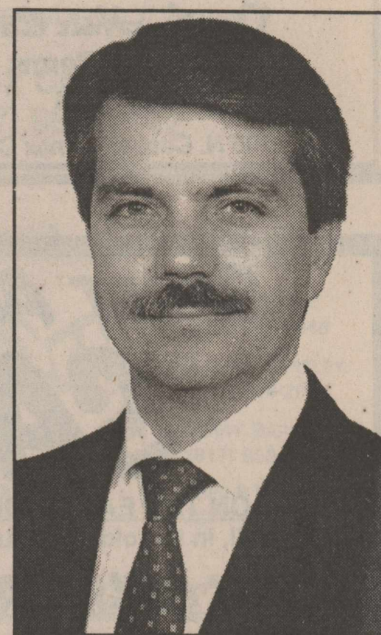
From peers in Texas Pharmacy Association

**Even Start participants making literacy gains**

COLLEGE STATION — Former participants in Even Start family literacy programs in 10 Texas communities indicate parents are making significant education gains, follow-up research reveals. Of the 296 former participants surveyed, 33.8 percent have acquired their GED certificates and 29.2 percent have enrolled in further training. These are a portion of the preliminary findings Texas A&M University professor Don Seaman and research coordinator Ann Martinez reported at a national conference. Speaking at the 1997 Commission on Adult Basic Education Conference in Detroit, Mich., Seaman and Martinez said, the results from the survey of the 10 programs indicate that educational gains for parents have translated into more parental interaction with their children's education and better pay at work.

## Knox City - O'Brien CISD announces dress code for 1997-1998 school year

### DRESS AND GROOMING

The District's dress code is established to teach grooming and hygiene, prevent disruption, and minimize safety hazards. Students and parents may determine a student's personal dress and grooming standards, provided that they comply with District guidelines.

Dress and grooming practices that create safety hazards or disruption and therefore are prohibited include the following:

1. Pictures, emblems or writing on clothing or elsewhere that are lewd, offensive, vulgar or obscene, that advertises or depicts tobacco products, alcoholic beverages, drugs or any substance prohibited under school policy or that suggests devil worship/occult activities, either explicitly or by innuendo. This would include skeletons, skulls or demonic representations that are commonly used by many types of musical

2. Shirts that expose the midriff when the student's arms are raised. Tank-tops and jerseys may be worn over t-shirts, if otherwise appropriate.
3. Trousers worn down around the hips. (sagging trousers are expressly forbidden)
4. Skirts and dresses not extending to at least the fingertips when arms and fingers are extended to the sides.
5. Shorts or skorts, except during PE.
6. Clothing that is considered revealing, excessively tight, clothing with slits, splits, tears or holes, or deemed inappropriate by the building principal.
7. Hats, caps, head-dress, etc., shall not be worn in school buildings or at any indoor school-sponsored functions. Caps worn to outdoor functions must be worn with the bill forward.
8. Ornaments in, on, or around

the ears or nose of male students or nose ornaments on female students.

9. Facial hair.
10. Male students hair that extends past the bottom of the collar on a normal dress shirt or the middle of the ear or impairs vision.

Male student's hair must be neatly groomed. The length and bulk of the hair will be such that it does not present a ragged, unkempt or extreme appearance. The hair should present a tapered appearance when combed and not fall past the middle of the ear or eyebrow or past the collar on a normal dress shirt.

Male students will not wear "tails" or ponytails of any form. There will be no designs shaved in the hair or multiple lengths of hair above the ears.

"Chili bowl", "chopped" or "cropped" cuts do not conform to the above policy.
