Perry's Variety Store, a landmark well known to everyone in Knox City and the surrounding area will close here Saturday.


Perry's will close their doors forever, according to a spokesperson for The Ozer Group in Seattle, Washington, who is supervising liquidation of the firm.

The name of Perry's will cease operation with the local store being closed and the remaining merchandise "shipped east". The representative with The Ozer Group further stated that "a deal is hoped to be finalized and the store re-opened under a new name". But, as of Tuesday afternoon, nothing on a finalization had happened and no other information on the possible identity of a new store was available

Local store manager Julia Hardin, who has been with the Knox City Perry's for a number of years, found out about the Saturday closing prior to The Ozer Group's call to the *News* on Tuesday morning.

A long standing cornerstone of the downtown business economy, Perry's has always 'been there' for residents who needed something in a hurry. Conveniently located on the West side of North Central,, the variety store has always offered a wide range of items from clothing to household items and just about everything else. Perry's has been in the present location for approximately 25 years and before that was in the building now occupied by *The Knox County News*.





Dyess Air Force Base Schedules Big Country Appreciation Day

To show appreciation for all the residents of the Big Country area, the United States Air Force



has announced a "Big Country Appreciation Day' at the Air Force Base in Abilene. Home to both the B-1 Bomber and C-130 cargo aircraft, the base promises more than 100 air and ground demonstrations during the day on Sunday, September 14. With the gates open to the public beginning at 9:00 a.m., flying activities are scheduled to begin at noon. Admission and parking are free, food and beverages will be on sale.

He recently Monday, August 11, to discuss the status of law enforcement in Knox County. At that meeting it was decided that the Knox County Commissioners' Court would accept applications or resumes for the office of Knox County Sheriff. Applications and resumes will be accepted at the Knox County Judges office until September 2, 1997. At that time the Commissioners' Court will determine who is the best qualified applicant and will appoint that person as Sheriff.

The appointed individual will act as Sheriff until the winner of the March 1998 primary election takes office at the beginning of January 1999. The filing deadline for the March 1998 primary is the first of January 1998.

Gretchen Howell Colehour will celebrate her ninety-seventh year next Monday, August 18. She was born in Terrell, Texas to Will and Gertrude Melcher Howell. She attended school in historic Fort Concho Elementary and graduated from San Angelo High School. As a child, she rode her pony "Shorty" to school and looked for concho pearls in the Concho River.

Her grandfather George Howell bought land north of Knox City in 1905. The Howell family of J.W., "Will" and Gertrude and children Gretchen, Mabel, R.B. and Mary moved to Knox City in







On A Wizer Note.... By Paul Weiser, Knox County Extension Agent - Ag.

How heat affects cotton.....

Here it is the middle of August. Most people are complaining about the heat and farmers are still harvesting wheat. It sure has been an unusual spring/summer.

I overheard a conversation about the unusually cool, wet weather. The question about it's effects on the cotton crop was brought up. Is it hot enough for the cotton to receive the proper amount of heat units? What is a heat unit? How is it figured?

For cotton to become 100% mature, it must receive 2600 heat units. Heat units are calculated by adding the daily high temperature and the daily low temperature. This number is then divided by 2. Subtract 60 from this number and you have calculated the number of heat units for that particular day. Do not use any numbers over 100. If the daily high temperature is over 100 degrees F. use 100 in the formula.

Here is a quick example, using temperatures recorded at the TAMU Vegetable Research Station in Munday, the heat units for July 7, 1997 would be calculated as follows: $98^\circ + 68^\circ = 166$ divided by 2=83-60=23 heat units. A cotton plant would require 113.04 days of temperatures in this range for complete maturity. How is 1997 comparing to 19962 After calculating three 7

1996? After calculating three 7 day periods I have begun suffering from mild depression.

On June 14-20, 1996 we recorded 190 heat units. June 14-20, 1997 had 160.5 (29.5 less in 1997) . June 24-30, 1997 had 171 while 1996 recorded 197.5 (26.5 less in 1997) . Heat units for July 1-7 were as follows: 1997 - 152.5; 1996 - 205 (52.5 less in 1997). If you add these three 7 day- period together 1997 has had 108.5 less heat units than 1996.

Here is a short chart on heat unit requirements for cotton. From planting to seedling emergence -90 to 100 heat units. Square initiation requires 500 heat units while First Flower needs 1000. Peak Flower will begin at 1500 heat units followed by First Open Boll at 1800. Heat units adding up to 2100 are required for 50% Maturity while 100% Maturity is obtained at 2600.

Is there a bright side to any of this? Maybe!

The cotton is very late this year. Therefore the cooler temperatures we are experiencing are typical of late May/early June. If we can keep from having an early fall the cotton crop may not suffer as much as if we get hit by an early freeze or a cool late summer/early fall.



historic three story red brick Knox City School in the 1920's. Her class had fifty-two students. One sixth grade student reportedly threw his books in the big pot bellied stove. She still has her grade books and taught Knox Citians including Ruby Robinson, Neal Logan and Winnie Johnston, and has outlived many students. During this period, she also taught at Rule, alternating going to college and working during the "lean" years.

She took a teacher exam at Benjamin in 1920. She rode the train over and stayed in a Benjamin hotel.. During the exam, a cow meandered down the hall of the Benjamin School from the adjoining pasture.

Gretchen's travels and studies took her most of the forty eight states. She studied Library Science and English at the University of Illinois, West Texas State, Harvard University, East Texas State University and the University of Texas. After earning several degrees, and working as the college librarian she stayed at East Texas State until 1950. At that time, she and her husband Philip Colehour moved back to the family ranch to write. She has been involved with the family farm and ranch operation ever since.

She spent five years in the 1950's working as county librarian. She and her husband donated books to the local schools, Harvard University, Midwestern University and started the First Methodist Church library. Her gift to anyone-always-is a book and a word of encouragement.

Gretchen kept her brother R.B.'s parrot Bill for a number of years, and Bill died at the long age of sixty-three years of parrot life. R.B. was on the Knox City School Board when he died in 1956. The family survived the Knox City tornado in 1953.

Being an avid bird watcher and keeping a life-long journal of Texas wildflowers has kept her

mind keen and alert. She is quoted as saying, "The Lord has been good to me. The Knox prairie has been good to my family. I never intended to live this long, but I am glad that I did."

Gretchen has been a faithful supporter of education and has the interest of the town and community always on her heart.

Gretchen's encouragement as a mentor has steered many students to a goal in education. "Always do your best." She is a charter member of Texas teacher's Delta Kappa Gamma of 60 years, First United Methodist Church, Texas Library Association and Texas Folklore Society.

Gretchen's family consists of her sister Mary Stone, Susan Harvey and Jessica, Becky and Jim Baker, Amanda and Ryan and Doris and Clint Jones of Knox City. Also, Chris, Heather and Chase and Adam Stone, Roger and Cindy Potts, Katie and Sara and Margaret and Bob Goss, Erica, Erin and Evin Ann.

117 counties, including a check of \$21,627.01 to Knox City. The rebate to Knox City reflects an increase of 15.59% from a rebate check of \$18,708.76 for the same period in 1996. Knox City collects a 2.000% rate of sales tax, with a full 1.000% of the tax directed towards EDC funding.

Texas cities received \$209 million, 9.5 percent higher than payments of \$190.7 million at this same time one year ago. Counties received a total of 18.6 million in rebates, 14.7 percent above the \$16.2 million in allocations for the same period in 1996.

June, 1997 payments include taxes collected by monthly filers on June, 1997 sales and reported to the Comptroller in July of 1997.

For other Knox County cities, Benjamin received \$822.51, a 57.65% increase from \$521.73 for the same period a year ago. Goree received \$666.42, down 22.72% from a payment of \$862.39 last year at the same time. Munday received \$9,437.87, up 3.76% from a payment of \$9,095.38 in 1996 at the same time. 



Benjamin ISD Announces School Lunch Guidelines

The Benjamin school serves meals each school day. Children may buy lunch for $80 \notin / 1.00 and breakfast for $80 \notin / 1.00 .

If you now get food stamps or AFDC / TANF for your children, your children can get free meals. If your total household income is the same or less than the amounts on the Income Chart below, your children can get free meals or reduced-price meals. A foster child may get free or reduced - price meals regardless of your income. The reduced price is 40¢ for lunch and 30¢ for breakfast. To apply for free or reduced price meals, you may pickup and application at the school office.

HOW TO APPLY

If you now get food stamps or AFDC/TANF for the children you are applying for, the application must have the children's names, a food stamp or AFDC/TANF case number for each child, and the signature of an adult household member. If you are applying for a foster child, the application must have the child's name, the child's "personal use" income, and an adult signature. If you do not list a food stamp or AFDC/TANF case number for all children you are applying for, then the application must have the children's names, the names of all household members, the amount of income each person got last
