





Over 19,000 Jobs Created, Saved in Rural Areas This Year

More than 19,000 jobs will be created or saved in rural areas this fiscal year through the U. S. Department of Agriculture's Rural Development Administration (RDA) Business and Industry Program, according to RDA Acting Administrator Wilbur T. Peer.

"The RDA Business and Industry program is helping to provide new jobs in rural areas by working with banks to make financing available to new or expanding businesses," Peer said. "Thousands of jobs also are being saved by helping companies that would have to go out of business without additional financing."

"The Administration is emphasizing the Business and Industry Program as part of its commitment to participate with the private sector to help create jobs and improve the rural economy,"

Nationally, RDA has invested \$114,942,250 for 81 loans this fiscal year, which began last October first. Nearly \$135 million remains available for the rest of the fiscal year which ends September 30, 1994.

Veterans of Battle of The Bulge Plan 50th **Anniversary Event**

December 16, 1994 marks the 50th anniversary of the commencement of America's greatest land battle-the Battle of the Bulge. This battle took place from December 16, 1944 through January 25, 1945, in the bitter cold and snow of the heavily-forested Ardennes Forest of Belguim and Luxembourg.

More than one million young men took part in this bloody World War II battle-600,000 of them Americans. There were 81,000 American casualties, including 19,000 killed.

Those who fought and survived the Battle of the Bulge will never forget. Those who sacrificed their lives will be remembered by the survivors and others December 16, 1994, with memorial services and the dedication of a plaque at the Soldiers' Memorial Military Museum in St. Louis, Missouri. World War USA Commemoration Committee has designated St. Louis as the site for the national commemoration of the 50th Anniversary of the Battle of the Bulge.

Many other activities are being planned in connection with the 50th Anniversary Commemoration to be held December 15-18, 1994, in St. Louis. Complete information regarding these ceremonies is available from the Veterans of the Battle of the Bulge, Inc. (VBOB). VBOB is an international, non-profit organization founded in 1981 to perpetuate the memory of the sacrifices involved in this battle and has enrolled over 12,000 members during

1994 Wheat Trials **Confirm Yields Down** From Previous Year

Texas Agricultural Experiment Station scientists are confirming what many producers were expecting-grain yields are lower this year compared to records set in 1993.

Variety trials conducted in the Texas panhandle by TAES wheat breeders, Drs. Mark Lazar at Bushland and David Worrall in Vernon, show yields dropping 38 percent in dryland wheat and 20 percent in fully-irrigated crops.

While yields are down this year, producers should keep in mind that 1993 was an exceptional year, with higher-than-usual yields, especially for dryland, says Dr. Brent Bean. agronomist with the Texas Agricultural Extension Service at Amarillo.

"There are several reasons this year's crop came in below average," Bean said. Wheat yield potential was first hurt by an early, hard freeze in late October causing the wheat to turn dormant earlier which stopped the plant from producing tillers.

Many parts of the Panhandle were unusually dry throughout the winter resulting in poor soil moisture going into spring. This was followed by three, late-season freezes after the wheat began jointing which resulted in fewer viable wheat heads at harvest, Bean


