



Soviets saying no to grain for vodka

WARHINGTON (AP) Cattle, pies and chickens in the Noviet Inion have a record amount of grain to eat, but vodka makers are going to have to keep on skimping, says an Agriculture Department analyst

Domestic use of grain for feed is estimated at a record 132 million (metric) tons, reflecting the continued Soviet policy of boosting livestock production," according to Christian J. Foster of the department's Reonomic HPAPAPULI APPVICE

The latest UNDA estimates show Noviel total grain produe: tion this year at 215 million tons, up from 211.4 million tons in 1987 and \$10 1 million tons in 1986 an unprecedented string of bumper harvests for the Soviet Union.

The 132 million tons of grain experted to be used as feed in 1988 An compares with 47 million tons for human food, 25 million tons for sped, and only 5 million tons for industrial purposes, which in: cludes the manufacture of vodka. Also, an estimated 25 million tons will be lost to spoilage and other mainly beer, wine and brandy mal harvest causes

Industrial use of Soviet grain peaked at around 6 million tons in the late 1970s and again as recently as 1984

Foster said Soviet industrial use of grain "remains below the 1984 peak because of decreased vodka production" as part of Noviet leader Mikhail S. Gorbachev's anti-alcoholism cam-Dalan

"Soviet production of vodka in 1987 declined for the third consecutive year, down 16 percent from 1986 and 58 percent from 1980," Foster said in the June issue of Agricultural Outlook magazine. "Both wheat and rye are used in making vodka. Harley is used in beer.

But Foster added that as the Noviel Union's official state production of alcoholic beverages has dropped, illegal distilleries have proliferated

"In 1987, more than 500,000 people were fined or arrested for the illegal production of alcohol," he said. "The number of fines and arrests is up 13 times from 1984." Foster added "Because of public tensions over the reduction in vodka for sale, Soviet authorities have decided to increase alcohol production in 1988.


Hours later, about 100 people who largely supported the Japanese visitors attended an evening with them at the Richland Public Library.

However, Mary Baird, of Richland, defended the dropping of atomic bombs on Japan at the end of the war, saying they prevented even greater slaughter of Americans and Japanese.

"It's unfortunate that a nuclear war occurred, but I will not accept the blame for my country," she said, noting that the Japanese launched hostilities in the Pacific.

The Japanese visitors have been in this country since May, when they attended a United Nations special session on disarmament in New York. Since then, they have been touring U.S. nuclear facilities.

Hanford was created by the Manhattan Project in World War II to make plutonium for nuclear weapons. The jobs of up to 30,000 Richland residents are tied to the nuclear weapons industry, and criticism of their role in that work is a sore point with many locals.

Reeves County sheriff said under indictment

PECOS, Texas (AP) - Reeves jury indictment, but he says he plans to continue working

The three-term sheriff was indicted last week on a charge of perjury. The misdemeanor charge accuses Florez of making a false sworn statement on an election petition.

The perjury charge is the latest in a string of legal troubles that started about five years ago when a grand jury no-billed him after he was accused of using jail inmates to improve his house.

It continued after last year's County Sheriff Raul Florez' legal tornado ripped through problems were added to by a per-Saragosa. Thousands of people sent money, building materials and other items to the sheriff's department for distribution. After rumors surfaced that some sheriff's employees helped themselves to some of the items, Rural Legal Aid asked for the department's financial records.

Legal Aid officials complained about sloppy bookkeeping, but found nothing illegal.

Florez' main political oppo-nent, Eddy Markham, accused the sheriff last July of punching Markham during an altercation at the Law Enforcement Center, a county-run prison for state and

federal detainees. That assault case has not yet come to trial.

Markham, who is the LEC's controller, ran for sheriff in the March Democratic primary, but Florez captured 59 percent of the vote.

That election campaign might have something to do with Florez' attempt late last month to oust Markham from the LEC. He removed the furniture from Markham's office, and the controller has had to do some business in his car and at home. **County Attorney Scott Johnson is** seeking an attorney general's opinion on whether Florez has the legal right to deny Markham the office space.





Gott Medication can affect taste

DEAR DR. GOTT: My doctor found out I had high blood sugar and put me on Dia-Beta. After two weeks I lost my sense of taste completely. Is this a side effect of diabetes?

DEAR READER: Loss of taste (hy-pogeusia) can result from diabetes, but it is more likely to be an unusual consequence of sulfonueureas, antidiabetes pills such as Dia-Beta. Check with your doctor about this, as well as to make sure that your blood sugar is under satisfactory control with the

DEAR DR. GOTT: When I was man to brush his hair at least 50 strokes a day. What would be the

benefits of this habit? DEAR READER: The only reasons I can think of are that the brushing are stimulates circulation in the scalp and distributes natural oils more evenly over the hair shaft. This has not been shown to affect baldness. And, as far as I know, it serves no useful function.

DEAR DR. GOTT: My mother, 66, has been having increasingly numer-ous medical complaints, near-acci-dents and incidents of forgetfulness over the past six months. She finally agreed to see a doctor, who found she had high blood pressure, a urinarytract infection, hematuria, degenera-tive joint disease, swelling of the an-kles and an enlarged liver. He hasn't suggested any liver tests. Should I press the matter? DEAR READER: That depends on

what he has done.

Your mother's early signs of de-Your mother's early signs of de-mentia (brain malfunction) could be due to her hypertension. This condi-tion is related to stroke, as well as to a problem called "micro-embolic in-farcts," meaning that she may be ex-hibiting behavioral changes that re-sult from tiny blood clots that are carried to the brain, causing death of brain times and progressive senility. brain tissue and progressive senility. By placing an inordinate strain on the

heart, your mother's high blood pres-sure also could be causing cardiac failure; this produces swelling of the ankles and the liver.

Hematuria (blood in the urine) is a common consequence of urinary in-fection, which, in turn, could be con-tributing to her hypertension. The de-generative joint disease is simply the

arthritis that comes with age. If I were your mother's doctor, I'd treat the urinary infection with anti-biotics. Once that problem has cleared, if her blood pressure remains high, I would administer anti-hypertensive medication. Of course, her hypertension and presumed heart disease could be treated simultaneously with a diuretic - medicine to rid the body of excess fluid by stimulating the kidneys. In addition, I'd investigate your mother's brain function, in conjunction with a neurologist, with appropriate tests.

In your situation, I'd not press the liver issue. I believe that her brain, urinary tract, hypertension and heart the priority areas for investigation.

CANYON, Texas (AP) - T. Boone Pickens Jr. came to the s rescue of West Texas State

with the compatible dent, pledging support for Ed Roach and blasting faculty critics of the president.

Pickens, chairman of the school's board of regents, defended Roach at an emergency meeting of the regents Tuesday.

Faculty members have accused Roach of retaliating against. some of their ranks who speak out against his policies and say his management style is dictatorial.

"We have heard the grievances of the faculty and while individually some were substantive, most were petty," Pickens said.

Acknowledging that many faculty have called for Roach's resignation, Pickens said WTSU's president "serves not at the pleasure of the faculty, but at the pleasure of the board of regents.'

We will not bow to pressure tactics nor will we be intimidated by those who spread dissension through rumors, innuendoes and false reports," he said.


About 50 faculty members present then shouted for the board's resignation.

After cries for Roach's ouster escalated during the spring semester, the regents brought in an external review panel of academics to examine faculty charges that academic freedom was being violated under Roach. But the board on Tuesday re-

jected the panel's finding that academic freedom is "virtually non-existent" at the school.

'The plain fact of the matter is that almost all of the charges that have been made, including those contained in the panel's report, which can be in any way substantiated, are trivial in nature," said regent Dee Osborne of Houston, reading a regents' committee analysis of the panel's report.

Backing his judgment, declarer played a low diamond from dummy. When East played the eight, he put up the queen, losing to West's king. West played a club, and East won the ace and played back a club to declarer's king. South now led a diamond, West played the nine, and declarer played low from dummy. Sure enough, the ace from East had to beat the air, and declarer had made his contract.





AN ORDINANCE GRANTING A FRANCHISE IN THE CITY OF SNYDER, TEXAS, SETTING FORTH CONDITIONS ACCOM-PANYING THE GRANT OF FRANCHISE, AND PROVIDING FOR REGULATION OF THE SYSTEM.

WHEREAS, the city of Snyder has, without necessity of expressed enumeration, each and every power which has been granted to the City by virtue of Article XI, Section V, of the constitution of the State of Texas, and all such powers, whether expressed or implied as contained in the City charter.

WHEREAS, Article IX of the City charter contains general provisions for franchises including the inalienability of the City's right of control and use of the public streets, highways, sidewalks, alleys, parks, public squares, and public places of the City; and,

WHEREAS, Snyder Cablevision Associates, is found to be subject to the powers and regulatory authority granted to the City of Snyder by its charter, and that the City is a franchising authori-

Now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SNYDER, TEXAS;

ARTICLE 1. GRANT OF FRANCHISE AND GENERAL PROVI-SIONS

Section 1. Title of Ordinance

This ordinance shall be known and may be cited as the Snyder Cablevision Associates, (SCA), Television Franchise, and it shall become a part of the code of ordinances of the City of Snyder

Section 2. Rights and Privileges of Cable Operator

The franchise granted by the City pursuant to this ordinance shall grant to Snyder Cablevision Associates, the right and privilege to erect, construct, operate and maintain in, on, along, across, above, over and under the streets and easements, now in existence and as may be created or established during its terms; any poles, wires, cable, underground conduits, manholes and other television conductors and fixtures necessary for the maintenance and operation of a cable television system for the interception, sale, transmission and distribution of television programs and other audio visual electrical signals and the right to transmit signals to the inhabitants of the City on the terms and conditions set forth below.

Section 3. Agreement and Incorporation of Application by Reference

A. On City's passage of this franchise, SCA agrees to be bound by the terms and conditions contained in this franchise, except those terms and conditions that become invalid as a result of changes in state or federal law.

B. SCA also agrees to provide all cable television service in the City of Snyder and by its acceptance, SCA grants and agrees that all attachments are incorporated by reference and made a part of the franchise and this ordinance.

Section 4. Purpose

A. There is hereby granted to SCA the right and privilege to construct, maintain and operate in the present and future streets, alleys, easements, and public places of the city of Snyder, Texas, towers, poles, lines, cables, necessary wiring, and other apparatus for the purpose of originating, receiving, amplifying and distributing cable communication signals, including television and FM radio signals and other forms of signals whether video, audio, or digital, to the City and its inhabitants.

tained with the City Secretary during the term of the franchinse, and may be changed from time to time to reflect changing liability limits or conditions. SCA shall immediately advise the City of any litigation that may develop that would affect this insurance.

Section 10. Performance Bond and Letter of Credit

Within sixty (60) days after the award of this franchise SCA shall file with the City a Performance Bond in the amount of Twentyfive thousand dollars (\$25,000) in favor of the City.

Section 11. Indemnification

A. SCA shall, at its sole cost and expense, fully indemnify, defend and hold harmless the City, its officers, boards, commissions and employees against any and all claims, suits, actions, liability and judgments for damages, arising out of SCA's cable TV operations or this franchise, including but not limited to expenses for reasonable legal fees and disbursements and liabilities assumed by the City.

ARTICLE II. CABLE TV SYSTEM EXTENSION, OPERATION, STANDARDS AND PROCEDURE.

Section 1. Service Availability

SCA shall provide cable television service throughout the entire franchise area pursuant to the provisions of this franchise and shall keep a record for at least three (3) years of all request for service. This record shall be available for public inspection at the local office of SCA during regular office hours.

Section 2. Cable TV System Construction and Standards

A. SCA will expand the system's channel capacity to 35 channels as soon as practicable.

B. Performance Tests on Expanded System:

1. Not later than ninety (90) days after new or substantially rebuilt portion of the system is made available for service to subscribers, performance tests shall be conducted to demonstrate full compliance with the technical standards shown in the attached Appendix.

2. Such tests shall be performed by, or under the supervision of a qualified engineer. A copy of this report shall be submitted to the City describing and summarizing test results, instrumentation, calibration, and test procedures, and the qualifications of the engineer responsible for the tests.

C. New construction, installation and maintenance of the cable television system shall be performed in a high quality, professional manner. All cables and wires shall be installed where possible, parallel with electric and telephone lines.

1. For all new construction, SCA shall at all times comply with:

a. National Electrical Safety Code (National Bureau of Standards);

b. National Electrical Code (National Bureau of Fire Underwriters);

c. Applicable FCC or other federal, state and local regulations.

2. The system shall not endanger or interfere with the safety of persons or property in the franchise area or other areas where SCA may have equipment located.

3. Any contractor proposed for work of constructon, installation, maintenance, and/or repair of the system or equipment must be properly licensed under laws of the state, federal regulatory agencies, and all local ordinances. could be the shared responsibility of one or more utility, the absence of such facilities shall not be justification by and of itself to deny such service extension. In the event joint use of facilities set forth in this paragraph cannot be accomplished, SCA shall arrange for the provision of such facilities independently or in conjunction with other utilities and at the expense of SCA and/or in cooperation with other utilities.

D. In the event that, at any time during the period of this franchise, the City, County, State, or other authority shall lawfully elect to alter or change the line or grade of any street, road, public way, alley, or easement, SCA, upon reasonable notice by the proper authority, shall remove or relocate as necessary its poles, wires, cables, unerground conduits, pedestals, manholes and other fixtures.

E. SCA shall, on the request of any person holding a building moving permit issued by the city, temporarily raise or lower its wires to permit the moving of buildings. The expense of such temporary removal, raising, or lowering of wires shall be paid by the person requesting the same, and SCA shall have the authority to require such payment in advance.

Section 4. Overhead (Aerial) and Underground Service and Extensions,

A. The cable communicatons system authorized and required in this franchise ordinance during reconstruction, relocation, renovation, or extension throughout the term of the franchise, may be installed or extended by means of overhead or aerial construction except in those areas within the franchised territory where both telephone and electric utility facility are underground at the time of reconstruction, relocation, renovation, or extension of the cable communications system. Where not otherwise required to be placed underground and at the request of adjacent property owners or developers, provided any excess of underground over that of aerial or overhead cost shall be borne by the property owner or developer making the request.

All cable passing under improved roadways, streets, and paved alleys, shall be installed in conduit and shall be installed as directed and specified by the City to minimize or eliminate the need for the open cutting of improved streets, roads, paved alleys, or walks. The City's specifications for boring, trenching, backfilling, encasement and embedment for installation of utilities within public rights-of-way including permit and fee requirements as same may exist on the effective date of this franchise or as same may be enacted or adopted by amendment during the term of this franchise and extensions shall be conditions of this franchise as if fully set forth here. Failure to comply with the directions and specificaions shall be deemed a violaton of the franchise ordinance and shall be enforceable as such.

B. Where a system is already installed, the total cost of replacement with a new underground system shall be borne by the developer making the request.

ARTICLE III. CAPACITY AND SERVICES

Section 1. Capacity and Rates

A. SCA shall provide a cable communications system capable of receiving and transmitting 300 mhz for video, audio, and/or digital signals for visual programs or other uses to subscribers within the franchise area, and 35 channels of capacity.

B. SCA shall provide or reserve the following public educational, and government access channels:

1. One (1) channel for government purposes;

B. This ordinance and franchise creates and sets conditions accompanying the grant of a franchise period and provides for the regulation of a system designed and constructed for the purpose of distributing video and other forms of electronic signals in the City and referred to as the "cable communication system." The system is recognized to be subject to regulation by this City by virtue of its charter and the Cable Communications Policy Act of 1984 as amended from time to time.

C. This franchise is nonexclusive. The City reserves the right to grant at any time additional franchises for cable communications systems on substantially the same terms and conditions.

Section 5. Duration and Acceptance of Franchise

The franchise and the rights, privileges and authority granted shall take effect and be in force from and after final passage as provided by law, and shall continue in force and effect for a term of twelve (12) years, provided that within thirty (30) days after the date of final passage of the franchise SCA shall file with the City Manager its unconditional acceptance of the franchise and promise to comply with all its provisions, terms, and conditions.

Section 6. Police Powers

In accepting this franchise, SCA acknowledges that its rights are subject to the police power of the City to adopt and enforce general ordinances necessary to the safety and welfare of the public and it agrees to comply with all applicable general laws and ordinances enacted by the City pursuant to such power.

Any conflict between the provisions of the franchise and any other present or future lawful exercise of the City's police powers shall be resolved in favor of the City except that any such exercise that is not of general application in the jurisdiction or applies exclusively to SCA or cable television systems which contains provisions inconsistent with this franchise shall prevail only if upon such exercise, the City finds an emergency exits constituting a danger to health, safety, property or general welfare or such exercise is mandated by law.

Section 7. Franchise Required

No cable television system shall be allowed to occupy or use the streets of the City, or be allowed to operate, without a cable television franchise containing requirements substantially the same as those imposed on SCA.

Section 8. Costs of Franchising

A. SCA shall pay the City for the direct and indirect costs of franchising up to a maximum of \$15,000, which shall include consultants, legal, and other costs of examination of SCA's performance, qualifications, and proposal.

Section 9. Liability and Insurance

A. SCA shall maintain, and by its acceptance of this franchise specifically agrees that it will maintain throughout the term of the franchise, insurance in the minimum amount of liability: each occurrence \$500,000; aggregate \$1,000,000.

B. Certificates of insurance which show proof of the policies obtained in compliance with this section shall be filled and main-

Section 3. Use of Streets, Alleys, Easements and Public Ways

A. The cable communicatons systems and facilities, including SCA owned poles, lines, equipment, pedestals, and all appurtenances, shall be located, erected and maintained so that such system and facilities shall not:

1. Endanger or interfere with the health, safety or lives of persons;

2. Interfere with any improvements the City, County, State, or other governmental authority may deem proper to make;

3. Interfere with the free and proper use, access, ingress, or egress of public ways, streets, roads, alleys, or easements except during actual construction or repair;

 Interfere with the rights and reasonable convenience of private property owners;

5. Obstruct, hinder or interfere with any gas, electric, water, sewer, telephone, or other utilities located within the public ways, streets, roads, alleys, or easements.

B. In case of any disturbance of pavement, sidewalk, driveway, other surfacing, landscaping, fencing, plantings, retaining walls, embankments, drainage channels, structures, or parking areas, SCA shall, at its own cost and expense and in a manner approved by the City, replace and restore all paving, sidewalk, driveway, landscaping, fencing, plantings, retaining walls, embankments, drainage channels, structures, or parking areas or surface of any street, alley, road, easement, or public way disturbed, in as good a condition as before work commenced in an efficient workmanlike and timely manner in accordance with standards set for such work by the City. Such restoration shall be undertaken within no more than 10 days after the damage is incurred, and shall be continuously pursued until completed to the satisfaction of the City. All permits and procedures for notification to the City or other owner, authority, or utility, shall be obtained or complied with in advance of the disturbances contemplated within this paragraph.

C. Erection, Removal and Common Use of Poles.

1. No location of any pole or wire-holding structure of SCA shall give rise to a vested interest, and such SCA owned poles or structures shall be removed or modified at SCA's expense whenever the City reasonably determines that the public convenience would be enhanced.

2. Where poles already exist for use in serving the City and are available under just and reasonable terms and conditions, for use by SCA, but it does not make arrangements for such use, the City may, with reasonable cause, require SCA to use such poles and structures if the City determines that the public convenience would be enhanced. Where a public utility serving the City desires to make use of the poles or other wire-holdng structures of SCA, but agreement with the SCA cannot be reached, the City may, with reasonable cause, require SCA to permit such use for payment and terms as the City shall determine to be just and reasonable, if the City determines that the use would enhance public convenience.

3. Where SCA desires or is required to extend cable communicaion service to a location not then served with existing poles, wire holding devices. conduit, or trenches, whether or not such poles, devices, conduits, or trenches 2. One (1) channel for educational purposes;

3. One (1) channel, if available, for purposes requested by the City Council.

4. SCA shall be authorized to provide temporary shared, joint, or cooperative use of one or more of the channels assigned to public, educational, government uses until such time as there is demand for use of the shared channels. Shared use shall cease on notification by the City Council.

C. 1. The city may regulate rates to the extent allowed by law.
2. When basic channel service is increased to 24 channels, SCA may raise its rate for service to \$16.95 per month.

Section 2. Continuity of Service Mandatory

A. It shall be the right of all subscribers to continue receiving service insofar as their financial and other obligations to SCA are honored. In the event that the SCA elects to overbuild, rebuild, modify, or sell the system with the consent of the City, or the City gives notice of intent to terminate or fails to renew this franchise, SCA shall act so as to ensure that all subscribers receive continuous, uninterrupted service regardless of the circumstances. Revenues shall continue to accrue to SCA until transfer occurs, unless otherwise agreed to be SCA and transferee.

B. In the event of termination of the franchise, SCA shall cooperate with the City or new operator in maintining continuity of service to all subscribers.

Section 3. Complaint Procedure

A. SCA shall maintain a local office in Scurry County for the purpose of receiving and resolving complaints, which shall be accessible by a local, toll-free telephone. The local office shall be open to receive inquiries or complaints during normal business hours, and in no event less than 9:00 a.m. to 5:00 p.m., Monday through Friday, excluding legal holidays. SCA shall provide the means, such as an answering service or machine, to accept calls twenty-four (24) hours a day, seven days a week. During the rebuilding period (first 18 to 24 months), the City may require SCA personnel to receive and resolve complaints 9 a.m. to 7 a.m. Monday through Saturday.

B. SCA shall investigate and act on all service complaints by the end of the following business day. Service complaints shall be resolved within a reasonable period of time.

C. As subscribers are connected or reconnected to the system, SCA shall, by appropriate means such as a card or brochure, furnish information concerning the procedures for making inquiries or complaints, including the name, address and local telephone number of the employee or agent to whom such inquiries or complaints are to be addressed.

D. On failure of SCA to remedy a loss of service attributable to the cable system within twenty-four (24) hours of receipt of notification of such loss, SCA shall rebate, at the request of the subscriber, one-thirtieth (1/30) of the regular monthly charge to each requesting subscriber so affected, for each twenty-four (24) hours after receipt of notification, until service is restored, unless such restoration is prevented by strike, injunction or other cause beyond control of the SCA. Loss of service shall be considered as a failure to receive less than two-thirds (2/3) of the available channels.

A. SCA shall provide and maintain PEG access channels for purposes outlined below, which shall be capable of providing service 24 hours per day.

1. SCA's sole responsibility shall be to facilitate use of access channels and not to provide a studio, production or play back equipment or personnel. SCA shall lend technical assistance to users in order for users to deliver video signals to SCA for showing on access channels.

2. Educational access channels shall be available for use by public and private school authorities.

3. Government access channels which shall be available for local governmental use.

4. SCA shall incorporate into its cable television system equipment which will permit the City, in times of emergency, to override the audio on all channels simultaneously. It will be activated by telephone provided by SCA.

ARTICLE IV. ADMINISTRATION

Section 1. Performance Evaluation

A. The City and SCA shall schedule performance evaluation sessions and public hearings at the April Council meeting during the fourth (4th) and eighth (8th) years. The sessions shall be open to the public and announced in a newspaper of general circulation in accordance with legal notice. When there exist other reasonable evidence, which in the judgement of the City, questions the quality of service, the City may require SCA to test the signal quality and performance.

B. Topics which may be discussed during evaluation may include, but not be limited to, rate structures, franchise fee, penalties, free or discounted services, application of new technologies, system performance, services provided, programming offered, customer complaints, amendments to this ordinance; judicial and FCC rulings, and SCA or City rules.

C. SCA shall file with the City a report giving an assessment of its performance evaluation 60 days prior to review. SCA shall bear reasonable cost of City to review performance in the fourth and eighth years.

D. SCA shall run proof of performance tests during the fourth and eighth years conforming to FCC and franchise requirements, and present the results to the Council for consideration of performance review. (When there exists other reasonable evidence, which in the judgment of the City, questions the quality of service, the City may require SCA to test the signal quality and performance.) The City may require the tests to be supervised by an engineer, whose reasonable expense shall be paid by SCA, chosen by the City. The engineer shall sign all records of special tests and forward such records to the City with a report interpreting the results, and recommending action to be taken.

invest substantial capital in right-of-way costs and acquisitions; therefore, SCA shall pay the City an amount equal to three percent (3%) per annum of SCA's gross annual revenue from all sources attributable to the operations within the confines of the City. This payment shall be in addition to any other tax or payment levied or required by the City from SCA.

B. Nothing in this Article shall limit the fees, taxes, and charges required by this franchise for other permitted purposes or costs. but this fee shall include the amount of tax, fee, or assessment imposed by the City on SCA or its cable subscribers solely because of their status as such. The term "franchise fee" does not include bonds, security funds, letter of credit, insurance, indemnification, penalties, liquidated damages or other reguirements which are necessary to the enforcement of this franchise. The franchise fee shall be in addition to any tax, fee, or assessment imposed on other persons as well as on cable operators or cable subscribers.

C. The franchise fee shall be payable quarterly to the City, and SCA shall file a detailed, verified statement of all gross receipts within the City during the period for which the payment is made. The payment shall be made to the City not later than ninety (90) days after the expiration of SCA's fiscal quarter. The City shall have the right to inspect SCA records and to audit and recompute any amounts determined to be owed; provided, however, that such audit shall be initiated within thirty-six (36) months following the submission of the report. Additional amount due as a result of the audit shall be paid within thirty (30) days following written notice to SCA. The notice shall include a copy of the audit report or findings of the recomputation. Costs of any independent audit or special accounting shall be charged to SCA if the audit finds the actual amount due to be higher than the amount paid.

D. The acceptance of any payment required by the City shall not be construed as an acknowledgement that the amount paid is the correct amount due, nor shall acceptance of payment be construed as a release of any claim which the City may have for additional sums due and payable. Fee payments shall be subject to audit by the City or its appointed agents, and additional assessment or refund shall be made if the payment is found to be in error. In the event that such an audit or audits result in an assessment by, and an additional payment to the City, the additional payment shall be subject to interest at the rate of eighteen percent (18%) per year from the date on which the said original payment was due and payable.

Section 4. SCA Rules and Regulations

SCA shall have the authority to promulgate such rules, regulations, terms and conditions governing the conduct of its business as shall be reasonably necessary to enable SCA to exercise its rights and perform its obligations under this franchise, and to assure uninterrupted service to each and all of its customers. Provided, however, that such rules, regulations, terms'and conditions shall not be in conflict with the provisions of applicable State and Federal laws, rules and regulations. If such rules, regulations, terms, and conditions are maintained in written form, SCA shall provide copies to City.

D. If the City Council finds that the violation by SCA has occurred and that the violation has not been cured, the City Council may, by resolution, declare that the franchise of SCA shall be forfeited and terminated. SCA retains all rights to challenge such termination in the appropriate court of law.

Section 3. Renewal

This franchise may be renewed in accordance with the terms of the Cable Communications Policy Act of 1984 as amended from time to time.

Section 4. City Right to Negotiate to Purchase System

In the event SCA forfeits or the City terminates the franchise pursuant to provisions in Section 2, Article V of this franchise, the City reserves the right to enter into negotiations for the purchase of the cable communications system, and applicable provisions of the Cable Communictions Act (Section 627, Conditions of Sale) shall apply, but such right shall not be interpreted to exclude other parties from simultaneously entering into the negotiations for purchase of the cable system.

Section 5. Removal of Cable Television System

At the expiration of the term for which this franchise is granted, or any renewal, or upon its termination as provided, SCA may be required, upon notice by City to remove at its own expense all designated portions of the cable television system from all streets and public property within the City. If SCA fails to do so, City may perform the work at SCA's expense. A bond shall be furnished by SCA in an amount sufficient to cover this expense.

ARTICLE VI. EFFECT DATE

APPENDIX **Technical Requirements** I. Technical Standards

The system will operate and be maintained to meet the highest standards required by law.

Section 2. Reporting and Availability of Records

A. SCA shall keep complete and accurate books of accounts and records of its business and operations in connection with this franchise. All such books and records shall be consistent with generally accepted accounting practices and shall be made. available to the City at SCA's principal office in the City.

B. The City shall have the right, relating to rate regulation of cable service provided by SCA, at reasonable times and for reasonable purposes, to examine, audit, review, and/or obtain copies of the papers, books, accounts, documents, maps, plans, and other records of SCA and/or it's affiliates and to inspect, inventory, and/or appraise the plant, equipment, and other property of SCA within the City's jurisdiction. SCA shall fully cooperate in making available its records and otherwise assisting in these activities.

C. The City shall have the power to require that SCA report such information relating to SCA and/or its affiliates as the City may consider necessary for the purpose of regulating rates, when applicable. The City shall have the right, relative to rate regulation of cable service provided by SCA to establish forms for all reports, determine the time for reports and the frequency with which any reports are to be made, and require that any reports be made under oath.

D. The City shall have the right relating to cable service provided by SCA, when necessary for the purposes of regulating rates, if applicable, to require that all contracts or arrangements between SCA and any affiliated interest be in writing and that copies be filed with the City.

E. The City may, at any time, make reasonable inquiries concerned with the management and affairs of the SCA System. SCA shall respond to such inquiries on a timely basis.

F. SCA shall provide the following reports:

(1) Quarterly reports to be furnished 90 days after end of calendar quarter:

(a) Gross revenues and the basis for calculation of franchise fee.

(2) Annually by April 30:

(a) Copies of audited financial statements of income, assets, and liabilities.

(b) Summary of operations certified by SCA officer: number of subscribers by class, connects and disconnects, miles of trunk and distribution, homes passed.

(c) Future plans: rate changes, service changes, possible introduction of new features, services, or new technology.

(d) Description of investment and property installed by type and account number and cost.

(e) Ownership report, showing partners or major stockholders or parents holding 5% or more of stock or ownership.

(f) Copies of petitions, applications, and non routine communicatons with FCC, SEC, or other state or federal regulatory agency having jurisdiction over matters affecting system or this franchise.

Section 3. Franchise Fee

SCA acknowledges that the streets, alleys, easements, and rights-of-way of the City to be used by SCA in the operation of this and within the boundaries of the City are valuable public properties acquired and maintained by the City at great expense to its taxpayers. The grant to SCA for the use of its streets is a valuable property right without which SCA would be required to Section 5. Compliance with State and Federal Laws

Notwithstanding any other provisions of this franchise to the contrary, SCA shall at all times comply with all laws and regulations of the state and federal government or any of its administrative agencies. Provided, however, that if any such state or federal law or regulation shall require SCA to perform any service, or shall permit SCA to perform any service, or shall prohibit SCA from performing any service in conflict with the terms of this franchise or of any laws or regulations of the City, then SCA shall notify the City of the conflict believed to exist between such regulation or law and the laws or regulations of the City or this franchise.

If the City determines that a material provision of this ordinance is affected by subsequent actions of the state or federal government, the City and SCA shall have the right to modify provisions to such extent necessary to be in compliance with all laws and to carry out the full intent and purpose of this franchise.

ARTICLE V. TRANSFER, TERMINATION AND PEMOVAL

Section 1. Transfer of Franchise

Any such franchise shall be based on the qualifications of SCA, and cannot in any event be sold, transferred, leased, assigned or disposed of, in whole or in part, either by forced or involuntary sale, merger, consolidation or otherwise without prior consent of the City Council expressed by resolution, and then only under such conditions as may be prescribed herein. The consent of the City will not be unreasonably withheld; provided, however, the proposed Assignee must show financial responsibility and must agree to comply with all provisions of this ordinance; and provided, further that no such consent shall be required for a transfer in trust, mortgage, or other hypothecation as a whole, to secure an indebtedness.

Section 2. Termination

A. In addition to all other rights and powers retained by the City under this franchise or otherwise, and the City reserves the right to forfeit and terminate the franchise and all rights and privileges of SCA in the event of a substantial breach of material terms and conditions. SCA shall not be excused by mere economic hardship nor by misfeasance or malfeasance of its directors, officers or employees.

B. In the event that the City decides to initiate procedures to terminate this franchise pursuant to this Article V, the City shall make a written demand that SCA comply with any such provision, rule, order, or determination under or pursuant to this franchise. If the violation by SCA continues for a period of thirty (30) days following such written demand without written proof that the corrective action has been taken or is being actively and expeditiously pursued, the City may place the issue of terminaton of the franchise before the City Council. The City shall cause to be served upon SCA, at least twenty (20) days prior to the date of such City Council meeting, a written notice of intent to request such termination and the time and place of the meeting. Public notice shall be given of the meeting and issue which the City Council is to consider.

C. The City Council shall hear and consider the issue and shall hear any person interested, and shall determine in a reasonable manner whether or not any violaton by SCA has occurred and whether the violaton has been cured.

1. SCA shall test the system in accordance with FCC recommended procedures good industry engineering practices. Tests will be conducted at 10 locations in the system. (a) Four at the end of the largest cascade in each of East, West, North and South directions from center.

B. Tests

(2) Compliance with performance specifications shall be determined from measurements and tests applied to the worst case; e.g., the signal received by the farthest subscriber, including distribution system and largest super trunk effort.

(3) The procedure shall be overseen by an engineer who shall certify the results in a report to the City. These tests shall apply to the performance in the fourth and eighth years.

The spread of AIDS among cocaine abusers, which Des Jarlais has observed in New York City and San Francisco, is also of concern because of the difficulty of treating cocaine addiction, Des Jarlais said.





Columnist still against handguns

WASHINGTON (AP) - Syndicated columnist Carl T. Rowan says he still strongly opposes handguns, even though he used one to shoot a teen-ager who had taken an uninvited dip in his backyard swimming pool.

"I am absolutely for gun control. I still am, said Rowan. "But as long as we have a situation where druggies can get guns easily, you have to protect yourself." Rowan shot the 18-year-old youth in the wrist early Tuesday morning at his home in an af fluent section of the city. He said he fired only after the young man lunged at him. The youth, Ben Smith of Chevy Chase, Md., disputed Rowan's account, saying he was trying to flee when Rowan shot him. 'That's no reason to shoot a person - for swimming in his pool,' Smith said. Smith and a companion were initially charged with unlawful entry, but those charges were dropped later on Tuesday. Police said the .22 caliber pistol Rowan used was not registered with the city, which has some of the toughest gun-control laws in the nation. Rowan said, however, that it was registered with the federal government. The District of Columbia passed a law in 1976 saying that only guns already then registered were legal for private possession. Police said their investigation was continuing.

Vines said the political ramifications of the fundamentalist upsurge were "spinoffs" from the theological concerns.

Jackson said the split "ob-viously isn't over theology," but over different styles of leadership, since he accepts the Bible's infallibilty, but he respects those holding other views.

"I believe we'll stay together, may God deliver us," he said. "I don't want anybody to panic."

Annexation move is endorsed by **Armenian officials**

MUSCOW (AF) - The Armenian legislature today endorsed a move to annex part of a neighboring republic, turning a fierce ethnic dispute into a constitutional issue for the central Soviet government to resolve.

A correspondent for the Armenian Communist Party newspaper Kommunist said the southern republic's Supreme Soviet voted to approve the request of the disputed region's legislature to secede from Azerbaijan and join Armenia.

89% 34% 89 44% He said the meeting was broadcast live on television, a first for the republic.

In Moscow, several hundred Armenians applauded and raised clenched fists as Tiran Gureghian, the Armenian church representative in Moscow, told them the vote had been unanimous to annex the Nagorno-Karabakh region, which is predominantly Armenian

Azerbaijan's Supreme Soviet voted Monday to reject the move, saying it would "be contrary to the interests of the Azerbaijani and Armenian population of the republic.'

Armenians and Azerbaijanis have long been divided by religion and culture. Most Armenians are Christian while most Azerbaijanis are Moslem.

The dispute appears headed for consideration by the central government's Supreme Soviet in Moscow, which according to the Soviet constitution must resolve territorial disputes among the country's 15 republics.

Moscow Communist Party officials rejected the annexation demand in February, touching off a wave of ethnic violence and strikes in the two southern republics.

Gureghian, speaking from the steps of the red-brick church in a wooded Armenian cemetery, said Armenians would now wait for Moscow's decision: "The people are united in their mood. Everyone is waiting for a just decision."

in February and on the 28th of that month, there were riots in the Azerbaijani city of Sumgait in which 32 people were killed, most of them Armenians.

The crisis, which has touched off economically damaging strikes in the disputed region and brought out thousands of demonstrators in Yerevan, represents a major test of Soviet leader Mikhail S. Gorbachev's policy of "glasnost," which permits more open discussion of Soviet problems.

With the Armenian and Azerbaijani governments now taking opposite stands on the issue, the dispute sets up a legal test as well.

"Moscow will now have to play the role of an arbitrator," the journalist said.


The Soviet Constitution requires that changes in territorial boundaries be approved by the republics involved and be ratified by the central government. It us unclear whether Armenians will be able to get their way in light of the rejection of the annexation request by Azerbaijan's government.

Unrest related to the dispute continued today. More than 150 students remained outside Yerevan's Opera Theater, staging a sit-in they began May 25, the Kommunist journalist said.

Three of the students have been lying on the square in a hunger strike since June 4, said Mofses Gorgisyan, an Armenian nationalist activist.

On Monday, Armenians staged a general strike in Yerevan, and tens of thousands demonstrated.

Armenians in Nagorno-Karabakh have been striking and marching since May 23, the Communist Party newspaper Pravda has reported.

"She called and calmly said she had reason to believe that she was the boy's grandmother," English said.

Authorities found the freckled, brown-haired boy, named Sabat by his Mexican guardians, wandering near Juarez, Mexico, last November. He had scars that looked about two years old and could have come from hometreated injuries.

He was unable to identify himself to authoritie or say where he was from.

Sabat suffers from impaired hearing and communicates mostly by drawing pictures and gesturing. His pictures seem to indicate that he survived the crash of a four-seat, singleengine airplane that killed his parents and sister.

After Mexican authorities noticed Sabat preferred hamburgers and hot dogs over Mexican fare and responded more enthusiastically toward American cartoon characters, they contacted their Texas counterparts.

His story has received international media attention and pictures of the boy have circulated in France, England, Mexico and throughout the United States.

English said the French woman, who asked not to be identified, provided the address and telephone number for her son who lives in El Paso, not far from where the boy was found.

She said she had not spoken to her son for several months and that the telephone had been disconnected, English said, adding that the son also is French.

English said he called Terry Kincaid of the FBI in El Paso and passed along the information.

"He said it was the best lead he had had in months," English said, adding that Kincaid planned to check out the address early today.

The woman said her son was married to a Mexican woman and that the couple had three children. She had not seen them for several years.

Her daughter, who lives in Paris, also recognized the boy from pictures accompanying the news story, he said.

English said the daughter today was to deliver photographs of the boy that would be sent to the FBI.

Texas officials have said the boy is 7 or 8 years old. The French woman said he was close to 12.

Rowan said he was awakened at about 1:55 a.m. by the sound of someone outside his bedroom window.



Doctor Wants to Open Eyes To Danger of Some Contacts

By Abigail Van Buren

DEAR ABBY: I am a busy ophthalmologist whose time is spent in treatment and eye surgery. I do not sell contact lenses. In fact, I forbid my patients to wear permanentwear contact lenses.

The main group desiring perma-nent wear contact lenses are myopic (nearsighted) people who want to put something in, and wear it all day and all night. It works most of the time, but there are enough devastating consequences of these permanent-wear contact lenses so. that I personally refuse to authorize them for my patients. If a patient asks for extended-wear contacts, say no. And if I get an argument, I simply ask, "Would you wear your shorts or panties for 30 to 50 days?" The answer is, "No, never!" I then explain that contact lenses

collect moisture, mucus, sugar and other proteins from the tear fluid that will grow bacteria. The eye is a warm, moist place where all types of severe parasitic diseases can flourish As far as I am concerned, the best contact lens by far is a soft lens that is placed into, a heat sterilizer after each wearing. Every day the wearer starts with a clean lens, which cannot grow enough bacteria or fungus in 24 hours to harm the eye.

As a physician, I feel responsible for my patients' care, and I think the legal system would probably feel that I bear some responsibility were I to prescribe permanent-wear lenses that damaged my patients' eyes. I simply don't want my patients to take the risk, although the major manufacturers would

"These guys don't make any money until they collect," said Robert Ford, deputy assistant at-torney general for Debt Collec-tion Management in Washington. "Our purpose is to ensure that debtors' realize the federal government is cerious about try-ing to collect its debts," Ford said at a press conference Tues-day morning in Houston. An estimated \$32 billion in non-tax debt is owed to the federal government, in addition to \$50 billion owed to the Internal Revenue Service, he said. The pilot program currently will not refer criminal fines, ball forfeitures or civil debts over \$25,000 to private counsel for col-lection. In addition, the law ex-empts tax debts and debts aris-ing under the Social Security or tarfiff laws. But the private law firms will tarfiff laws.

But the private law firms will be trying to collect delinquent loans from the Department of Education, Small Business Ad-ministration, Veterans Ad-ministration loans, Department of Housing and Urban Develop-ment and other federal agencies. The first debts in the southern

The first debts in the southern district to be handled by the private firms will be drawn from a pool of about 2,300 backlogged civil cases, said Henry K. On-

cken, U.S. attorney for the Southern District of Texas. Although officials in the debt collection unit have obtained judgments totaling about \$8 million against those civil deb-

The contracts allow the private firms to sue to recover debts of up to \$10,000 in state, local or federal courts, but require that

all suits to recover debts of over \$10,000 must be brought in the federal district court where the

debtor lives. Although the firms cannot gar-nish wages, they can go after Leigh, an attorney with Eiken-burg & Stiles.


In addition, assets can be seiz-ed and sold to help pay off debts. The debts are those the federal government already had tried to collect through various pro-

cedures, said Frank Conforti, chief of the district civil division. The debt-collection contracts stgned Tuesday were awarded under the Federal Debt Recovery Act of 1986, which empowers the

Act of 1986, which empowers the sciences general in contract with private lawyers to help collect some non-tax debts owed the federal government. Ford said. The three year pilot program will first be implemented in five judicial districts and then be ex-panded to include five more districts. The four other areas are the Eastern District -st Michigan, the Eastern District of Michigan, the Eastern District of Michigan, the Eastern District of New York, the Southern District of Florida and the Cen-tral District of California. Texas' southern district in-cludes Houston, Corpus Christi and the Rio Grande Valley. Various reports and data col-lected from each district will help officials determine the effec-tiveness of the program, Ford said.

said. Oncken said the four Houston law firms were selected from 12 bidders. The firms are Eiken-burg & Stiles: MacNaughton, Alonzo. Leufven & Cersonsky; Ross. Banks, May, Cron & Cavin; and Zapata & Associates. Oncken noted that during fiscal year 1987, his debt collection unit recorded over \$22.5 million in civil and criminal collections. "The current debt balance in the Southern District of Texas alone is estimated at almost \$68 million in criminal fines and ball forfeitures imposed by the courts, as well as almost \$25 million in civil judgments obtain-ed by attorneys in this office," he said.
