

# 40 patient count is Cogdell goal

A simple formula to make operations at Cogdell Memorial "break even" in the near future was proposed Tuesday by administrator Tom Hochwalt.

'All we need is 40 patients a day,'' he said.

Hochwalt's comments followed hospital budget discussions Monday, which indicated a projected net operating loss at. Cogdell for 1989 of some \$487,000. This marks a turnaround in the growing operational deficit, but is viewed as only the "first step," Hochwalt noted.

'In the long term, Cogdell Hospital cannot survive on 25 to 30 patients a day," the administrator said.

For 1989, an average daily census of patients at Cogdell is projected at 26

'Rate increases and cost reductions will help reduce our

operating losses, but our cash position will continue to deteriorate or at best it will simply stabilize with this level of admissions.

The key to Cogdell's future, he said, is "an increase in patient volume," adding that an average daily census of 40 patients would allow the hospital to "break even.

A further concern, he said, is that the majority of major equipment items at the hospital are fully depreciated. "This is not equipment that we'd like to replace because some technology has come along to make it better. This is equipment that is ap proaching being worn out," he said.

He estimated some 75 percent of Cogdell's \$2.3 million worth of equipment is now fully depreciated.

# Speaker noted for feisty style

AUSTIN, Texas, (AP) - Ann in 1986 Richards, tapped as the keynote speaker for the Democratic National Convention, is known for using blunt rhetoric tempered with wicked humor to get her point across.

At a recent Democratic Party fundraiser in Houston, one man after another - none of them minorities - came to the podium to speak. Finally it was the turn of Ms. Richards, the Texas state treasurer and potential 1990 gubernatorial candidate.

Now are there any other white men who haven't spoken yet? don't want to leave any of you out

The audience roared with laughter, as Ms. Richards' audiences usually do. And, as usual, her audience got the message.

On Monday, her stump style was praised by Democratic Party chief Paul G. Kirk as he announced her selection as the speaker whose address will open the party's convention next month in Atlanta.

The 54-year-old Ms. Richards, Kirk said at a Washington news conference. "has the ability to tell it like it is.

She will be the second woman in party history to deliver the convention keynote speech. Kirk said Michael Dukakis, the Democratic nominee-apparent, had urged the selection of a woman keynote speaker.

# 3 shooting deaths linked to religious dispute

HOLISTON (AP) believe a religious dispute spanning two countries may be the cause of the execution-style shooting deaths of a man, his 8year-old daughter and his brother

The three were fatally shot in two separate shootings Monday. Police have not yet made any arrests in the slavings.

Duane Chynoweth and his daughter Jennifer were found shot to death in a pickup truck parked outside a vacant house, Houston police spokesman Dan Turner said. The shootings occurred shortly after 4 p.m.

Duane Chynoweth was shot several times in the head, while the girl was shot once in the face, Turner said

The father apparently was delivering an appliance to the vacant house, and police were trying to determine who called him about making the delivery.

At around the same time, Duane's brother, Mark Chynoweth, was found shot to death at a business about 10 miles away, he said.

Turner did not have the ages of the two men.

A neighbor of the Chynoweth family said Lillian, Mark Chynoweth's wife, explained the cult connection after the killing.



About \$2 million worth of jewelry and other goods seized by federal authorities will go on the block at trendy Hart Galleries, which is more accustomed to handling auctions of antiques and art objects of Houston blue bloods.

Most of the jewelry doesn't highlight the former owner's profession and gallery owner Jerry Hart is expecting some 500 bidders for the auction, scheduled for Wednesday.

"I doubt anyone ever seized jewelry of this quality in this amount," J. Keith Gary, U.S. Marshal for the Eastern District of Texas, said Monday of the nearly 200 items that once belonged to Bruce Emery "Pee Wee" Griffin. Gary described Griffin as a Florida drug dealer who used a ranch in Aubrey north of Dallas — to launder drug money

Griffin, convicted of marijuana possession, is now on parole from prison.

The items on display at Hart Galleries, which earlier this year handled the bankruptcy auction of former Texas Gov. John Connally, offer a glimpse of the

Included are such things as gold-plated and monogrammed tape measures and a gold toothpick that slides out of its own gold holder.

A showpiece item is an 18-karat gold ring emblazoned with a 9.49carat emerald-cut diamond surrounded by 56 other diamonds. The ring is estimated to be worth some \$130,000.

"You've got to understand this man had just a tremendous amount of money and he could buy whatever he saw," Hart said. "It appears he was very Golden Terrace selective about what he purchased. He bought nothing but investment quality stones and diamonds."

# Area farmers hope recent rains mean healthy crops

LUBBOCK, Texas (AP) -With harvest two months away, area growers hope recent crucial rains will mean they'll be taking healthy crops to a market where prices have risen due to a drought scorching much of the

Farm Belt. The croplands of the South Plains and Panhandle were sprinkled Monday and over the weekend, providing rainfall just when things were beginning to dry out, said county agents. Most of the area received 1-2 inches of rain Sunday and Monday, said the National Weather Service.

"We were approaching the critical stage for cotton said moisture, NWS meteorological technician Jerry English on Monday. "We got the rain we need at just the right time.'

But in the Midwest and Tennessee Valley, suffering the nation's worst drought since the Dust Bowl, fields of corn, grain and soybeans are disaster areas due to lack of rainfall and high temperatures.

"The way these commodity prices have gone up on corn and soybeans, if you're going to have something to sell, it looks pretty promising right now," said Bob Benson, Hale County Extension Agent.

Although county extension agents said anything could happen between now and the fall harvest, the corn and soybean crops are thriving at the same pace as prices.

In the past month, corn prices have doubled from \$1.70-\$1.85 in May to \$3.52½ a bushel, for July delivery, at Monday's closing on the Chicago Board of Trade. Soybeans closed at \$10.59 a bushel for July delivery. Wheat prices, which hit \$4 a bushel Monday, are up about \$1 from last year's level.

The healthy progress of the sugar beet and feed corn crops in Deaf Smith County has sparked keen interest in agricultural marketing firms, said county agent Dennis Newton, with marketing representatives calling frequently to check conditions.

"It's a shame that somebody else has to suffer before someone. else makes a crop," said Benson. 'A few years ago we were in a drought and the Midwest was laughing off with good prices. But that's just the cold, hard facts of farming.

One group of Panhandle farmers wasn't able to capitalize on higher, drought-driven prices.

With harvesting about 80 percent completed, wheat yields are down by almost half on dryland crops due to disease and dry conditions in the early spring.

The updated document would be drawn in closer consultation with the Vatican and acceptable to the entire conference, church leaders said after a closed session at St. John's University.

'The division among ourselves, the teachers, is reflected among the people,' said a statement released by Cardinal Joseph Bernardin of Chicago, who made the motion for the new paper. "We cannot allow it to continue festering. Our unity must be restored so we can get on with our business."
