Meese report issued

WASHINGTON (AP) - Independent counsel James McKay concluded in a report released today that Attorney General Edwin Meese III probably willfully filed a false income tax return, failed to pay taxes on time and broke a criminal conflict-of-interest law. But McKay said he had decided not to seek criminal charges against the attorney general because "there is no evidence that Mr. Meese acted from motivation for personal gain... There is no evidence that he acted out of self-interest."

In an 814-page report, McKay said Meese's 1985 tax return did not declare some capital gains from the sale of securities and that Meese did not pay income tax on his capital gains from those sales when he filed the return.

"A trier of fact would probably conclude beyond a reasonable doubt that Mr. Meese violated" a section of the Internal Revenue Code by filing "a materially false tax return," said McKay, who added that Meese probably also violated a section of the Internal Revenue Code for "willfully failing to pay tax at the time required by law."

Meese also probably violated a criminal conflict-of-interest law in connection with his holdings of \$14,000 in regional Bell telephone stock, but the independent counsel who investigated Meese for 14 months disclosed today that he had decided not to prosecute the case.

WINSTON-SALEM, N.C. (AP) - A man went on a shooting spree with a highpowered rifle and .38-caliber pistol in a residential neighborhood near Winston-Salem, killing four people and wounding six, authorities said.

The gunman later was shot and wounded by police and was in custody, authorities said.

"We're still trying to figure it out," said Capt. Bill McGuirt of the Forsyth County Sheriff's Department. "All of our people are down there now.

The shooting apparently occurred late Sunday night, officials said.

Resolution fights highway fund use

Scurry County commissioners Monday passed a resolution discouraging the state legislature's possible diversion of highway trust funds for uses other than highway construction.

The resolution also urges support for a proposed constitutional amendment sponsored by the Texas Good Roads Association that would prohibit such diversions.

County Judge Bobby Goodwin reported on a Good Roads Association meeting in Austin last week at which State Rep. Stan Schlueter of Killeen, chairman of the House Ways and Means Committee, said the Legislature is likely to divert the highways funds to ease the state's budgetary problems if the amendment is not approved.

The Legislature would then probably have to raise taxes to finance highway construction projects and would "blame it on the highway department, 'Goodwin said.

He noted that the 9-cent federal fuel tax funnels \$800 million annually into the state highway trust fund.

Other business in the 10 a.m. meeting included County Treasurer Billy Wayne Thompson's quarterly report, in which he said the county earned \$71,674 from its money market investments and \$8,790 from its Super NOW funds during the second quarter.



Treasurer Ann Richards, the keynote speaker for the Democratic National Convention, says she learned how to act like a good ol' boy from the best ol' boy she knew — her father.

After he apologized to the University of Minnesota regents, they gave him a unanimous vote of confidence. North Dakota State since has asked him to renew his application for the presidency.

Sauer's troubles were followed by the athletic department coming under further investigation. Luther Darville, former acting director of the school's Office of Minority and Special Student Affairs, was indicted in May on three counts of felony theft by swindle.

Darville has fled to his native Bahamas and authorities have started extradition proceedings.

University officials acknowledge that the turnover among top personnel has caused problems, but they say the school is running more smoothly than might be expected.

'I think the fact is that the university is being well-governed by the interim people," said University of Minnesota Board of Regents.

David Merkowitz, spokesman for the American Council on Education, said he couldn't recall any other university having so many problems recently.

Still, Merkowitz said, "I am absolutely sure a university like Minnesota with 45,000 students is going to survive these things."

Presentation of the 289-page study to the U.S. Commission on Civil Rights, which had ordered it, prompted concern over its impact. One commissioner, Mary Frances Berry of the University of Pennsylvania, said it might lead to more discrimination when the public realizes how much more Asians are earning.

Six of the seven commissioners voted Friday to hold off on adopting the document as an official government report until more outside experts can review and interpret it.

The study, billed as the first comprehensive look at the incomes of nearly 4 million Asian-American residents, shows that native-born American families with Chinese ancestry earn 50 percent more than families in which both husband and wife are white, and Korean and Japanese families earn 46 percent and 44 the study says. percent more, respectively.

DEAR DR. GOTT: My son-in-law uses the same eating utensils that his dog does. He's a very clean and nice person, but this looks terrible. What can I tell him that would stop this habit?

DEAR READER: If your son-inlaw washes the utensils between uses, I see no health reason why he and his dog shouldn't share plates, knives and forks. If he doesn't wash them, I'd worry about his gastronomical preferences, because dried dogfood is not particularly tasty.

I think that your son-in-law is probably old enough to make his own decisions about hygiene. Why bother yourself about his preferences? If he is good to your daughter, brings home his paycheck, helps put a roof over their heads and doesn't lift his leg on the furniture, what difference does it make that he uses kibbles as snacks? Now, if his dog drinks out of the Waterford crystal or insists on using a linen tablecloth with a full place setting of your grandmother's sterling, you've got a problem.

DEAR DR. GOTT: I'm 76, and, as a young person, was uncomfortable with anyone who had epilepsy. Five years ago I had my first seizure and was treated with Dilantin, although I did not have an EEG until last month. Please tell your readers that epilepsy

is not a mental condition and that people with epilepsy can lead normal lives

DEAR READER: People with epilepsy can certainly lead normal and productive lives. The condition

which is physical, not mental - is readily treatable with anticonvulsant medicine. You are correct in stating that epilepsy is an illness, not an emotional disorder. DEAR READER: You are taking in a tankcar of caffeine that is probably acting as a strong kidney stimulant. In addition, you're consuming a whale of a lot of fluid in your cofee and cola. Cut down to a maximum of two cups of coffee a day, enjoy a soft drink as an occasional snack and see if your daily urine flow diminishes to a more normal level. I think that 48 ounces of caffeine-containing beverages are the reason for your problem.

When responder showed two suits and then removed three no-trump to four spades, he was clearly inviting South to go to slam. South had enough sound values to accept, so he asked for aces and bid six. When dummy came down, declarer could see that the success of the contract rested simply on being able to bring in the spade suit with only one loser. It seemed that East would need to hold the jack of spades for the slam to succeed, so declarer won the opening lead with dummy's jack and led dummy's spade six. When East followed low, declarer inserted the 10, losing to West's jack. Later a spade to the queen forced out East's ace, and South could eventually pick up East's guarded nine. The contract was down only one, but proper play would have won the day.

The correct technique is for South to first lead toward the spade queen in dummy. This succeeds in today's deal because West holds the singleton jack, but it would also work if West held the singleton ace. When the jack appears, declarer can later get to dummy and play East for the nine of spades. That will bring in the trump suit with only one loser, and the slam will make.

WASHINGTON (AP) Drought and heat have riddled much of this year's grain crop, but some conservationists already are worried about 1989 and what might happen if good weather sends farmers flocking into fields to catch up.

Assuming the drought breaks season in 1989, beginning with winter wheat crop, producers touches on an emergency aid

In Movie Theaters

A WORLD APART (PG) This directorial debut for cinematographer Chris Menges ("The Killing Fields") has a beautiful, bracing simplicity. The movie is based on screenwriter Shawn Slovo's actual childhood in '60s South Africa - when she watched her well-heeled white parents suffer the consequences of their anti-apartheid political activism. It is a portrait of heroic resistance in the face of enormous repression, plus a study of the toll taken on a family by that heroism. The film has its conventionally stirring side - its noble, white-liberal sentiments. But it's a haunting portrait of those sentiments, one painted in swift, fluid strokes.

The film's triumph - as with a curious number of other good movies recently - is to filter tumultuous events through the consciousness of a child. The child here is Molly (marvelous newcomer Jodhi May) - an alert, quizzical 13-year-old who is ostracized by her suburban friends. This happens when her father skips the country and her dissident journalist mother, Diana Roth (Barbara Hershey), is arrested under the infamous 90-Day Detention Act.

The movie bristles with menace as the police, led by a deviously humane chief interrogator (David Suchet), work to break down Diana. Meanwhile, on the outside, Molly and her

sisters watch their bourgeois paradise of a life start to disintegrate.

Since we see Diana through Molly's eyes, there is a limit to our understanding of her. Barbara Hershey's superbly flinty performance almost makes up the difference: She gives us a brusque, handsome woman whose idealism can also be seen as a form of selfishness. Diana simply cannot sit back and watch a minority of ruling whites destroy South Africa's black population, even if it means she must neglect her own family. Though it hurts her daughter to realize it, Diana's real family is her country - a family of whites and blacks together. GRADE: * * * 1/2

BULL DURHAM (R) People who go to this movie expecting a salty little baseball romp are in for something of a surprise. Yes, the movie is chockfull of sports lore, locker room antics, and after-hours bawdiness. But it's more than that, too.

Written and directed by Ron Shelton, this picture takes a sneaky pleasure in subverting our expectations. Despite its jock predilections, Shelton's script is literary with a vengeance: When's the last time you heard an athlete in a movie mention that the novels of Susan Sontag are overrated?

That athlete is an aging minorleague catcher (Kevin Costner), who suddenly finds himself confronted with a callow new pitcher (Tim Robbins) who needs some seasoning.



That preserved what little suspense remained in the Democratic script. More to the Jackson point, it preserved the losing candidate's role on the convention stage.

Jackson's platform dissent will be played out on Tuesday. His name will be entered in his losing cause on the roll call for presidential nomination on Wednesday night. He isn't saying yet whether he will have it entered again for the vice presidential nomination on Thursday, but it is almost certain somebody will put his name up against Sen. Lloyd Bentsen of Texas, Dukakis' choice and the certain nominee.

Nonetheless, Jackson says that by the end of convention week, the party will be united.

Dukakis will be in control from tonight's opening gavel. When delegates vote on a major issue, they will vote with Dukakis although his camp can afford to provide conciliatory leeway for victories by the Jackson minority on some points.

Jackson says he isn't after a job, a title or a position. "I seek a partnership, I seek equity, I seek shared responsibility," he said. Later, the black candidate

tried a plantation analogy. "I don't mind working," he said. "I'll go out and pick the voters. I'll go back and bale up some votes. But when I get back to the big house I want to help count the cotton."

Jackson complains that the Democrats have not defined a place "for the progressive wing in the campaign.'

Dukakis could, of course, reply that he is something of a progressive - or at least that some of his best friends are progressives.

Dukakis and his lieutenants have said repeatedly that they want Jackson in the councils of the party and on the campaign for the Democratic ticket. They've said that Jackson's campaign allies will have a role. But they are not about to give away pieces of the political command the Massachusetts governor won in the Democratic presidential primaries.

Dukakis said Sunday that Jackson is an important member of the Democratic team, but added pointedly that he won't be calling the plays. "Every team has to have a quarterback," the Massachusetts governor said.

NICOSIA, Cyprus (AP) - Iran tion from Iraq, which has already be labeled the aggressor before it U.N. resolution calling for an immediate cease-fire in its nearly 8year-old war with Iraq, which has claimed an estimated 1 million lives.

However, Iran also said it will not withdraw its troops from its borders and called on Iranians to prepare to thwart further Iraqi aggression.

The announcement came one day after President Saddam Hussein of Iraq cited his country's recent string of battlefield victories and urged Iran to accept an 'honorable" peace.

In a message to U.N. Secretary General Javier Perez de Cuellar, Iran said it accepts cease-fire Resolution 598 in the "interests of security on the basis of justice," the official Islamic Republic News Agency said.

In a report monitored in Nicosia, the news agency said the **General Command of the Iranian** Armed Forces announced in Tehran that the government was accepting the cease-fire resolution.

"Today new conditions have been created which call for adoption of new stances in order to continue the sacred defense and protect Islam," IRNA said.

"We once again urge the Iranian people to man the war fronts to confront the enemies' aggressive nature and foil their criminal acts," the General Command of the Armed Forces said. "All Muslim combatants deployed on the war fronts are prepared to respond to any aggression and movement of the enemy."

Iran did not say when the cease-fire would go into effect. There was no immediate reac-

The statement said the ceasefire acceptance was part of a strategy of defending the Islamic Revolution that toppled the government of Shah Reza Pahlavi in 1979.



NASA delays decision on removing space shuttle

CAPE CANAVERAL, Fla. (AP) - Discovery's tiny fuel leak has been stopped but not fixed, and officials have decided to test-fire the ship's three main engines before deciding whether to remove the space shuttle from the launch pad for repairs.

While preparing for that crucial July 28 test, engineers will decide if there is a way to fix the difficult-to-reach leak on the pad, whether the leak can be isolated from the fuel system or if it is so insignificant that is does not pose a flight hazard if left as

"By draining and purging the line, engineers have stabilized the leak and feel it is safe to proceed with the flight readiness firing," Chuck Hollinshead, director of public affairs at the Kennedy Space Center, said Sunday.

If Discovery has to be rolled back to a hangar, its planned launch as the first post-Challenger shuttle flight would be delayed up to two months. The flight readiness firing of the three engines already has been

delayed two days, so even if the shuttle stays on the pad, there likely will be a delay of at least a few days of the Sept. 6 launch target date.

The decision Sunday by shuttle managers came after engineers traced the source of the gas leak to a fitting on a line leading to an oxidizer tank that serves a steering engine system.

The steering engines maneuver the shuttle in orbit and are separate from the main propulsion engines that are to be test fired.

The oxidizer tank is deep within an engine compartment and engineers said the leak probably could not be reached without removing the 22-foot-high compartment, a very complex operation never before done on the launch pad.


