WASHINGTON (AP) -Investigators of last month's Delta Air Lines crash in Texas are trying to determine whether several "click" sounds on the jet's cockpit voice recorder are indications the flight crew set the flaps before takeoff.

The Boeing 727 crashed seconds after taking off from the Dallas-Fort Worth airport Aug. 31. Fourteen of the 108 people aboard died as a result of the crash. The investigation has focused on whether a false flap setting may have kept the plane from gaining altitude.

"Before the hurricane got there, they were saying it's just a little storm that would blow over," he said.

Their seven-day vacation turned into a nightmare. Todd and friend Carl Pope, 26, watched satellite dishes, trees, shingles and tin scraps fly through the air from the door of their hotel. Troy Dinger and Derrick Rains, 26, slept through the worst of it.

The water-filled bathtub was the only drinking water they had for the next two days.

After they were ordered out of the hotel, "We were no longer tourists. We were refugees. No one would tell us anything," Todd said.

A cab driver charged \$15 to take them to another hotel oneeighth of a mile away, Rains said, and the hotel manager told them to take only a toothbrush.

"He said we would be allowed to come back the next day, Rains said. When they finally returned, their suitcases had been rifled for valuables. A camera, shoes and watch were missing. Hotel officials dismissed the problem, saying the hurricane could have blown them from the room anyway.

"A hurricane didn't unzip our suitcases, and that's how we found them," Todd said.

Once they got to the airport, they were relieved they hadn't arrived earlier. With 5,000 people crammed into the tiny terminal, it was like a sauna and smelled bad. Some people were so sick they vomited quietly in corners or out in the open. Babies cried as constantly as the drone of flies inside and people who spent the night there gave reports of cockroaches the size of a toddler's foot. It took two days for some to get out.

"We would have gone anywhere just to get out," Rains said.

growth fund will be managed by a board of trustees consisting of four members appointed by the Governor and one member from and elected by the membership of each of the following: The Board of Regents of the University of Texas System; The Board of Regents of the Texas A&M System; The Board of Trustees of the Teacher's Retirement System of Texas; The Board of Trustees of the Employee's Retirement System of Texas; and the State Board of Education. The trustees may set the investment policy of the fund, enter into investment contracts, and take any action necessary for the creation, administration, and protection of the fund. The amendment authorizes the Board of Regents of the University of Texas System and the State Board of Education, in managing the permanent university fund and the permanent school fund, to acquire, exchange, sell, supervise, manage, or retain any kind of investment, including investments in the Texas growth fund. The fund will be phased out after the tenth anniversary of its creation, but the Legislature may create a second growth fund by a two thirds vote of each house.



Senate Joint Resolution 8 proposes a constitutional amendment providing that when the federal government reimburses the state for expenditures of state funds dedicated to acquiring rights-of-way and for constructing, maintaining, and policing public roadways, such federal funds must also be used for

those purposes. The proposed amendment will appear on the ballot as follows:

"The constitutional amendment and/or clarification providing that federal reimbursement of state highway dedicated funds are themselves dedicated for the purpose of acquiring rights-of-way and constructing, maintaining, and policing public roadways."

PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 2 proposes a constitutional amendment to establish an economic stabilization fund in the state treasury. The fund would consist of one half of the unencumbered balance of general revenues at the end of a biennium and three fourths of the difference between the net oil and gas production taxes received in a fiscal year and the net oil and gas production taxes received in the 1987 fiscal year. During any fiscal biennium, the amount in the economic stabilization fund could not exceed 10% of the total deposited in general revenue in the preceding biennium.

The state comptroller and the state treasurer could decide to trans-

general revenue fund to alleviate a temporary cash shortage in general revenue. The legislature could make appropriations from the fund on approval by a three fifths vote of each house to make up the difference between anticipated general revenue and appropriations. On approval of two thirds of the members of each house of the legislature, the legislature could appropriate monies from the fund for any purpose.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment establishing an economic stabilization fund in the state treasury to be used to offset unforeseen shortfalls in revenue."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 5 pro-poses a constitutional amendment that establishes the Texas growth fund. All investments of the Texas growth fund must be directly related to furthering economic growth and employment opportunities in Texas. At least 50 percent of the fund must be invested in equity and/or debt security for the initial construction, expansion, or modernization of business or industrial facilities in Texas. Not more than ten percent of the fund may be invested in venture capital investments. Of the funds available for venture capital investments, not more than 25 percent may be invested unilaterally, and the remaining investments must be matched at least equally by funds from other sources. Are drugs causing excess sweating?

By Peter H. Gott, M.D.

DEAR DR. GOTT: I was on Dyazide. Recently my doctor put me on Tenormin and Zantac. Something is giving me the sweats. Sometimes sweat runs off the end of my hair. My doctor has no answer.

DEAR READER: Neither Tenorata blacking drug for bear disease and hypertension, nor Zantac, an inhibitor of gastric acid production, has been reported to cause excessive sweating. However, you may be experiencing an idiosyncratic reaction to one or the other medicine.

If your sweating began at the time you changed therapy, your doctor should assume that the medicine caused the symptom, even though this possibility is remote. Ask him or her about changing your treatment. For example, a calcium-channel blocker could be a good substitute for Tenormin; another anti-acid might be more tolerable than Zantac. I think that your doctor ought to experiment so that you will be more comfortable. I am sending you a copy of my Health Report "Consumer Tips on Medicine." DEAR DR. GOTT: My daughter, 25, has small hard lumps above her right eye. They are movable, change position and shape. Should she worry?



DEAR READER: Lumps in the eyelid can be caused by cysts, stys, tumors or chalazions. A chalazion is an enlargement of one of the glands in eyelid skin. At onset, it is usually painful and resembles a sty. However, the infection ordinarily subsides, leaving a movable, slow-growing lump on the lid. This can easily be removed by an ophthalmologist. Because the basis of your daughter's eyelid problem is unclear, I think that she should see a doctor for diagnosis. She needn't worry, but medical attention is appropriate.

DEAR DR. GOTT: What happens when a person is strangled or hung?

DEAR READER: In theory, strangulation and hanging are two distinct entities. Strangulation is suffocation caused by pressure on the windpipe that prevents a person from breathing. At the risk of making a macabre distinction, I have read that hanging - when performed properly - instantaneously breaks the neck. Therefore, asphyxiation is not the cause of death. A hangman's knot is specifically designed to exert sudden maximal pressure on the neck bones, thereby causing instant subluxation (dislocation) of the cervical vertebrae. Some experts believe that hanging is a less agonizing way of dying than is strangulation because it is so quick.

While the toxin would not kill the virus that causes acquired immune deficiency syndrome, previous research suggests it might prevent the virus from infecting new cells, Moss said.

American makes belly landing at DF

GRAPEVINE, Texas (AP) -National Transportation Safety Board investigators and ding, an unidentified passenger American Airlines officials today injured an ankle when those inwere studying a damaged Boeing side evacuated American's 727 airliner that slid for nearly one mile on one wheel and its belly after a landing gear failed.

The emergency landing came on Runway 18-L at Dallas-Fort Worth International Airport, the same runway where another Boeing 727 crashed three weeks ago. The crash of Delta Airlines Flight 1141 on Aug. 31 resulted in 14 deaths

One person was injured in Wednesday's emergency lan-Flight 135 on an emergency slide, said American spokesman John Hotard.

The plane, carrying 81 passengers and seven crew members, was due at 9 p.m. CDT from Oklahoma City on a nonstop flight when the pilot could not get one of two main landing gears in the rear of the plane to descend, Hotard said.

The pilot had called the DFW American spokesman tower and put them on alert, saying he might have a problem, said Angel Biasatti, a spokeswoman for the DFW Department of Public Safety. The crew then looked down into a well of the plane and saw that one landing gear was not down and called the tower again to send emergency vehicles to the runway apron.

"He (the pilot) decided to retract the one main landing gear that had extended before and just come in to DFW with the nose landing gear extended," said

Jim Brown.

The pilot circled the airport to expend fuel, then brought the 727 in about 9:40 p.m. CDT.

'The aircraft belly-landed and the foam was immediately applied," Biasetti said.

The plane slid along the runway, heavily scraping its underside, but did not break up or catch fire.

Runway 18-L sustained no serious damage and airport workers cleared it of debris left by the belly landing, Biasatti said.

County attorney planning to seek ouster of Wade

ORANGE, Texas (AP) - There was a buzz at the Orange County eourthouse after county employees learned former Sheriff James Wade had been convicted of nine federal charges including conspiracy to manufacture and sell drugs, but official reaction was. scant.

"We are pleased that the incident is over and the department can now continue with normal routine business," said a prepared statement by Wade's replacement, Sheriff Newton Johnson Jr.

Wade was convicted Wednesday by a jury in Sherman and is being held by U.S. Marshals until a pre-sentencing report can be completed. U.S. District Judge Howell Cobb moved the trial to Sherman after ruling that it was impossible for Wade to be tried fairly in Beau-111010

Orange County Attorney Steve Howard also issued a short statement, saying his office will request Wade be removed permanently from office, citing state law that provides for such action when a county officer is convicted of any felony.

Howard said Wade, who was temporarily removed on charges of official misconduct, cannot finally be removed until he is sentenced.

Then should Wade appeal, the court would decide whether he could hold office pending the case's outcome

One unidentified county employee told the Beaumont Enterprise that she felt Wade's conviction tainted anti-drug efforts with Orange County children.

But she expressed relief the trial was finally over, saying, "In January, we can go in with a new sheriff and go forward.'

Hardin County Sheriff H.R. "Mike" Holzapfel, who first uncovered evidence that led to the FBI investigation of Wade, said Wade's case was a good example of local and federal lawmen working diligently to determine if another cop had gone bad.

'Some people say this puts all sheriffs in a bad light, but if people will go back and look at how this case started, it should send a message to the people that we (law officers) clean up our own business, too," Holzapfel told the Beaumont newspaper


Wade faces penalties of up to 115 years in prison and fines of more than \$4 million.

Prosecutors claimed Wade recruited drug dealers, who then manufactured speed and distributed marijuana using materials stolen from the sheriff department's evidence lockers.

Protestors reported to attack office in Armenian enclave

MOSCÓW (AP) - Radio Moscow said today that protesters attacked a prosecutor's office in widespread ethnic unrest plaguing an Armenian enclave of the southern Soviet Union that officials have sealed off and put under curfew.

The radio also said a strike in the territory had closed schools, transportation and many staterun enterprises. Public gatherings were banned.

In Yerevan, the capital of the neighboring republic of Armenia, soldiers today blocked streets around government and Communist Party buildings and protesters rallied again to demand annexation of the enclave, an editor of the local Tass affiliate said in a telephone interview.

The disputed enclave, Nagorno-Karabakh, is a predominantly Armenian region of mainly Moslem Azerbaijan. Armenians, who are mostly Christian, began pressing in February for its transfer to Armenia.
