
The annual subscription rates will be \$45 for an in-county mailing address, and \$50 for an out-of-county address.

of earth at the site during the groundbreaking ceremonies. The new facilities will accommodate the steadily increasing student population at New Home Independent School District.

The \$18 million bond project, approved by voters in May 2021, includes a new football stadium and 8-lane track, as well as the new elementary campus, on land located just east of the current school facilities, on the north side of FM 211.

The new elementary facility will have approximately 25 classrooms for students in pre-k through fifth grade, a cafeteria, and a multi-use gymnasium.

"The construction phase is estimated at about 16 months, but realistically we are hoping to be able to move in to the new campus for the Spring Semester beginning in January 2024," New Home ISD

Superintendent Shane Fiedler told The News this week.

The new Leopard football stadium, featuring a new 8-lane track around an artificial turf football field, is anticipated to be completed by October of 2023. It will be the first track facilities built for the school district.

New Home ISD is working with BGR Architects and Lee Lewis Construction on the projects.

After the new elementary campus is completed, the current elementary classrooms will be incorporated into the current middle school and high school campuses, to allow for the growth of the student populations at New

Supt. Fiedler has stated that there are multiple factors leading to the growth of the community and school.

"New Home ISD is the only district that borders both Lubbock Cooper and Frenship ISD's. As they continue to grow and Lubbock pushes south, families will continue

the only road that continues past FM 41. In speaking with home developers, this creates a natural funnel towards New Home. The construction of the outer loop in south Lubbock will also direct more construction our way," said Supt. Fiedler.

"Finally, New Home ISD continues to set high marks in terms of student achievement, and families that are moving our direction are looking for a quality education for their children. I believe that we provide this as well as anybody, and I am proud of our accomplishments in the classroom and in extra-curricular events," he added.

The school added portable buildings to accommodate the growing needs of the district, until the new elementary campus is completed.

### Hospital opens new space providing rehab for children

SNYDER - Cogdell Memorial Hospital in Snyder has opened a new space for pediatric clients, offering an array of therapeutic services for children.

Autism Spectrum Disorder (ASD) is diagnosed in about one out of every 54 children. Research shows that early diagnosis of and intervention for autism are likely to have major longterm positive effects on symptoms and later skills.

Early intervention programs can include family training, speech therapy, hearing impairment services, physical therapy and nutrition services.

"When a child gets early intervention they can become more independent with activities of daily life at an early age and they can start communicating their wants and needs," said Jaci Johnson, speech language pathologist. "That affects their ability to participate in school."


City Manager Adam Niolet said the original plan before Silver Layer became involved was to drill three wells and use the American Rescue Plan money for the project.




"Oddly enough, between all three, the burglars took around \$300 in petty cash. That's all they got," Peterson told the Lamesa Press-Reporter.

Autism Spectrum Disorder (ASD) is diagnosed in about one out of every 54 children. Research shows that early diagnosis of and intervention for autism are likely to have major longterm positive effects on symptoms and later skills.

Early intervention programs can include family training, speech therapy, hearing impairment services, physical therapy and nutrition services.

"When a child gets early intervention they can become more independent with activities of daily life at an early age and they can start communicating their wants and needs," said Jaci Johnson, speech language pathologist. "That affects their ability to participate in school."





Fellow SLATON - Scouting is a USDA has issued \$557.5 million in Texas emergency relief program payments

Vilsack recently announced agricultural producers nationwide have already received more than \$4 billion through of the more than \$6 billion projected to be paid through this phase of the program. Eligible producers in Texas have received \$557.5 million in funding to date. The U.S. Department of Agriculture (USDA) mailed out pre-filled applications in late May to producers with crop insurance who suffered losses due to natural disasters in 2020 and 2021. Commodity and specialty crop producers have until July 22 to complete applications.

"Over the course of the past two years, natural disaster signed by the FSA, producers events in Texas have resulted in catastrophic production and property losses for our agricultural producers," said FSA will be sending pre-filled Kelly Adkins, State Executive Director for FSA in Texas. "Although these payments will not make these producers whole, they will help alleviate some of the financial stressors brought on by these severe and devastating weather events." USDA is implementing ERP as a two-phased program, with the first phase utilizing existing claim data to provide relief expediently, and the second phase focusing on ensuring producers not covered by other programs receive assistance. For phase one, USDA used crop insurance and Noninsured Crop Disaster Assistance Program (NAP) claim data. Both ERP and the previously announced Emergency Livestock Relief Program (ELRP) are funded by the Extending Government Funding and Delivering Emergency Assistance Act, President which Biden signed into law in 2021. The law provided \$10 billion to help agricultural producers impacted by wildfires, droughts, hurricanes, winter storms and other eligible disasters except for crops intended for experienced during calendar years 2020 and 2021. Eligible livestock producers received ELRP payments totaling more than \$590 million since the program was rolled out in late March. Livestock producers in Texas have received \$61.2 million in ELRP payments to offset the impacts of extreme ERP phase one payments are drought conditions. **Pre-Filled Applications** eligible crop insurance claims have received pre-filled applications, which included eligibility requirements and payment calculations. Agriculture Secretary Tom Producers who have previously participated in FSA programs likely have these required forms already on file.

ERP provisions allow for the Emergency Relief Program a higher payment percentage (ERP), representing nearly 67% for historically underserved producers, including beginning, limited resource, socially disadvantaged and military veteran producers. To qualify for the higher payment rate, individuals must have a Form CCC-860, Socially Disadvantaged, Limited Resource, Beginning and Veteran Farmer or Rancher Certification on file.

To receive a payment, producers must complete and submit their forms by the July 22 deadline. Once the completed ERP application for payment is submitted to and enrolled in direct deposit should look for their payment within three business days.

used to populate ERP phase one pre-filled applications included claim data on file with USDA's Risk Management Agency (RMA) as of May 2, 2022. At that time, claim data for the Supplemental Coverage Option (SCO), Enhanced Coverage Option (ECO), Stacked Income Protection Plan (STAX), Margin Protection Plan (MP) or Area Risk Protection Insurance (ARPI) were not complete, so crop/units including these coverage options were not included in the pre-filled ERP application form. In late summer 2022, updated claim information will be used to generate a second pre-filled application for those crop/units on file with RMA not included in the first mailing.

ERP covers losses to crops, trees, bushes and vines due to a qualifying natural disaster event in calendar years 2020 and 2021. Eligible crops include all crops for which crop insurance or NAP coverage was available, grazing. Qualifying natural disaster include events wildfires, hurricanes, floods, derechos, excessive heat, winter storms, freeze (including a polar vortex), smoke exposure, excessive moisture, qualifying drought and related conditions.



> Vilsack recently announced agricultural producers nationwide have already received more than \$4 billion through the Emergency Relief Program (ERP), representing nearly 67% of the more than \$6 billion projected to be paid through this phase of the program. Eligible producers in Texas have received \$557.5 million in funding to date. The U.S. Department of Agriculture (USDA) mailed out pre-filled applications in late May to producers with crop insurance who suffered losses due to natural disasters in 2020 and 2021. Commodity and specialty crop producers have until July 22 to complete applications.

"Over the course of the past two years, natural disaster events in Texas have resulted in catastrophic production should look for their payment and property losses for our within three business days. agricultural producers," said FSA will be sending pre-filled

Agriculture Secretary Tom Producers who have previously participated in FSA programs likely have these required forms already on file.

> ERP provisions allow for a higher payment percentage for historically underserved producers, including beginning, limited resource, socially disadvantaged and military veteran producers. To qualify for the higher payment rate, individuals must have a Form CCC-860, Socially Disadvantaged, Limited Resource, Beginning and Veteran Farmer or Rancher Certification on file.

To receive a payment, producers must complete and submit their forms by the July 22 deadline. Once the completed ERP application for payment is submitted to and signed by the FSA, producers enrolled in direct deposit

USDA is implementing ERP as a two-phased program, with the first phase utilizing existing claim data to provide relief expediently, and the second phase focusing on ensuring producers not covered by other programs receive assistance. For phase one, USDA used crop insurance and Noninsured Crop Disaster Assistance Program (NAP) claim data.

Both ERP and the previously announced Emergency Livestock Relief Program (ELRP) are funded by the Extending Government Delivering Emergency Assistance Act,

which President signed into law in 2021. The law provided \$10 billion to help agricultural producers hurricanes, winter storms and other eligible disasters experienced during calendar years 2020 and 2021. Eligible livestock producers received ELRP payments totaling more than \$590 million since the program was rolled out in late March. Livestock producers in Texas have received \$61.2 million in ELRP payments to offset the impacts of extreme drought conditions.

**Pre-Filled Applications** Eligible producers with eligible crop insurance claims have received pre-filled applications, which included eligibility requirements and payment calculations. Producers received a separate application form for each program year in which they experienced an eligible loss.

applications for about 9,000 producers nationwide with NAP coverage in mid-July.

The federal crop insurance data used to populate ERP phase one pre-filled applications included claim data on file with USDA's Risk Management Agency (RMA) as of May 2, 2022. At that time, claim data for the Supplemental Coverage Option (SCO), Enhanced Coverage Option (ECO), Stacked Income Protection Plan (STAX), Margin Protection Plan (MP) or Area Risk Protection Insurance (ARPI) were not complete, so crop/units including these coverage options were not included in the pre-filled ERP application form. In late summer 2022, updated claim information will be used to generate a second pre-filled application for those crop/units on file with RMA not included in the first mailing.

ERP covers losses to crops, Biden trees, bushes and vines due to a qualifying natural disaster event in calendar years 2020 and 2021. Eligible crops include all impacted by wildfires, droughts, crops for which crop insurance or NAP coverage was available, except for crops intended for grazing. Qualifying natural disaster events include wildfires, hurricanes, floods, derechos, excessive heat, winter storms, freeze (including a polar vortex), smoke exposure, excessive moisture, qualifying drought and related conditions.

All producers who receive ERP phase one payments are statutorily required to purchase crop insurance or NAP coverage where crop insurance is not available for the next two available crop years.

Producers should contact their local Service Center if they have questions.



#### Lamesa Jail at maximum capacity

LAMESA - Continuing to seek options for housing an overflow population of county jail inmates, Dawson County officials recently approved yet another contract to house local prisoners elsewhere.

The latest contracts, approved by the Dawson County Commissioners Court at the recommendation of Sheriff Matt Hogg, will allow up to six inmates at a time to be housed in the Martin County Jail at Stanton.

Dawson County will pay \$55 per day for each prisoner housed in the Martin County lockup.

"They're pretty close, and they're handy," County Judge Foy O'Brien said of the Martin County facility.

Earlier this year Dawson County officials agreed to a contract to house local prisoners in Parmer County. Hogg said at the time, however, that Parmer County would be used as an option of last resort because of the distance and the cost. Parmer County is charging \$85 per inmate per day, which is \$30 higher than what any other county is charging for local inmates.

Dawson County has had to house local inmates in various other counties for a number of years because the local jail simply is not large enough to hold all of them.

Rudy Sauseda, chief deputy with the Dawson County Sheriff's Office, said the county jail here had to stop taking any prisoners during the July 4 holiday weekend.

"We had nowhere to send them," he told the commissioners court.

At that time, Hogg said, 46 prisoners were being housed in the Dawson County Jail and another 18-20 local prisoners were in various other county jails.

As of Tuesday (July 12), 41 prisoners were being housed in the Dawson County Jail and 10 in other locations.

Officials had said in April that Dawson County's costs to house prisoners elsewhere could reach close to \$1 million this fiscal year.

County officials several years ago were looking at building a new, larger jail here until it was discovered, after a sharp drop in taxable property values, that the cost of a new jail could put the county dangerously close to the maximum property tax rate allowed by state law.

With the cost of housing inmates elsewhere nearing the annual payments needed to fund construction of a new jail, however, members of the commissioners court have suggested it may be time to again look at building a new jail.

She didn't pick up the banjo until graduating from Colorado College with a degree in art. She was introduced to bluegrass music before dedicating herself to learning the banjo. Her musical talent led her to become the first woman to win the National Banjo in 1996, 1998 and 1999, and Championship in Winfield, chose the title track from her Kansas, and the first person to solo album, "Mama's Hand," win the honor twice - once in as Song of the Year in 1996. 1979 and again in 1981. #### \$16 million in revenue to state LAMESA - The Klondike school district could send close

to \$16 million to the state this coming year as part of Texas' system for funding public education.

That's according to Klondike Superintendent Steve McLaren following action by the school board recently to select one of the various systems for redistributing school tax revenue.

Board members opted to send Klondike's required amount to the state for redistribution to other schools rather than send the money directly to another school.

The state's public school finance system requires that a portion of the tax revenue raised by so-called "propertywealthy" school districts - those with larger-than-average taxable property values - be redistributed to schools with lower-than-average taxable property values.

"It's not set in stone yet, but we figure it's going to be around the \$16-million mark - \$15 or \$16 million," McLren said of the property tax revenue Klondike will be required to send to the state this year.
