# **State Capital Highlights**

# Abbott issues orders targeting Chi-

Gov. Greg Abbott issued three executive orders last week targeting the Chinese government and the Chinese Communist Party, The Dallas Morning News reported

Abbott said the orders were intended to protect Texans of Chinese descent from "harassment and intimidation" by the Chinese Communist Party and government, and to fight threats to state security.

"Texas will not tolerate the harassment or coercion of the more than 250,000 individuals of Chinese descent who legally call Texas home by the Chinese Communist Party or its heinous proxies," Abbott said.

The orders:

- Instruct the Texas Department of Public Safety to establish a hotline for victims and to "target and arrest" operatives in the state working with the Chinese Communist Party and the Chinese government.
- Direct all state agencies, colleges and universities to "harden" their systems against foreign governments. That includes stronger background checks on employees with access to critical infrastructure and banning state agencies from doing business with companies owned wholly or partially by foreign adversary coun-
- Direct the Texas Department of Emergency Management and the Public Utility Commission to create a task force to study vulnerabilities to potential cyberattacks and run simulations of possible responses.

"China has made it clear that they can — and will — target and attack America's critical infrastructure," Abbott said.

#### State plan for \$3 billion to expand broadband approved

The state has won federal approval to move forward with its plan to improve broadband internet access for the estimated 7 million Texas residents who don't have access, The Texas Tribune reported.

The approval came from the National Telecommunications and Information Administration, means the state now has access to about \$3.3 billion in federal funding included in the 2021 Bipartisan Infrastructure Law.

The state has already awarded more than \$1 billion in state and federal funding for broadband investments. Last week, applicants in 15 counties were awarded \$580 million to connect 80,000 locations, according to the Texas Broadband Development Office. "We want to make sure the data being provided to us by the federal government is accurate and up to date," Greg Conte, director of the TBDO, said.

#### More buoy barriers added in Rio Grande

Despite a dramatic decrease in border crossings in recent months, Abbott has ordered expansion of the 1,000 feet of orange buoys in the Rio Grande near Eagle Pass, the Houston Chronicle reported.

"We're not letting up at all; we're continuing our efforts," Abbott said.

The barriers have prompted lawsuits from the federal government, which are tied up in an appeals court.

Monthly border crossings have dropped steadily since March. U.S. Customs and Border Protection data for October indicate that 27,000 migrants were encountered that month in the five Texas sectors of the border with Mexico – fewer than the 44,000 monthly migrants encountered in the final months of the first Trump presidency.

### Newly purchased ranch could be deportee staging area

A Starr County ranch purchased last month by the state has been offered as a staging area for potential mass deportations promised by President-elect Donald Trump, according to The Washington Post. Texas Land Commissioner Dawn Buckingham sent a letter to Trump on Nov. 14 extending the offer.

Tom Homan, former director of the U.S. Immigration and Customs Enforcement agency and Trump's pick to be "border czar," said the incoming administration would "absolutely" use the 1,400-acre parcel of land.

"We absolutely will. When we find somebody — it's a targeted enforcement operation. When they get arrested, they'll be detained," Homan said.

"We feel like this is actually very well-located. The land is very flat there. It's adjacent to major airports. It's also adjacent to a bridge over the river," Buckingham said. "So, if it's helpful, then I would love to partner up with the federal government. And if it's not, then we'll continue to look to ways to be helpful to them."

### Texas still leads nation in job growth

The Lone Star State has again led the nation in job creation over the past 12 months - October 2023 to October 2024 -- adding nearly 275,000 nonfarm jobs during that time pe-

"With the best business climate in the nation and a skilled and growing workforce, Texas is where innovative entrepreneurs and businesses find the freedom and tools needed to succeed," Abbott said.

Coming in second in job creation during that same time frame was California, which added 212,000 jobs, according to the Bureau of Labor Statistics, followed by New York, which added 133,600 jobs.

The state's unemployment rate has changed little in the past year, reported at 4.1% last month, up just twotenths of a percentage point from October 2023.

#### Lawmaker seeks funds to plug wells, cut emissions

A West Texas legislator has introduced bills that would provide millions of dollars to the state to seal abandoned oil and gas wells.

The money would come from taxes being collected from oil and gas companies that now go to schools, highways and the state's "rainy day fund," or savings account.

State Rep. Brooks Landgraf, R-Odessa, is seeking to use the money now going to the rainy-day fund that is collected from those companies. The measure would require approval of the Legislature, governor and voters in a November 2025 amendment election.

So-called orphaned wells have proven to be hazardous, with at least eight erupting with briny water since October 2023. For example, a well blew out last December in Imperial that took more than two months and \$2.5 million to clean up, according to The Tribune.

#### Specialty license plate auction draws big bids

The bidding is over for the My Plates Great Plate Auction 2024, with winners spending more than \$71,000 on 50 different messages that were offered. The most expensive plate was "ACE," which sold for \$20,500, according to the Chronicle. Coming in a distant second was "006," a play of James Bond's 007. It sold for \$9,000.

"BOSSMAN" sold for \$3,600, while REAL and TEX4S each garnered \$2,700. None of those bids compare to the most expensive license plate ever sold in Texas. That was in 2013, when 12THMAN sold for \$115,000.







# National average gas price lowest since 2021

Average gasoline prices in Texas fell 0.4 cents per gallon last week, averaging \$2.59 per gallon, according to GasBuddy's survey of 13,114 stations in Texas. According to GasBuddy price reports, the cheapest station in Texas was priced at \$2.18 while the most expensive was \$3.87 per gallon.

The national average price of gasoline fell 1.4 cents last week, averaging \$3.01 per gallon. The

national average price of diesel declined 1.3 cents last week and stands at \$3.503 per gallon.

"Ahead of Thanksgiving, motorists continue to be teased by the prospect of a \$2.99 per gallon national average, a level now seen in 32 states. But for the last few weeks, the stars just haven't quite aligned," said Patrick De Haan, head of petroleum analysis at GasBuddy.

As Americans prepare to hit the road for Thanksgiving, we're seeing the lowest national average price of gasoline since 2021, with a far better economic picture than when gas prices were last this low," De Haan added.

GasBuddy data is compiled from more than 11 million weekly price reports covering over 150,000 gas stations across the country.

### **Fantastic Black Bean Chili**

#### **Ingredients**

1 tablespoon vegetable oil 1 onion, diced 2 cloves garlic, minced

1 pound ground turkey

3 (15 ounce) cans black beans, undrained 1 (14.5 ounce) can crushed tomatoes

1 ½ tablespoons chili powder 1 tablespoon dried oregano

1 tablespoon dried basil leaves 1 tablespoon red wine vinegar

### **Directions**

Heat oil in a large heavy pot over medium heat. Add onion and garlic; cook and stir until onion has softened and turned translucent, about 5 minutes. Add turkey; cook and stir until browned and crumbly, 5 to 7 minutes. Stir in beans, tomatoes, chili powder, oregano, basil, and vin-

egar. Reduce heat to low, cover, and simmer until flavors are well blended, about 1 hour.

# "...as we also have forgiven our debtors."

Jesus' example in his model prayer in Matthew 6:12 to pray for forgiveness captures the two sides of forgiveness that must be addressed if you will have prayers that pass the ceiling. The first aspect of forgiveness deals with forgiveness from God in the context of those who have been saved and are his children. The second aspect to forgiveness deals with us forgiving others. This is much easier said than done, as hurts can be deep, wrongs done can impact lives for years and years, and our fleshly sense of revenge beckons to hold on to unforgiveness as the just penalty for our retribution when

sinned against.

Forgiving others can be so difficult, yet Jesus mentions in verse 14-15 that holding unforgiveness is a sign of a serious problem, "For if you forgive others their trespasses, your Heavenly Father will also forgive you, but if you do not forgive others their trespasses, neither will your Father forgive your trespasses." Jesus didn't mince words about forgiveness, because those who have been forgiven of their sins through faith in Jesus, are able to forgive others because of the full forgiveness they have received. Ephesians 4:32 echoes this by saying, "Be kind to one another, tender hearted, forgiving one another, as God in Christ forgave you."

Notice the ability to forgive others is because of God's forgiveness of you. When forgiveness is focused on the offender, your rights, or the sin, unforgiveness will remain, but when one's focus is on Christ Jesus and his full forgiveness, then how could you not forgive someone else. Forgiving someone does not cancel out the consequences that sin brings, but biblical forgiveness says that one will no longer dwell on the sin against me, that I will move ahead in light of the forgiveness given, and that this is possible because of God's forgiveness in Christ.



# Amponsah wins 2nd National Championship, Buffs finish fourth

CANYON. Texas - West Texas A&M's William Amponsah remains atop of the Division II cross country mountain as the senior claimed his second straight NCAA Division II Cross Country National Championship on Saturday afternoon at Arcade Creek Cross Country Course in Sacramento, California.

The incorporated areas of the WTX Division are comprised of Amarillo, Lubbock, Dalhart, and Channing (collectively, the "ALDC Cities") and the cities of Abernathy, Amherst, Anton, Big Spring, Bovina, Brownfield, Buffalo Springs Lake, Canyon, Coahoma, Crosbyton, Dimmitt, Earth, Edmonson, Floydada, Forsan, Friona, Fritch, Hale Center, Happy, Hart, Hereford, Idalou, Kress, Lake Tanglewood, Lamesa, Levelland, Littlefield, Lockney, Lorenzo, Los Ybanez, Meadow, Midland, Muleshoe, Nazareth, New Deal, New Home, Odessa, O'Donnell, Olton, Opdyke West, Palisades, Pampa, Panhandle, Petersburg, Plainview, Post, Quitaque, Ralls, Ransom Canyon, Ropesville, Sanford, Seagraves, Seminole, Shallowater, Silverton, Slaton, Smyer, Springlake, Stanton, Sudan, Tahoka, Timbercreek Canyon, Tulia, Turkey, Vega, Wellman, Wilson, Wolfforth (collectively, the "WTX Cities").

The proposed change in rates will affect residential, commercial, industrial, transportation, and public authority customers within all incorporated and unincorporated areas served by the WTX Division, which includes the incorporated ALDC Cities, WTX Cities, the Triangle system, and all unincorporated areas served by the WTX Division. The proposed effective date of the requested rate change is November 29, 2024.

If approved, the proposed rates will increase the annual revenues received from the unincorporated and incorporated areas served by the WTX Division by approximately \$66.1 million, which is a change of 19.95% including gas costs and 31.54% excluding gas costs. Because the proposed changes will increase the Company's total aggregate revenue within the WTX Division by more than 2.5%, the proposed changes, if approved, constitute a "major change" in rates as that term is defined by Tex. Util. Code § 104.101. The proposed rates do not, however, exceed 115% of the average of all rates for similar services within all municipalities served by the Company within the same counties, pursuant to Tex. Util. Code § 104.006.

The Company proposes to implement the rates included in Tables below:

\*Note to Tables 1 through 3 and 5 through 10: The Company is proposing to withdraw its Public Authority tariff and transition customers taking service under this tariff to the Commercial Gas Service tariff at the rates shown above.

\*\* Note to Table 4: The Company proposes to withdraw the Triangle system tariff(s) in effect within the unincorporated areas and the Cities of Lubbock and Hereford. Customers taking service under the Triangle system tariff(s) will move to the Transportation Gas Service tariff or the proposed Rate Schedule-WAT, as applicable. Only three Triangle system customers that have a unique character of service off of the Triangle system are eligible for the proposed, new Rate Schedule – WAT.

In addition to the proposed change in rates and withdrawal of the Public Authority and Triangle system tariff(s), the Company seeks to:

- Obtain a prudence determination on the capital investment made in the existing WTX system between January 1, 2018 and September 30, 2024, as well as the investment made in the Triangle system between April 1, 2019 and September 30, 2024;
- Obtain a Commission determination that the WTX Division has correctly reflected changes to utility rates to account for all the impacts of the lowered federal corporate income tax rate consistent with the Accounting Order issued in Gas Utilities Docket ("GUD") No. 10695;
  Establish new depreciation rates for the WTX Division's plant assets, as well as the plant assets held by Atmos Energy's Shared Services Unit;
- Obtain approval to record Cloud Computing costs as a capital investment recoverable through its annual interim rate adjustment filings made pursuant to Tex. Util. Code \$ 104.301:
- Increase the meals and lodging limitations to levels that have been approved as reasonable by the Commission in recent rate proceedings;
- Adopt a new System Safety & Integrity Rider ("Rider SSI") that will, based on a benchmark established as part of this request, allow the Company to recover or refund to customers, third-party expenses incurred for: (1) inspection activities to confirm that there is no existing cross-bore damage on facilities installed prior to 2016; (2) specific damage prevention activities necessary to install technology to make unlocatable facilities electronically locatable; (3) incremental leak surveying and detection activities conducted by third-party contractors; (4) supervisory activities related to third-party excavation near Atmos Energy facilities; and (5) pipeline integrity testing and records review required by the Pipeline and Hazardous Materials Safety Administration. The pipeline integrity testing and records review costs will capture both activities currently being performed within the legacy WTX system and the Triangle system activities currently being recorded to the SSI regulatory asset as authorized by the Commission in GUD No. 10900;
- Adopt a new Rate Schedule WAT for the WTX Division's unincorporated areas, which will grandfather the service currently being provided to three existing customers with a unique character of service currently receiving transportation service on the Triangle system;
- Adopt a new Rider SUR Surcharges ("Rider SUR"), which will provide for: (1) the recovery of the outstanding interest expense balance related to Winter Storm Uri (2) the recovery of authorized rate case expenses; (3) the refund of uncertain tax provisions, which have historically been referred to as FIN 48; (4) the recovery of the existing SSI regulatory asset balance; (5) the refund of the residual Excess Deferred Income Tax ("EDIT") amortization balance to customers. The Company further proposes to recover Rider SSI amounts under the Rider SUR, if the tariff is approved. The Company further notes that it is proposing areaspecific Rider SUR Surcharges due to timing differences to assist with cost recovery of interest expenses related to Winter Storm Uri and the refund of residual EDIT amortization balance to all unincorporated customers;
- Withdraw the Rate Review Mechanism (RRM) tariff currently in effect in the WTX Cities so that new base rates resulting from the Statement of Intent filing can take effect;
- Adopt updated tariffs reflective of the WTX Division's actual cost of providing service, align operating division nomenclature, update its line extension policy, and clarify the responsibilities of the utility and its customers;
- Identify the specific annual amount of Pension and Other Postemployment Benefits as provided for in Tex. Util. Code § 104.059; and
- Recover all of its reasonable rate case expenses.

In addition to the adoption of the proposed Rider SSI and Rider SUR discussed above, the Company proposes additional tariff changes. In the Company's Gas Sales Service Tariff, the Company proposes to revise its WTX Division Residential, Commercial, Industrial & Transportation rate schedules to reflect the proposed rates and to provide additional clarity regarding the applicability of state and local taxes. The Company also proposes to revise its Industrial & Transportation tariffs to revise and/or emphasize certain terms of service.

The Company also proposes rename its Other Service Charges tariff to Miscellaneous Service Charges to align operating division nomenclature and achieve consistency with the references to Miscellaneous Charges in the gas sales service tariffs. The Company proposes to adopt a definitional section in its tariffs and update the Quality of Service tariff. The proposed Quality of Service tariff revisions include a new construction section and clarify Atmos Energy's line extension policy, as well as the Company's right to access customer premises for operational purposes, including the installation of necessary equipment, as well as what customers' responsibilities are if Company facilities are damaged. The Company has also included language to further clarify billing adjustments. Lastly, the changes describe in more detail the responsibilities of customers for their facilities and equipment and the limitations of responsibility of the Company for loss or damages. Finally, the Company proposes to revise the Rider TAX - Tax Adjustment tariff to clarify the applicability of the Rider and address: (1) the treatment of residual EDIT; (2) the proposed refund of amounts related to the Company's FASB 740-10 FIN 48 Uncertain Tax Positions; and (3) timing issues created by tax rate changes that may be made at the local, state, and federal levels, as well as the implementation of the Corporate Alternative Minimum Tax, which was signed into law in August 2022.



# Five holiday safety tips to prevent fires

# AgriLife Extension encourages families to stay safe throughout holiday celebrations

The holidays bring joy, but unfortunately, they also bring increased risk of fires in homes. Candle, electrical and cooking fires occur the most during the holiday season.

Bryan Davis, Texas A&M AgriLife Extension Service Disaster Assessment and Recovery South Region area chief, Seguin, offers five reminders for families across the state to keep in mind as the holidays progress.

# Tip 1: Be mindful of candles in the home

**Davis** cautions against forgetting to extinguish candles, because it can be an easy Remember mistake. to put them out before you leave the house or go to bed. If needed, he encourages setting a reminder on your phone when you light them, especially if you have forgotten to put them out in the past.

Similarly, keep your candles away from flammable items like curtains and Christmas trees. Use sturdy candle holders with a drip plate for hot wax. Also, keep candles in sight to reduce the chances

of someone knocking them over. Always remember that pets can easily knock over candles.

Replace your candles before they burn all the way down. Never place candles directly on surfaces like mantles, furniture or countertops.

# Tip 2: Use electrical lighting alternatives

Although candles are nice and contribute to a holiday ambiance, they can cause fires. A safer way to light up your home for the holidays is to use battery-operated flameless candles. They provide ambiance and some also produce fragrance.

When putting up lights inside or outside your house, check for damaged or old wiring. This can be a fire hazard, so replace any faulty wires. Using LED lights are also the best option because they generate less heat than filament bulbs.

# Tip 3: Be careful with holiday greenery

While holiday greenery and Christmas trees are a tradition and house fires caused by

them are relatively rare, they do occur. Davis reminds us that real trees can burn extremely rapidly, which increases the danger.

One trick is to pick a tree that is still fresh and to preserve its freshness when you get home.

When shopping for a real tree, two signs of freshness will be a deep green color and that its needles do not shed when you shake its limbs. Once you get home, cut a few inches from the tree's base and submerge it in water to get moisture to the needles. After a few hours, place the tree in

a holder with a water reservoir and check the water level daily.

Be especially mindful of light strands on trees and inspect them for any frays or exposed wiring. When choosing an artificial tree, buy one labeled "fire resistant" to add that layer of fire protection.

# Tip 4: Practice extra caution when cooking

Cooking fires are most common between Thanksgiving and New Year's. Therefore, there is no better time than now to plan for fire prevention. Davis recommends storing a Class

K fire extinguisher in or near the kitchen because it can put out grease fires.

If you're smoking or frying a turkey, make sure your equipment is a safe distance from the house, as you don't want embers to ignite fallen leaves or dry grass. You also don't want an oil fire to catch your deck or garage ceiling on fire. Level, barren ground or a concrete or rock surface can be safer spots to grill, smoke or use a fryer.

Thaw turkeys completely before placing them in a fryer. The key is to avoid adding too

much oil to the pot. If you do, the turkey may cause a spill onto the burner. You also want to lower the turkey in slowly to avoid a splash of oil contacting the burner and then catching fire.

# Tip 5: Learn the fundamentals of fireplace safety

Fireplaces may not get much use in the more southern parts of Texas, however safety should be a priority when using them. Make sure the flume is clear of any debris like soot buildup or bird nests before the first fire. Also, use fire screens to stop embers from escaping. Always make sure the fire is out before going to bed.

Keep trees, decorations and other flammable material a safe distance from them as well.

"It's just a good practice to think about safety as it relates to these seasonal activities," Davis said. "The holidays can be busy and stressful but following these simple tips will help prevent fires. This way, you can enjoy your time with family and friends."
