The War Price and Rationing Board for Haskell county, originally consisting of three members when established early in the war, has been increased to include a board of seven members who will serve on two divisions or "panels." It was announced this week. All members of the board serve without pay. The Board met Friday, July 10 to reorganize and map working plans for the future rationing and price control so that it might be better able to serve the public and carry on the war effort. Names of new members added to the Board, and their assignment in the two branches, were announced at the conclusion of last Friday's meeting. New members are Joe Lowrey, Rule; Edd F. Fouts, Haskell; B. Kupat, Sagerton; and Theodore Jones, Weinert. When first set up, the Board was composed of S. N. Reed, O'Brien, chairman; W. A. Montgomery, Haskell; and W. A. Davis, Rule.

The "Panel System" was adopted by the board, wherein there will be two divisions in the board.

One division or panel taking care of Tire, Car and Miscellaneous Rationing, will meet on Fridays of every week at 9:00 o'clock A. M. This division consists of three members: S. N. Reed, O'Brien, Chairman, Joe Lowrey, Rule and Edd Fouts, Haskell. The other panel will be in charge of Food Rationing and Price Control. Four members make up this panel. They are: W. A. Montgomery, Haskell, Chairman; Bruno Kupat, Sagerton, Theodore Jones, Weinert and W. A. Davis, Rule. This panel will meet on Wednesday morning of every week at 9:00 o'clock.

Every War Price and Rationing Board Member is working without compensation and their sole aim is to help—the Nation to conserve and win the war and help everyone to get a fair share of everything that is rightfully coming to them.

Sugar Rationing Need Not Affect Canning Program

Sugar rationing need not interfere with canning peaches, according to Miss Cathryn Sands, county Home Demonstration Agent, who explained that the small amount of sugar ordinarily used is not needed to keep fruits from spoiling, but the sugar does help to hold a fruit's flavor and color.

Fruits for diabetic diets are commonly canned without sugar. If there is abundant fruit that might go to waste for want of sugar on hand, some may be canned without sugar and sweetened to taste when it is opened, using sugar from the family's current supply. When sugar is omitted, can juicy fruits in their own juices. The less juicy fruits canned without sugar require the addition of water. Use as little water as possible to preserve the natural flavor of the fruit.

Funeral Service Held In Rule Friday for Billy Joe Kevil, 15

Billy Joe Kevil, 15, son of Mr. and Mrs. T. K. Kevil of Rule, was killed late Thursday evening, July 9, when struck by a bolt of lightning as he stood in the shelter of a small two-room out-fitted building on his father's farm several miles southwest of Rule, where he had taken refuge during a thunderstorm.

The youth had been hoeing cotton on the farm, and had gone to the building when the storm came up. The bolt which struck the youth also set fire to the small building, and a neighbor, O. L. Singleton, residing about 100 yards from the house, saw the flames and found the boy dead. He apparently died as the result of the lightning, according to Justice of the Peace John A. Lee and Dr. W. M. Rogers of Rule, who were called to the scene.

Funeral services for the youth were held at the First Baptist Church in Rule Friday afternoon at 4 o'clock, with Rev. C. A. Powell officiating. Interment was in the Rule Cemetery with arrangements in charge of Gauntt Funeral Home, Rule.

That "something about a soldier" which appeals to boys and girls is especially strong when the soldier is father and husband. Vernon, Jr., age 6, shows a preference for the U. S. Army uniform of his father, while Bobby, age 3, wears the sailor suit selected by his mother.

Senator Lemens served in World War I, was an active Legionnaire and reserve officer in the peace period, and is now on duty as assistant adjutant with the tank destroyer command at Camp Hood. As Senator of the Twelfth District he will be granted leave to serve in Austin during the session of the Legislature under War Department rules governing reserve officers holding public office at the time of army induction.

He is asking a promotion to Lieutenant Governor so that he can preside over the Senate. He feels that his fourteen years of continuous legislative service and his military experience and standing especially fit him to direct the Senate in the wartime session ahead. The duties of Lieutenant Governor require no more time in Austin than those of Senator, which he now is.

On The Home Front

Sugar was the topic of the hour on the Home Front in the Southwest this week, and while American shipping braves Axis mines and submarines to bring in more sugar, liberal allowances are being made.

This applies to canning both by housewives and institutions, and a "bonus" is even being allowed with War Ration Stamp No. 7.

The Office of Price Administration is emphatic in denying rumors that actually there is a sugar surplus. Max L. McCullough, region OPA Administrator, describes reports of bulging sugar warehouses as creating a distorted picture of the available sugar supply.

There is a severe shortage of sugar in some of the Eastern states, he said, because sugar is having to be moved by rail from Southern ports, and already jammed transportation facilities are not adequate for this abnormal war time traffic. Many warehouses in the Southwest are taken up by other products that move faster than sugar. Hence the false impression that there is a sugar surplus.

Local rationing boards already have been instructed to allow wholesalers and retailers to increase their sugar inventories. Allowments have been increased to cafes, hotels, boarding houses and institutional users, if the number of meals they are serving has increased.

As a further liberalization of the sugar program, local boards that started out following Department of Agriculture estimates and granted only six pounds per person for city dwellers and nine pounds of sugar yearly to rural residents for canning, have now been told to go ahead and issue certificates to the limit of one pound of sugar for each four quarts of finished fruit, where the circumstances of each individual quantity.

These certificates for home canning sugar still are limited to the circumstances of each individual applicant. The board must weigh such facts as the number of quarts of fruit a family canned last year, how much it has on hand, and how much fruit is available to it for packing this year.

Farmers, too, are to be given extra sugar allowances at the rate of half a pound a week per person for seasonal laborers, such as cotton choppers, grain threshers, corn huskers, and other workers whom a farmer employs and boards in addition to his own family. This extra allotment of sugar is for the period of a seasonal worker's employment only. A farmer may apply to the local War Price and Rationing Board in the county where he lives for such an allotment.

Typewriters Needed
War Production Chairman Donald Nelson has appealed to American business to sell to the government as many old typewriters as can be spared. In a letter to 25,000 of the largest users of typewriters he has pointed out that the Army and Navy need at least 500,000 machines. Less than a third of this number can be had from manufacturers. A typewriter is an essential piece of equipment for every bomber, battleship, aircraft carrier, cruiser, and destroyer.

Used typewriters will be bought by new typewriter dealers and factory representatives serving as agents for the procurement division of the U. S. Treasury Department. The machines should be standard typewriters, made not earlier than January 1, 1935.

Austin — Construction of 24 fenced brooding areas for grouse in the Panhandle has been completed by field biologists, the Game Department announced today.

The areas, located in Wheeler County, are approximately 50 yards square and include excellent grouse, or prairie chicken range. Similar prairie chicken restoration work is being conducted in other Panhandle Counties in an effort to restore the species to relative abundance.

Known to Texans and most other Southwesterners as the prairie chicken the bird really is a grouse, of the sub-species known as the pinnated grouse. It gets this name from the wing-tufted feathers about its neck which are most readily seen during the mating or "booming" season.

The grouse is now protected by law in Texas and may not be molested at any time. Aside from its excellent qualities, as a game bird it also is consistent feeder on insects such as grasshoppers and is thus worth thousands of dollars annually to Panhandle farmers. Its value to farmers as a predator on insects that devour crops was one of the principal factors that led to the prairie chicken restoration program, the Executive Secretary of the Game Department said.

There are two sub-species of grouse or prairie chicken in Texas. Those in the Panhandle are known as the Lesser prairie chicken and occupy a range spread over about 26 Panhandle Counties and extending southward to the lower South Plains adjacent to the New Mexico state line. The other sub-species is found along the Gulf Coast and is known as the Attwater's prairie chicken. Neither of the species is abundant, and in fact face extermination unless restoration work is continued, officials said.

Beaver Orphans Perish

Things like this will happen. A man saw a mother beaver with two young on a ledge below Marshall Ford Dam in Central Texas. The mother fled on being disturbed. The man was relieved of the two tiny beaver by a Game Warden and the animals were placed in a small pen and given food.

Bird Chases Man Off

Nesting prairie chicken hens will scrap hard to keep the nest intact, as a Game Department field biologist can well testify. In the course of making a field survey and census of the chickens in the Panhandle recently the biologist was violently attacked by a nesting hen. The biologist, not the bird, took to cover.

Notes From the Plains

Nesting of mourning doves and bobwhite quail in the Panhandle this year was somewhat later than ordinary due perhaps to temperatures lower than usual and frequent heavy rainfall the last three months, field men of the Game Department report.

Beat At Their Own Game

Prairie chickens, vain creatures try to chase each other off the "booming grounds" when courtship begins in the Spring. But recently a bunch of them got their hands called! A struggling ring-neck pheasant cock showed up while the prairie chickens were calling their mates on a booming ground in Wheeler County. The pheasant chased all the prairie chickens away after a thrilling fight, according to the Game Department biologist in that area. The pheasant is not a native Texas bird. The straggler's appearance in Wheeler County probably was the result of the release of a number of ring-necks in the Canadian River bottoms several years ago.

Possum Statistics
A Game Department survey shows that the annual take of opossums in Texas probably exceeds one million per year. The possum is the State's most numerous fur-bearing animal.



Cables Wife From Australia
Mrs. Rex Packwood of this city received a cablegram Thursday of last week from her husband, Staff Sergeant Rex Packwood, who is with the American expeditionary forces in Australia. In the cable to his wife, Sgt. Packwood stated he was "all right, receiving your letters; keep writing". This was the fourth cablegram received by Mrs. Packwood from her husband during the past five months he has been in Australia, and was warmly welcomed by his relatives here. Sgt. Packwood was in the first contingent of U. S. troops to land in Australia early this year.

Proper Care of Home Appliances Is War Necessity

Mrs. Homemaker, faced with the probability that she soon will be unable to buy new electric appliances is reminded by the West Texas Utilities that her sweeper, iron, food mixer and the like will last longer if kept in good repair.

Even new parts are becoming scarce and harder to get, says H. C. King, WTU local manager. Practically all the factories, which once made household appliances, now have been converted to war production of some kind. For instance, a plant that used to make vacuum sweepers now is making gas masks.

The company, as a means of helping to "keep 'em working", has worked out a plan whereby appliances can be kept in useful condition for the duration.

Regardless of make or where originally purchased, WTU servicemen are prepared to repair electric appliances insofar as new parts are obtainable. This special service is offered only as a convenience to electric users in communities where such repairs are not otherwise available, or the dealer from whom the appliance was originally purchased has discontinued business.

Small appliances, in need of repairs, should be taken to the local office for information about parts and costs while repairs for major appliances in most cases can be made in the home.

"By spending a little now," King said, "you may save a lot—and keep 'em working."

Timely Suggestions On Canning Peaches Given By Home Demonstration Agent

With peaches now coming on the market in large quantities, the following timely suggestions about selection and canning peaches are given by Miss Cathryn Sands, county Home Demonstration Agent.

Peaches are good sources of vitamin A—especially the yellow-fleshed varieties rate excellent in this respect. They also contain vitamin C, vitamin B1 and a little vitamin G.

Good peaches should be fairly firm. This is evident from the appearance of the fruit—or from examining one or two of the lot. It is not good shopping etiquette to pinch every peach. Each pinch means another bruise.

Canned peaches are always a popular favorite. To prepare them for canning, immerse them in boiling water for about one-half minute or until the skins will slip easily, plunge at once into cold water for a few seconds, remove the skins, cut the peaches into halves and discard the pits.

Peaches may be packed raw but a better pack is obtained if they are pre-cooked for a few minutes. Pre-cooking brings out juice which is usually sufficient to cover the fruit. Juice is extracted more readily from sliced peaches than from halves. If peaches are juicy, heat slowly to boiling point, adding sugar to sweeten to taste and to help draw out juice. Be careful not to cook peaches until they are soft.

If of a less juicy variety, a syrup may be prepared and the peaches then may be precooked like juicy fruit, but in the syrup. To make a thin sugar syrup, boil together 5 cups of sugar and 1 gallon of water for about five minutes. Remove any scum on top.

Pack precooked peaches quickly and have glass containers hot before packing. Sliced fruit takes up less jar space. If the fruit is cut in halves, place them pit side down in overlapping layers. Cover

the peaches with boiling hot juice or syrup in which they have been pre-cooked. If necessary, add a little boiling water, since fruit must be covered by liquid.

Adjust caps to partly seal the jars and process pre-cooked peaches in boiling water for 15 minutes. Complete the seal at once when jars are removed from the water bath.

If peaches are packed raw, cover with hot syrup and partly seal the jars. Process in boiling

water for 25 minutes if the peaches are soft, or 35 if they are firm. Complete the seal at once.

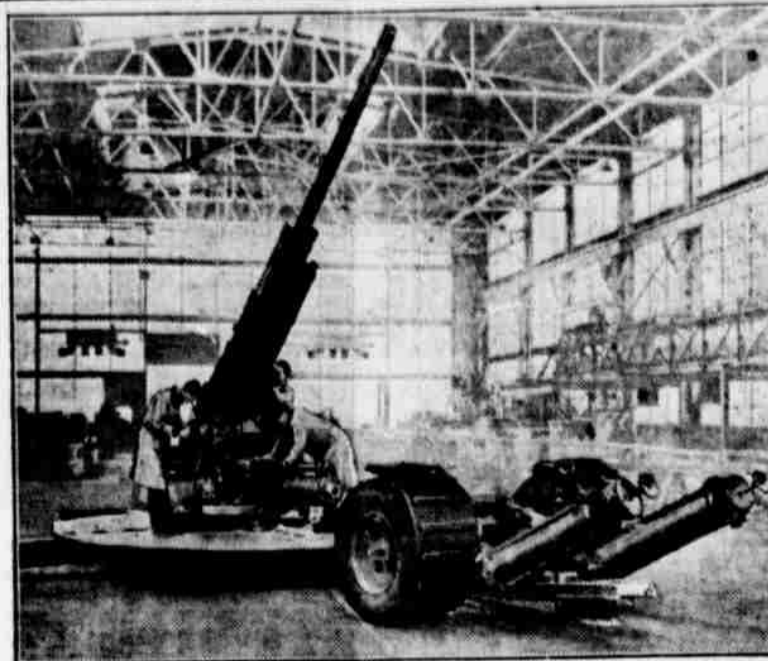

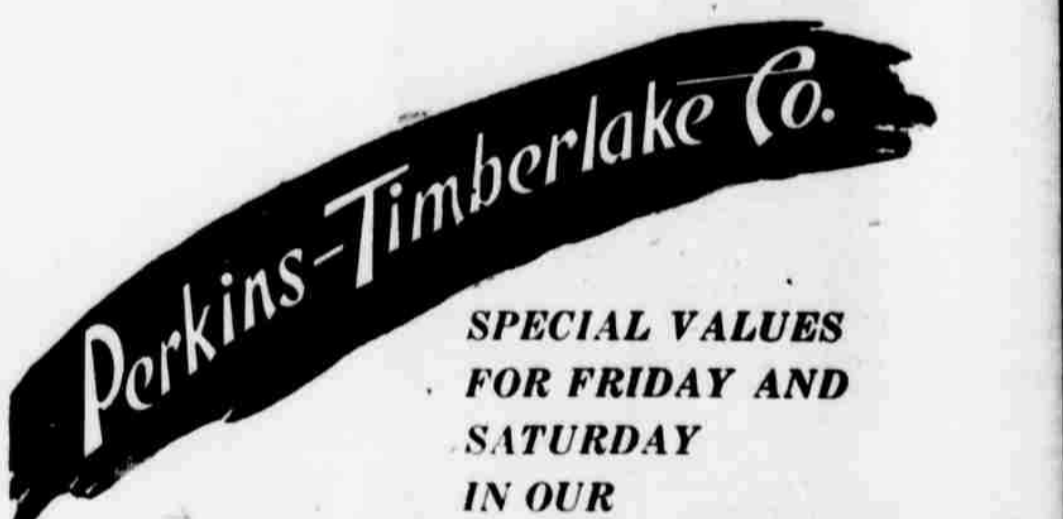
