There are interests who are seeking to promote municipal oil engine ownership and seeking to exploit the nation's present economic and social crisis to advance their own selfish cause. They are captializing on the distress and misfortune of millions of families in order to advance their own interest. Let us get this fact straight. LET US TURN AWAY THE MASK OF PUBLIC WEL-FARE WHICH IS WORN BY THE PROMOTERS OF THIS VEN-TURE. Let us recognize the fact that there is no sanctity about the "municipal ownership" business as such.

There is indeed a most cruel feature connected with such municipal plant promotion which has imposed itself upon a nation's recovery program. It is promises of the many local jobs which never exist. It is the promises of rate reductions and even tax reductions. It is the raising of hopes in the minds of the layman that cannot be fulfilled. In the building of any municipal plant, not more than 5 per cent or 7 per cent of its cost can be expended for local labor. Nearly all of the money that is spent is paid to promoters, supervisors, salesmen, lawyers, and factories far removed from this state and the city of Baird.

#### A TAX-PAYER IN BAIRD

The West Texas Utilities Company and its employees are taxpayers and a part of this community and, as West Texas citizens, are honor bound to do everything in their power to protect our many investor's property, and prevent the scuttling of the city, its customers, and the tax-paying property holders of Baird

its customers, and the tax-paying property holders of Baird. The promoters may bring in much literature, outside paid speakers, as they have done in other locations, with claims that some municipal plant or other has succeeded in one phase of the business or another. They will put on a regular three-ring circus in their strong endeavors to put this promotional deal over. The citizens can remember this: We are part of the community we serve and will continue to be here after the machinery interests have gone and that we will review all such promoters' claims and give further correct information on same. We are in a position to know the true facts regarding the costs of providing modern-day, reliable electric service to the city of Baird and we state to you truthfully that you cannot divide the business in Baird, duplicate the investment, and pay the expenses connected therewith on present rates.

town of Baird. This was on a 50-50 division of the business. To include depreciation expense and assume the oil engine plant could last efficiently for 25 or 30 years would throw such a project far in the red. It would lose many thousands of dollars every year. Rates would have to be raised and this was on a gift from the government with PWA money of 45% and was without the correction of the omission of bad debt losses and a simple mathematical error that was overlooked in checking the operating expenses, both of which were not refuted when called to the attention of the engineer; that is, with twice as much business and with about the same investment as Baird promotional engineer said would be required for Baird, the engineer the city has employed for checking the Moore proposal has already rendered a report to another city disclosing there would be a substantial loss on equal division of the business on rates that are already higher than West Texas Utilities Company rates for towns the size of Baird, and this with a PWA gift of 45%. You may see a photostatic copy of this engineer's report in our office.

# MAJORITY OF CUSTOMERS BACK W. T. U. C.

It has been proven that division of business is slightly less than 50% to the municipal plant and slightly more than 50% of business to West Texas Utilities Company on such municipal competitive plants. It was also found by a survey of municipal plants in the state by the established competent engineering firm of Hawley, Freese and Nichols that the division of business is on a definite 50-50 basis. While only 85 per cent of the customers so far have been contacted and some have indicated they would advise later, yet more than 60% of our customers, who in turn pay more than 75% of the total income from service rendered in Baird, have signed statements and indicated:

#### (1) That they do not desire this company to turn its property over to be operated as a municipal project from the City Hall;

#### WHY "\$160,000" IN BONDS?

You might ask your city attorney or any reliable attorney in the city of Baird if it was necessary to call an election to vote \$160,000 worth of bonds when the project was being promoted as a PWA project, asking the Government for a gift of the taxpayers' money to Baird of 45% of the total cost, leaving \$88,000 in bonds necessary. Any misrepresentation of the total amount of money required for the project to the PWA would be in violation of the PWA Law and Criminal Code Law which reads as follows:

"Section 9 of the Emergency Relief Appropriation Act of 1935, reads as follows:

'Any person who knowingly and with intent to defraud the United States makes any false statement in connection with any application for any project . . or attempts so to do, or assist in so doing, shall be deemed guilty of a misdemeanor and shall be fined not more than \$2,000 or imprisoned not more than one year or both".

Section 35 of the Criminal Code, as amended, provides a penalty of not more than \$10,000 or imprisonment of not more than ten years, or both, for knowingly and wilfully making or causing to be made "any false or fraudulent statements . . or use or cause to be made or used any false . . . account, claim, certificate, affidavit or deposition, knowing the same to contain any fraudulent or fictitiouus statement . . " relating to any matter within the jurisdiction of any governmental department or agency.

Another item which we would like to call to the attention of all fair-minded citizens is the fact that this company paid \$83,-399.10 as a 3% sales tax imposed by the Federal Government for its relief funds. This was collected by the company from residential and commercial electric service last year. This is just one of the taxes. There are numerous other taxes on which it paid out on its business and property in Baird last year \$4,755.45.

# WOULD HAVE TO RAISE TAXES OR RATES

This is verified by the report of Hawley, Freese, and Nichols, who reviewed within three days time the Moore report and established by Mr. Moore's own errors and omissions that such project, even with the gift of government funds, would have to raise rates and-or taxes. This will be verified by the report of any unbiased, non-promotional engineer. It also will be verified even by the checking engineer the Commission has employed to check the Moore report and who, through some kind of arrangement, spent considerable time canvassing our customers with various questions

The reason why we know that the engineer whom the Commission is now using to review the Moore report will have to establish that such a project in Baird could not meet its obligations, and that the City would have to raise electric rates and-or taxes, is that we have secured a photostatic copy (which will be placed on file in our Baird office) of a recent report made up and filed in the PWA office at Fort Worth, August 27, 1938, by the same engineer and his concern for a city in West Texas that has 75% greater population than Baird with double the electric business in Baird.

# BUSINESS DIVIDED ON 50-50 BASIS

His report claimed a profit of \$1,158.54, but HE SAID this was before including depreciation expenses and that it included no reduction of rates, which rates were already higher than those charged by West Texas Utilities Company in the similar sized Jeer about the berg added

- (2) That they do not favor the promotional endeavors being carried on at this time for a competitive municipal plant;
- (3) That if such municipal plant venture were ever established, they would nevertheless continue to take service from this company on equal rates.

In addition to this, you have the privilege of conferring with the firm of Hawley, Freese and Nichols. Mr. Nichols offers to come to Baird for consultation with any individual, committee, or mass group for the discussions of the feasibility of such project as disclosed by the promotional engineer, Mr. Moore's report.

#### SWAP BONDS FOR MACHINERY

One item that has not been covered in our discussions of such a project was the calling of an election for the voting of \$160,-000 worth of bonds that could be put out at 5% interest. It has been called to our attention that the State Laws will not permit discounting of bonds, but they do not prohibit certain machinery interests from bidding in on a trade of their machinery and equipment for such bonds that is, this project could be a machinery interest promotion which would supply machinery and cheap dis\_ tribution facilities to the actual cost or extent of some \$80,000, about that originally estimated in the first night meeting with the promoter. That is, the machinery interest would then secure bonds or warrants on which the city would be bound by law to pay someway or other as much as 5% interest on the \$160,000 face value with the principal payments over the 15 years proposed in the report by the promotional engineer, that is, the one pay-ment alone would require \$15,414.76 per year which alone is more than 50% of the business in Baird and is more money than the City Hall plant could collect on present rates. Where would the operating and depreciation expense come from? It would have to

#### TAX MONEY USED IN COMPETITION

Is it fair to take \$83,399.10 a year from the West Texas Utilities Company as a Federal sales tax, then offer this money back to anyone in any community who might promote a Federal project to duplicate the investment of the company who has paid in such money; and to thus destroy its property and business and hinder its rate reduction program it has carried on for a number of years to the numerous communities it serves, including the community of Baird? The answer rests with you. The way to reduce taxes and electric rates is to cut governmental expenses and extravagance and refrain from creating more debt and obligations. This is just one of the small items of hindrance that has been put in the way of continuing the rate reduction program of the West Texas Utilities Company.



Even though they "listen good", you will find that many such things never exist, and if they do, they are offset by increases in taxes, increases in water rates, and the sum of the three costs more in the so-called successful municipal plant towns without competition than they do in the towns receiving the modern-day electric service from a major system at such rates as are being charged today.

To install a competing plant, and even let it be foreclosed on would by the Constitution of the United States even require the charging of such rates as would not confiscate the investment but would yield a return upon the used and useful investment dedicated to the public service, which would mean rates even higher than the old isolated plant in Baird used to have to charge; that is 60% or more higher than they are today. This con not be successfully refuted.



• The No. 1 taxpayers to the state of Texas are the oil industry and its customers. One dollar of every \$2.00 of taxes in the state is paid by oil; during 1937, the total of gasoline taxes alone was nearly \$48,-000,000.
