### COUNTY TAX RATE CUT TEN PER CENT FOR YEAR

At a recent meeting of the Knox County Commissioner's court the tax rate for the year 1938 was set at 85 cents. This is a reduction of 10 cents from the 1937 rate. The road bond rate for the Knox City precinct was set at 15 cents, a reduction of 5 cents from the rate of last year. Precinct No. 4 gets a reduction of road bond tax of 5 cents. Precinct No. 2 is given a 10 cent rate for road bond purposes, while Precinct No. 3 has no road bonds.

The new tax rate gives the Knox City precinct quite a saving in tax payments. The greatest reduction in recent years is shown in the road tax. In 1934 this precinct had a road bond tax of 60 cents, while the 1938 rate for this purpose will be 15 cents.

#### ABSENTEE BALLOTING TO BEGIN JULY THIRD

Any qualified voter of Knox County, who intends to be absent from the County on July 23 may cast an absentee ballot any time from July 3rd to July 19th inclusive.

You may call at my office and leave your ballot or you may make application to have a ballot sent you to any place out of the County where you may be.

Any one who is physically disabled and cannot go to the voting place may make application to me and have a ballot sent them, which may be voted in their home in the presence of a notary public.

If there is any matter pertaining to the voting of absentee ballots that you may not thoroughly understand, I will be glad to help you in any way that I can.

In as much as some may wish to come to the office and cast their ballots Sunday and Monday, July 3rd and 4th, I will be in the office Sunday morning until 9 o'clock and Monday until noon.

### Stamford Ready For Reunion

STAMFORD, June 30.—Completion of the new grandstand and the enlarged cowboy bunkhouse this week provided facilities for accommodating the largest crowd in history at the Ninth Annual Cowboy Reunion which opens here Monday, July 4, to continue for three days.

The new grandstand increases the seating capacity of the rodeo arena to 15,000 and the doubling of the floor space in the bunkhouse gives more room for the cowboy square dances held there each night and for the meetings of the Texas Cowboy Reunion Association. The association, composed of oldtime cowboys, will elect their officers during the Reunion.

Three Rodeo performances will be held daily, at 8:30 a. m., 2:00 p. m. and 8:00 p. m., each program including cowboy contests in roping, bronc-riding, steer-riding and wild-cow-milking. The cutting-horse contest, originated by the Reunion, will be held on the morning of July 5. A special calf-roping contest for men over 55 years of age is always a popular rodeo feature.

The grand parade, always the high spot of the Reunion, will be held on Tuesday at 11:00 a. m. Governor James V. Allred is expected to lead the procession. Lesser parades of the cowboys and sponsors will be held just before the afternoon rodeo performances on Monday and Wednesday.

The old fiddlers contest, biggest free entertainment of the celebration, will be held at the City Auditorium Wednesday starting at 8:30 a. m. Contestants 50 years of age or over will compete for prizes totaling \$32.50. Breakdown tunes must be used.

Cowgirl sponsors, representing the various towns and cities are coming from greater distances than ever this year. South Pasadena, California, and Tulsa, Oklahoma, are among the cities who are sending sponsors to compete for the prize saddle offered in this event.

### AUTO RACES AT HASKELL SUNDAY AND MONDAY

West Texas will pay tribute to King Gasoline, Sunday afternoon, July 3 and Monday, July 4th on Haskell's 5-8 mile speed way at Fair Park the fastest dirt track in Texas.

Sunday's and Monday's seven events program will get under way at 1:30 with time trials and the first race at 2:30 p. m. The races are sponsored by open competition and any driver who can pass the safety test can enter his car.

The track is in perfect condition and dustless from the application of many tons of calcium chloride and water. The banks have been rebuilt since last year and will give drivers an opportunity to throw caution to the wind with many new records likely to be made.

Heading the list of crack Southwestern drivers is Red Hodges, Dallas, greatest money winner on the S. A. R. A. circuit. He was declared the south western champion for the last three years.

Most prominent among the invading drivers, are Herschel Buchanan, Shreveport and Ken Fowler, member of the Buchanan race team, flashiest speed combination in the country on the dirt tracks.

Besides Red Hodges and Herschel Buchanan, other outstanding drivers competing will include Tex West, Gene Fredrick, Pop Stewart, Possey Reeves, O. Lawrence, Johnny Holland, Carl Mayfield, Waldo Barnett, Truman Brooks, Red Edmonds and others.

The July 3 and 4 auto races will be the only ones that will be held this year at Haskell, so be sure to come early to get a seat. Popular prices will be charged — general admission 50c, children 25c and grandstand 25c.

### Haskell Farmer Kills Himself

HASKELL, June 25.—A verdict of suicide was rendered this afternoon in the death of Jack Sellers, 35, which occurred about 2 o'clock at his farm home nine miles northwest of Haskell. The inquest was conducted by Justice of the Peace Bruce Clift, aided by County Attorney Walter Murchison and Sheriff Giles Kemp.

Sellers killed himself by firing a bullet from a .38 calibre automatic pistol through his heart. The act fulfilled, his wife said, a threat which he had made often in the past several months.

Mrs. Sellers told the officers that her husband repeated his threat early this afternoon. After pleading with him for about 30 minutes, she said she sent one of their children to summon a neighbor. In the meantime Sellers walked from the room, and fired one shot from the pistol. He slumped to the floor of the kitchen, and was dead when she reached him, Mrs. Sellers reported.

The body was taken in charge by Holden Fune, at home and rites were set for Sunday afternoon.

Immediate survivors are his wife, four children, and two brothers, George and E. V. Sellers of Haskell.

The Texas Highway Commission has called for bids, to be received at the July meeting, on 10.2 miles of asphalt surfacing on Highway 16 in Knox County between Benjamin and the north line of the county. With the completion of this section of road, Highway 16 will be paved entirely through the county.

It may be of special interest to the people of the Knox City territory to know that since the surfacing was started on Highway 16 in Knox County in 1935 \$483,494.58 has been spent, or is now under contract, in the completion of the hard surfacing of this road through this county.

Highway 16 is of great importance to this section of the state. The road will soon be paved from the Red River north of Quanah south to the Gulf. This gives Knox City connecting paved road with several of the most important highways of the state.

### W. W. KELLY PROMOTED GENERAL AGENT

Appointment of Warren W. Kelly as general purchasing agent of the Santa Fe System Lines, effective July 1, was announced today by S. T. Bledsoe, President. Kelly succeeds the late John J. Conn.

Prior to his appointment as general purchasing agent, Kelly was chief engineer of the Western Lines of the Santa Fe at Amarillo, Texas. He was born November 20, 1885, and was educated at the Washburn Academy at Washburn College, Topeka, Kansas, and at the Rose Polytechnic Institute, from which latter institution he received the degree of Bachelor of Science in Civil Engineering in 1907.

Kelly first worked for the Santa Fe as chairman during summers from 1903 to 1906, while attending college. He has been continuously in Santa Fe service since September, 1907, advancing successively in various positions in the engineering department until his appointment as chief engineer of the Western Lines at Amarillo in September 1929. He became one of the best known railway engineers in the Southwest on the Pacific Coast.

He is a member of the American Society of Civil Engineers and also the American Railway Engineering Association.

There are several special events in this section that the people may attend, as there will be no celebration in this town. In Haskell the auto races will be in full blast, in fact they open there Sunday and will continue through Monday. In Stamford the ninth annual Cowboy's Reunion will open Monday and will last 3 days. Governor Allred will be there Monday to lead the parade. At Rhinecland there will be a basket picnic and dancing in the afternoon and night and all Knox County and other candidates are invited to attend. No doubt several families from here will spend the day at Lake Kemp fishing. Monday no doubt will be a dull day in Knox City for those who choose to stay at home.

## POLITICS ARE GETTING WARM

The politics is getting warm in this county and by the middle of July it will probably reach a fever heat. ## SENATOR GRADY WOODRUFF

Senator Grady Woodruff of the Decatur district is up again for re-election and has three opponents and a hot campaign is underway in that district. While this editor is not a resident of that district any more we resided there for fourteen years and had occasion to watch Senator Woodruff and worked four months in the Senate during the regular session of the legislature last year.

There is no question about the standing and ability of the Decatur Senator, as he was considered one of the outstanding senators in that body. He was always championing the cause of the common people and little business man, farmer and stockman. He is the author of the anti-race horse bill and waged a fight almost single handed for more than thirty days for its repeal. He was chairman of the Educational committee and secured the passage for all the appropriations for all the state schools and colleges. During the last called session of the legislature Senator Woodruff single handed defeated the Morse bill which permitted the sale of whiskey by the drink, after it had passed the House of Representatives. For two days and nights he spoke on this bill and finally killed it by a filibuster. We are not trying to dictate to the voters of that district whom they should support for State Senator but we do know that the majority of the gamblers and whiskey drinkers are opposed to him for he never votes for any bill that favors them.

Last week a radio across the street was broadcasting a speech of President Roosevelt, who was talking in his most alluring manner. Yet, so far as we could see, there were but three listeners, and they did not stay on the job long. It seems that American people are getting fed up on political speeches, whether under the guise of opening a bridge, dedicating a dam, or what have you. Folks become tired of hearing anyone talk all the time — even over the air waves.
