## Rochester Fire Destroys Four Businesses Thursday

An explosion in Berryman's Service Station and Garage about 2:45 a.m. last Thursday, July 8, started a blaze that completely destroyed four business establishments in Rochester.

Volunteer fire departments from Knox City, Haskell, and Rochester fought the fire for over three hours before bringing it under control about 6:00 a.m. Approximately 40 men were involved in extinguishing the blaze.

C. W. Berryman's Service Station and Garage, Ruby's Beauty Parlor, and a barber shop operated by Claude Norman were a total loss, as was Acree Oil Company owned by Edward K. Acree.

The beauty parlor and barber shop were located in a building owned by Berryman. KC Fire Chief Drew Holcomb reported that the oil drums at the service station exploded and threw flames and debris 130 to 150 feet in the air. Firemen were concerned with other large tanks in the area and kept a steady stream of water on them to keep them from going up.

Berryman estimated his losses at between \$50,000 to \$60,000. Asked if he planned to rebuild, he said "I'll do something, but right now I don't know what I'll have to do something, I've got too many kids to feed."

Acree guessed his losses to be in the vicinity of \$25,000 to \$30,000, but added he was fairly well covered by insurance and would be back in business.

Norman, who lives in Rule, is Rochester's only barber and plans to go back in business. He was uninsured and lost about \$1000 worth of equipment.

Mrs. Ruby Watkins of Knox City lost everything in her beauty shop, but says there is no reason why she can't open another shop as she still has her customers.

Miraculously no one was injured and there was no wind which could have spread the fire through the whole business district and perhaps ignited the petroleum tanks of the wholesale dealer.

## Law Requires Immunization For All Age Group Students

The recent Legislature, in passing Senate Bill 27, has made it mandatory for all school children entering elementary or secondary school to be appropriately immunized against specific diseases.

According to Mrs. Wretha Fitzgerald, school nurse, students in Benjamin, Gililand, Gooee, and Knox City schools will be required to have the following immunizations:

CHILDREN IN KINDERGARTEN AND GRADES ONE THROUGH FIVE - POLIO - At least three doses of oral vaccine, provided one or more doses have been received since the fourth birthday.

DIPHTHERIA/TETANUS - Minimum of three doses, with at least one dose having been received since the fourth birthday. (Usually given as DTP for children less than six years of age, and TD for children six years of age and older.)

MEASLES - One dose of vaccine, or history of measles illness.

RUBELLA - One dose of vaccine. Not required past age 12 years.

SMALLPOX - One vaccination within the past 10 years.

Schools are required to have records for each child and to complete these records by January 1, 1972.

Letters will be sent from the schools for immunizations and boosters that are not up to date.

The offices of Dr. R. G. Howell and Associates will have records of those who received Measles, Rubella and Polio given the past three years at school.

Parents should check with their family doctor if they are not sure what their child needs, Mrs. Fitzgerald said.

RUBELLA - Not required past age 12 years.

SMALLPOX - One vaccination within the past 10 years.

**SS Reports**

Social security benefits were being paid to residents of Knox County at a rate of \$111,000.00 a month at the close of 1970, Wayne Klipping, social security manager in Vernon, said today.

A benefit increase signed into law by President Nixon on March 17 raises the monthly rate of payment by 10 percent for most of the 1.75 Social Security beneficiaries in Knox County, Klipping added. A small number of beneficiaries over age 72 who are not receiving regular social security case benefits received a 5 percent increase.

The increased benefits amounts were made effective back in January 1, 1971. First checks in the new monthly rate reached beneficiaries on June 3, Klipping said.

Of the social security beneficiaries living in Knox County, 944 are retired workers and their dependents. Another 304 are receiving benefits as the survivors of workers who have died, and 96 are getting benefits as disabled workers or their dependents.

**Grass Is Nature's Pollution Control**

Grass is one of the most effective pollution control and air conditioning devices that nature has to offer.

"One acre of grass releases about 2,400 gallons of water on a summer day through evaporation and transpiration," according to Arche Leib, head of the U. S. Department of Agriculture's Soil Conservation Service office in Knox City.

"This much evaporation equals the cooling effect of a 70-ton air conditioner," Leib continued. "And grass is ideal for erosion control, beautification, and animal forage."

Leib said grasses vary widely within individual species. There may be dozens of strains of side-oats grama, for example, growing within an area of only a few counties. These variations are caused by differences in climate, soils, elevation and other factors.

SCS conducts a constant search for superior strains of grasses and other plants, Leib said.

"What we're looking for are strains of grasses that will help solve some specific environmental problems," Leib explained. "In Texas, we need grasses that will thrive on several droughty soils; cool season plants that will extend the grazing season; and plants that will provide forage for livestock while also providing better food and cover for more kinds of wildlife."

Leib added that conservationists also need salt tolerant grasses that will grow on a wide variety of problem sites, forbs and woody plants useful to wildlife and livestock that can be planted in range seeding mixtures, and water-tolerant plants that will curb wave action on earthen dams.

To help coordinate the search for better plants, SCS operates 20 plant materials centers in the United States. One is located in Texas at Knox City. Scientists at these centers grow and evaluate plants from all over the world to help find strains that will solve specific problems.

The most recent grass selected and put into use by SCS plant materials work in Texas is Selection 75 Kleingrass. Released in 1965, the plant is a leafy, highly palatable grass that is now being grown widely in Central Texas. It is used mostly in tame pastures where high rates of fertilizer are used.

Kleingrass is being grown successfully on several farms in Knox County. One of these is the J. E. Hunter farm located between Knox City and Munday.

**TOP COTTON YIELDS**  
"Better cotton yields for profits and markets" in 1971 is the theme for an all out Belt-wide campaign to aid the cotton industry.

Fred C. Elliot, Extension cotton specialist, said the objective is to increase cotton yields to the maximum profitable level, using recommended practices for each producing area to increase producer income. In view of the present situation, he added, a major goal is to stabilize the current competitive position of the fiber crop and build a base for market expansion.

Elliott noted for five consecutive years, more cotton has been sold than produced and it now appears the carryover by the end of July will be no more than four and a quarter to four and a half million bales, the lowest in 20 years. The same situation exists worldwide, he said.

Although no ruinous shortage has yet developed, the uncertainty about next season's supply has already affected the cotton market, he said. Some mills, he noted, because of the uncertainty of adequate supplies of cotton, are shifting to blends rather than continuing to use 100 per cent cotton despite the strong demand for all-cotton fabrics. This shift is being made to conserve cotton supplies.

The strong demand for denims, corduroys, print-cloths and cotton knits over the last year or so has caused a turnaround in the outlook for cotton and we cannot afford to lose the gains made, emphasized Elliott. The strong demand affords a real opportunity for grower profit.

Since cotton is now planted, the increase in production must come from better management, including insect and weed control, cultural practices, wise use of irrigation and improved harvesting methods, the specialist said. Too, he noted, ground-soaking general rains over the state would give a real boost to cotton production prospects.

The Golden Anniversary Conference of the Texas Pecan Growers Association will be held in Austin, July 19-21, 1971. Conference headquarters will be at the Sheraton Crest Inn.

The Texas State Pecan Show will be judged and opened to the public by 1:00 p.m., Monday, July 19. Many new types of harvesters, sprayers and processing equipment will be on display.

Newly elected President Jack Williams of Texas A&M University will be the featured speaker Tuesday morning.

Pecan marketing, trickle irrigation, pruning, shuck disease and several other subjects will be topics discussed during the conference.

**Beef Cattle Shortcourse**

Texas A & M University will host its 21st Annual Beef Cattle Short Course August 16-17 at the Memorial Student Center on the Texas A & M Campus. The theme for the program is "Improving Reproductive Efficiency in Beef Cattle." Information will feature subjects on breeding heifers, feeding programs for breeding animals and calving difficulties. Reports on studies in calving and calf performance in exotic cattle will also be made.

**Screwworm Situation**

The first screwworm case ever to be recorded in Arkansas was confirmed June 29 from a larvae sample collected in Miller County, near Texarkana on the Texas-Arkansas line. Just across the line in Texas, Bowie County had its second case of screwworms confirmed within a week on July 1. A team of state and federal livestock inspectors is collecting samples and spraying herds in the areas with infestations. Officials of the eradication program urge stockmen to send a sample of any worms found in animal wounds to the Mission Lab for positive identification.


