## Hunting and Fishing Day To Be Observed Locally

At a breakfast meeting called Tuesday morning at City Cafe, Chamber of Commerce president J.B. Tabor reported on progress being made on plans for a Hunting and Fishing Day in Knox City.

The Knox City Hunting and Fishing Day, set for Saturday, September 22, will coincide with National Hunting and Fishing Day, and will be held at the Brazos Valley Recreation Association's arena on the O'Brien highway.

Exhibits, showing the contributions of America's hunters and anglers to recreation, and conservation, and their effect on the economy of a community, will be placed at intervals around the outside of the arena.

The inside of the arena will be used for demonstrations, exhibitions, shows, and contests arranged by participating clubs and agencies.

Clubs and agencies participating in Hunting and Fishing Day activities include the Bassmasters Club, Knox City Gun Club, Boy Scouts, Future Farmers of America, Soil Conservation Service, Texas Parks and Wildlife, and the 4-H Club.

The Bassmasters are sponsoring a casting contest for children, with the Chamber of Commerce providing a trophy for the winner. The club will also place a tank in the arena for an exhibition on the proper use of lures.

The Gun Club plans a trap shooting exhibition, and a hunting dog show in the arena.

The Chamber of Commerce will provide a trophy for the winner of the BB gun marksmanship contest being staged by the Boy Scouts.

The 4-H Club will give a demonstration of gun safety procedures inside the arena.

Tickets for prizes being given in connection with Fishing and Hunting Day are available and can be purchased from Mr. Tabor, Mrs. Doris Crowner, or from members of the Cham-

## Ranch Proposal Explained

Lubbock County during the preceding two year period, and that by 1975, a 20% increase in the number of neglected boys is anticipated.

These children needed to be provided with a Christian home, without fences or barriers, until they finish high school, master a trade, or until their home situation becomes such that they could return. They needed a home with firm supervision and control, tempered with love, understanding and guidance.

The group chose the idea of a ranch home for these boys, as it has been proven that dealing with animals provides the most successful means of rehabilitation for youngsters with unhappy backgrounds. Moffitt explained that children can be reached many times through their love for an animal when other means have failed.

Texas Boys Ranch was formally organized in January 1973. It adopted as its motto, "Believing in Boys Today for the Men of Tomorrow."

Moffitt told the group at the Courthouse that Benjamin was an ideal location for a Boys Ranch. The board hopes to establish five facilities in the state, and land has already been donated at Lubbock and Brownwood. Building of the Lubbock

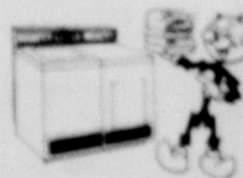

# CEMETERY (From Page One)

The Endowment for the perpetual care of a grave site may be used only for the purchase of Government bonds, or other securities approved for investment of Trust funds in the State of Texas. The money paid for endowing a lot can never be used for any purpose other than the investment in the bonds described above and must be held perpetually for that purpose, it was explained.

The interest from these bonds provides the funds for the care of the grave site, such as mowing, hoeing, and general maintenance. These proceeds may not be used for any purpose other than the care of the grave site. If there is any excess interest, it is to be used to maintain streets and alleys around the grave site.

No further dues are to be paid for the care of the endowed lots as the interest from the money invested in bonds will provide the funds for this care. The funds from the interest will annually be paid to the Knox City Cemetery Association for this purpose by the Endowment Trust.

The Knox City Cemetery Association, which had been active at various times in the past, was reorganized in 1969. The present chairman of the association is Mrs. Oleta Fitzgerald, and the secretary-treasurer is Mrs. Faye Rallsback.

In order to answer the numerous inquiries regarding grave site locations, the city, assisted by the Cemetery Association, began mapping the cemetery in mid 1971. This mapping was completed in 1972, with Mrs. Fitzgerald mapping the east half of the cemetery, and Mrs. Gloria Webb mapping the west half of the cemetery. Mapping is kept current as burials occur, and as information regarding unmarked graves becomes available.

A map mounted on an easel located in City Hall is maintained by the city, which also has a folding map that can be carried to the cemetery for updating.

The city also has established and maintains an extensive cross filing system on the grave sites at the Knox City Cemetery. An alphabetical index gives the full name of the person buried, the block number of the grave site, whether or not the person was a veteran, and whether or not the grave site is in perpetual care.

The numerical index card gives the names of all persons buried in each block, their veteran status, and whether or not the grave sites are in perpetual care.

At the time of reorganization, Mrs. Fitzgerald compiled a list of names and addresses on present block owners and provided leads on others. Questionnaires were sent out in late 1971 to those responsible for plots.

The answers received from the questionnaires provided much valuable information, and confirmed much previously recorded information. Many colorful stories of Knox City's early history came to light. Members and officers spent many hours sending these inquiries, following up on information received, and assembling data.

In an affidavit on file with the city, it is stated that the land for the cemetery was given by the Williamsons to the Oddfellows Grand Lodge of Knox City. This group disbanded in the 1930s and by its request the cemetery was turned over to the city to be maintained as city property.

The oldest known grave site in the Knox City Cemetery is that of a child, Ola May House, who died in 1893. She was the daughter of J.T. and Lula House, and was a sister of Wade House of Benjamin. Her grave is in the far southeast corner of the cemetery.

The grave of another child, Tessa Senter, is the next oldest known grave site. It is also located in the far southeast corner of the cemetery. No information has been obtained about this child, other than her name and the date of her death, in 1894, listed on her grave marker.

As with Tessa Senter, little or nothing is known about some of the graves in the Knox City Cemetery. Further information on unmarked graves or any possibly unmarked graves would be appreciated, Mrs. Rallsback said. Anyone having this type information is asked to contact Mrs. Rallsback at City Hall.

Allotments To Triple

# 1974 Wheat Program Details Are Announced

Texas wheat producers' allotments for 1974 will be about three times the size of their 1973 allotments, according to Jerry May, County Executive Director of the Knox County Agricultural Stabilization and Conservation Service Office in Knox City, Texas.

The 1974 allotments will be based on the national allotment of 55.0 million acres, announced August 16 by Secretary of Agriculture Earl L. Butz, and that individual allotment notices will be mailed to farmers in a few days.

The allotment represents the number of harvested acres of wheat, based on the estimated average yield, which would result in production equal to estimated domestic and export disappearance of the 1974-75 marketing year. The allotment does not restrict the amount of wheat that can be planted on the farm.

Secretary Butz announced the 1974 wheat program shortly after the four-year Agriculture and Consumer Protection Act of 1973 was signed into law. The Secretary said the program is designed to encourage all-out production.

Listed below are major details of the 1974 Wheat Program:

1. New to the wheat program is the target price feature. If the average market price for wheat is at or above the \$2.05 per bushel target price, the producer will receive no payment. If the price average is below the target, the producer will receive the difference between the target price and the average price received by all farmers during the period from July through November, 1974.

2. There will be no preliminary payment. Any payment due will be paid after December

1, 1974. If the five-month average price falls below the \$2.05 target, the producer would be paid on an amount of bushels determined by multiplying the farm allotment times the projected yield established for the farm by the ASC County Committee.

## Three Accidents Occur In County

The Texas Highway Patrol investigated three accidents on rural highways in Knox County during the month of July, according to Sergeant J.W. Garner, Highway Patrol supervisor of this area.

These crashes resulted in no persons killed and four persons injured.

The rural traffic accident summary for this county during the first six months of 1973 shows a total of 40 accidents resulting in one person killed and 17 persons injured.

The rural traffic accident summary for the 90 counties of the Lubbock Department of Public Safety Region for July, 1973, shows a total of 658 accidents resulting in 21 persons killed and 366 persons injured as compared to July, 1972, with 713 accidents resulting in 34 persons killed and 388 persons injured. This was 55 less accidents, 13 less fatalities, and 22 less injured in 1973 at the same period of time.

The 21 traffic deaths of the month of July, 1973 occurred in the following counties: Lubbock, Sherman, Wilbarger, three each; Palo Pinto, Parmer, two each; Hockley, Jack, Lamb, Parker, Wise, Hutchinson, Potter, and Oldham, one each.

facility will begin in six to eight months. It may be as long as two years before a ranch could be established at Benjamin, Moffitt said.

Texas Boys Ranch is non-denominational but requires that each boy attend the church of his choice regularly, and take part in its activities.

The boys will be enrolled in public schools, and in order not to overload a school system, no more than 100 boys will ever be located at one facility. The boys will be encouraged to participate in all school programs.

Moffitt also explained that a boy must be approved before being allowed to date.

Each boy would be required to take part in the normal ranch work as well as doing his share in caring for his living quarters. Each boy would receive an allowance.

Only ten boys will be assigned to a ranch initially. They will live in a cottage with house parents. All house fathers will work on the ranch and should have some vocational skills in ranching.

The board of Texas Boys Ranch will hire a ranch administrator who in turn will hire the ranch staff, including house parents for each cottage, and any other necessary personnel.

The meeting concluded with a question and answer period. It was decided to have another meeting for further discussion at a later date.

Other Boys Ranch officials attending the Benjamin meeting were Pat Mathis, secretary of the board; Roy Johnson, and Sax Moore. Accompanying the group to Benjamin were Mrs. James Moffitt, Anderson, Mathis, and Johnson.

3. As announced earlier, there will be no set-aside requirement for 1974 and there will be no conserving base requirements for the four-year life of the 1973 Act. This provision applies also to Feed Grains and Cotton.

4. For 1974, producers may substitute any annual non-conserving crop or a cropland conserving crop used for haying or grazing in order to preserve their wheat allotments and to make them eligible for any payments under the target price feature of the Wheat Program. Crops for which a marketing quota is in effect (such as peanuts) are, of course, excluded.

5. Loans will be available to producers on their 1974 crop wheat at a national average of \$1.37 per bushel, which is an increase of 12 cents over 1973 crop loans.

6. The requirement that processors purchase certificates valued at 75 cents per bushel on each bushel of wheat processed for human consumption has been eliminated by the 1973 Act.

Mr. May stated that he hoped that the entire Act would soon be available in the county office for release to farmers. As soon as this information is received it will be released to the public.

### Yellow Houses Only

Developers of a new suburban neighborhood thought it would look nice if all the houses were painted yellow. Accordingly, in selling lots, they included a "yellow only" requirement in each deed.

But after a number of homes had gone up, one incoming family decided they liked green better. The developers refused to allow any deviation, and, in due course, the dispute landed in the courtroom.

"This kind of restriction," the family argued, "is an unlawful interference with our personal liberty. We have a right to follow our own tastes."



However, the court held they would have to stay with yellow whether they liked it or not. The court said the requirement was a reasonable means to a reasonable end—to benefit the community as a whole.

It is common, in developing a neighborhood, to impose deed restrictions of one kind or another. They may cover anything from the size of houses to the height of hedges, from the style of architecture to the type of fencing. And, by and large, the law will enforce these restrictions. Although they reduce the rights of the purchaser, they do so on the basis of a lawful contract, freely entered into, at the time of original sale.

True, some restrictions may be unenforceable for reasons of overriding public policy. The leading example is the racial restriction, now outlawed everywhere.

Furthermore, a restriction valid at first may gradually lose its validity as the neighborhood changes. Say a dozen home owners in the "yellow only" neighborhood had been allowed to get away with different colors. At that point, even if the developers suddenly decided to crack down, a court would probably refuse to enforce the restriction. As one judge put it: "Restrictions will not be enforced where the character of the neighborhood has so changed as to defeat the original purpose of the plan."

## Insurance Companies Must Include New PIP Coverage

The new Personal Injury Protection (PIP) insurance went into effect for Texas motorists Monday, August 27, under provisions of a new law passed by the 53rd Texas Legislature.

PIP provides additional coverage on automobile insurance policies for medical expenses and wage losses due to personal injury up to \$2,500 each for driver and passenger and also will be available in \$5,000 and \$10,000 increments. The coverage provides payments from the insured's own insurance company for these medical expenses and loss of income resulting

from automobile accidents. While the Texas insurance code requires that PIP be included as part of all automobile insurance policies, the policy owner can reject the new coverage by signing a form which his agent must send to him, and then returning the form to the agent. Even though the new coverage can be rejected now, it can be added at a later date.

More than likely present policies provide for medical payments in the event that medical treatment is required because of an automobile accident. If so, the new PIP policy costs very little more while providing broader coverage. A \$2,500 policy will cost for personal injury \$22 a year and medical payments \$15 a year; a \$5,000 policy, \$32 and \$17; a \$10,000 policy, \$44 and \$22. (These rates apply to one car used for pleasure or driven to and from work, with no male operator under 25 years or unmarried female under 21 years of age.)

## OEO Grant Announced For Area

Governor Dolph Briscoe announced Friday approval of a \$6,232 Office of Economic Opportunity grant to Aspermont-Small Business Development Center, Inc. for providing economic development assistance to 17 rural counties.

Funded under Title II of the Economic Opportunity Act, the grant is effective Oct. 1, 1973, through Nov. 30, 1973.

Governor Briscoe said the grant will enable the agency to provide economic development assistance to small business projects in 17 rural counties. Counties included are Donley, Briscoe, Hall, Childress, Motley, Cottle, Foard, Hardeman, Wilbarger, Knox, King, Haskell, Jones, Fisher, Kerr, Dickens and Stonewall. Projects in other counties are assisted upon request by the Small Business Administration in Lubbock.

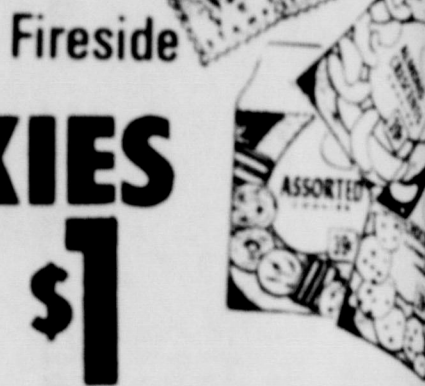

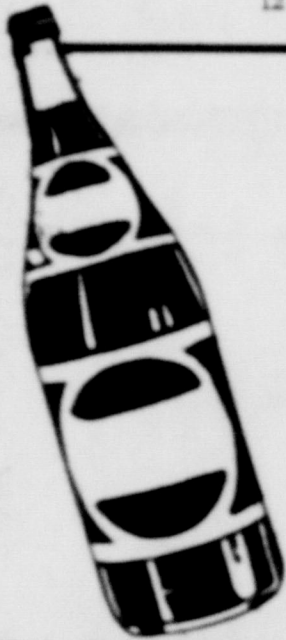

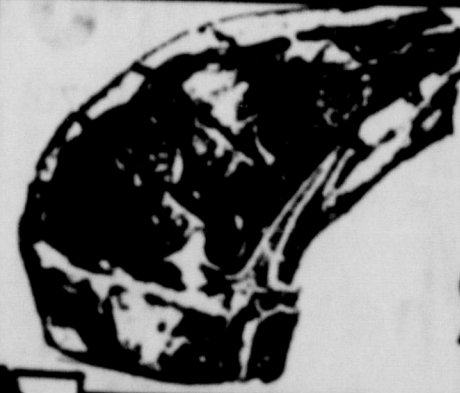
