## Meetings Scheduled In Area to Discuss Farm Labor Problem

Labor problems of the West Texas cotton farmer will be discussed at three conferences in the region, August 28, 30 and 31.

How to obtain Mexican nationals for gathering the cotton crop as well as how to keep them will be discussed by officials of several agencies figuring in the labor supply picture.

Conferences will be held at the Kemp Hotel, Wichita Falls, Tuesday, August 28; at the Settles Hotel, Big Spring, Thursday, August 30; and at the Lubbock Hotel, Lubbock, Friday, August 31.

S. N. Reed of Knox City, vice president of the Texas Cotton Ginners Association, Robert M. Fielder of Abilene, chairman of the WTCC agriculture committee, and Frank H. Kelley of Colorado City, chairman of the WTCC taxation and legislation committee, will act as presiding officers for the meetings.

Sponsors of the conferences are the chambers of commerce of the three cities, the Texas Cotton Ginners Association, and the WTCC.

It is feared that West Texas may be faced with the same situation reported from South Texas, where migratory farm labor crews are stopping very briefly and moving on to Central and northwest Texas, where the cotton crop is not so retarded by drought.

Mrs. Matt McCall, manager of the Lamesa Chamber of Commerce, will relate in these conferences how Dawson county got off the Mexican government's "blacklist" with cooperation of that government itself. Measures that were taken to satisfy the Mexican officials there would be no discrimination against its nationals will be described by her.

## Oil Notes--

(Note: Some of the reports in this column are as of the Monday preceding publication, while others are unofficial reports obtained locally on Wednesday or Thursday.)

Sunray Oil Co. has set surface casing and is waiting on cement on its No. 1 Frances Snelson, 1910 feet from the north and 467 feet from the east lines of D. G. Burnett survey No. 6, block 6. This wildcat, Sunray's first venture in this area, is five miles northeast of Knox City, in the North Knox City Palo Pinto field.

One and a half miles north of town, Skelly Oil Co. set 220 feet of surface casing on its No. 2 G. F. Stubbs, and is waiting on cement. The company's No. 1 Stubbs is being prepared to flow into tank battery.

The No. 2 well is in the 45-acre Stubbs tract west of the railroad. Contract depth is 4,400 feet.

On the Stanolind Oil & Gas Co. No. 2 Edna Travis, Lewis Drilling Co. set surface casing Tuesday, and is drilling ahead today.

In the Katz Field west, a new rig has been moved in and is being set up for the No. 2 Jack Dozier.

On the T & P Coal and Oil Co. Lorentzen No. 5, operators topped the second Strawn sand at 4953 and cored at 4956-66 and 4966-80 feet, recovering heavy oil saturated sand. Wednesday night tests were underway at 5182-5216 feet.

Pipe was set at 5242 on the Katz No. 4 Dozier, and casing was perforated at 4878-88 feet with 8 shots per foot. The Frank Wood, Inc., rig is being skidded from this well to location for the T & P Coal and Oil Co. State Co. No. 2.

Among new locations announced for the Katz field are the No. 2 W. D. Lewis, the No. 3 S. S. Dozier, and the No. 3 and No. 4 R. H. Underwood.

## FORGERY TRIO NABBED BY COUNTY OFFICERS

It was reported this week that Sheriff Homer T. Melton and Munday Chief of Police D. E. Whitworth, working with other law enforcement officials, have solved one of the most baffling forgery cases they had ever encountered.

Three men were identified, placed in jail, and have signed confessions acknowledging their parts in the scheme.

The "scheme" consisted of all three men working in cahoots, and the actual maker of the instruments in most cases was in the background. Only the "pusher" was seen on the scene, and then in clothes that did not belong to him.

A small purchase was usually made and the forged instrument offered in payment, expecting to draw the difference on the check. After deducting the actual cost of the article purchased (which went to the passer) the balance was split between the three men.

Sheriff Melton says this kind of swindling would be impossible if all merchants obeyed the "Instruction Card" which is furnished by the sheriff's department to hang in each place of business.

"Know your endorser," states the sheriff. "Take down his auto license number, secure his personal identification, such as driver's license (but not social security card) . . . and just don't cash the check unless you know the maker, endorser, and also the 'passer'. In this case the merchants are the losers of the money involved in the transaction, for these men are not in a position to make restitution, and all the officials can do is place them where they cannot do it again soon."

### Proposed Constitutional Amendments

#### SENATE JOINT RESOLUTION NO. 8

proposing an Amendment to Section 48-d of Article III of the Constitution of the State of Texas, authorizing the Legislature to provide for the creation and establishment of rural fire prevention districts so as to provide that the Legislature may authorize an ad valorem tax not to exceed Fifty (50c) Cents on the One Hundred (\$100.00) Dollars valuation.

**Be It Resolved by the Legislature of the State of Texas:**  
Section 1. That Section 48-d of Article III of the Constitution of the State of Texas be amended to read as follows:

"Sec. 48-d. The Legislature shall have the power to provide for the establishment and creation of rural fire prevention districts and to authorize a tax on the ad valorem property situated in said districts not to exceed Fifty (50c) Cents on the One Hundred (\$100.00) Dollars valuation for the support thereof; provided that no tax shall be levied in support of said districts until approved by vote of the people residing therein."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electorate of the State at an election to be held on the second Tuesday in November, 1951, at which election all ballots shall have printed thereon (or in counties using voting machines, the said machines shall provide) the following:

"FOR the constitutional amendment authorizing the Legislature to provide for the levy of an ad valorem tax not to exceed Fifty (50c) Cents on the One Hundred (\$100.00) Dollars valuation for the creation and establishment of rural fire prevention districts;" and

"AGAINST the constitutional amendment authorizing the Legislature to provide for the levy of an ad valorem tax not to exceed Fifty (50c) Cents on the One Hundred (\$100.00) Dollars valuation for the creation

and establishment of rural fire prevention districts."

Each voter shall mark out one of said clauses on the ballot, leaving the one expressing his vote on the proposed amendment; and if it shall appear from the returns of said election that a majority of the votes cast are in favor of said amendment, the same shall become a part of the Constitution of the State of Texas.

Sec. 3. The Governor of the State of Texas shall issue the necessary proclamation for said election and have the same published as required by the Constitution and laws of this State.

#### HOUSE JOINT RESOLUTION NO. 37

proposing an Amendment to Article VII of the Constitution of the State of Texas by adding a new section after Section 11 thereof to be designated as Section 11a, providing for the investment of the Permanent University Fund in additional securities to those now enumerated in Section 11 of Article VII of the Constitution of the State of Texas; providing for the necessary proclamation and publication, and calling of an election therefor.

**Be It Resolved by the Legislature of the State of Texas:**

Section 1. That Article VII of the Constitution of the State of Texas shall be amended by adding after Section 11 thereof a new section to be designated Section 11a, which shall read as follows:

"Section 11a. In addition to the bonds now enumerated in Section 11 of Article VII of the Constitution of the State of Texas, the Permanent University Fund may be invested in such other securities, including bonds, preferred stocks and common stocks, as the Board of Regents of the University of Texas may deem to be proper investment for said fund; provided, however, that not more than fifty per cent (50%) of the said fund shall be invested at any given time in stocks, not

shall more than one per cent (1%) of the said fund be invested in securities issued by any one (1) corporation, nor shall more than five per cent (5%) of the voting stock of any one (1) corporation be owned; and provided further that stocks eligible for purchase shall be restricted to stocks of companies incorporated within the United States which have paid dividends for ten (10) consecutive years or longer immediately prior to the date of purchase and which, except for bank stocks and insurance stocks, are listed upon an exchange registered with the Securities and Exchange Commission or its successors. This amendment shall be self-enacting."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at an election to be held throughout the State on the second Tuesday in November, 1951, at which election all ballots shall have printed thereon:

"FOR the Constitutional Amendment providing for the investment of the Permanent University Fund in additional securities to those now enumerated in Section 11 of Article VII of the Constitution"; and

"AGAINST the Constitutional Amendment providing for the investment of the Permanent University Fund in additional securities to those now enumerated in Section 11 of Article VII of the Constitution."

Sec. 3. The Governor shall issue the necessary proclamation for said election and have the same published as required by the Constitution and laws of this State. The expense of publication and election for such Amendment shall be paid out of the proper appropriation made by law.

#### HOUSE JOINT RESOLUTION NO. 22

proposing an Amendment to the Constitution of Texas by adding to Article XVI thereof a new Section to be numbered 63; and authorizing the Legislature to provide for a statewide system of retirement and disability pensions for appointive officers and employees of the several counties of this State; providing that participation therein by counties shall be voluntary, and authorized by the qualified voters of such county; providing the Legislature shall not be authorized to make an appropriation to pay any retirement or disability benefits authorized herein; and providing that administration of said system may be committed to the same body set up to administer the statewide municipal retirement system authorized under Section 51f of Article III; providing for the calling of an election and the publication and issuance of the proclamation therefor.

**Be It Resolved by the Legisla-**

#### ture of the State of Texas:

Section 1. That Article XVI of the Constitution of the State of Texas, be amended by adding thereto a new Section, to be numbered Section 63, which shall read as follows:

"Section 63. The Legislature shall have the authority to provide for a statewide system of retirement and disability pensions for appointive officers and employees of the counties of this State under such a plan and program as the Legislature shall authorize; provided, that participation therein by counties shall be voluntary and shall first be authorized by vote of the qualified voters of such county; provided further that the Legislature shall not be authorized to make an appropriation to pay any retirement or disability benefits authorized herein. Administration of such system may be committed to the same body as may be set up to administer the municipal retirement system provided for by Section 51f of Article III."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to the qualified electors at an election to be held throughout this State on the second Tuesday in November, 1951, and at said election the ballots shall have printed thereon the words:

"FOR the Constitutional Amendment authorizing a statewide system for retirement and disability pensions for appointive county officials and employees," and

"AGAINST the Constitutional Amendment authorizing a statewide system for retirement and disability pensions for appointive county officials and employees."

Each voter shall strike out one of said clauses on his ballot, leaving the one unmarked which expresses his vote upon the proposed Amendment.

Sec. 3. The Governor of the State of Texas shall issue the necessary proclamation for said election, and shall have the foregoing proposed Amendment published as required by the Constitution for proposed amendments thereto.

Sec. 4. If at said election, a majority of the votes are "FOR the Constitutional Amendment authorizing a statewide system for retirement and disability pensions for appointive county officials and employees" the

foregoing proposed Amendment shall become Section 63 of Article XVI of the Constitution of Texas, and proclamation shall be made by the Governor thereof.

### Proposed Constitutional Amendments

#### HOUSE JOINT RESOLUTION NO. 4

Proposing an Amendment to the Constitution of the State of Texas, amending Article III, Section 5a, providing that the Legislature shall have the power to provide assistance to and provide for the payment of same to residents of the State of Texas who are needy aged persons over the age of sixty-five (65) years, needy blind persons over the age of sixteen (16) years, needy children under the age of sixteen (16) years, removing the Thirty-five Million Dollars (\$35,000,000) limitation upon expenditures for such purposes and providing for a limitation of Forty-two Million Dollars (\$42,000,000) upon such expenditures, providing a maximum payment of Thirty Dollars (\$30) per month from State funds for old age assistance, providing payment of assistance after disposition of property under certain conditions, providing for the acceptance of financial aid from the Government of the United States of America for such assistance, providing that the payment of

such from State funds shall never exceed the payments from Federal funds, providing for the necessary action and providing for the form of law, proclamation, and publication.

Be It Enacted by the Legislature of the State of Texas:

Section 1. That Section 5a of Article III of the Constitution of the State of Texas be amended, and the same is hereby amended so that the same shall hereafter read as follows:

Section 5a. The Legislature shall have the power, by general law, to provide, subject to limitations and restrictions herein contained, and such other limitations, restrictions, and regulations as may by the Legislature be deemed expedient for assistance to, and for the payment of assistance to:

(1) Needy aged persons who are over the age of sixty-five (65) years, provided that no such assistance shall be paid for any inmate of any State-supported institution, while such inmate remains and provided that any resident of the State, if otherwise eligible, may not be excluded who has resided in the State for one (1) year immediately preceding the filing of such application.

(4) Needy aged persons who are over the age of sixty-five (65) years, provided that no such assistance shall be paid to any inmate of any State-supported institution, while such inmate remains and provided that any resident of the State, if otherwise eligible, may not be excluded who has resided in the State for one (1) year immediately preceding the filing of the application for such assistance, including the one (1) year continuously immediately preceding the filing of such application.

(5) Needy children who are under the age of sixteen (16) years, provided that no such assistance shall be paid to any inmate of any State-supported institution, while such inmate remains and provided that any resident of the State, if otherwise eligible, may not be excluded who has resided in the State for one (1) year immediately preceding the filing of the application for such assistance, including the one (1) year continuously immediately preceding the filing of such application.

The Legislature shall have the authority to accept from the Federal Government of the United States such moneys and the assistance of the Federal Government, which moneys and assistance shall be used for the purpose of providing for the payment of assistance to, and for the payment of same to, needy aged persons over the age of sixty-five (65) years, needy blind persons over the age of sixteen (16) years, and needy children under the age of sixteen (16) years, provided that the total amount of such assistance shall not exceed the amount of such moneys and assistance received from the Federal Government, and provided that the total amount of such assistance shall not exceed the amount of such moneys and assistance received from the Federal Government, and provided that the total amount of such assistance shall not exceed the amount of such moneys and assistance received from the Federal Government.

"FOR the amendment to the Constitution giving the Legislature power to set up a system of payments of assistance to needy persons over sixty-five (65) years of age, to needy blind persons over the age of sixteen (16) years, to needy children under sixteen (16) years of age, removing the Thirty-five Million Dollar (\$35,000,000) limitation upon amount of State expenditures for such purposes, disqualifying persons who dispose of property under certain conditions, providing a maximum payment of Thirty Dollars (\$30) per month from State funds for old age assistance, providing for the acceptance and expenditure of funds from the Federal Government, providing that expenditures from State funds shall not exceed the expenditure from Federal funds with respect to any individual, and providing conditions as to residence within the State in order to be eligible to receive assistance; and providing a limitation of Forty-two Million Dollars (\$42,000,000) per year on State fund expenditures for such purpose each year."

Section 5. **Constitutional Amendments**

as the Veterans' Land Board, which shall be composed of the Governor, the Attorney General, and the Commissioner of the General Land Office. The Veterans' Land Board may issue not to exceed One Hundred Million Dollars (\$100,000,000) in bonds or obligations of the State of Texas for the purpose of creating a fund to be known as the Veterans' Land Fund. Such bonds shall be executed by said Board as an obligation of the State of Texas, in such form, denominations, and upon the terms as are now prescribed by Senate Bill No. 29, Chapter 318 of the Acts of the Fifty-first Legislature (provided, that when the limitation of Twenty-five Million Dollars (\$25,000,000) is used in said Senate Bill No. 29, the same shall hereafter be construed as One Hundred

Million Dollars (\$100,000,000), or as said Act may be hereafter amended, or by other laws that the Legislature may hereafter enact; provided, however, that said bonds shall bear a rate of interest not to exceed three per cent (3%) per annum, and that the same shall be sold for not less than par value and accrued interest. "In the sale of any such bonds, a preferential right of purchase shall be given to the administrators of the various teacher retirement funds, the Permanent University Funds, and the Permanent School Funds; such bonds to be issued as needed, in the opinion of the Veterans' Land Board. "The Veterans' Land Fund shall be used by the Board for the sole purpose of purchasing lands suitable for the purpose hereinafter stated, situated in this State: (a) owned by the United States, or any governmental agency thereof; (b)

owned by the Texas Prison System, or any other governmental agency of the State of Texas; or (c) owned by any person, firm, or corporation. "All lands thus purchased shall be acquired at the lowest price obtainable, to be paid for in cash, and shall be a part of the Veterans' Land Fund. "The lands of the Veterans' Land Fund shall be sold by the State to Texas Veterans of the present war or wars, commonly known as World War II, and to Texas Veterans of service in the armed forces of the United States of America subsequent to 1945, as may be included within this program by legislative act, in such quantities, and on such terms, and at such prices and rates of interest, and under such rules and regulations as are now provided by law, or as may hereafter be provided by law. "All moneys received and which have been received and

which have not been used for repurchase of land as provided herein by the Veterans' Land Board from the sale of lands and for interest on deferred payments, shall be credited to the Veterans' Land fund for use in purchasing additional lands to be sold to Texas Veterans of World War II, and to Texas Veterans of service in the armed forces of the United States of America subsequent to 1945, as may be included within this program by legislative act, in like manner as provided for the sale of lands purchased with the proceeds from the sales of the bonds, provided for herein, for a period ending December 1, 1959; provided, however, that so much of such moneys as may be necessary during the period ending December 1, 1959, to pay principal of and interest on the bonds heretofore issued and on bonds hereafter issued by the Veterans' Land Board shall be set aside for that purpose. After December 1, 1959, all moneys received by the Veterans' Land Board from the sale of the lands and interest on deferred payments, or so much thereof as may be necessary, shall be set aside for the retirement of said bonds and to pay interest thereon, and any of such moneys not so needed shall not later than the maturity date of the last maturing bond or bonds be deposited to the credit of the General Revenue Fund to be appropriated to such purposes as may be prescribed by law. All bonds issued hereunder shall, after approval by the Attorney General of Texas, registration by the Comptroller of the State of Texas, and delivery to the purchasers, be incontestable and shall constitute obligations of the State under the Constitution of Texas. Of the total One Hundred Million Dollars (\$100,000,000) of bonds herein authorized, the sum of Twenty-five Million Dollars (\$25,000,000) has heretofore been issued; said bonds are hereby in all respects validated and declared to be obligations of the State of Texas. This amendment shall become effective upon its adoption."
