The candidate receiving the largest number of votes becomes chairman; the second largest vote-getter, vicechairman; third-high, regular



ficers. They also assist the County ASC Committee in local administration of Government farm programs and help keep farmers informed on how the programs affect individual farm operations.

Any farm owner, tenant, or sharecropper who is of legal voting age may vote if he has an interest in a farm and is eligible to participate in any ASCS program administered in his community. Others who may vote are: spouses of eligible voters; a minor who supervises and conducts the farming operation of an entire farm; a legal guardian who manages a farm for a child; and a person representing a legal entity such as a partnership or cor-

for the ballot to be counted. A list of known eligible voters is open for inspection at the County ASCS Office, Any person who believes he is an eligible voter but who is not listed should get in touch with the County ASCS Office as soon as possible, Navratil said.

He concluded that any voter who has not received a ballot in the mail within a few days after September 1 should call the County ASCS Office to ar range to receive a duplicate ballot if necessary.

Six Accidents Investigated In Knox County

The Texas Highway Patrol investigated six accidents on rural highways in Knox County during the month of July, according to Sergeant J. W. Garner, Highway Patrol supervis-

or of this area, These crashes resulted in five persons injured and an estimated property damage of \$6,400,00.

The rural accident summary for this county during the first seven months of 1970 show a total of 42 accidents resulting in no persons killed, 13 persons injured, and an estimated property damage of \$31,830.00.

times he masters his difficulties; sometimes they are too much for him. His struggles are all that the world sees and it naturally misunderstands them.


