
Early planting will provide early

At a meeting held April 7, Knox County cotton producers unanimously selected Monday, May 12, as the uniform cotton planting date. The meeting was co-sponsored by the Knox County Boll Weevil Association and the Knox County Crops Committee.

Larry Smith, chairman of the crops committee, presented the date of May 12 to the producers as the planting date recommended by the crops committee and boll weevil association. The date selected is a week earlier than usual, so as to encourage all Knox County producers to participate in this proven boll weevil control program.

Judge Perdue Makes Changes In County Voting Locations

County Judge David N. Perdue has announced three polling place changes and the realignment of voting precincts for Knox City and Benjamin only.

In Knox City, all registered voters will remain in the same voting precinct. The locations will be changed to the Knox County Aging Center. from the Community Center and City Hall, which were used in the past. The Aging Center will be divided inside with Precinct 1 on the south end of the building and Precinct 2 on the north end of the building. All will enter the west door of the center.

In Benjamin, the Memorial Building will be used instead of the County Courthouse.

All other precincts in the county will remain the same.

These changes became necessary to comply with the Voting Accessibility Act for the Elderly and Handicapped, which became effective January 1, 1986.

Increased Rebate Checks Boost City, **County Treasuries**

County tax rebates are still on the upswing, according to statistics sent by the office of State Comptroller Bob Bullock, who recently mailed checks totaling \$50.6 million in local sales tax rebates to the 1,015 cities in Texas that levy the one-percent city tax. The April checks represent taxes collected on sales made in February and reported to the comptroller's office in March.

Munday's check for \$2,291.51 was almost \$500 larger than last year's April rebate. Our 1986 total is \$14,989.68, 7.74 percent more than at this point in 1985.

Knox City received a check for \$4,053.13, an increase of less than \$100 from last year's check. But their four-month total of \$26,725.68 is still more than 20 percent ahead of this time last year, although it is predicted that a slump in oil production will begin to show up in Knox City's economical outlook before long.

Knox County has now received \$45,229.01 in tax rebates in 1986, which is an increase of 21.43 percent over 1985.

WATCH FOR RUSSIAN WHEAT APHID

The Russian wheat aphid is a new pest facing Knox County wheat producers. Emory Boring, Extension Entomologist, has found a few of these aphids in the county.

They are easily distinguishable from other aphids common to this area. It is only about two millimeters long, has very short antennae, is green, and has a distinctive projection above the cauda, on tail,

which gives it a "double tail" appearance.

The Russian wheat aphids are found in the newest growth in rolled up leaves. After the leaves unroll the aphids disappear.

According to Boring, uninfested headed wheat is not likely to become infested. The infested plants are being found in spots three to five feet in diameter.

The aphid does its damage by injecting a toxin into the plants as it feeds. Infested plants turn purple, can have white streaking on the leaves and, when heavily infested, may make the tillers lie almost parallel to the ground.

Fields where these aphids are found should be inspected. The percentage of the field infested should be considered when determining the need for chemical control. An economic threshold has not been established. If chemical measures are needed parathion or methly parathion might be combined with a systemic insecticide such as dimethoate or disulfoton. ****

FmHA Accepting Emergency Farm Loan Applications

Applications for emergency farm loans for losses caused by hail, high winds, excessive rainfall and abnormally low temperature between May 19, 1985 and December 12, 1985, are being accepted at the Farmers Home Administration (FmHA) office in Knox City, FmHA county supervisor Joe T. Boone said Friday.

Knox County is one of 15 in Texas recently named by Secretary of Agriculture John R. Block as eligible for loans to cover part of actual production losses resulting from the drought.

Boone said farmers may be eligible for loans of up to 80 percent of their actual losses, or the operating loan needed to continue in business, or \$500,000, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest rate on the first \$100,000 borrowed is 5 percent; interest is 8 percent on the balance borrowed over that amount. For farmers who can obtain commercial credit but who choose to borrow from FmHA, the interest rate is 13.75 percent.

As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FmHA emergency loan, Boone said. Farmers participating in the PIK or federal crop insurance programs will have to figure in proceeds from those programs in determining their loss.

Applications for loans under this emergency designation will be accepted until December 3, 1986, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and

possibly carry over into the new farming season, Boone stated.

FmHA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognized farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U.S. citizens, and to farming partnerships, corporations or cooperatives in which U.S. citizens hold a majority interest.

The FmHA office in Knox City is open from 9 a.m. to 5 p.m. Monday through Friday.

PLANNING LOW-COST. HIGH PROTEIN MAIN DISHES Protein foods add important nutrients to our diets. So even if you're trying to save money, you'll want to keep these foods in your diet.

But there are some things you can do to plan low-cost protein main dishes:

*Use more low-cost protein foods, such as dry beans, eggs, peanut butter, turkey and chicken. Hamburger and liver are good buys in red meats.

*Shop the sales for red meats.
