**Ballots for regional boll weevil vote due by March 11**

Cotton farmers and landowners with cotton production are eligible to vote in a March 11 referendum that will determine whether a boll weevil eradication program should continue in the 22-county Rolling Plains Central Boll Weevil Eradication Zone.

Eligible voters in the Rolling Plains Central Boll Weevil Eradication Zone should have received an official ballot by mail the week of February 18. A postage-paid return envelope will be included. Completed ballots must be post-marked before midnight, March 11 to be counted. Producers who planted cotton in 1997, but do not receive a ballot should contact the Texas Department of Agriculture at (512) 463 - 7593.

In addition to deciding if an eradication program should continue in the zone, voters will elect a board member from the Rolling Plains Central Zone to serve on the statewide board of directors for the Texas Boll Weevil Eradication Foundation Inc.

Those candidates seeking to represent

the Rolling Plains Central Boll Weevil Eradication Zone on the statewide board are Woody Anderson of Mitchell County and Mike Massey of Nolan County. Both candidates are cotton producers who farm in the zone and who have grown cotton for at least seven years.

Unlike establishment referenda where two-thirds of all voters must approve a proposition, a majority of those returning ballots will determine whether an eradication program will continue. Growers in the Rolling Plains Central Zone initially approved a boll weevil eradication program December 1, 1994 and a maximum assessment of \$10 per land acre to fund it. If cotton producers vote to continue the program, the assessment rate will remain at that level.

The March 11 referendum for the zone was established by new legislation that corrects a constitutional problem found by the Texas Supreme Court with the statewide boll weevil eradication program. Under the new statute,

the Texas Boll Weevil Eradication Foundation continues to carry out the program. However, TDA takes on additional responsibilities that include setting new elections on assessments and eradication programs in regional zones and appointing advisory committees for each zone.

Counties in the Rolling Plains Central Eradication Zone are: Baylor, Callahan, Comanche, Eastland, Erath, Fisher, Haskell, Jones, Knox, Mitchell, Nolan, Palo Pinto, Scurry, Shackelford, Stephens, Stonewall, Throckmorton, Young and parts of Archer, Borden, Brown and Taylor.

The Munday Moguls won the Bi-District Championship game last night over the Throckmorton Greyhounds 61 to 44 in Haskell.

Throckmorton scored first on the opening tip-off. The Moguls settled in and took a 19 to 10 first quarter lead with six points coming from steals by Wesley Spells and Jonathan Reagins.

Munday began a 15-0 run late in the first carrying over until 4:20 left in the second quarter when the Greyhounds hit a three point shot. From there the Moguls managed four points to Throckmorton's 9. Munday led 32-19 at the half.

The Moguls increased thier lead in the third quarter 46 to 27. The Greyhounds stormed back in the fourth outscoring Munday 9-2 in the first four minutes. Throckmorton closed the Moguls' lead to 7, 51-44 with less than three min-

utes to play, but that's as close as Munday would allow. The Moguls hit 6 of 6 free throws and a basket by Donald King added the insurance for the 61-44 win.

Munday hit 11 of 13 free throws to Throckmorton's 4 of 7. Both teams had four three pointers. Eric Beaty was high point for the Moguls scoring 24, Jonathan Reagins hit 15, Donald King and Wesley Spells 9 each, and Brandon Sosa 4.

Munday will now face the Guthrie Jaguars in the Area round of the playoffs. Site and time were not available at press time. Possible sites were at Vernon or Seymour. Check with the school on Friday.

The Moguls went 1-1 last week in practice games hosting both the Haskell Indians and the Jayton Jaybirds.





# Visions of Munday fill English gent's head

Fairytales to most American's consist of castles, bridges, green rolling hills covered with feeding sheep standing in a cloud of mist and, of course, royal families. But for one young English man, fairytales are made of rolling wheat fields as far as the eye can see, combines gliding over glistening yellow land and cattle grazing in the fenced areas near by.

Darren Rockford Murphy, 35 and single, says his "hearts dream is to go there (the wheat fields of the U.S.) and cut the grain."

Darren, who works for American Bank in London as a graphic designer and artist in the advertising department, has no desire to see the coasts of the United States or party in the large well-known cities of our continent. In-

stead he says, "I believe the Wild West is still alive. At least for me it is. All I want to do is work with the wheat harvesters and travel the fields across the country. I could probably come to your country for a visit and rough it, but what I am really captivated with is the wheat fields."

Darren doesn't have any experience with harvesting crops. "Here in England our fields are very small. There are only a few (custom) harvesters and not much work for them," he explains. He did grow up living around farming areas but was never directly involved in the process. "I have imagined what it would be like and it seems to me that when the wind is blowing through those vast fields it would be most captivating - almost like being adrift in the

middle of the sea. I would rather believe it to be almost a spiritual experience."

But why would a young man with a respectable job in the storybook city of London want to come to work on the wheat harvest? "London is like a concrete jungle to me. In those fields there is a beauty and tranquility that I want to experience. I know I need to do this (work on harvest). I just want to do it now before I get too old or settle down a bit and get married," says Darren.

Among the stories and pictures of wheat harvest that have influenced Darren's dream of combining was a recent television documentary that he viewed. "The show I recently watched was called 'Country File' which is a

farming program that airs on Sundays. On one particular segment they showed the farming and ranching areas around Munday, Texas during wheat harvest. That is how I learned of your community and began making inquiries."

Darren currently holds two passports, one English and one Irish, and has completed the paperwork for a third visa that would allow him to come to the United States to work. He can furnish references, including his present employer, for anyone who would care to check out his character and work ethics.

## Letter to the Editor

Dear Editor,  
In the February 4 issue of your newspaper you included an article by Cynthia White concerning the changes in home health as a result of the 1997 Balanced Budget Act. While I commend your efforts to advise your readership of the trend by Medicare to limit coverage, I am concerned that certain sections of Ms. White's article might unduly alarm recipients of home health services. As the Vice President of Mediplex Home Health, which has provided home health services in the Munday area for the past six (6) years, I feel an obligation to clarify that under the current Medicare reimbursement guidelines, there is no "dollar amount" which can be "used up by the patient".

ing for any one patient against the cost of caring for all patients." In theory those patients who require less care will be averaged with those who require more care, to reach an average for each patient cared for by the agency. The letter continues to state that agencies cannot limit the medically necessary care of a patient based on their average beneficiary limit without jeopardizing their participation in the Medicare program.

I have enclosed a letter sent to all Home Health Agencies by the Health Care Financing Administration (HCFA) Administrator which clarifies the coverage limits. In that letter HCFA indicates that each agency's total cost billed to Medicare are not allowed to exceed certain limits. One of those limits is an "aggregate cap based on the average cost per beneficiary at each home health agency". This new cost cap is designed to allow a specific home health agency "to balance the cost of car-

The effect of these dollars limits, as well as other restrictions imposed by Congress, will have its greatest impact as you noted in the solvency of individual agencies. An agency's ability to survive will depend on its skill at walking that fine line between providing the care each patient requires with meeting the new financial constraints. Medicare's current movement toward the managed care model, will likely provide patients reduced care overall and a greater responsibility of families and communities for care of the elderly and ill. The Balanced Budget Act of 1997 was just one of many steps yet to come.



## "On A Wizer Note"

At the 1998 Knox County Junior Livestock Show, youth exhibited about twice as many market goats as they did in 1997. Will this increase continue? Will we go from fifty-eight to 116 goats in 1999? Only time will tell.

For those who are planning to raise show goats for this fall or spring of 1999, there is an educational video you may want to watch. It is titled "Show Goats" and was developed by the Texas Agricultural Extension Service.

This 45 minute video includes topics such as facilities, nutrition, exercise, health, clipping, showing, and selection. These areas are discussed by three Extension personnel: Dr. Frank Craddock, Extension Sheep and Goat Specialist - San Angelo; Ross Stultz, Extension Sheep and Goat Specialist - San Angelo and Joe Raff, County Extension Agent/Agriculture - Wichita County.

There are two copies of this tape in the Knox County Extension office. These are available for loan with a \$5 deposit. This deposit will be refunded when the tape is returned.

Also available through the Extension office are copies of tapes produced by Nutrena Feeds. These tapes cover show steers, lambs and hogs. These can be loaned out with a \$5 deposit.

## DPS warns about fund raising activities

Although some law enforcement associations may claim to be raising money on behalf of the Texas Department of Public Safety, they are not affiliated with the agency. The DPS does not benefit from funds the groups and their professional telemarketers raise.

"Over the years, we have gotten numerous questions and complaints from Texas citizens regarding telephone solicitations by law enforcement associations," said Colonel Dudley M. Thomas, director of DPS. "The DPS does not solicit financial contributions from private citizens. We receive our funding from the Texas Legislature."

Some organizations solicit funds using names similar to those of the DPS, including "Texas Rangers," "State Troopers," "Texas Highway Patrol" or "Department of Public Safety." While some DPS officers may be members of these organizations on their own time, these associations are not affiliated with the DPS, Thomas said. They raise money to fund their own programs, some of which may benefit officers and families.

The 75th Texas Legislature enacted a law that requires these organizations to clarify that they are not part of the DPS and prohibits them from implying that the money they raise will go to the DPS. In addition, solicitors cannot use names, symbols or statements that are similar to those used by the Texas Department of Public Safety or the Texas Rangers to confuse or mislead someone who is being asked to give money.





forcement in general. I would appreciate your vote.

Looks familiar, doesn't it? This message is the same one that was on the fliers that were placed throughout the county and handed out to citizens during the past month or so. I won't bore you with a lot of detailed education statistics or big promises of what I will or won't do, but would like to say that without the education that applies to realistic law enforcement, I would not have the above mentioned employment history. I am proud to have shared my education ad gained experiences with nearly all law enforcement departments and personnel in the county, and that I can use my education to benefit the whole county in general. There have, in the past, been many nights when we held "class" on the trunk of a patrol car or over the phone, digging through the law books to try to apply a law to a certain situation. The Munday Police Department, present Knox City Police Department, as well as the Knox County Sheriff's Department have joined in the class at various times.

This past year seemed to be quite a problem for the Sheriff's Department, with the Knox County Commissioners electing to receive applications for the vacated position of Sheriff. Several did submit applications, and after citizen input to the Commissioners and County Judge, I was appointed in mid October. Since accepting the job of Sheriff, which incidentally is much more than a position, the general overall attitude toward the Sheriff's Department has improved, as did the working environment. After accepting the job of Sheriff, "all" Sheriff's Department employees were advised that I didn't want them to work "for" me, but rather I wanted them to work "with" me in trying to improve the quality and performance of this department. Many things had been left undone, so mere "catch-up work" occupied a lot of time. I'm happy to say that most of the "catch-up" work is completed, although there are other things that need to be done to bring the Sheriff's Department up to the efficiency stage where it should be. With the Sheriff's Department personnel pulling together, we can all make the changes happen a lot sooner.

Over the next three years, the Postal Service will issue special commemorative stamps honoring the first half of the century while the American public will be voting on stamp subjects for the latter part of the century.

Approximately every 3 months between February 3, 1998 and the year 2,000 the Postal Service will issue a sheet of 15 commemorative stamps heralding the most significant event of each decade of the twentieth century. Ballots for each decade beginning with the 1950's are available at our Post Office now.

For example, in February, 1998, the stamp sheets for the first decade, for the 1900's and 1910's are on sale at the Post Office now.


