

## Clyde Parade At 6 P. M. Friday

## Ace Hickman Dies Suddenly

Ace Hickman, prominent Baird church, business and civic leader, died suddenly about 12:30 p. m. Sunday at his ranch home located just east of the Baird city limits. Mr. Hickman apparently suffered a heart attack while watching a grass fire which threatened his home and did some damage to out buildings.

He had attended church at the Baird Methodist Church Sunday morning and had taught the men's class as he had done for many years. He complained of feeling ill after church and went to his home with Mrs. Hickman. When he reached home, he opened the gate to allow firemen and equipment into the pasture to fight the blaze. While holding the gate open, he collapsed and apparently died instantly.

Born April 19, 1881, seven miles west of Rising Star, he had lived in Callahan County since 1913.

He married Beulah Reaves near San Saba on Oct. 25, 1908. He was a longtime member of the Methodist church, and a teacher of the men's class at the church since 1929. He was also a steward in the local church and had been a district Methodist steward since 1928.

Mr. Hickman was a charter member of the Callahan County Luncheon Club and a charter member of the Sheriff's Posse here.

He had been a director of the First National Bank of Baird since 1922 and was named chairman of the board in 1951.

Mr. Hickman had also been active in Boy Scout work and work of the West Texas Chamber of Commerce.

In 1946 he donated an 18-acre tract of land in east Baird to the city for a municipal park. Baird Jaycees honored him in 1947 by naming him the Outstanding Citizen of Baird.

Funeral was held at 10 a. m. Tuesday at the First Methodist Church, with Rev. Bruce Parks, pastor, officiating. Burial was in Ross Cemetery with Wylie Funeral Home in charge.

Survivors include his wife; a son, Reaves of Albany; two daughters, Mrs. Houston Zinn of Big Spring and Betty Jean Hickman of San Marcos; a sister, Mrs. S. W. Browning of San Antonio; and a brother, Ray, of Slaton.

## Baird Kin Found Shot to Death

A General Dynamics employe, who had been working on a missile installation at Altus, Okla., was found shot to death Thursday morning, about five miles southwest of Memphis.

The death of James Clay Ellis, 25, whose home was in Kress, was ruled a suicide by Peace Justice J. S. Grimes of Memphis.

Ellis, whose body was found in the front seat of his car just off State Highway 256, had been shot with a double-barreled shotgun. Notes and the weapon were found near the body.

The Air Force veterans is survived by his parents, Mr. and Mrs. Harry Ellis of Kress; a sister and two brothers.

Mr. Ellis was a nephew of Mrs. A. H. Turner of Baird. Attending the funeral Sunday were Mrs. Turner, Aic and Mrs. Fred DuPont, Olan Geiger, and Mr. and Mrs. Sam Franklin of Abilene.

## Housing Project Begins Wednesday

Rouse and Parsons Construction Company, of Abilene, are scheduled to begin work Wednesday on the low rental housing project for Baird, it was reported by Charles Walker, chairman of the Housing Authority of the City of Baird.

The Abilene firm was awarded the contract after negotiations between company officials, the Baird authority, the architect and the Public Housing Authority. The original bids were all in excess of the estimates by the architectural firm when they were opened on July 18.

The negotiations brought the cost of the 16 units to slightly above \$155,000. The original figure submitted by Rouse & Parsons was \$156,497.50.

The Abilene contractors were scheduled to begin clearing the building site in Northwest Baird Wednesday. They were to move in men and equipment Wednesday, it was reported.

Officials of the local authority and of the Baird Chamber of Commerce expressed gratification that a negotiated contract was awarded. It prevented the redrawing of plans and specifications and saved several months in beginning the project.

## Revival To Begin At Baird Baptist Church

Rev. Eklund said that the nursery would be open for each service, and a competent person placed in charge.

The theme, Under Two Flags, teaches patriotism and faith in Christ and tries to show the meaning in each, and the difference.



## New First Baptist Church Sanctuary Planned

In recent meetings of the Baird First Baptist Church, members voted to build a new sanctuary, make extensive changes in the present education building, accepted preliminary plans, and employed Adam A. Bliss of Dallas as the architect for the new building.

The new building will replace the present sanctuary of the church, which will be torn down

to make room for the new building.

Plans call for an auditorium which will seat slightly more than 400 people. In addition, there will be room for a future balcony which will seat another 100. The building will be of laminated beam construction with masonry exterior. New oak pews will be installed and new matching pulpit furniture is included.

The new sanctuary will be complete with refrigerated air-conditioning and central heating.

The new building will tie into the present education building, which is scheduled to undergo extensive changing. In the education building, partitions will be moved and classrooms changed. The nursery department will also be modernized. The plans, which were accepted

by the congregation, allow for future expansion of the educational facilities.

The Bliss firm said that construction could begin sometime near the first of December or January. Total cost of the new sanctuary and the remodeling of existing structures was estimated to be between \$50,000 and \$55,000.

## City Council to Call Election For Construction of Sewage Plant

A special meeting of the City Council will be held Friday to order an election for the voting of some \$200,000.00 Water and Sewer Revenue Bonds, for the purpose of constructing a modern sewer treatment plant, additional trunk line, and to retire \$77,000.00 outstanding Water & Sewer Revenue Bonds.

In November, 1961, the Council voted to employ the firm of Fowler & Grafe, Inc., consulting engineers, to make a preliminary survey of the existing sewerage facilities and recommend the proper system that would adequately serve Baird now and for some years to come.

On Feb. 13, 1962, James D. Fowler came before the Council to present and explain the report submitted by his firm. The Council approved the report and notified the Division of Water Pollution Control of the State Health Department of the appointment of Fowler & Grafe, Inc., as consulting and designing engineers for the City of Baird, for the purpose of drawing plans and specifications for a Sewage Treatment Plant, etc. The Council authorized and directed Mayor J. L. Ault to make application for a Federal Grant for the City of Baird, under Public Law 660, 84th Congress, to be applied on the cost of construction of the sewer facilities. Under the present government program, the federal grant can amount to 30% of the total cost.

Mayor Ault was notified by a telegram Thursday morning from Congressman Omar Burleson that the Public Health Service had approved the grant for \$36,375.00 for construction of the Baird Sewage Treatment Plant. The present sewer system was built in 1927 and was designed to serve some two to three hundred customers. It is now considerably overloaded, caring for 544 customers. The new system is designed to serve a city of 3,500 population, and is modern in every respect. The cost of the proposed new plant is estimated at \$121,500.00, and the City's share would be approximately \$85,000.00.

The present plans of the City Council is to vote \$200,000.00 in Water & Sewer Revenue Bonds, but to sell only the amount necessary to retire the existing outstanding \$77,000 Water & Sewer bonds, and the amount necessary to finance the City's part of the cost of the new sewerage treatment plant, or a total of approximately \$165,000. The remaining \$35,000 bonds in this

issue would be sold later when needed, as the Fire Insurance Commission is requesting certain changes and improvements in the water system in order to maintain our fire rate. These bonds will assist in meeting some of these requirements.

This bond issue will be strictly a revenue bond, and will not affect taxes in any way.

It is of vital importance that the present sewer facilities be improved before they fail to comply with Department of Health requirements, city officials said.

The new president then appointed permanent committees: Elton Ables and Dick Vestal, publicity; Tom Barton, James Snyder, Frank Crow and Don McBride, membership. Jim Roy Higgins and James Eubanks are to be scorekeepers. Meeting night will be each Monday evening, beginning Aug. 27, at 7:30.

The project for the coming year is to purchase a projector for the football team, and film as many games as possible. At the first home town game, a booth will be set up inside the ball park stadium to solicit memberships. Membership fees will be \$3.00 per person, and everyone is urged to join and be a Baird Bear Booster and support your team, says Jack Sims, secy-treas.

Proposed CONSTITUTIONAL AMENDMENT NUMBER SIX ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 6, 1962.

HOUSE JOINT RESOLUTION NO. 16 proposing an Amendment to Article XVI of the Constitution of the State of Texas...

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. Subsection (b) of Section 62 of Article XVI of the Constitution of the State of Texas is amended to read as follows: "(b) Each county and any other political subdivision of this State shall have the right and the Legislature may enact appropriate regulatory laws to provide for and administer a Retirement, Disability and Death Compensation Fund for its elected and appointive officers and employees; provided same is authorized by a majority of the qualified voters voting in such election of the county or other political subdivision. No person shall qualify for benefits unless he shall have served in such capacity for at least twelve (12) years, except for those persons who are qualified prior to the effective date of this Amendment. The amount contributed by the county to such Fund shall equal the amount paid for the same purpose from the income of each such person, and shall not exceed at any time five per centum (5%) of the compensation paid to each such person by the county and State."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors in this State at an election to be held on the first Tuesday after the first Monday in November, 1962, of which election all ballots shall have printed thereon the following:

"FOR the Constitutional Amendment authorizing retirement, disability, and death benefits for elected and appointive officers and employees of counties and political subdivisions who have served in such capacity for twelve (12) years or more."

"AGAINST the Constitutional Amendment authorizing retirement, disability, and death benefits for elected and appointive officers and employees of counties and political subdivisions who have served in such capacity for twelve (12) years or more."

Sec. 3. Should the Legislature enact enabling laws in anticipation of the election and the Amendment shall be published in the manner and for the length of time as required by the Constitution and laws of this State.

Proposed CONSTITUTIONAL AMENDMENT NUMBER FIVE ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 6, 1962.

HOUSE JOINT RESOLUTION NO. 51 proposing an Amendment to Article IX of the Constitution of the State of Texas by adding thereto a new Section to be known as Section 9...

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article IX of the Constitution of the State of Texas be, and the same is hereby, amended by adding thereto another Section to be designated as Section 9, which shall read as follows:

"Section 9. The Legislature may by law provide for the creation, establishment, maintenance and operation of hospital districts composed of one or more counties or all or any part of one or more counties with power to issue bonds for the purchase, construction, acquisition, repair or renovation of buildings and improvements and equipping same, for hospital purposes; providing for the transfer to the hospital district of the title to any land, buildings, improvements and equipment located wholly within the district which may be jointly or separately owned by any city, town or county, providing that any district so created shall assume the full responsibility for providing medical and hospital care for its needy inhabitants and assume the outstanding indebtedness incurred by cities, towns and counties for hospital purposes prior to the creation of the district, located wholly within its boundaries, and a pro rata portion of such indebtedness based upon the then last approved tax assessment rolls of the included cities, towns and counties if less than all the territory thereof is included within the district boundaries; providing that after its creation no other municipality or political subdivision shall have the power to levy taxes or issue bonds or other obligations for hospital purposes or for the purchase, construction, acquisition, repair or renovation of buildings or improvements for the levy of annual taxes at a rate not to exceed seventy cents (70c) on the one hundred dollar valuation of all taxable property within such district for the purpose of meeting the requirements of the district's bonds, the indebtedness assumed by it and its maintenance and operating expenses, providing that such district shall not be created or such tax authorized unless approved by a majority of the qualified property taxing electors thereof voting at an election called for the purpose; and providing further that the support and maintenance of the district's hospital system shall never become a charge against or obligation of the State of Texas nor shall any direct appropriation be made by the Legislature for the construction, maintenance or improvement of any of the facilities of such district."

"Provided, however, that no district shall be created except by act of the Legislature and then only after the (20) days' public notice to the district affected, and in no event may the Legislature provide for a district to be created without the affirmative vote of a majority of the taxing voters in the district concerned."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to the qualified electors of the State at the General Election to be held the first Tuesday after the first Monday in November, 1962, at which election all ballots shall have printed thereon:

"FOR the Constitutional Amendment authorizing the Legislature to create hospital districts and prescribing limitations upon the powers of such districts."

"AGAINST the Constitutional Amendment authorizing the Legislature to create hospital districts and prescribing limitations upon the powers of such districts."

Sec. 3. The Governor of Texas shall issue the necessary Proclamation for the election and this Amendment shall be published in the manner and for the length of time as required by the Constitution and laws of this State.

Constitutional Amendments To Be Voted On In November

In this issue of the paper there appears the full text of seven of the 14 Constitutional Amendments to be voted on at the upcoming General Election (Nov. 6). They are published so that citizens may be fully informed on each proposed measure in its entirety, and study all of them carefully before election time.

A brief digest of the 14 proposed Amendments follows:

Number One on the Ballot (HJR 25) — Provides Workmen's Compensation Insurance for the employees of all political subdivisions.

Number Two on the Ballot (SJR 9) — Raise the limit on use of state funds to assist needy blind and needy children from Forty-seven Million Dollars (\$47,000,000) to Fifty-two Million Dollars (\$52,000,000).

Number Three on the Ballot (SJR 22) — Permits creation of hospital districts in Ochiltree, Castro, Hansford and Hopkins Counties.

Number Four on the Ballot (HJR 46) — Provides for a State program of acquiring conservation storage facilities in reservoirs.

Number Five on the Ballot (HJR 51) — Creates hospital districts and limits their power.

Number Six on the Ballot (HJR 36) — Authorizes retirement, disability, and death benefits for elected and appointive officers and employees of counties and political subdivisions who have served in such capacity for twelve (12) years or more.

Number Seven on the Ballot (SJR 13) — Insures continuity of state and local governmental operations in periods of emergency, resulting from disasters caused by enemy attack, by providing prompt and temporary succession to the powers and duties of public office, except members of the Legislature.

Number Eight on the Ballot (SJR 7) — Establishes a ceiling of Two Million, Five Hundred Thousand Dollars (\$2,500,000) per year on the amount that may be paid out of state funds for assistance payments to the totally and permanently disabled.

Number Nine on the Ballot (HJR 70) — Authorizes the construction, equipping, maintenance and financing of a home for the aged in Titus County and permits the Legislature to authorize the creation of two (2) hospital districts in Brazoria County.

Number Ten on the Ballot (SJR 12) — Permits state employees to serve as consultants or on advisory committees, or as members of a Public School Board, provided they are not members of the teaching profession, with a state agency or any political subdivision thereof.

Number Eleven on the Ballot (SJR 25) — Authorizes resale of repossessed lands in the Veterans Land Fund, to any buyer, after having been first offered for resale to veterans.

Number Twelve on the Ballot (SJR 19) — Delegates limited zoning powers to any county bordering on the Gulf of Mexico or the tidewater limits thereof.

Number Thirteen on the Ballot (SJR 6) — Provides that taxes or bonds previously voted in any Independent School District, major portion of which is in Dallas County, shall not be abrogated, cancelled or invalidated by any change in boundaries and authorizes the continuance of the levy of taxes after such change without further election.

Number Fourteen on the Ballot (HJR 32) — Provides for trials de novo on all appeals from actions, rulings, or decisions of administrative or executive agencies of government.

PUBLIC NOTICE Proposed CONSTITUTIONAL AMENDMENT NUMBER EIGHT ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 6, 1962.

SENATE JOINT RESOLUTION NO. 7 proposing an Amendment to Article III of the Constitution of the State of Texas, relating to assistance to needy persons totally and permanently physically or mentally disabled, renumbering said Section and providing that the amount paid out of state funds for assistance payments to the totally and permanently disabled may never exceed Two Million, Five Hundred Thousand Dollars (\$2,500,000) per year.

"The Legislature shall have the authority to accept from the Government of the United States such financial aid for individuals who are permanently and totally disabled. The Government may offer not inconsistent with the restrictions herein provided."

Section 1. That Section 51-b of Article III of the Constitution of the State of Texas, relating to assistance to needy persons totally and permanently physically or mentally disabled be amended to read as follows:

"Section 51-b-1. The Legislature shall have the power to provide General Laws, under such limitations and restrictions as may be deemed by the Legislature expedient, for assistance to needy individuals who are citizens of the United States, who shall have passed their eighteenth (18th) birthday but have not reached their sixty-fifth (65th) birthday, who are totally and permanently disabled by reason of a mental or physical handicap or a combination of physical and mental handicaps and not feasible for vocational rehabilitation, and who are residents of the State of Texas and who have resided in this state for at least one (1) year continuously immediately preceding the date of application for assistance; and providing further, that no individual shall receive assistance under this program for any period when he is receiving old age assistance, aid to the needy blind, or aid to dependent children, or is receiving any other benefit from any completely state-supported institution; and provided further, that the amount paid out of state funds to any individual may never exceed Two Million, Five Hundred Thousand Dollars (\$2,500,000) per year."

Section 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1962, at which election all ballots shall have printed thereon the following:

"FOR the Constitutional Amendment to establish a ceiling of Two Million, Five Hundred Thousand Dollars (\$2,500,000) per year on the amount that may be paid out of state funds for assistance payments to the totally and permanently disabled."

"AGAINST the Constitutional Amendment to establish a ceiling of Two Million, Five Hundred Thousand Dollars (\$2,500,000) per year on the amount that may be paid out of state funds for assistance payments to the totally and permanently disabled."

Sec. 3. The Governor of Texas shall issue the necessary Proclamation for the election and this Amendment shall be published in the manner and for the length of time as required by the Constitution and laws of this state.

PUBLIC NOTICE Proposed CONSTITUTIONAL AMENDMENT NUMBER FOUR ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 6, 1962.

HOUSE JOINT RESOLUTION NO. 46 proposing an Amendment to the Constitution of Texas by adding to Article III a new Section to be known as Section 49-d authorizing the Texas Water Development Board to acquire and develop storage facilities in reservoirs and to dispose of such storage facilities in whole or in part upon such terms as the Legislature shall prescribe; providing for the use of funds received from the disposition of acquired storage and water; providing that any enabling Acts shall not be invalid because transferred in character; prescribing the form of ballot and providing for the necessary proclamation and publication.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article III of the Constitution of Texas be amended by adding a new Section thereto to be known as Section 49-d, as follows:

"Section 49-d. It is hereby declared to be the policy of the State of Texas to encourage the optimum development of the limited number of feasible sites available for the construction or enlargement of dams and reservoirs for conservation of the public waters of the State, which waters are held in trust for the use and benefit of the public. To this end, and with the approval of the Board of Water Engineers or its successor, the proceeds from the sale of State bonds deposited in the Texas Water Development Fund as provided in Article III, Section 49-c of this Constitution, may be used by the Texas Water Development Board, under such provisions as the Legislature may prescribe by general law, for the additional purposes of acquiring and developing storage facilities, for the conservation and development of water for useful purposes in and from reservoirs constructed or to be constructed or enlarged within the State of Texas or on any stream constituting a boundary of the State of Texas, by any one or more of the following governments or governmental agencies: by the United States of America or any agency, department or instrumentality thereof; by the State of Texas or any agency, department or instrumentality thereof; by political subdivisions or bodies politic and corporate of the State; by interstate compact commissions to which the State of Texas is a party; and by municipal corporations."

"Under such provisions as the Legislature may prescribe by general law, the Texas Water Development Board may, with the approval of the Board of Water Engineers or its successor, execute long-term contracts with the United States or any of its agencies for the acquisition and development of storage facilities in reservoirs constructed or to be constructed by the Federal Government. Such contracts when executed shall constitute general obligations of the State of Texas in the same manner and with the same effect as State bonds issued under the authority of the preceding Section 49-c of this Constitution, and the proceeds in said Section 49-c with respect to payment of principal and interest on

State bonds issued shall likewise apply with respect to payment of principal and interest required to be paid in respect to such storage facilities as are acquired for a term of years, such contracts shall contain provisions which shall provide that the State investment in such facilities shall be secured by the aggregate of the bonds authorized by said Section 49-c, plus the proceeds from the sale of State bonds issued or contractual obligations incurred under any contracts authorized hereunder, shall not exceed the amount of the purchase price of such storage facilities as authorized by said Section 49-c of Article III of the Constitution."

"The Legislature shall provide terms and conditions for the Texas Water Development Board to sell, transfer or lease, in whole or in part, any acquired storage facilities or the right to use such storage facilities as authorized by said Section 49-c, and the Legislature may provide terms and conditions for the Board to sell any unappropriated public waters of the State that might be stored in such facilities. As a prerequisite to the purchase of such storage or water, the applicant therefor shall have secured a valid permit from the Board of Water Engineers or its successor authorizing the acquisition of such storage facilities or the water impounded thereon. The money received from any sale, transfer or lease of storage facilities shall be used primarily to pay the principal and interest on State bonds issued or contractual obligations incurred by the Texas Water Development Board, provided that when money is sufficient to pay the full amount of indebtedness then outstanding and the full amount of interest to accrue thereon, any further sums received from the sale, transfer or lease of such storage facilities may be used for the acquisition of additional storage facilities or for providing financial assistance as authorized by said Section 49-c. Money received from the sale of water, which shall include standby service, may be used for the operation and maintenance of acquired facilities, and for the payment of principal and interest on debt incurred."

"Should the Legislature enact enabling laws in anticipation of the adoption of this Amendment, such Acts shall not be void by reason of their anticipatory character."

"The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at the General Election to be held on November 6, 1962, at which election all ballots shall have printed thereon:

"FOR the Amendment to Article III of the Constitution of Texas by adding a new Section to be known as Section 49-d, authorizing the Texas Water Development Board to acquire and develop storage facilities in reservoirs and to dispose of such storage facilities in whole or in part upon such terms as the Legislature shall prescribe; providing for the use of funds received from the disposition of acquired storage and water; providing that any enabling Acts shall not be invalid because transferred in character; prescribing the form of ballot and providing for the necessary proclamation and publication."







Proposed CONSTITUTIONAL AMENDMENT NUMBER THREE ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 6, 1962.
SENATE JOINT RESOLUTION NO. 8 proposing an amendment to Article IX of the Constitution of the State of Texas, by adding a new Section thereto to be known as Section 11, providing that the Legislature may authorize the creation of hospital districts in Callahan, Castro, Hansford and Hopkins Counties, each district to be coextensive with the limits of such county, authorizing the levying and rates of taxes; providing for the acquisition of land and properties for hospital use, as well as the maintenance and the improvement of the same; and authorizing the issuance of tax bonds for the purpose of the purchase, construction, acquisition, repair or renovation of hospitals; and further providing that any enabling Acts shall not be invalid because of their anticipatory character.



Proposed CONSTITUTIONAL AMENDMENT NUMBER FOURTEEN ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 6, 1962.
HOUSE JOINT RESOLUTION NO. 11 proposing an amendment to the Constitution of the State of Texas to authorize the Legislature to provide for trial de novo on all appeals to the courts from actions, rulings or decisions of administrative agencies and executive departments of the State of Texas or any of its political subdivisions.
BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
Section 1. That the Constitution of Texas be and same is hereby amended by the addition to Article II of a new Section to be known as Section 2, said new Section 2 to read as follows:
"Section 2. Notwithstanding any other provision of the Constitution, the Legislature shall have the power, by general law, to provide for appeals to the courts from actions, rulings or decisions of administrative agencies and executive departments of the State of Texas or any of its political subdivisions, under such provisions and limitations as the Legislature shall deem necessary and desirable; and the courts of Texas shall have no power or authority to refuse, deny, or change the manner of such appeals, if brought in the manner provided by general law, even though such appeals shall be provided de novo as that term is used in appeals from County Courts; and should the Legislature provide for such appeals to be tried completely de novo and independent of any administrative or executive action, ruling or decision, the courts shall comply with such general law and shall hear and determine such appeals in the manner and under the conditions prescribed by the Legislature, even though such action on the part of the courts involves administrative or executive rather than judicial powers; provided, however, in the absence of legislation enacted subsequent to the adoption of this amendment, all such appeals shall continue to be prosecuted in the manner now provided by law, as interpreted and applied by the Appellate Courts of Texas on the date of the adoption of this amendment, and no change in the manner of such appeals shall be effected except by legislation enacted subsequent to the adoption of this amendment."
Section 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at an election to be held throughout the State on the first Tuesday after the first Monday in November, 1962, at which election all ballots shall have printed thereon the following:
"FOR the Constitutional Amendment granting the Legislature power to provide for trials de novo on all appeals from actions, rulings, or decisions of administrative or executive agencies of government."
"AGAINST the Constitutional Amendment granting the Legislature power to provide for trials de novo on all appeals from actions, rulings, or decisions of administrative or executive agencies of government."
If it appears from the returns of such election that a majority of the votes cast therein are for such amendment, same shall become a part of the Constitution of Texas.
Section 3. The Governor of the State of Texas is hereby directed to issue the necessary proclamation for such election and this amendment shall be published and the election shall be held as required by the Constitution and laws of this State.

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 6, 1962.
SENATE JOINT RESOLUTION NO. 6 proposing an Amendment to Article VII of the Constitution of Texas by adding a Section to be known as Section 3-b, providing that school taxes theretofore voted in any independent school district in the major portion of which is within Dallas County, shall not be abrogated, canceled or invalidated by a change in boundaries nor shall bonds voted, but unissued, at the time of such change, be invalidated by such change; authorizing the levy of taxes after such change without further election in the district as changed; providing an exception in the case of the annexation or consolidation of whole districts; providing for an election and the issuance of a proclamation therefor.
BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
Section 1. That Article VII of the Constitution of Texas be amended by adding thereto the following:
"Section 3-b. No tax for the maintenance of public free schools voted in any independent school district, the major portion of which is located in Dallas County, nor any bonds voted in any such district, but unissued, shall be abrogated, canceled or invalidated by change of any kind in the boundaries thereof. After any change in boundaries, the governing body of any such district, without the necessity of an additional election, shall have the power to assess, levy and collect ad valorem taxes on all taxable property within the boundaries of the district as changed, for the purposes of the maintenance of public free schools and the payment of principal of and interest on all bonded indebtedness outstanding against, or attributable, adjusted or allowed to, such district or any territory therein, in the amount, at the rate, or not to exceed the rate, and in the manner authorized in the district prior to the change in its boundaries, and further in accordance with the laws under which all such bonds, respectively, were voted; and such governing body also shall have the power, without the necessity of an additional election, to sell and deliver any unissued bonds voted in the district prior to any such change in boundaries, and to assess, levy and collect ad valorem taxes on all taxable property in the district as
