What's in a name?

If we were cattle, we guess it could be called our brand. It's a moniker that was hitched onto us when we were quite young--too young, in fact, to raise any objections or fuss about in a manner in which we could be understood.

It's something we're right proud of--something bestowed upon us by our loving and doting parents when we first made our appearance in the piney woods of East Texas over three score and ten years ago.

Realizing it was something we'd carry all through life, our parents must have given much thought and consideration to the idea of "branding" us in this manner. They must have had hopes that we'd be pleased with it, honor it, protect it, and cherish it with dignity for many, many years.

The trouble was that instead of one, they had to select names for two of us. When we made our arrival, we were one of twin boys!

Our guess is that we were the first to be named. When we were given the name of Aaron, some pressure was brought on to name the other twin Moses. In that manner, we would always carry the biblical names of two brothers, Moses and Aaron.

Mother wouldn't give the idea much consideration. She decided the names of Aaron and Amon would be given her first (and as it turned out, only set of twins. Amon survived only ten days after birth, and he was buried in Oak Hill Cemetery, in the piney woods a few miles out of Yellowpine, Texas.

We've had no burning desire to pursue our heritage any further. As one of the eight children (six boys and two girls) who grew to adulthood under the protection of our parents, we always thought that Dad and Mother did a pretty good job.

We all managed to stay out of prison and to keep the family name clean!

But another person had a different idea, and told us about it on a post card, saying in part:

"The Edgar family heritage book is being published . . . It is a guide to the discovery and documentation of your personal family heritage.

"I have spent thousands of dollars and months of work to research through 70 million families and I have located almost every Edgar family in the United States.

"The Edgar name is very rare, and my research has shown there is only about one Edgar family for every quarter million Americans.

"Because of this rarity, there will only be one edition. It is limited to one book per household, and it will be printed only on your specific order . . ."

We finally found, in a very small type, that this book might be a bargain of the century at \$27.85!

About the best we can do is say: "Thanks, but no, thanks."

As we've said, we're right proud of our name. It's one we've learned to answer to all these years, and we've never seen anything in print to imply that it is not still an honorable name.

But we're not intensely interested in delving into its heritage!

Like, when we were working with others in compiling the history of Munday, we asked a friend about writing her family history for the book. "We don't know much about our family history," the friend said. "We're afraid to look into it--we might find some horse thieves way back yonder!"

With our sister, it's different. She's been working on our family history for years and years in an effort to complete her book. She's talked it, too, but not enough to instill a "working interest" with us.

We're reminded of the poet who said: "He who steals my purse steals trash, but he who takes from me my good name robs me of that which profits him nothing, but makes me poor, indeed!"

Funds Increasing For Purchase Of Ambulance

Between attending classes and all the other various and sundry items that make up the individual Munday Ambulance volunteer's life, several efforts on their part as a group to raise funds for a new ambulance are now history.

The Ernest Tubb-Tony Douglas concert on Thursday evening brought a lot of out-of-town people to Munday and the Munday people supported it fairly well, too. However, the cost for a show, such as this is sizeable. Bobby Hutchinson wanted the area people to know that \$3239.00 was brought in but the expenses totaled \$3700.54, so they reaped a deficit of \$461.54 on that particular project.

Bank's Deposits Climbing!

A condensed statement of the First National Bank in Munday for the first quarter of 1981 was released this week, and some of the figures contained therein are nothing short of amazing!

For instance, the bank's deposits continue at a near-record high figure, and the "\$64 question" is "Why?" Anyway, they tell the story that Munday is not quite in a depression era!

According to the statement, the bank's deposits stood at \$19,677,260.59 at the close of business on March 31, 1981. That figure is \$19 million, folks, in case you have trouble reading figures that high.

Loans and discounts stand at a record figure of \$10,603,398.92, which is due to drought conditions in 1980, resulting in short crops.

Commenting on the record deposits, Gary Schur, president of the bank, said: "We don't know just exactly why our deposits remain so high, since we've had no cash crop income since December 31. We can name two contributing factors, however: 1. That money market savings certificates are very popular, and we've experienced rapid growth in this area; and, 2. That SBA disaster loans have brought about an increase in deposits."

At any rate, the bank's statement reflects very stable conditions in this area--and that's nothing to be ashamed of!

Council Holds Special Session

The City Council of the City of Munday, Texas met April 20, 1981 in special session at the Munday City Hall at 7:30 p.m.

Members present: Mayor James W. Reid and aldermen A. Dale Selzer, M. M. Boone, and Ray Lynn Hardin. Members absent: Donald Hobert and Larry Smith.

Mayor Reid called the meeting to order. Minutes of the April 7, 1981 regular meeting were read. Selzer moved for approval as written. Hardin seconded, all for.

First business was examination of the proposed seal-coat project for 1981. Advertisement for bid forms call for seal coat of 34,462 square yards of paving. Selzer moved the project proposed be approved and it be advertised for bid. Hardin seconded. All members voted for. (Bid opening will be at 7:30 p.m. on May 12, 1981 at the City Hall).

Next business was discussion of bids received on some waterworks supplies. This was delayed until Donald Hobert returns to Munday.

Notice is to be given to the Munday Courier for applications for pool operator for the summer of 1981.

General Telephone Company is to be contacted in regard to an underground line now being installed in the East part of Munday. Planning for this line was totally inadequate and will cause maintenance problems to other utilities from now on.

No other business. Meeting was adjourned.

over the outcome. They gleaned a profit of \$462.36 on the barbecue supper served in the high school cafeteria the same evening. The also harvested \$1259.25 in proceeds from the television they gave away at the concert. M. L. Waggoner was winner of the television. An auction of their labor by members of Youth In Action brought in money, too.

The concession stand at the volleyball tournament netted the fund \$415.00 several weeks ago.

When the other ambulance was purchased four years ago, a savings account was immediately opened. All donations have been placed in this account and to date the account stands at \$9608.40.

Since fund raising began "for real" on a new ambulance, the volunteers have raised \$1675.07. Memorials and private donations have totaled \$2132.50 during this time period, so \$3807.57 in this short time is great!

There is no rest for the volunteers because they are truly a "working bunch". The next item on their agenda for bringing in needed funds is a concession stand at the Munday Lions Club Slow Pitch tournament Thursday, April 30 through Saturday, May 2. They will also have a concession stand on the city square Saturday, Mar 9, during the art and craft sale.

The volunteers do not feel their efforts have been in vain, and hope that people are understanding that the need for an ambulance is real. The "new" ambulance, as we continue to refer to it, is now four years old, and has the mileage on it that is considered very near the life of an emergency vehicle. However, the volunteers and Bobby Hutchinson feel it will make an ideal "back-up" vehicle--something they do not now have in the old Pontiac. Both ambulances were in service at the same time on Monday of this week.

In commenting on the overall task before them, Bobby Hutchinson stated, "We will reach the needed goal. At this time, we do not know how many fund raising events will be needed but we are prepared to do whatever is necessary. I take this opportunity to thank all the volunteers, who work so closely with me, for their untiring efforts. On behalf of these volunteers and myself we thank the Munday firemen who helped us, both inside and outside, at the concert Thursday evening. We also appreciate the time given by so many interested citizens. We couldn't do without you and feel you will be there when we need to call on you again."

Coach Lowrey Comments

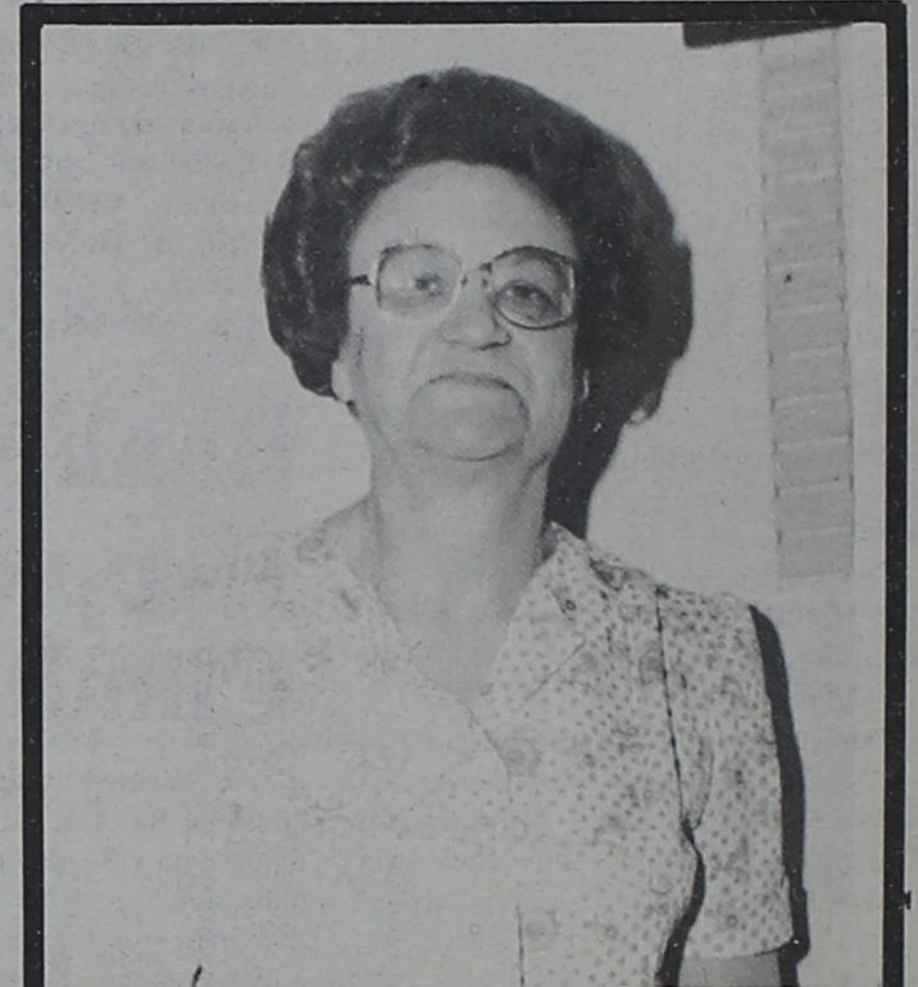

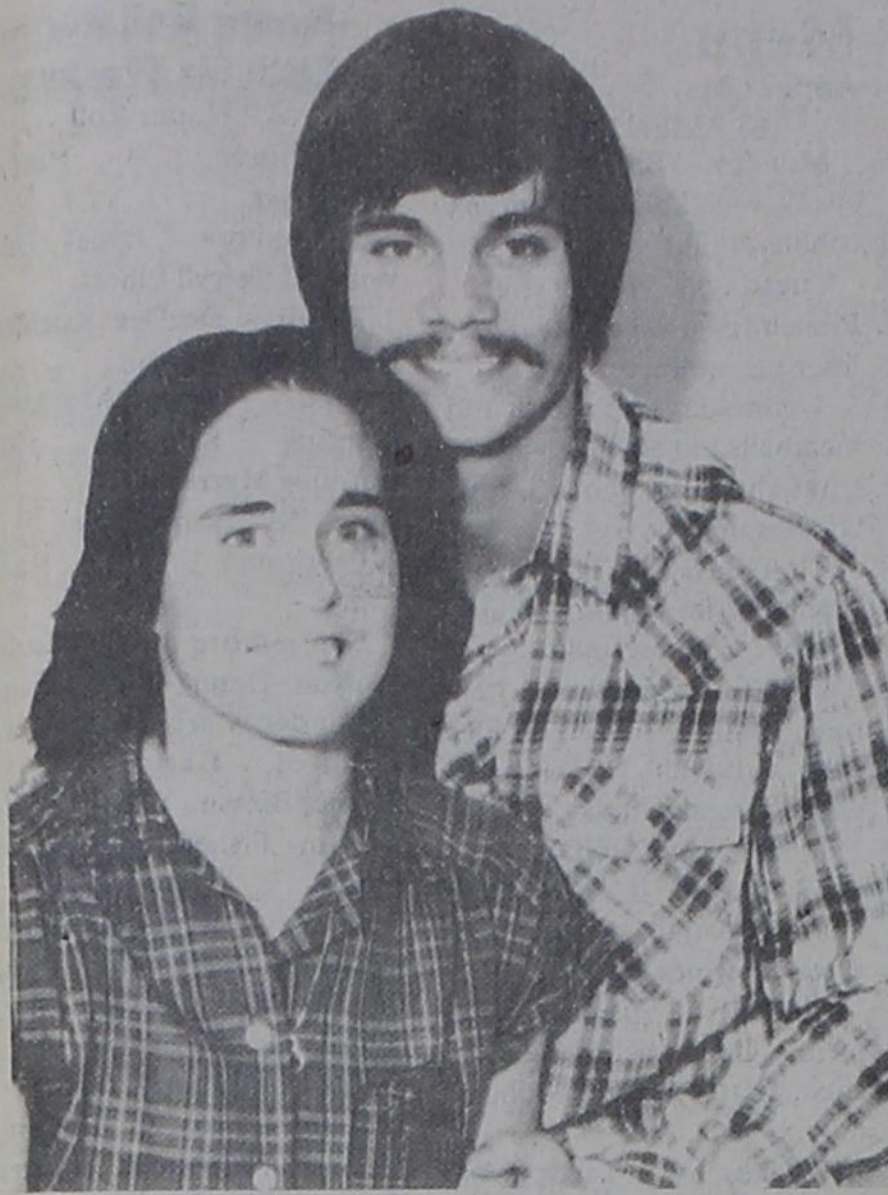

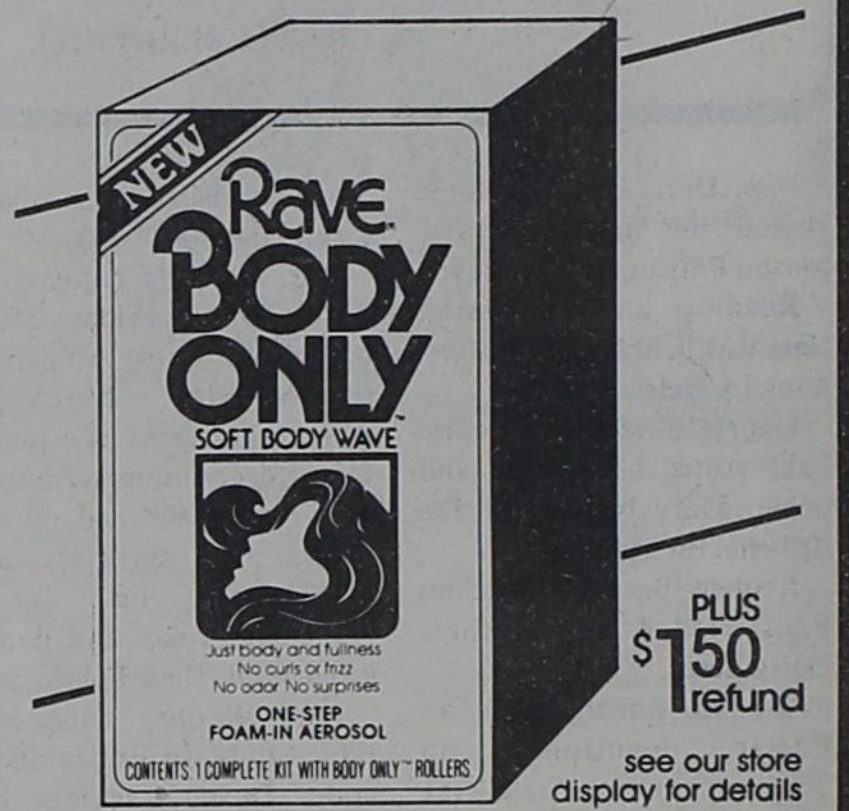

Wheat Report

Some scattered showers with cooler temperatures during this week brought temporary relief to parts of the Hard Red Winter Wheat Belt. It continues to be the general impression for most of the Belt, however, that additional rainfall during the next five to six weeks will be sorely needed. In most areas it is generally believed that subsoil moisture is severely lacking, with topsoil moisture in short supply, no doubt because the moisture received thus far has been so light, in addition to the earlier problems of higher-than-normal temperatures along with the high winds, with these conditions fairly prevalent prior to the last couple of days.

The status of the Hard Red Winter wheat crop was reportedly rated as follows: Oklahoma was rated fair-to-good, with approximately 70% jointed, as compared with 40% at this stage last year; Kansas was rated good, with 45% having jointed as compared to only 5% at this stage last year; and Texas was rated fair-to-good, with 5% being headed, compared with 3% at this time last year.

Early in the week the wheat market sagged 5 1/2¢ per bushel and rallied somewhat each day thereafter, closing out today up 7¢ from last Friday's close. The wire service reported optimism of some individuals in Washington that an end to the U. S. S. R. embargo might be drawing near.

This week found various purchases of U. S. wheat, with Japan buying 3.4 million bushels of Hard Red Winter and Peru buying 2.8 million bushels of Hard Red Winter. In addition, we understand Egypt bought 3.9 million bushels of U. S. Western White wheat over last weekend. The results of the tender by Saudi Arabia are unknown as of this writing. This week also found both the Philippines and Indonesia passing concerning their respective tenders.

Possible new business is anticipated next week as tenders have been announced by Brazil, Japan and Mexico. Mexico has also announced a tender next week for either No. 2 Yellow grain sorghum or No. 3 Yellow corn. Word was also received that Venezuela is expected to be in the market soon for purchases of corn and grain sorghum.

Wheat export inspections for the week ending April 9, 1981 were 28,113,000 bushels, compared to 31,398,000 bushels for the previous week. Total loadings since June 1, 1980 were 1,271,154 bushels, compared to 1,139,831 bushels for the same period a year ago. *****
