Moguls Squeak By Haskell In Opener

If excitement was what the Munday Mogul fans were looking for in the season's first contest, excitement was certainly what they got, as the team took a dramatic come-from-behind victory over the Haskell Indians. The 27-25 win came with only five seconds left in the game when placekicker Lowell Hutchens booted a 29-yard field goal.

It was Hutchens' second three-pointer of the night, and the burly junior also nailed all three of his extra point attempts. Hutchens was injured on his final play, but is expected to be able to play Friday when the Moguls take on district rival Knox City on Greyhound turf. The Hounds, 13-7 losers to Seymour last week, are expected to be contenders in the north zone of District 5-A, while the Moguls are predicted to win the south zone.

Pacing the Mogul running game was senior tailback Anthony Stinnett, who accounted for 189 yards on 34 carries and scored Munday's first two touchdowns. Stinnett also shared some time at quarterback with sophomore Marc Andrade.

Munday took early control of the game when Brian Ramirez tipped Haskell's first pass and Terry Collier rushed in for the interception. Just three plays later, Stinnett took a third and seven handoff and exploded through the right side, outrunning everybody on the field all 64 yards to the goal. Hutchens connected on his first PAT, and Munday took a 7-0 lead with 8:05 left in the first quarter.

Then the scoring see-saw began, as Haskell came back with its passing game intact. A 58-yard strike from Chan Guess to Mark Young put the Indians inside the Mogul ten, and after a couple of short running plays, Guess hit Louie Torres for the score. The kick failed, and Munday held on to a narrow lead.

Starting from scrimmage on their own 46, the Moguls mounted a twelve-play drive, aided by a 15-yard Indian penalty that gave Munday a first down inside the Haskell 25. Stinnett nicked and dived it to the goal, plunging over from the one just as the first quarter clock ran down, and Hutchens' second PAT extended the Moguls' lead to 14-6.

Again the Indians fought back, taking only six plays to reach paydirt. Stephon Brockington did the honors, wrenching away from Mogul tackles for a 19-yard sprint into the endzone. Opting for a two-point attempt to tie the game, the Indians had to settle for just the touchdown again as the run failed and Munday still led.

On Munday's first play after the kickoff, freshman back Terry Collier hauled in an Andrade pass, then tried to change directions and was hit, causing the ball to pop loose.

Haskell recovered, but the Indians' passing attack stalled and they were forced to punt. The Moguls coughed the ball up again on Stinnett's fumble, and Haskell had another chance but couldn't get much past the line of scrimmage. After the ball went over on downs, Munday reeled off four quick first downs before Andrade's third pass from the ten was intercepted by Guess just before the half ended.

Haskell took the lead for the first time on the initial series of the second half. A good kickoff return put the Indians in Mogul territory, and runs by Brockington, Patrick Perez, Fred Shaw and Alberto Alvarez and a pass to Derrick Billington set up Shaw's two-yard burst across the goal. Again the two-point run was no good, but the Moguls found themselves having to play catch-up, even after Hutchens kicked a 24-yard field goal later in

Local Firefighters To Host Convention

A large group of out-of-towners is expected here Sunday, September 13, for the 109th semi-annual convention of the West Texas Firemen and Fire Marshals' Association. Registration for firemen will be from 10 a.m. to 1 p.m. at the local

fire station, and a business meeting and election of officers is set for 1 p.m. in the Munday High School auditorium.

The evening meal will be served at 6 p.m. at the fire station by the local fire department with out-of-town firemen and their families as guests.

It will be an afternoon of free fun and excitement, and everyone is invited to come downtown and watch the events.

Munday Schools Claim Increase In Enrollment

Munday schools ended their first week of the 1987-88 year with 410 students, up some five young people from last year. The largest gain is in junior high, which picked up eight students this year.

The largest class this year is the seventh grade, with 41 pupils. The eighth grade class, with only 24 students, is the smallest, followed by the fifth, tenth and eleventh grades with 25 each and the third grade with 26.

Broken down into the three separate schools, elementary principal Doug Donoho reported 221 students the first day of school and 229 on Friday, September 4. Junior high enrollment, according to secondary principal Bill Kingston, is 65, and 116 students entered in high school.

Knox County 4-H Program Ready To Roll in 1987-88

Three sign-up periods for youths interested in joining 4-H have been announced by county Extension agents Jane Rowan and David Tumire. 4-H is open to young people in the third grade through age 19. Those who are already in a 4-H club need to re-enroll again each year.

Signups will be held at 4:15 p.m. Monday, September 14, at the Extension office of the Knox County Courthouse in Benjamin; at 7 p.m. September 14 at the Knox City Community Center; and at 7 p.m. Tuesday, September 15, at the First United Methodist Church in Munday.

The 4-H program, administered by the Texas Agricultural Extension Service, is for all youths regardless of race, color, ethnic background, economic status or cultural differences. The purpose of 4-H is to develop leadership and character in young people. 4-H'ers learn by doing through working on projects and participating in club meetings and 4-H activities.

Members can participate in a variety of projects, such as foods, clothing, animal projects, electricity, photography, arts and crafts and many others. Organized recreation is also planned, and 4-H'ers go on trips and tour interesting and

Bloodmobile To Be Here September 18

A Red River Regional Red Cross Bloodmobile visit is planned for Friday, September 18, at the Munday Community Center. Donors are urged to take time to give blood between the hours of 2:45 and 6:30 p.m.

People offer a variety of reasons for not giving blood - "Nobody asked me." "I never thought about it." "There's just no convenient opportunity." But the reasons for giving far outweigh those listed.

In our region, over 95 units or pints of blood are needed each day, year-round, including holidays. What are these units needed for? A child who has been burned, a man undergoing heart surgery, a young woman with a bleeding ulcer, a leukemia patient. It takes only a short time to give blood - approximately 40-45 minutes - and it means so much to the patient who uses it and to that patient's family.

Through the American Red Cross, "community responsibility philosophy," patients who use the blood do not have to worry about being personally responsible for replacing it. This philosophy is used in collecting 80 percent of all the blood donated in the United States.

If nobody ever asked you before, consider yourself invited to donate. To give or not to give, only you can make the decision when the Bloodmobile is in Munday next week.

New Class To Aid Reading Skills For Young Students

Young students at Munday Elementary School who have trouble in reading and spelling will be able to take part in a new class this year. First and second graders who need additional help in these subjects will attend a reading improvement and tutoring class from 2:35-3:30 p.m. daily. The school day for other first and second graders ends at 2:35.

The new class will begin September 14 and will be conducted by the regular first and second grade teachers.

Knox City Men Sponsor Supper

The Knox City Methodist Men are hosting a pancake supper from 5-7:30 p.m. Friday, September 11, at the church, which is located at 406 S. Second. Proceeds from the meal will help finance new foyer doors for the church.

Students will be introduced to the "Montgomery Model", a highly concentrated phonics reading and spelling program. Students who need this extra help will receive it along with their regular reading program, and first and second graders who need extra assistance in math will also receive tutoring at this time.

"It is very important that children this age are given the opportunity to learn to read and learn basic spelling, grammar and math," said elementary principal Doug Donoho. "Success in these basic areas will help ensure success later on in all subject areas."

Students in grades three through six who need additional help in reading will participate in this new program, along with their regular class work, during their normal reading and spelling classes.

The regular tutoring program available for any student in all subjects, which has been in effect the past two years, will continue. Tutoring classes begin September 21 before and after school.

The officers invite all Knox County producers to this meeting. The Brazos Valley Young Farmers organization is open to any person interested in agriculture.

Retirement Of Longtime Farm Manager Announced

The last day of June, 1987, marked the end of an era in the life of Jack A. Nuckols of Goree, who retired that day after 34 years of employment by the Goode Farms.

When Nuckols was first hired as farm and ranch foreman for the late William J. 'Bill' Goode, he was working as parts manager at Nolen Farm Machinery in Seymour. They sold and repaired Oliver tractors, and Nuckols used only Oliver tractors on his farms - 17 at that time. In 1953 farm workers earned 60 cents an hour, and many farm workers were needed to run that many tractors. Nuckols was able to put his experience in disassembling and repairing Oliver tractors to good use; he said he has probably trained as many as 150 or 200 young men to work on the tractors without a single major accident.

After 34 years of farming, he doesn't remember any crop failures - just a few slim years. Nuckols is not retiring completely, as he will still be farming some acreage for a few more years and enjoying doing some tractor driving himself.

For his retirement gift from Goode farms, George and Jan Goode Wise of Goree and Marilyn Goode of Washington, D.C. presented Jack and his wife, Dean, with

a gift certificate for a seven-day trip to Hawaii. They reported a great trip with time spent on Oahu and Maui Islands. The couple enjoyed golfing and sightseeing in low 90 degree temperatures - then they found out that it had been in the 80's at home!

During their years in Goree, the Nuckols raised two children, Troy of Munday and Cinda Foerster of Weatherford, and they have six grandchildren. The couple has been involved in various school and community activities as well as supporting the Munday Chamber of Commerce and other local organizations.

NEW IDEAS IN MICROWAVABLE FOODS

Food processors are rushing to meet the demands of their newest market - microwavable food. New products are being tailor made for microwave use and test marketed in places around the country. According to Food Technology magazine, the following products may soon be at a grocery store near you.

*Shelf stable prepared entrees - These entrees have an 18 month shelf life, and don't require refrigeration. They can go directly into the microwave and be ready to eat in two minutes, or eight to ten minutes in a conventional oven. These entrees are available in ten different varieties.

*Precooked and browned meat, poultry and fish - These entrees feature two servings of whole, select cuts of pre-browned, pre-cooked meat. This type of processing offers consumers the browning which some microwaves cannot do, and a grilled flavor. They are vacuum-packaged and available with chicken, sausage, fish or pork chops.

*Microwave chicken nuggets - These chicken nuggets, especially made for heating in the microwave, are pre-cooked, pre-browned, and coated with a special crumb breading that will stay crisp after heating.

*Individually packaged entrees, vegetables, side dishes, and desserts - By individually packaging this variety of foods, food processors are giving consumers a chance to create their own mix-and-match microwavable dinner. This concept should appeal to those who want a

fast "home cooked" meal and are tired of eating out. These products are intended to be eaten as fresh food, therefore their refrigeration shelf life is only two to four days.

*Soups - Microwavable soups are shelf-stable and come in containers that can be used in the microwave once the aluminum top is removed.

*Potato products - French fries, tater tots and hash browns are being packaged for microwave use. They brown with heating and remain crisp.

*Peanut brittle - Though the peanuts must be supplied by the consumer, this product features pieces of molded hard candy which melt during microwave heating. This was designed to allow consumers to make "fool-proof" peanut brittle.

*Sundaes - The microwavable sundae is a scoop of vanilla ice cream surrounded by a choice of fudge, mint, or caramel toppings. The toppings require thirty seconds of heating in the microwave, yet because of the way it's assembled, the ice cream doesn't melt.

These products are just the beginning of microwavable foods. There are many other varieties still in the research and development stages as food processors rush to get into the rapidly growing microwave market.

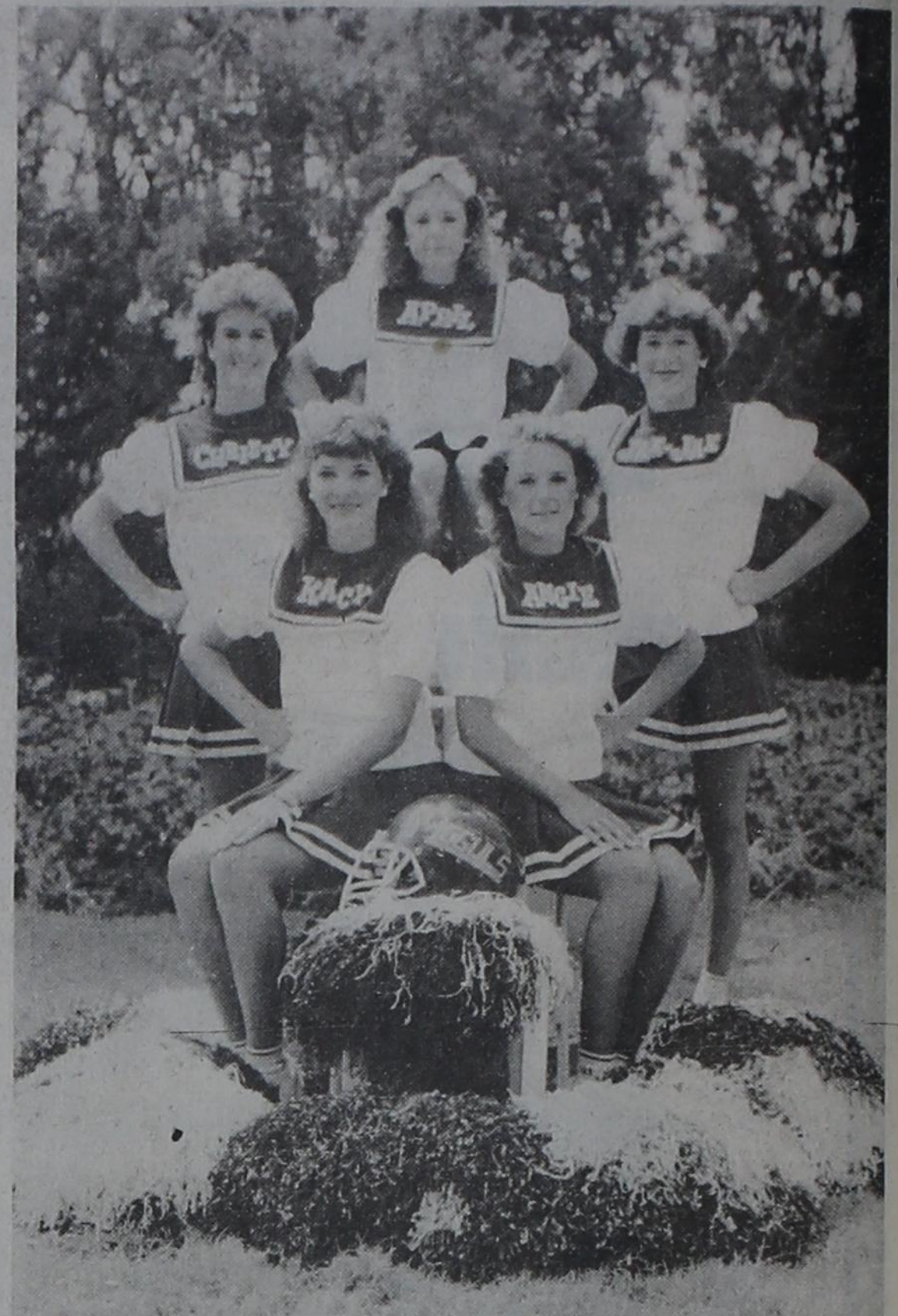

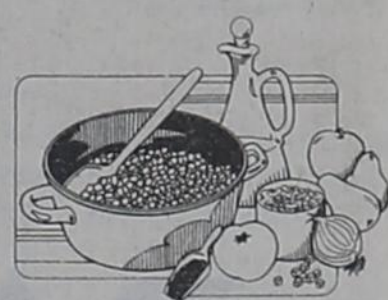

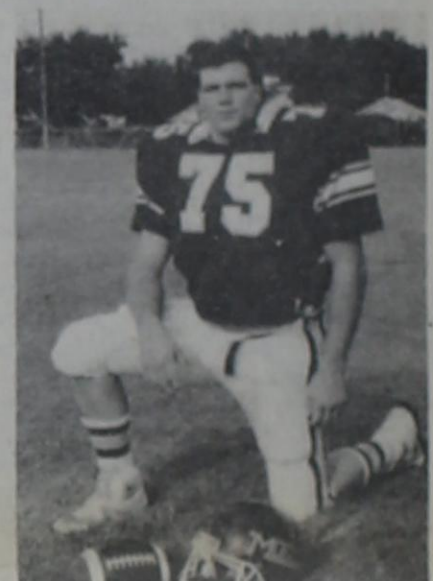

the quarter to narrow Haskell's lead to one point.

The fourth quarter was the one that really left fans on both sides of the field on the edge of their seats. On the second play, Collier nabbed his second interception, then two plays later caught a 32-yard touch-down pass to put the Moguls back on top. Hutchens' kick made it 24-18.

The teams added to the general hysteria by trading fumbles mid-quarter, but only Haskell took advantage of being on the receiving end of a give-away ball. Hampered by penalties sandwiched around a fumble the Indian offense retrieved, the series looked like it was going nowhere when a desperation pass on fourth down found its mark. Young pulled the ball in and was tackled on the one, from which point Brockington sped in for his second TD. With hundreds of eyes glued to him, Patrick Perez drilled his first extra point over the uprights to give Haskell a 25-24 lead with just under five minutes left to play.

Munday kept the ball for the majority of that five minutes, going with Stinnett and the steady ground game down to the nine, where time almost ran out. On first down and with only five seconds showing on the clock, Munday called time out and Hutchens went in to put Munday on top as the buzzer sounded.

Due to the Labor Day holiday, Coach Steele was only available for a brief comment about the game before the Courier went to press. He said he thought the team played very well for its first outing and was encouraged by the desire to win that was the impetus for the final drive.

"Knox City scares me to death," he continued, referring to this week's game. "They'll play us better than they will anybody else. They have one of the best running backs in North Texas in Anthony Oudems, another good back in Richie Saxton and a talented quarterback in Billy Large. We will have to play excellent football to win, especially on their home field."

The always heated cross-county rivalry fires up every year when Munday and Knox City play. Their last game, a bi-district contest in the fall of '86, ended with Munday surviving 21-7, and the last time the Moguls played in Knox City, in 1985, the Hounds held the defending state champions to only two touchdowns. Friday night's game is expected to be no different, and coaches for both squads are gearing their teams up for one of the year's toughest contests.

Munday is, in the coach's words,

"pretty banged up" from the Haskell game, and several players, including Stinnett and Donald Edgington, are listed as questionable. Trey Thompson and Sam Hunter are still out, as well. Knox City may have to play without Oudems, who was hurt against Seymour.

Kickoff for the game is 8 p.m. and a standing room only crowd is expected.

The Mogul junior varsity put on a good performance but was defeated by a larger Haskell team by an 8-0 margin Thursday night at Haskell. This week the JV makes its home-town debut, hosting the Knox City junior varsity at 7 p.m. Thursday, September 10.

Wildcats Outlast Loraine In Opener

The Goree Wildcats, beginning their second grid season after a year's layoff, were victorious in their first 1987 game Friday night. The Cats defeated Loraine 62-56 in a battle of the offenses.

Standouts for Goree were Spencer Dixon, who carried the ball 20 times for 143 yards and two touchdowns and also tallied on a 68-yard kickoff return, Grady Weaver, who scored once and rushed 71 yards on 11 carries and caught four passes for 60 yards and two more TD's, and quarterback Jimmy Castorena, who completed six of eleven passes for 123 yards, threw for four touchdowns and was never intercepted.

Paul Lucio was on the receiving end of two of Castorena's 15-yard scoring strikes, and Lonnie Shahan had a 48-yard reception for another touchdown. Lucio also connected on three of five extra point attempts.

It was a good outing for the team, according to coach Cliff Gilmore. Loraine was undefeated last year, and has more players than Goree, having planned to play 11-man football this year but dropping back to six-man just before school started.

The Wildcats will host the Harold Hornets this Friday, with kickoff set for 7:30 p.m. Harold won 48-6 over Woodson last week, and will be a test of the Wildcats' strength. Coach Gilmore said he was pleased with the team's offensive show but feels the defense must improve to keep up with other teams in the district.

HOME LAWN WEED CONTROL

Home lawn weed control can be very frustrating. Following a good maintenance program will help a lot in building a dense turf that will discourage the invasion of weeds. On the other hand, a weak, thin turf will allow weed seed germination and establishment.

Once a weed is established, it can either be removed physically by digging or it can be removed chemically. Physical digging is fine if the

weeds are few and if they do not have underground reproduction organs. The dallisgrass plant is a good example of just such a plant. You can dig it up but the chances are it will just regrow from the underground parts that you don't get.

When considering chemical weed control, it might be well to remember that you are trying to remove an undesirable plant that is growing among desirable plants and many times it is not an easy task.

Generally, lawn weeds may be divided into two groups, those that have broad leaves such as chickweed, henbit, spurge, etc. and those that have grassy type leaves such as dallisgrass, crabgrass, goosegrass, etc.

Grassy type weeds may be controlled in bermuda lawns with either MSMA (monosodium methanearsonate) or DSMA (disodium methanearsonate). Several applications may be necessary and the bermuda may turn yellow, but it should recover. Grassy type weeds cannot be selectively controlled in a St. Augustine lawn. They may be removed by spot treating just the individual weed with either of the above chemicals but they will kill the St. Augustine.

Broadleaf weeds are usually controlled with products containing 2,4-D, MCPP and dicamba. These chemicals are not safe for every lawn or for every situation. The only way to be sure is to check the label on the container. Be sure the chemical will control the weed you are after, is safe to use on the type of lawn you have and will not injure nearby ornamental plants.

For best results, apply the herbicide only when the weeds are actively growing. The hardest time to kill a weed is when it is hot and dry and the weed is under moisture stress. Try to pick a cooler day with little wind movement and when soil moisture levels are fairly high.

Summer annual weed control can be obtained by applying pre-emergent chemicals such as Balan, Dacthal or Betasan in mid to late-February each year. For winter annual weed control, apply pre-emergent chemicals such as Balan, Dacthal or Betasan in early to late September each year.

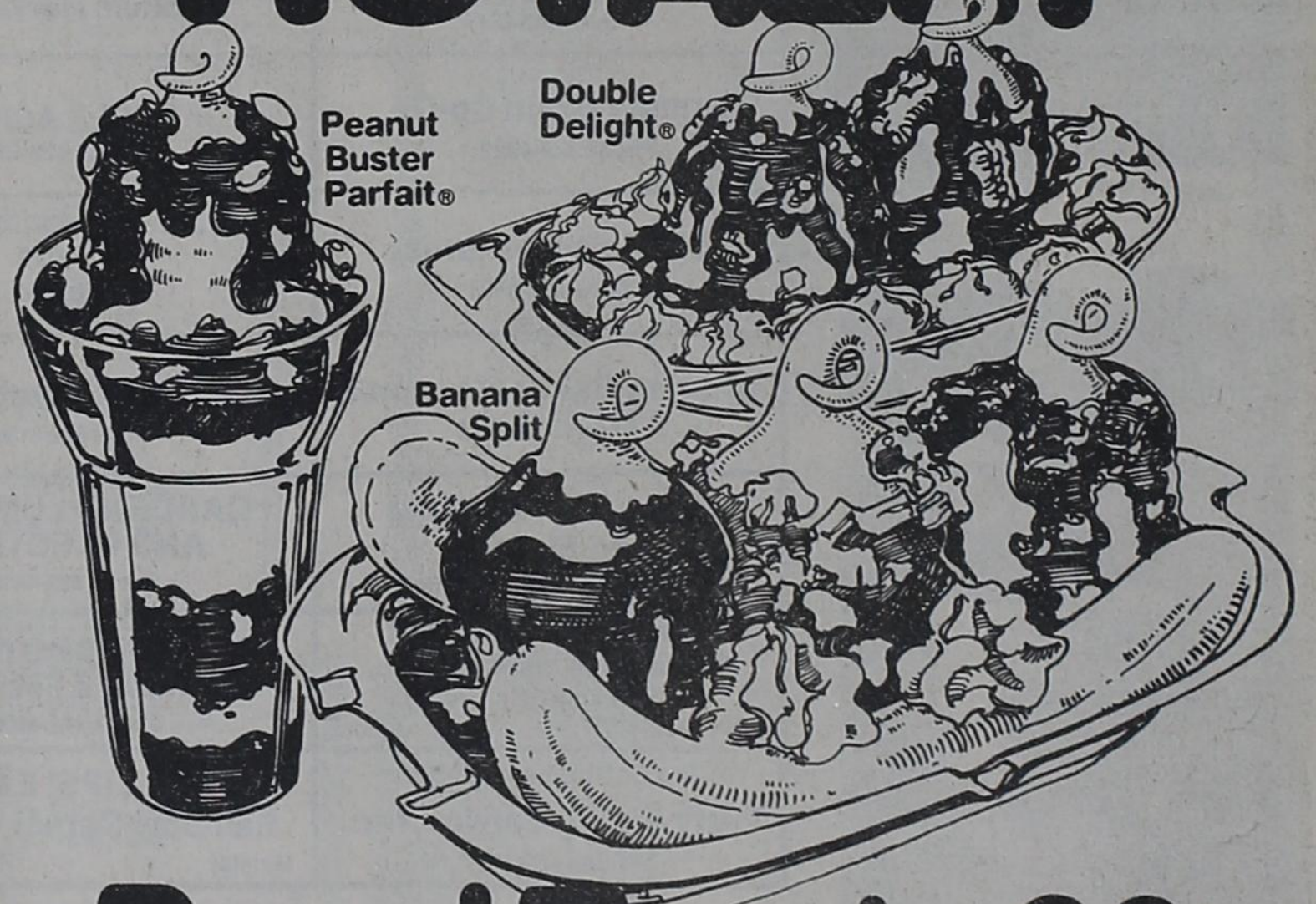

Third Anniversary Of Texas Safety Belt Law Observed

Two years after the safety belt law went into effect, Texans are still buckling up in record numbers and front-seat fatalities are still declining, says George R. Gustafson, president of Texas Safety Association and a spokesman for the Texas Coalition for Safety Belts.

"Our rate of safety belt use has quadrupled since pre-law days, and we've showed remarkable staying power," Gustafson announced September 1. "The latest study by Texas Transportation Institute shows about 60% of our drivers buckling up."

Col. Leo Gossett, director of the Department of Public Safety, said, "According to preliminary statistics, there's been a decrease of more than 100 traffic accident deaths in front-seat positions of cars and light trucks from September of 1986

through June of this year compared to the same period the year before.

"DPS troopers continue to be watchful for violations of the Texas safety belt and child restraint laws, issuing over 8,000 tickets a month on rural roadways," Gossett added.

During the upcoming Labor Day weekend, the Texas coalition will work with safety belt coalitions

from five neighboring states to make the good news better.

Oklahoma, New Mexico, Colorado, Missouri, and Kansas are cooperating in "Project Safe Conduct," a holiday safety campaign which will encourage motorists to wear their belts, watch their speed, and avoid driving under the influence of alcohol.

Highway troopers in several states, including Texas, will be out in force over the three-day weekend. The event will coincide with the DPS's "Operation Motorcade," in which the state headquarters in Austin keeps a running fatality count.

"Labor Day is a dangerous time for Texas motorists," Gustafson noted. "It's the last big weekend of the summer vacation season, and we usually see more vehicles on the

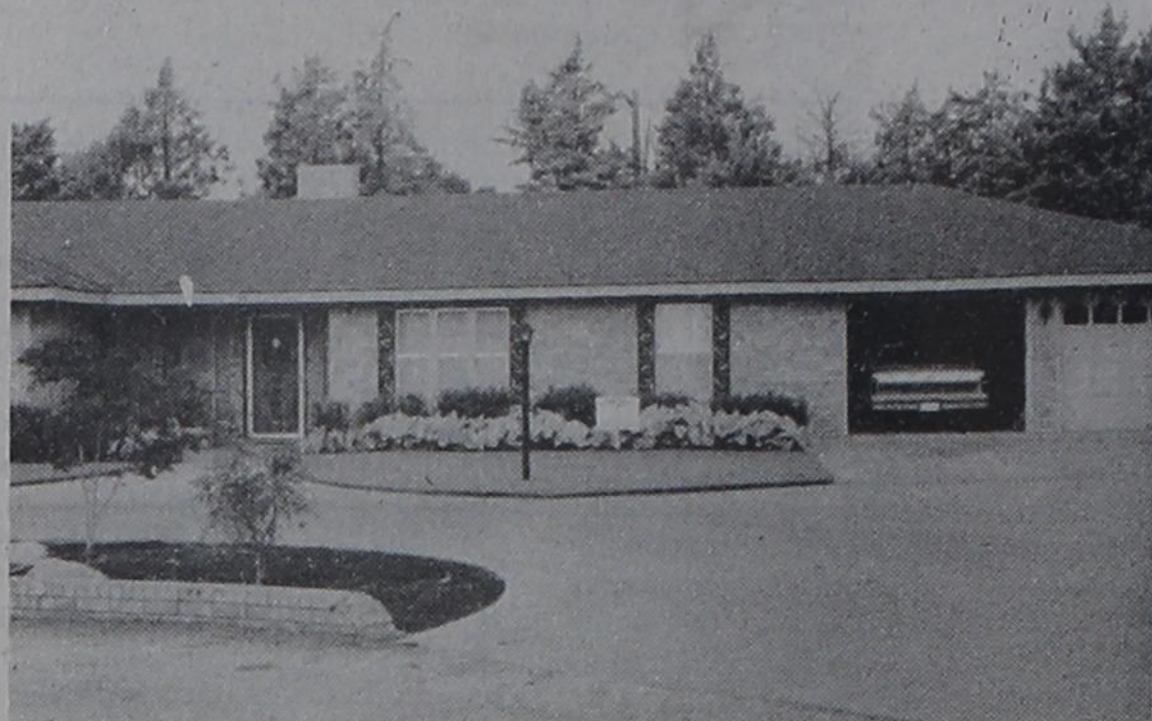
highway. We hope people will keep this in mind and use extra caution."

The Texas Jaycees, one of the coalition's member groups, will operate 125 rest stops on interstates and other major highways. The Jaycees will serve free coffee, soft drinks, and rolls, and will offer travelers a chance to get out of their vehicles for a few moments.

The coalition has encouraged other member groups to sponsor public awareness activities, either at the state or local level.

BRIEF EXPLANATORY STATEMENTS OF PROPOSED

CONSTITUTIONAL AMENDMENTS

SPECIAL ELECTION

NOVEMBER 3, 1987

PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 104 proposes a constitutional amendment to allow the legislature to provide a guarantee for the Texas grain warehouse self-insurance fund. The guarantee of the fund may not exceed \$5 million, and when the fund reaches \$5 million, the guarantee will cease. The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide for the surety of a grain warehouse fund to be established by the grain industry for the protection of farmers and depositors of grain in public warehouse facilities."

PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 60 proposes a constitutional amendment to permit rural fire prevention districts in counties with populations over 400,000 to levy a tax at a rate not to exceed six cents (\$.06) per \$100 property valuation for the district, if the voters of the district approve the tax.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to raise the maximum property tax rate that may be adopted by certain rural fire prevention districts, but only if approved by the districts' residents."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 48 proposes a constitutional amendment to extend the school ad valorem tax exemption for elderly persons to the surviving spouse of a person receiving the exemption. If a surviving spouse is at least 55 years old at the time of death of the person receiving the exemption, ad valorem public school taxes could not be increased as long as the homestead remained the residence homestead of the surviving spouse.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to limit school tax increases on the residence homestead of the surviving spouse of an elderly person if the surviving spouse is at least 55 years of age."

PROPOSITION NO. 4 ON THE BALLOT

House Joint Resolution 5 proposes a constitutional amendment to allow the legislature to create programs and make loans and grants of money for development and diversification of the economy, elimination of unemployment and underemployment, stimulation of agricultural innovation, promotion of agricultural enterprises, and development of transportation and commerce. Bonds or other obligations payable from ad valorem taxes must be approved by the voters in the political subdivision seeking such funding sources.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide assistance to encourage economic development in the state."

PROPOSITION NO. 5 ON THE BALLOT

House Joint Resolution 65 proposes a constitutional amendment to permit the State Department of Highways and Public Transportation to contract with the Texas Turnpike Authority and to contribute money to the costs of turnpikes, toll roads and toll bridges of the Authority. The amendment would authorize the governing body of a county with a population over 400,000, a county adjoining such county, and any city or district located in or partially in such county to make agreements with the Texas Turnpike Authority and levy ad valorem taxes to pay part or all of the principal and interest on Turnpike Authority bonds and to pay maintenance and operating expenses of the Turnpike Authority, if the voters approve the tax.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing agreements between the State Department of Highways and Public Transportation and the Texas Turnpike Authority and the governing bodies of counties with a population of more than 400,000, adjoining counties, and cities and districts located in those counties to aid turnpikes, toll roads, and toll bridges by guaranteeing bonds issued by the Texas Turnpike Authority."

PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 4 proposes a constitutional amendment to allow the legislature to establish three separate development funds. A Texas product development fund could be established to aid in the development and production of new or improved products in the state. The amendment would authorize the issuance of up to \$15 million of general obligation bonds to provide initial funding for the program. A Texas small business incubator fund could be established to foster and stimulate the development of small businesses in the state. Small businesses operating under the program would be exempt from ad valorem taxation. The amendment would authorize the issuance of up to \$10 million in general obligation bonds to provide initial funding for the program. A Texas agricultural fund could be established to promote the production, processing and marketing of agricultural products produced primarily in Texas by small Texas agricultural businesses. The amendment would authorize the issuance of general obligation bonds in the amount of \$100 million outstanding at one time to carry out the agricultural fund program. The legislature could require review and approval of the issuance of bonds and the use of bond proceeds.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide for state financing of the development and production of Texas products and businesses."

PROPOSITION NO. 7 ON THE BALLOT

Senate Joint Resolution 55 proposes a constitutional amendment to authorize the legislature to provide for the issuance of \$400 million in general obligation bonds to be used for loans to local governments for acquisition, construction, repair, renovation, and equipment of public facilities or for grants to local governments for planning public facilities. The amendment would also permit the issuance of revenue bonds for the same purposes to be repaid from excess revenue from repayments of loans made under the amendment and from other revenues pledged to the retirement of revenue bonds. The amendment also authorizes the legislature to provide for review and approval of the issuance of the bonds and the use of the bond proceeds.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of general obligation bonds to finance certain local public facilities."

PROPOSITION NO. 8 ON THE BALLOT

Senate Joint Resolution 56 proposes a constitutional amendment to allow the legislature to authorize the issuance of up to \$500 million in general obligation bonds to be used to acquire, construct, and equip new correctional institutions and mental health and mental retardation institutions or to repair existing institutions. The amendment also authorizes the legislature to provide for review and approval of the issuance of the bonds and the projects to be financed by the bond proceeds.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the issuance of general obligation bonds for projects relating to corrections institutions

and mental health and mental retardation facilities."

PROPOSITION NO. 9 ON THE BALLOT

Senate Joint Resolution 9 proposes a constitutional amendment to provide that a state legislator is eligible to serve in another state office even if the compensation of the office was increased during his legislative term or even if the appointment is made in whole or in part (including Senate confirmation) by the legislature. The legislator could not, however, receive the increased compensation approved during his legislative term.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide that a member of the legislature is eligible to be elected or appointed and to serve in a different state office but may not receive an increase in compensation granted to that office during the legislative term to which he was elected."

PROPOSITION NO. 10 ON THE BALLOT

Subsections (d) and (e) of Section 1 of Senate Joint Resolution 12 propose a constitutional amendment to allow the legislature to exempt from ad valorem taxation all tangible personal property except structures which are used as residential dwellings and property held or used for the production of income. This exemption would be in addition to the personal property homestead exemption already established by the constitution. If the legislature authorizes the exemption of additional personal property from taxation, under this amendment, local political subdivisions may pass resolutions providing for taxation of such property unless the property is exempt from ad valorem taxation under another law.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow the legislature to exempt from ad valorem taxation certain personal property not held or used for the production of income."

PROPOSITION NO. 11 ON THE BALLOT

Section 1, Subsections (f) and (g) of Senate Joint Resolution 12 propose a constitutional amendment to exempt from ad valorem taxation goods, wares, merchandise, and ores other than oil, gas and petroleum products. These items would be exempt from taxation only if they originated outside the state and were located in the state for a period of 175 days or less for purposes of assembly, storage, manufacture, processing, or fabrication. Such property could be taxed by a county, school district, or municipality if the governing body of the political subdivision took official action to provide for the taxation of the items while they were located in the political subdivision. If the governing body of a political subdivision took official action to tax the items before January 1, 1988, the tax would be effective for the 1988 tax year. If the action were taken after January 1, 1988, and before April 1, 1988, the tax would become effective January 1, 1989.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the exemption from ad valorem taxation of certain property that is located in the state for only a temporary period of time."

PROPOSITION NO. 12 ON THE BALLOT

Senate Joint Resolution 35 proposes a constitutional amendment to allow a married couple to agree in writing that all or part of their community property will become the property of the surviving spouse if one spouse dies.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment permitting spouses to hold community property with right of survivorship."

PROPOSITION NO. 13 ON THE BALLOT

Senate Joint Resolution 27 proposes a constitutional amendment to authorize the creation of special districts to provide emergency services. The commissioners court in a county participating in a district could, upon approval of the voters, levy an ad

valorem tax of up to ten cents (\$.10) per \$100 valuation of the property located in the district.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow for the creation and establishment, by law, of special districts to provide emergency services."

PROPOSITION NO. 14 ON THE BALLOT

Senate Joint Resolution 34 proposes a constitutional amendment to allow the state a limited right to appeal criminal cases. Under current law, only criminal defendants are allowed to appeal. This proposed amendment would allow the legislature to pass laws granting state prosecutors the right to appeal in limited circumstances.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment giving the state a limited right to appeal in criminal cases."

PROPOSITION NO. 15 ON THE BALLOT

House Joint Resolution 35 proposes a constitutional amendment to abolish the office of county treasurer in Gregg County and transfer the duties of that office to the county auditor or an elected official designated by the commissioners court. The amendment would also abolish the office of county treasurer in Fayette and Nueces counties if a majority of the voters in those counties vote in favor of the amendment. In Fayette County, the functions of the treasurer would be transferred to the county auditor or the officer succeeding to the auditor's functions. In Nueces County, the powers, duties, and functions of the treasurer would be transferred to the county clerk.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide for the abolition of the office of county treasurer in Gregg, Fayette, and Nueces counties."

PROPOSITION NO. 16 ON THE BALLOT

Senate Joint Resolution 6 proposes a constitutional amendment to allow the commissioners court in a county with a population of more than 150,000 to establish more than one Justice of the Peace court in each Justice of the Peace precinct, i.e., to provide for the election of more than one Justice of the Peace in each Justice of the Peace precinct.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing that certain justice precincts may contain more than one justice of the peace court."

PROPOSITION NO. 17 ON THE BALLOT

Senate Joint Resolution 26 proposes a constitutional amendment to allow the legislature to define by law those municipal functions that are governmental and those that are proprietary. This authorization would apply to laws passed by the 70th Legislature, 1987, and by future legislatures in regular or special session. A municipality is liable for damages arising out of acts committed under its proprietary functions, but not its governmental functions. Definition of such functions by the legislature would clarify the liability of a municipality in civil lawsuits filed against it.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to define for all purposes the governmental and proprietary functions of a municipality."

PROPOSITION NO. 18 ON THE BALLOT

House Joint Resolution 18 proposes a constitutional amendment to authorize the legislature to provide for the creation, operation, and financing of jail districts. Financing of a jail district could be accomplished through the issuance of bonds and other obligations, or by levy of an ad valorem tax on property located in the district if the qualified electors of a district approve an ad valorem tax or bonds secured by a property tax.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment relating to the creation, operation, and financing of jail districts."

PROPOSITION NO. 19 ON THE BALLOT

House Joint Resolution 88 proposes a constitutional amendment to authorize the issuance of \$500 million in general obligation bonds, the proceeds of which will be used to establish a superconducting super collider fund. The fund would be used to provide economic incentives for the superconducting super collider research facility, and the agency administering the fund would be authorized to grant land or property to the United States government for undertakings related to the facility.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the issuance of general obligation bonds to fund undertakings related to a superconducting super collider research facility sponsored or authorized by the United States government, and to make appropriate grants for such undertakings."

PROPOSITION NO. 20 ON THE BALLOT

House Joint Resolution 96 proposes a constitutional amendment to allow the legislature to provide ad valorem tax relief for mobile offshore oil and gas well drilling equipment. The tax relief would be limited to equipment that is being stored while not in use in a county that is adjacent to the Gulf of Mexico or on a body of water that is adjacent to the Gulf of Mexico.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the legislature to provide ad valorem tax relief for certain offshore drilling equipment that is not in use."

PROPOSITION NO. 21 ON THE BALLOT

Senate Joint Resolution 17 proposes a constitutional amendment to provide for legislative involvement in the executive branch of government by permitting the legislature to include the speaker of the house of representatives in the membership of an agency or committee that includes officers of the executive branch of government and performs executive functions. Under current law, the legislature is not allowed to exercise any powers in executive matters under Article II of the Texas Constitution, which provides for the "separation of powers" into three distinct departments.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment permitting the legislature to include the speaker of the house of representatives or the speaker's appointee in the membership of an executive agency or committee."

PROPOSITION NO. 22 ON THE BALLOT

Senate Joint Resolution 53 proposes a constitutional amendment to allow the legislature to limit the term of office of a gubernatorial appointee to a vacancy in a state or district office to a partial, temporary term if the appointment is made on or after November 1 of the last year of the governor's term and the governor is not reelected. Under this amendment, the legislature may provide that the tenure of such an appointee would end sooner than the term would normally expire.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow the legislature to limit the authority of a governor to fill vacancies in state and district offices during the end of the governor's term if the governor is not reelected."

PROPOSITION NO. 23 ON THE BALLOT

Senate Joint Resolution 54 proposes a constitutional amendment to authorize the Texas Water Development Board to issue an additional \$400 million in water development bonds. Of the \$400 million authorized, \$200 million would be designated for conservation and development of water resources, \$150 million would be designated for water quality enhancement, and \$50 million would be designated for flood control. The amendment also authorizes the legislature to provide for review and approval of the issuance of the bonds and the use of the bond proceeds.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the issuance of an additional \$400 million of Texas Water Development Bonds for water supply, water quality, and flood control purposes."

PROPOSITION NO. 24 ON THE BALLOT

House Joint Resolution 83 proposes a constitutional amendment to allow a county to use county equipment and personnel to perform work, without compensation, for another governmental entity if the commissioners court finds that the work will not interfere with the performance of county work and approves performance of the work. The governmental entity must be located wholly or partly in the county, and the governing body of the governmental entity must file a written work request with the commissioners court.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to permit a county to perform work, without compensation, for another governmental entity."

PROPOSITION NO. 25 ON THE BALLOT

Senate Joint Resolution 5 proposes a constitutional amendment to allow the Legislature to authorize Randall County to levy a tax for the benefit of the Amarillo Hospital District. Any such tax could be levied only on property located outside the City of Amarillo and outside the South Randall County Hospital District. The tax could not be more than 75¢ per \$100 property valuation and would be effective only upon approval by the voters in the area to be taxed. If the tax is authorized by the Legislature and approved by voters, the Amarillo Hospital District is to serve residents of part of Randall County. If a tax is levied under this provision, Randall County must repay the State for the cost of publication of this amendment.

The proposed amendment also permits the legislature to authorize a hospital district to change its boundaries or jurisdiction if the district was created or authorized by a constitutional provision that includes a description of the boundaries or jurisdiction of the district. Any change in the boundaries or jurisdiction of such a hospital district would become effective only upon approval of the voters in the district.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to permit the Amarillo Hospital District to serve certain residents of Randall County, to authorize Randall County to provide financial assistance to the district, and to authorize certain hospital districts to change their boundaries or jurisdiction with voter approval."

EXPLANATORY STATEMENT FOR STATEWIDE REFERENDUM NO. 1

Senate Bill 86 submits to the voters the question of whether the 15 members of the State Board of Education should be appointed instead of elected. If the proposition passes, the Governor will appoint a member of the board for each district, with the consent of the Senate. If the proposition fails, the members will be elected from these districts.

The referendum will appear on the ballot as follows:

"The State Board of Education shall be composed of members who are appointed from districts instead of elected, with equal representation throughout the State of Texas."

EXPLANATORY STATEMENT FOR STATEWIDE REFERENDUM NO. 2

The Texas Racing Act submits to the voters the question of whether pari-mutuel wagering should be legal in Texas on a county-by-county local option basis. If pari-mutuel wagering is adopted by the voters statewide, a county must also pass a separate proposition on pari-mutuel wagering at an election held in the county before any such wagering may be conducted in that county.

The referendum will appear on the ballot as follows:

"The legalization of pari-mutuel wagering under the Texas Racing Act on a county-by-county local option basis."

Number For Noah Hotline Announced

The local outreach service of the Noah Project began operating officially on September 1 in Haskell, Knox, Stonewall and Throckmorton counties and in Stamford. Its objective is to provide safety for men and women of all ages and children who are victims of family violence.

A 24-hour telephone hotline has been established, and the number is 817-864-3972.

Betsy Nanny is Noah outreach coordinator in this area. The advisory committee, which is made up of citizens of each county, meet every second Wednesday of each month in Haskell. The Noah Project shelter is in Abilene.

Mrs. Nanny said she has already received several calls on the hotline. Trained volunteers will answer the phone calls on a 24-hour basis. These volunteers have been trained to assist in basic counseling and in delivering information to victims who need help.

Many people are in need of help in dealing with family violence, Mrs. Nanny pointed out. Some do not have extended family members to call on, and others do not have relatives who will help, so someone outside the family is needed to help defuse a potentially violent situation or to work through the pattern of violence so everyone involved can get the therapy they need.
