

I seem to have a real knack for being in the wrong place at the wrong time. Some of the times have been serious. As a little girl, I saw a man stabbed to death right on the street. Another time I was driving behind a car in Stamford that ran over a little boy. Most of the time, however, it's little things like being within ear shot of an argument and expected to take sides.

Perhaps the most trouble this 'johnnyon-the-spot' syndrome has caused-me was in 1972 in a big city hospital.

Tommy had been injured in October in a roping accident and was still a patient in that particular hospital in December. He required constant care, and after he was released from intensive care on the first of November, I had watched him constantly, catching little cat naps beside his bed on the few occasions when he slept. The neurosurgeon told me that he was assigning a special duty nurse to stay with him from 10 p.m. until morning so I could rest and be able to care for him when he came home

Thinking of already staggering hospital bills, I tried to assure him that I could handle it, but I think I was secretly relieved when he insisted on having the nurse come in. I could stretch out in the recliner in Tommy's room when Mimms came on duty and sleep

The first Munday Bloodmobile for 1989 will be held Monday, January 6. Donations will be accepted between the hours of 2:45 and 6:30 p.m. at the Munday Community Center. All persons between the ages of 17 and 70 who weigh at least 110 pounds and are in relatively good health are encouraged to donate at the Bloodmobile.

The goal for the bloodmobile visit is 60 pints, according to chairman Latreace Lane. "We're asking all area residents to roll up their sleeves and donate," Mrs. Lane said. At the end of our last visit, we had collected 56 pints. We think we can top this with the help of everyone who is eligible," she continued.

With the beginning of a new year, Mrs. Lane encourages all citizens to resolve to donate blood regularly, beginning January 16 at the local bloodmobile.

fulout having to worry about him.

One cold December night after she had come in, I walked down the hall for a cup of coffee. My intentions were to go to the waiting room at the end of the hall--quiet at that time of night--and look out over the lights of the city from our seventh floor location. Just as I was in front of the elevators, the door opened and some nurses came hurrying out with a patient on a bed, followed by an elderly man whose shirt and hair were very wet.

He was shaking like he was having some kind of chill as he began to tell me, in an excited voice, how the ceiling had fallen in on them in his wife's room and soaked both of them before he could get her out. She was in a body cast and he was very worried about her. Since he looked so cold and I hadn't taken a drink of my coffee, I handed it to him in an attempt to both warm him up and calm him down.

I saw him in the hall during the following days and he told me they were trying to dry the body cast with sun lamps. Tommy's doctor released him soon after, however, and we came home and I forgot the incident of the man on the elevator.

Five years later, in 1977, Mr. Cotton came to tell me that an attorney was in his office asking to talk to me. It seemed that the man in the elevator was suing the hospital, claiming that due to negligence on their part, his wife had died. He remembered that a woman whose husband had been injured on a horse handed him a cup of coffee that night in the hall. Somehow his attorneys had tracked me down and wanted me to testify in the man's behalf. I told him that I really didn't know a lot about what had happened and I didn't think I could be of much help to his client.

A few days later, I walked out of the school cafeteria and found four junior high students waiting for me.

"The sheriff's looking for you." They could barely contain their excitement. The word spread across the entire junior high campus--"The sheriff's looking for Mrs. Greenwood"--so that by the time I walked to where he stood waiting, I was flanked on the right and on the left, and followed by more than half the junior high student body.

West Texas Utilities Co. requested a fuel factor increase effective in January, 1989, and the North Central Texas Municipal Water Authority received word that the boat ramp project for Miller Creek Reservoir had been approved by the Texas Parks and Wildlife Department.

The Munday ISD Board of Trustees approved the budget and tax rate for the 1988-89 school year and Kent and Bryan Latham took top honors in the sheep division of the Haskell Junior Livestock Show.

Plans were in the making for a benefit show hosted by the Munday EMS to raise funds for the purchase of a new ambulance.

The Mogulettes posted their second cross-country win of the season in Abilene while other Munday High School students were winning ribbons for their entries in the Haskell County Fair.







#### **Pets Should Be Protected During Cold Weather**

While people are busy preparing for winter, pet owners should give some extra attention for their companions of the outdoors.

Special care, such as shelter and adequate nutrition, should be given to protect family pets from wintertime hazards during the cold months ahead. Winter temperatures in Texas are not at such extremes that animals accus-

tomed to staying outdoors will be hurt. If the pet can seek shelter that keeps out chilling winds and covers cold ground, it will be adequately protected.

It is a good idea to provide a blanket

or hay in the dog house to aid in preserving heat for the pet.

Animals that are never outside or are very old or young should not be kept outdoors.

Healthy animals can tolerate cold weather. More food may be needed because the pets need more calories to produce body heat.

The daily water supply also should be checked to make sure the water has not frozen or the pet may suffer.

Each pet also should have a check-up before cold weather sets in. Animals should be checked for internal parasites and blood parasites such as heartworms, and they should have all needed vaccinations.



### **JANUARY 31, 1989**

IS THE LAST DAY TO PAY YOUR 1988 TAXES AND AVOID THE ADDITIONAL PENALTY AND INTEREST CHARGES

### HOMESTEAD EXEMPTIONS

Homeowners are not required to file a homestead exemption annually. If you are already receiving the state mandated \$5,000 homestead exemption or additional oversixty-five \$10,000 exemption, you need not reapply for the taxing year of 1989. However, if you became 65 after January 1, 1988 and before January 1, 1989, you need to apply for the additional over 65, \$10,000 exemption. If you have changed your place of residency, you need to apply for a new exemption. All homestead exemption applications must be filed with Chief Appraiser Oscar Mangis, between the dates of January 1, 1989 and May 1, 1989. These exemption forms are available at the Knox County Appraisal District Office, which is located in the Knox County Courthouse.

### **AG-USE EXEMPTIONS**

Annual applications for qualifying land for agriculture use is not required. If you have been receiving the AG-USE exemption on your land in prior years, you need not reapply for the exemption. If you have recently purchased a farm, you need to report this to the Chief Appraiser. AG-USE exemption forms are also available at the Appraisal District Office. Deadline



### Social Security Offers Services Free Of Charge

People in the area have again been receiving direct mailing solicitations asking that they pay \$7 to join an organization that says it will provide many services related to social security, according to Frances Braden, resident representative of the Vernon Social Security office.

First, there is no need to pay any firm money to obtain any of the services provided by the Social Security Administration.

In return for the \$7 payment, this firm offers to provide a statement of a person's earnings covered by social security, a plastic social security card, and a guide to social security.

Any person can obtain a statement of social security covered earnings without paying anybody. All a person has to do is call any social security office and ask for a request for statement of earnings form. After completing the form and mailing it, the person will receive the statement in a few weeks. This firm can do no more.

In addition, there is no need for a plastic social security card. It is of no use for social security purposes. The social security number card issued by the Social Security Administration is the only official card and should be used whenever a social security card is needed.

People can obtain many publications about social security free at any social security office. Just call the office and ask.
