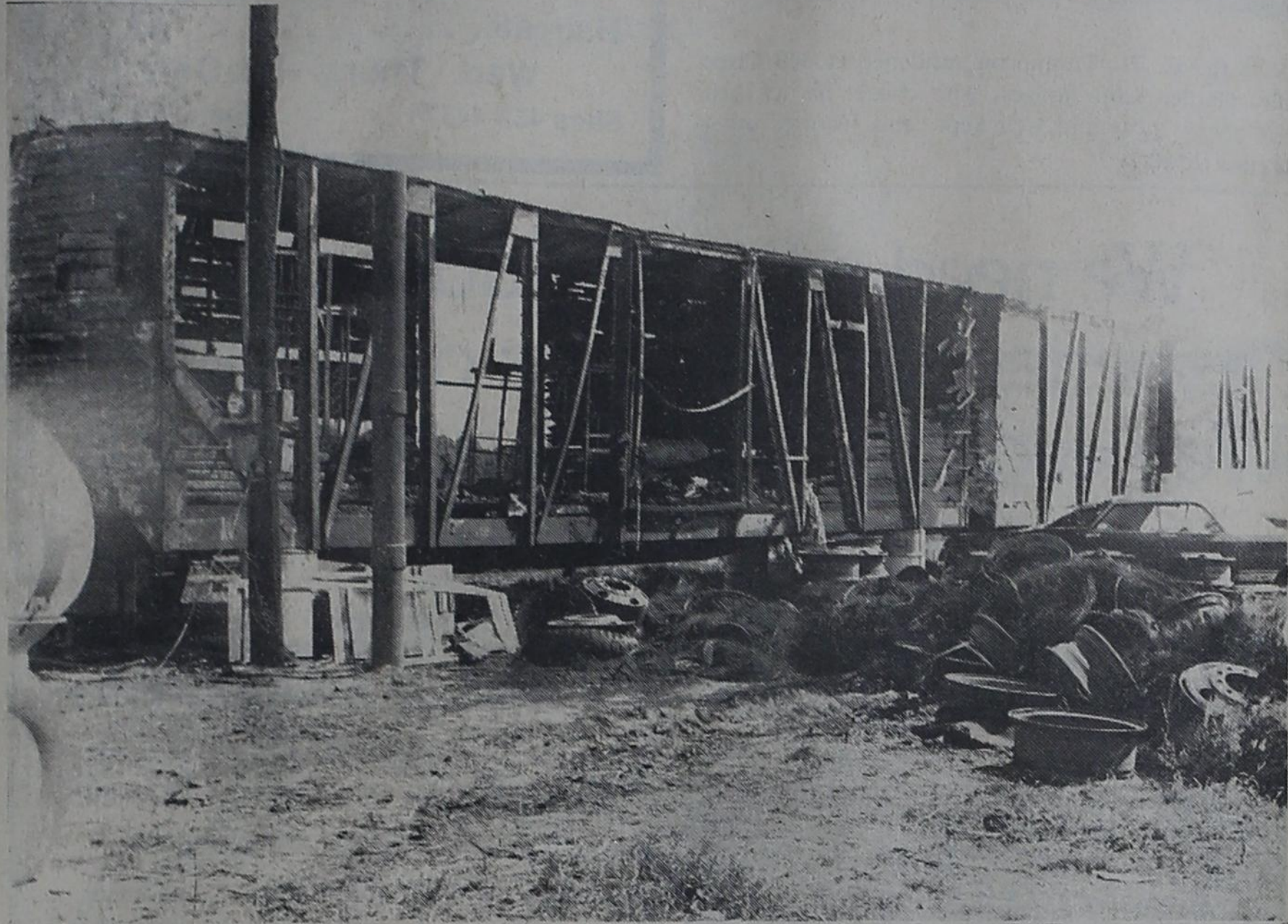

THESE SMOULDERING RUINS were left from a fire Saturday afternoon near the Billie Jake Myers place in Rhineland. The railroad boxcar was used for storage and held pieces of antique furniture which cannot be

replaced. A few firemen made haste to remove themselves from the scene when the truck tires began to explode. The blaze is thought to have been started by burning trash.

Damage Caused By Rhineland Fire

A fire in Rhineland Saturday afternoon caused in the neighborhood of \$25,000 in damage and loss, according to Billie Jake Myers, whose property burned when a trash fire apparently spread. Fire departments Munday, Benjamin and Knox answered the call.

Compounding the flames were explosions from a large number of truck tires which were destroyed. Myers estimated he was keeping between 100 and 150 tires at the time of the fire. Also destroyed was an old railroad boxcar which was used for storage. Myers said it held several pieces of antique furniture which had belonged to his parents and grandparents, along with other miscellaneous items.

Although the Myers residence or elevator were not damaged, a new elevator leg which had been recently purchased to replace old equipment was damaged severely and will probably have to be replaced.

County Highways To Receive Seal Coat

The State Highway and Public Transportation Commission has approved the 1984 Freeze Damage Program, according to Childress District Engineer Lewis H. White of the State Department of Highways and Public Transportation.

In the Childress District the freeze damage repair will consist of seal coating approximately seventy-five miles of highways in five different counties.

In Knox County seal coating is scheduled on State Highway 6 for 7.623 miles at a cost of \$95,400 and on U.S. Highway 82 from State Highway 6 in Benjamin east to Baylor County line for 19 miles at a cost of \$215,400.

White said the contract for the seal coating work was scheduled for the May letting to allow the work to be completed this summer.

Moguls Ready For District Track Meet

The Munday Mogul track team had a good meet at Bowie, running their best times of the year in most events to prepare themselves for stiff competition at the District 4-AA track meet to be held Thursday (today), April 19, in Hamlin.

Coach Jim Edwards commented, "I think we have a good chance at the district title. We need to pick up some points in the field events, which I think we will do, and we need some points from the 100 and 400 meter runs. Paul Wright has been hampered by an injury, but he is looking better and we hope he will be able to come back and run well in the 400. I think we will get some first place wins and have several representatives at the regional meet, but to win the district championship we must have some fourth, fifth and sixth place wins, also."

Edwards pointed out that the Mogul mile relay team is undefeated in competition this year. Other standouts include Frankie Stinnett in the 800 meter run, Todd Thompson in the 200 and Dent Offutt in the 300 meter intermediate hurdles. Quincy Adams, Tim Collier, Jim Earl Dockins and Adam Campos were also cited as having good chances to win at the district level.

GARON TIDWELL APPOINTED TO COUNCIL

Mayor, Councilmen Take Office April 10

The City Council of the City of Munday, Texas met in regular session April 10, 1984 at 8 p.m. at the Munday City Hall.

Members present: Mayor James W. Reid and aldermen Bob Therwanger, Von Marr, Jessie Tucker and Doris Dickerson; also present were aldermen-elect Gary Decker and Richard Albus.

Mayor Reid called the meeting to order. Minutes of the March 13, 1984 meeting were read with no alterations. Mayor Reid stated minutes approved as written.

Next business was examination of the April 7, 1984 election returns. Results determined after examination were as follows: for mayor, Doris Dickerson, 221 votes; (write-in votes - M. L. Wiggins 9, Norman Anderson 1, Gene Brown 3); for alderman (2 year terms) Richard Albus 239, Von Marr 239; (for 1 year term) Gary Decker 239; (write-in votes - Ray Lynn Hardin 1 vote; Garon Tidwell 1 vote). Therwanger moved the following results be declared: Mayor, Doris Dickerson; aldermen (two year terms) Richard Albus and Von Marr; alderman for one year term, Gary Decker. Marr seconded. Voting for were Therwanger, Tucker, Dickerson and Marr. Noes, none. Carried.

Mayor Reid asked the new mayor and council members if they wished to be sworn in at this time or wait until the end of the meeting. The latter was chosen without objection.

Bobby Hutchinson of Munday Ambulance Service met with the Council. Hutchinson presented the mayor a check for \$2,200 from the volunteer ambulance funds to repay a City of Munday loan made in January 1984 when the '82 ambulance was wrecked in the ice storm. Mayor Reid commended the Munday Ambulance Service personnel for early re-payment of the loan and for their ability to raise funds to purchase the ambulances we now own without cost to the taxing entities. The Council authorized payment of a replacement attendant one day while Hutchinson attended ambulance school. Next discussed was the paid coverage for the ambulance attendant - one weekend a month. The Hospital Board will probably consider this at their next meeting in late April. The county commissioners requested delay until after that action, also Goree has not been contacted.

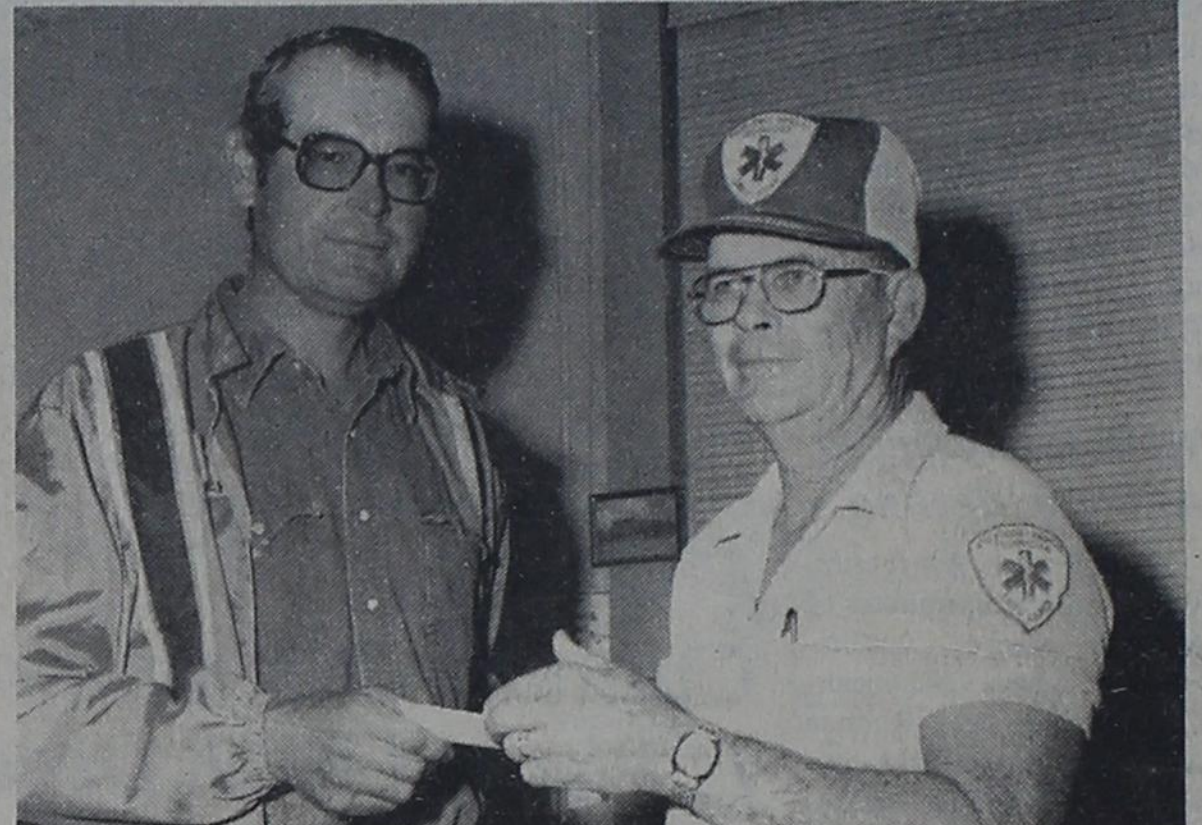
In regard to possible re-location of rental land for private hangers at the airport, a written request to T.A.C. is necessary prior to their review in this regard (recently discussed by phone).

Three men, Jim Graham, Steve Armstrong and Bob Gergens, were in Munday from the Corps of Engineers. After review of options to secure additional drainage from the county road due east into the Corps ditch, Corps personnel requested a letter be written stating the City Council and Drainage District board of directors believe this to be our best option for protection to Munday; also these men stated that some technical advice could possibly be given, subject to limitations of the guidelines under which they operate. The Council authorized the letter be written; also the mayor is to sign same. The City and Drainage District have been working together to try to work out a solution to excessive water at flood stage bypass.

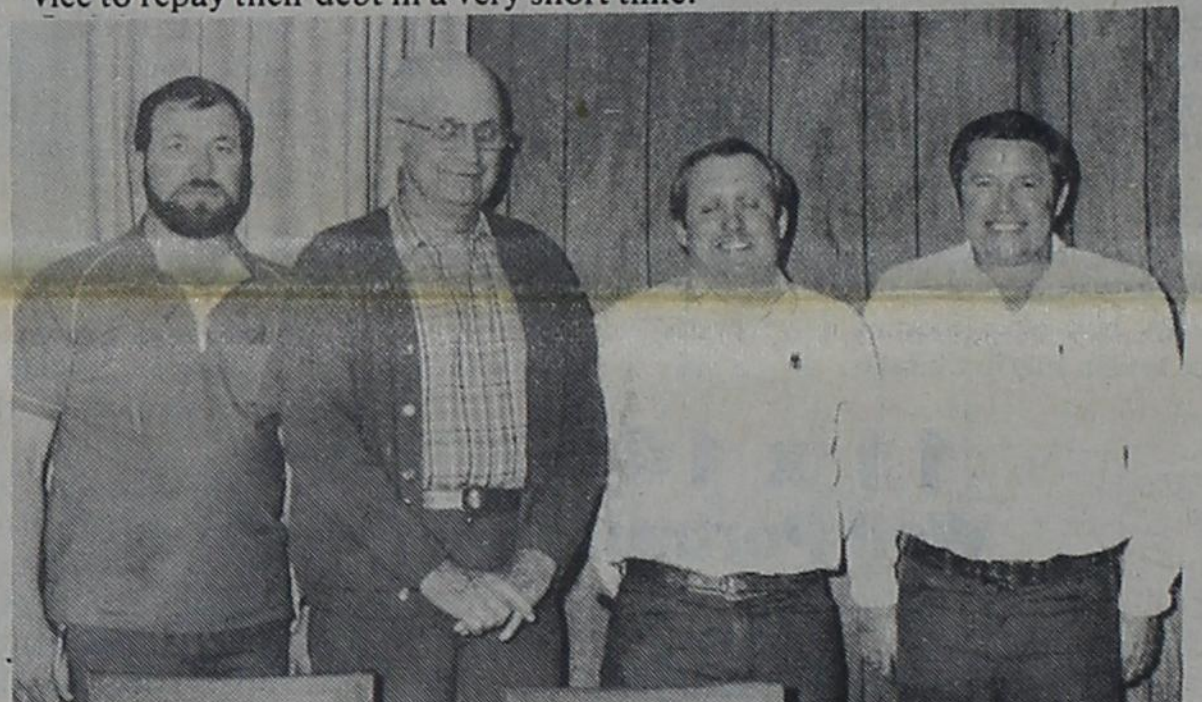

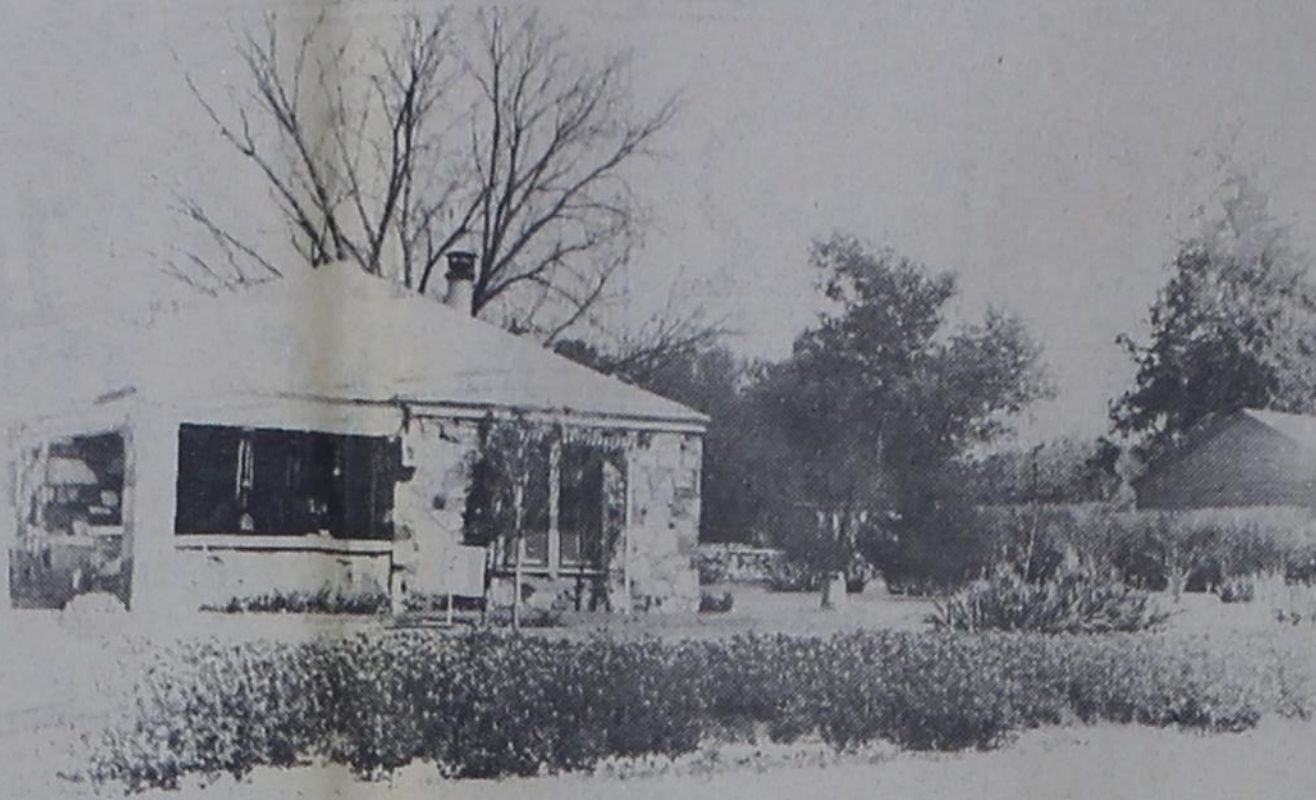

Small Decrease Seen In City's Tax Rebate Check

State Comptroller Bob Bullock recently sent checks totaling \$46.3 million in local sales tax payments to the 985 cities that levy the one-percent city sales tax.

Munday doesn't seem to be taking part in the recovery, however, as our tax rebate went down from \$1,850.11 in April, 1983, to \$1,833.49 this month. Our total rebate for the year is \$13,410.81, about \$500 or 3.64% less than last year's total at this time.

Knox City showed a gain of over \$1,200 in their April check. Our neighbor to the west has received \$21,887.27 this year, 7.72% over the 1983 total.

Benjamin and Goree both show small decreases in their rebate checks, while Weinert is up 26.08% over last year.

School Has Busy Schedule

Sports take the limelight at Munday High School this week, as several district and regional contests are scheduled.

The final district tournament for boys' golf teams was held Tuesday in Hamlin, and Hamlin was also the host city for boys' district tennis action on Monday and Wednesday.

Varsity, junior varsity and junior high Moguls will be in Hamlin on Thursday (today) for the district track meet, and school will be dismissed at 2:30 p.m. for that event. Six Mogulettes will compete in regional track contests at Lubbock on Wednesday and Thursday. Results of all the district and regional competition will be published in next week's Courier.

After all that action, the athletes will naturally be tired, but they will have a long weekend to recuperate, since school will not be in session on Friday, April 20, and Monday, April 23, to give students and teachers a holiday for Easter. Classes will resume at the regular hour on Tuesday morning, April 24.

sing Munday to the north on the west side of town.

City Administrator Hertel reported to the Council on the H.U.D. \$500,000 project progress. Work is being completed on the last concrete box culvert. Street oiling will commence this week and seal-coat work (weather permitting) will proceed shortly.

Operation of Johnson Cemetery was discussed. The new Council was briefed on present operation method. No City tax funds are being used at this time; however, the City continues to operate the cemetery. Present funds on hand will be used most of 1984, when funds will probably be depleted. Johnson Cemetery Trust Fund interest will be furnished by the Johnson Cemetery Trustees as needed after existing funds are expended. Lot sales also support cemetery maintenance.

After discussion Tucker moved that Kristi and Kelli Smith be employed to operate the swimming pool for the summer of 1984. Marr seconded. All in favor.

Easter Sunday is now only three days away. For the next three days we will turn our attention to some of the important implications of the resurrection for us today. Hopefully, you will be led to meditate and reflect upon the truths of the Easter story as you read this article.

Shortly before Jesus went to the cross, He began to prepare His own disciples for His imminent death. The Gospel of John records what He said to His followers for us in chapters 12 through 16. In John 14 as Christ is trying to console His disciples and prepare them for what lay ahead, He says something arresting in verse 18. "I will not leave you orphans; I will come to you." Reflecting back on that promise, we can

see what Jesus meant.

1. *The resurrection opened the door to Christ's abiding presence.* He promised not to abandon His followers, to not leave them hopeless or helpless. The resurrection made possible Pentecost and the coming of the Holy Spirit who abides in every believer. If Jesus remained human, He would have been limited to a particular place, and a particular time. As it is, He can dwell in every believer regardless of time and location. Because He rose from the dead and now lives, He is available and accessible to all. What Christ began in the first century, He now continues through His Spirit and His people. He has not abandoned us. But He has intensified and multiplied His presence among us. Though not visible, He is more with us now than ever before.

2. *The resurrection opened the door to anticipate Christ's return.* This is one aspect of Easter that we fail to adequately emphasize. The purpose of the resurrection is not fully consummated until our Lord returns in glory. He said that His going implied His return. The resurrection is not only an event that draws our gaze to the past, but that forces us to look to the future. Since He rose from the dead, we know He's alive. And we know that He will return to receive us to Himself. The resurrection is not complete until Christ returns for His own.

Munday Gym-Dandeez Win Third At State

"Oh boy, we're going to Amarillo!"

This shout could be heard from several Munday gymnasts when they learned they had made one of the top ten places at the state gymnastics meet held in Brownfield Saturday, April 14. By placing in the top ten, they now advance to regionals at Amarillo on April 28. Re-

gional competitors come from three states, Arizona, New Mexico and Texas.

Out of twenty-two teams entered in the West Texas Tumbling Association state meet, the Munday Gym-Dandeez won the third place trophy. Coach John Mix said this was quite an accomplishment for a team that had been tumbling less than a

year.

The Berryhill twins each placed in the top seven of their group. Also receiving participant ribbons in this age bracket were Robyn Clem and Andrea Longan.

In the Ability I level of girls 9-10, Bridgett Beaty placed eighth, Missy Reneau claimed 10th place, and Dixie Reid was 13th. These girls faced some stiff competition, but put in some prize-winning performances to claim their honors.

Out of a field of 11 boys in the 7-8 age group, Munday dominated the winners' circle as Aaron Kiser took the silver medal (2nd), Jai Reed won the bronze medal (3rd), and Doug Edrington received a 4th place ribbon. Following in these boys' footsteps, the older boys in the 9-10 age group took their fair share of the glory. Robert Under-

wood won the silver medal while Christopher Clem took home the bronze medal.

The Munday girls in the Ability I age 11 and up group grabbed all but three medals and ribbons in their division. Out of twelve girls, Ann Parker claimed the gold for first place, Melanie Little received the silver medal and Robin Reneau took the bronze. Winning ribbons were Jae-Jae Reneau, 4th; Angie Offutt, 5th; Jenni Bowman, 6th; April Offutt, 8th; and Kacy Longan, 9th.

Two Munday girls competed in the Ability II level. This was only their second time to compete in this level. Competition was stiff, but Alicia Cook won 6th in the 11-12 year old group and Lynn Parker won a gold medal for her performance in the 13 and over age group. These girls are to be commended for their wins in a more difficult ability level.

Competitors came from Lamesa, Lubbock, Anderson, Weatherford, Graham, Brownfield, Andrews, Amarillo, Seagraves, Hobbs, Denver City, Plains, Levelland, Poolville, Munday and Wellman.

Coach John Mix said he was extremely proud of the fine performances of the Munday Gym-Dandeez and would be working hard to get them ready for Amarillo.

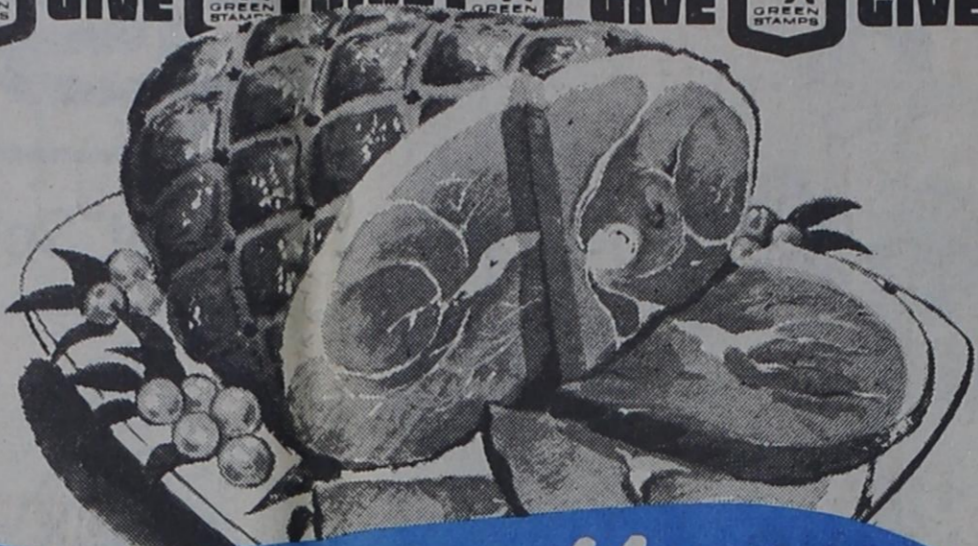

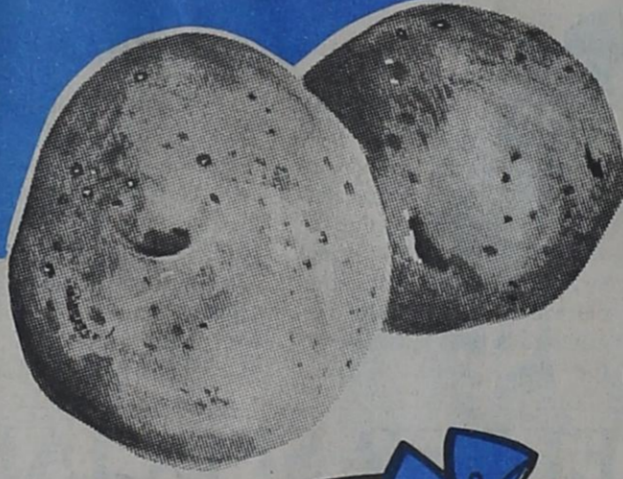

Microwave Ovens: Safety

We recently discussed some guidelines to consider in purchasing a microwave oven. Today let's talk about the safety of microwave ovens.

The microwave oven is probably the safest of all kitchen appliances. The danger of getting burned is much less than when cooking on a gas or electric range. The danger of getting burned by a microwave oven is as likely as getting a skin tan from moonlight.

Although a person is in no danger of getting burned there still seems to be a concern about radiation exposure. Stringent government standards regulate the amount of radiation leakage allowable. No other appliance has such strict manufacturing standards.

The major concern of exposure to radiation leakage is related to any leakage from around the oven door. Microwave oven doors are required to have two or more interlocks so that if one lock should fail to shut off the microwaves when the door is opened, another will take over.

Another regulation limits the amount of radiation that may be emitted around the oven door to levels below which there are clearly no harmful effects.

Microwaves lose power very quickly as they move away from the source that produces them. They would have to enter your body in large quantities to produce enough heat for you to even feel them. If a microwave oven could be made to work with the door opened wide, and if you stood 3 1/2 feet away from the oven, no microwaves could reach you. They are rapidly absorbed into the air.

Microwaves cannot be stored in food. Microwave energy can be compared with a light bulb, when the light bulb is turned off there is no more light. When the microwave oven is turned off the microwaves disappear.

The possibility of excessive microwave leakage is highly unlikely if manufacturers use and care instructions are followed. Check your microwave oven for shipping damage after it has been delivered to your home. The door seal should always be clean and free of food particles. Warm water and mild detergent followed by a thorough drying should be used. The door should never be closed with anything between it and the oven cavity (such as a pot holder). Some experts recommend having the microwave oven checked.

In the early years of microwave cooking, there was concern over the effects of microwaves on heart pacemakers. The early pacemakers received interference from a number of different electromagnetic fields: car motors, lawn mowers, neon lights, as well as microwave ovens. Today pacemakers are shielded and filtered to prevent any electromagnetic interference. It is recommended that any pacemaker wearer consult his physician before using a microwave oven but in most cases there should be no problem or danger.

Next week we will be looking at microwave cooking techniques. I hope you will join me again.

Judging Team Places Third

Spring Weed Control In The Home Lawn

Spring weeds usually get the spring on most home lawns. This problem is a common one that can be easily dealt with and needs to be.

Suzsie Ray of Knox City wanted to know what she could do to get rid of all the weeds in her yard. What Suzsie is seeing in her yard now is the ending cycle of the winter weeds. These include winter ryegrass and henbit. It is too late to justify trying to control these weeds. The best time to control these weeds would have been in January and February.

There is a double problem with weeds now because there are still winter weeds present with spring weeds emerging. All these weeds are competing with the emerging grass for water and nutrients. This makes life hard on the young grass.

The weeds emerging now could have been controlled easily with the application of a premerger such as balan or betasan during the first week of March and a second application the first week in

August. This would control broadleaf weeds and grasses like the grassbur in established bermuda and St. Augustine lawns. A disadvantage to this control method is it does not give 100% control.

It is too late for premerger control. The use of post-emerge chemicals can still do the job.

Most broadleaf weeds in the home lawn can be controlled with 2,4 Dichlorophenoxy acetic acid (2,4-D) with a label "for lawn use only". This is especially true on established bermuda lawns but limited on St. Augustine lawns. Some products cannot be used on St. Augustine lawns, so be sure to check the label before an application is made.

Mono sodium methyl arsenat (MSMA) is the post-emerge chemical to control grassy weeds such as crabgrass and grassbur in bermuda grass lawns only. Some browning may occur after an application is made. This chemical will kill St. Augustine.

To control grassbur in bermuda grass with MSMA, four applications are re-

quired. Applications must be made between May 1 and 7, between June 10 and 15, between August 1 and 7, and between September 25 and October 1. The goal of this program is to keep the grassbur from going to head.

Cultural control of grassbur can be used in a St. Augustine lawn with heavy fertilization, adequate watering and frequent mowing. This establishes a dense turf which crowds out the burrs.

The control methods outlined in this article are general and will work when chemical label instructions are followed. If you have a question about a problem in your home lawn I would be glad to hear from you. I am located on the second floor of the county courthouse in Benjamin or call the county Extension office at 454-2651.

Texas Highways Need Additional State Funds

AUSTIN — Traffic congestion, overweight trucks, and delayed construction and maintenance programs have undermined Texas' mammoth highway system, once touted as the best in the nation.

One segment of Interstate 610 in Houston handles as many cars each day as the total population of Corpus Christi, according to a study prepared by the University of Texas Center for Transportation Research.

With another seven million people expected to move to Texas between now and the year 2000, state government can no longer afford to postpone badly needed highway projects.

Highways are designed to last for 20 years with regular maintenance and, after that point, must be totally rebuilt. Texas has not kept pace with growth or the aging of its overall highway system, which now averages 20.5 years old. The state's farm-to-market roads lag even further behind with an average age of 22.7 years.

In 1982, the state surveyed its highway needs for a 20-year period and found it will cost \$61 billion to repair existing highways and build new ones to carry the state into the 21st Century.

Only \$4.8 billion would go to build highways at new locations, while the largest share, or \$35.2 billion, would pay to rebuild deteriorating roads. Another \$17.1 billion is needed over the next 20 years to rehabilitate and maintain existing highways.

A major boost in federal funding for Texas highway projects came in 1982 when Texas Sen. Lloyd Bentsen amended the Surface Transportation Assistance Act to guarantee that 85 percent of all federal motor fuel taxes paid by Texas motorists is returned to the state. Last year's nickel-per-gallon increase in federal motor fuel taxes raised more dollars to construct and rehabilitate Texas' interstates and federal highways.

But none of this federal highway money can pay for work on

state-built roads. Deterioration of state highways was aggravated by this year's freeze, which caused \$45 million more damage than occurs during a normal mild winter.

Complicating the problem is a requirement that all federal highway dollars be matched in kind with state dollars, leaving accounts for state-built roads close to empty.

Because highway and education funding require immediate attention, I will include both items on a special session legislative agenda early this summer.

I am pleased that Texas has a pay-as-you-go highway funding program, but user taxes and transfers from the state's General Revenue Fund have not kept pace with highway needs. New sources of highway funding are still under review.

No study of highway needs would be complete without an assessment of the demand for public transportation, estimated to cost \$700 million in state funds between now and 2002. If that

amount is appropriated, this state "seed money" would leverage federal and local funds to raise a total \$5.4 billion for public transportation.

To prevent premature wear and tear on our state highways, the Texas Department of Public Safety must enforce weight restrictions for trucks. During the 1983 legislative session, I wrote state lawmakers in support of a bill to increase such enforcement and prevent Texas from losing more than \$340 million in federal highway funds.

The legislation passed and my staff is working to identify additional measures that could strengthen this enforcement effort. Those violating truck weight limits hurt truckers who obey the law and cost Texas taxpayers thousands of dollars to rebuild damaged highways and bridges.

By planning ahead for the orderly care and upgrading of Texas' highway system, we can better manage growth without being strangled by it.

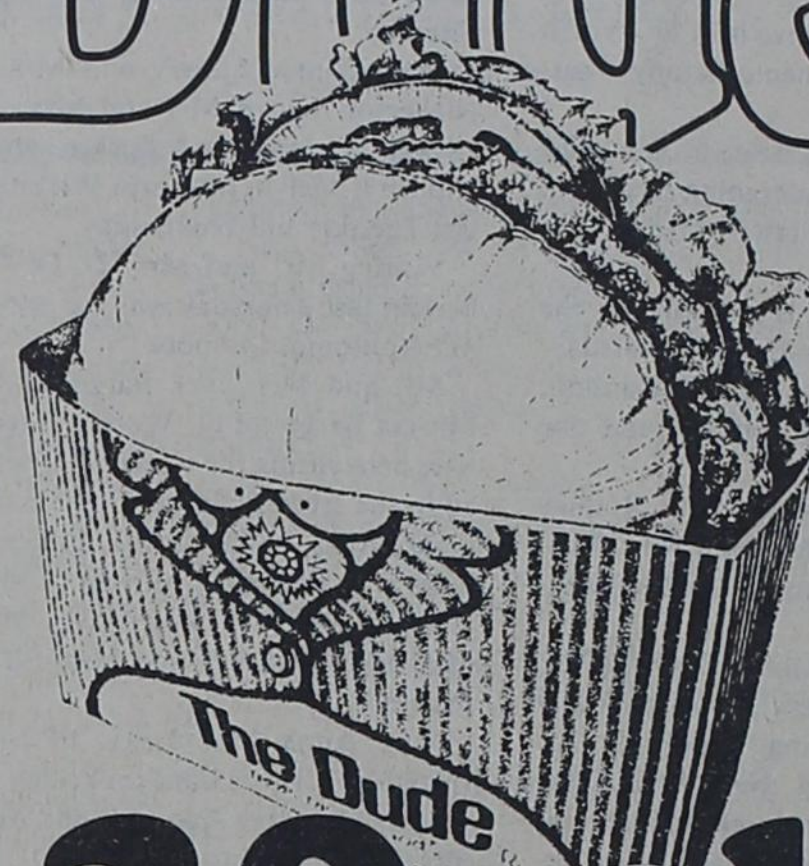

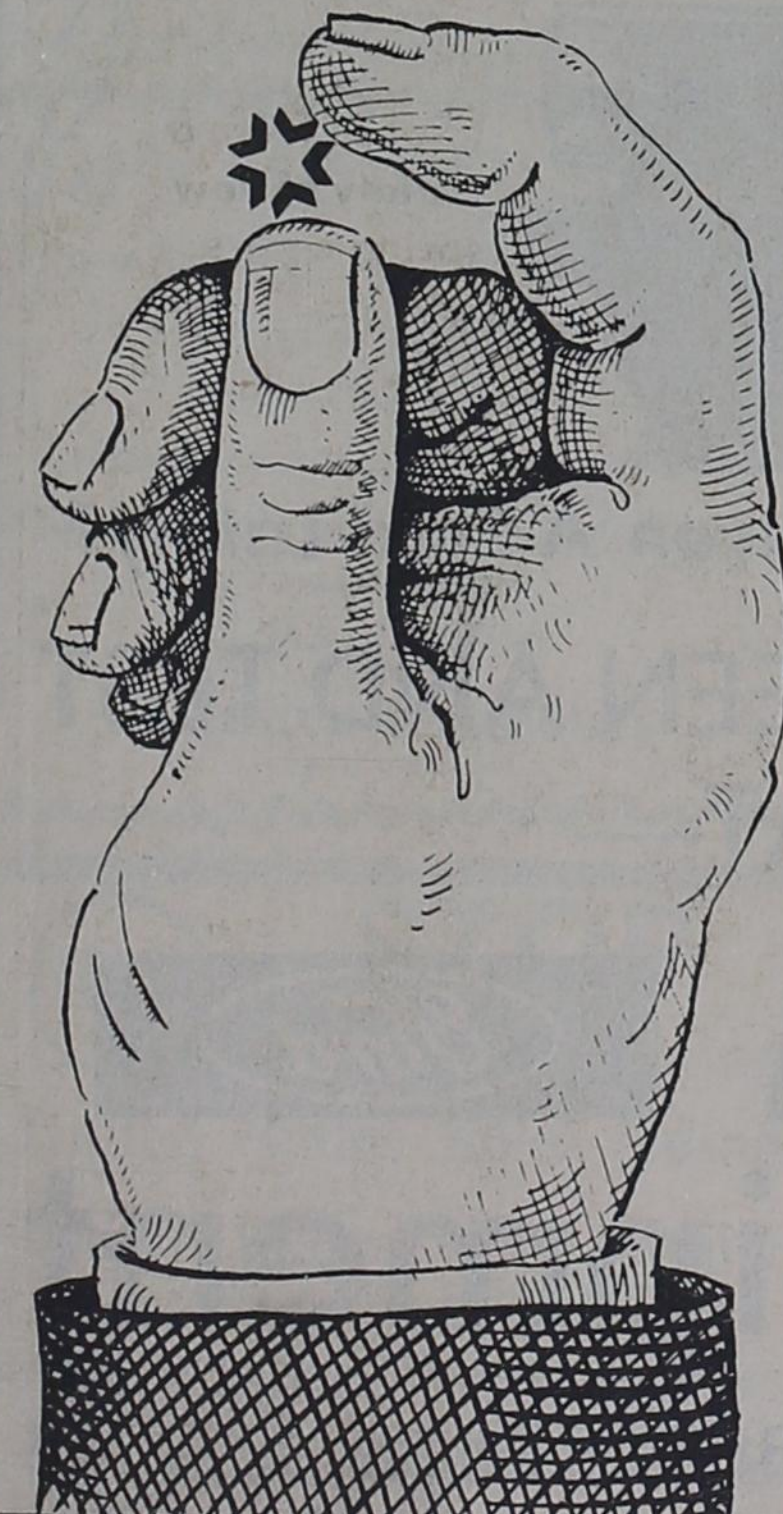

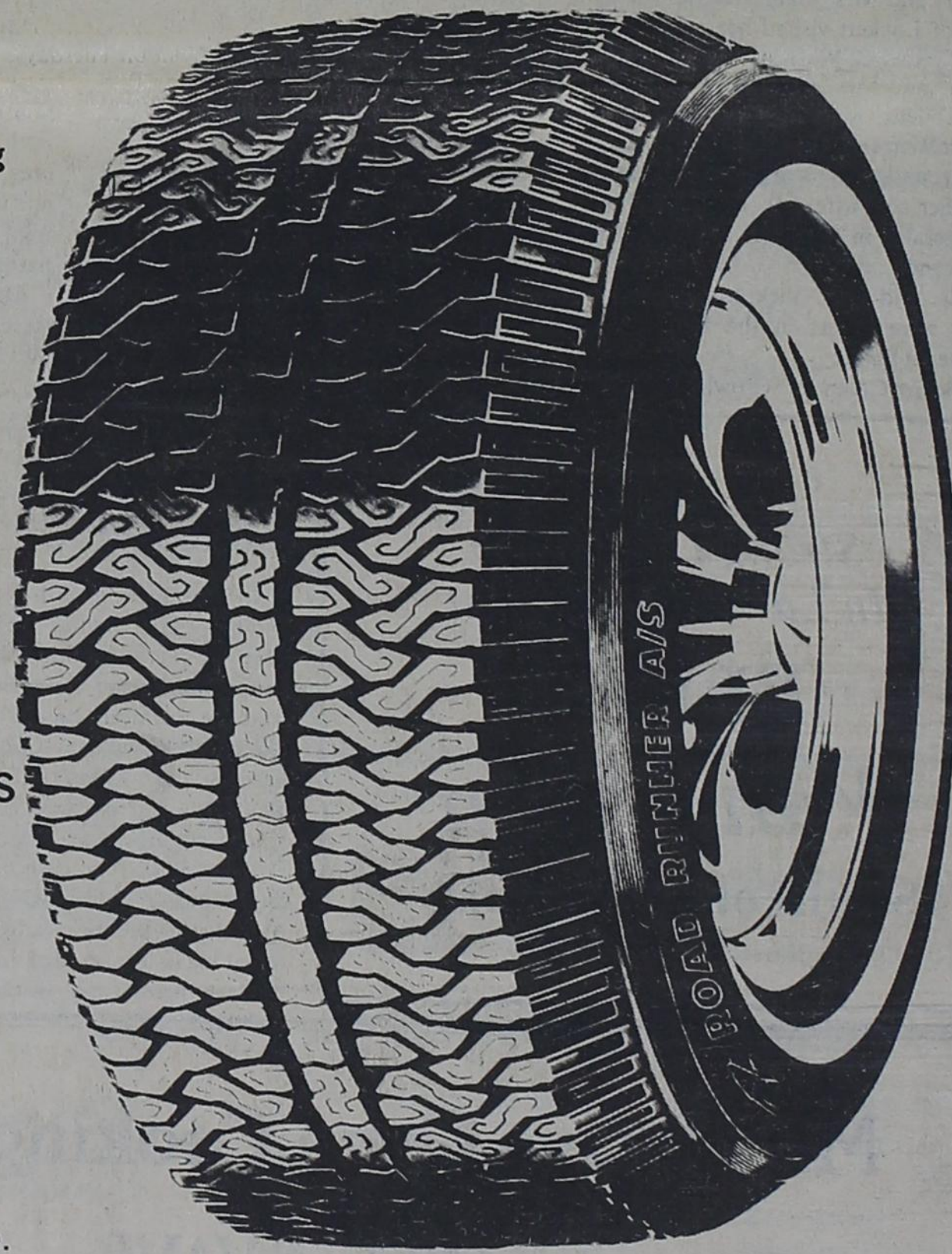

Farm Implement Sales To Rise

Agricultural equipment dealers are banking on farmers to do a little more buying in 1984.

"There is a pent-up demand in the market, and the purchasing cycle for farm equipment is overdue," says Dr. Forrest Stegelin, agribusiness economist with the Texas Agricultural Extension Service, Texas A&M University System. "Economists are predicting improvement in unit sales in all categories of farm machinery and equipment - with a 10 percent increase expected for combines, cornheads, tractors of more than 100 horsepower and four-wheel drive tractors."

"That also means prices will increase by 5 to 10 percent, depending on local demand, the season of the crop year and the competitors' marketing strategy," Stegelin notes.

An increase in cash farm income and prices received by farmers also should enhance demand for new equipment, he adds.

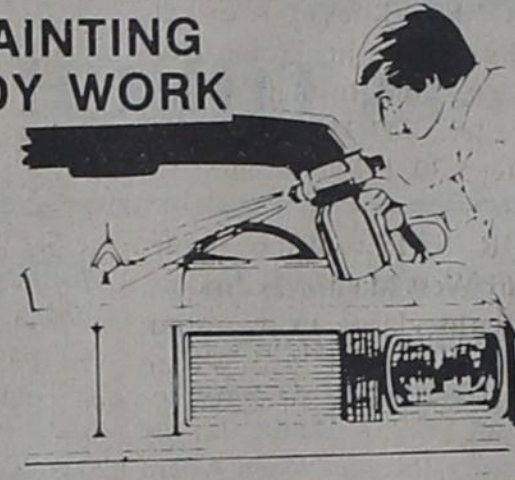
Although sales of tractors and implements are expected to rise, several factors could dampen dealer prospects for sales of new items, notes Stegelin. For instance, there is an abundance of low-hour, good condition, used farm equipment available for low prices at farm auctions and dealer lots. Also, while farm commodity prices are favorable now, increased crop production could lower prices during the second half of the year.

Finally, although loanable funds are available and interest rates for operating capital are not expected to increase appreciably, agricultural lenders are expected to be more selective than in the past, says the economist.

Stegelin advises farmers to shop wisely for machinery absolutely necessary for crop production so as to continue their debt paydown which made some progress last year.

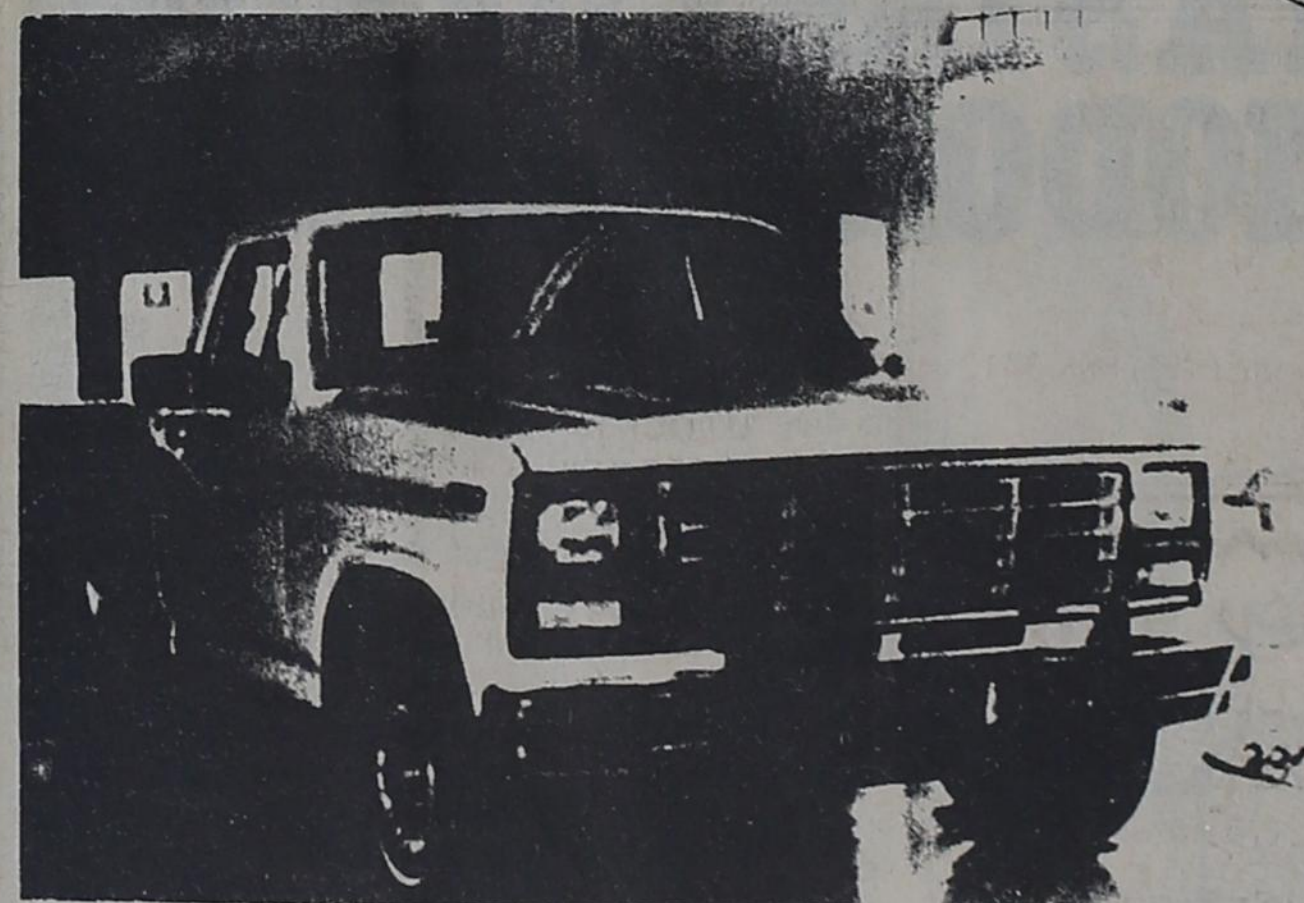




