Texas Election Laws, Art. 8.11: After fixing his signature on the back of each ballot, the election judge shall check all ballots to see that they are properly numbered. removing any mutilated or unnumbered ballots, thoroughly disarrange and mix the ballots so that they no longer are in consecutive numbered sequence or in any sequence of arithmetic or geometric progression, and then place the ballots face down in a stack or stacks from which each voter shall be allowed to take his own ballot without the number being known to or written down in any manner by the election judge. The election judge shall place a notation on the list of voters showing that the particular person has vot-ed, but shall not make any record of his ballot number."

#### Election Board

The unofficial election returns will appear on the big election board on the north side of the court house again this year. The Demo executive committee stated that the returns which will appear on this board will be unofficial and the returns will not be considered official until the votes are can-vassed Tuesday evening, July 29, at 7:30 o'clock at Shirley-Youree Drug. All of the precinct chairmen are urged to be present, as this meeting is necessary to make the election official and to complete the necessary forms to be sent to the State Democratic Executive Committee.

### Early Reports Requested

Mr. Shirley requested that the precinct chairmen bring or call to him at the county clerk's office in the court house results of the election in their respective precincts immediately after the votes have been counted This cooperation on the part of the election officials will be a great help in getting the returns to the people as soon as possible after the polls are closed.

I have heard a lot lately about a long term of office as a county official and that it was a sure way to destroy democracy.



Hudson, who was Sheriff of Van Buren County, Arkansas, for eighteen years. He resigned to avoid hanging three men who were to be hanged the day he resigned. I consider a long term in public office an honor bestowed by the people upon the person holding office, as an evidence they have served the people well. The longer they serve the more experienced they become which makes them better qualified to do their work more efficiently.

When these relatives of mine held office from eighteen to twenty-five years it did not destroy democracy, and there was not any confusion. All confusion that I know anything about is caused by a few on the outside and not the office holder. Good citizens do not cause confusion but do all they can to cooperate that we might have a better community in which to live. Confusion tears down and does not build up any place or any thing.

People should investigate and find out the facts, then stand by those who are trying to serve to the best interest of the people and this would stop a lot of the confusion and untruthful things that are told.

This is my personal feelings and I want to pass it on to the people of Foard County. I want to be a good citizen and I am for the long term office holder one hundred per cent, as they would not be in office if they had not made a good public servant.
